## FROM THE HELM

**B** ack in 1982 the Niguel Shores beach front revetment was damaged in a storm and, at that time, Orange County agreed they would be responsible to maintain and repair the revetment. On July 12, 2012, I attended the California Coastal Commission Hearing as Orange County Parks presented the Niguel Shores Revetment repair application to the Commission for approval. The staff report is available for your review on the Niguel Shores website. The Commission, by unanimous vote, denied the application giving their reasons for its denial.

The Coastal Commission agreed with the Staff recommendation on several key issues. First, relocate the revetment further inland, and increase its crest elevation. The proposed revetment encroaches onto public beach and is too low to prevent overtopping during storms. Staff also recommended that a public walkway be constructed along the top of the revetment that would connect the public walkways both upcoast and downcoast. The subject site is the "missing link" along what would become a1.25 mile long walkway between Salt Creek and the Headland. They felt the walkway would offset some of the public access impacts the revetment would have on the public beach.

They encouraged Orange County Parks, Niguel Shores and its residents, to agree on a plan that eliminates their concerns.

An open meeting for residents, the Board, and County Parks has been scheduled for August 8, 2012 at 6 p.m. in the ClubHouse.

- You submit your HRF to the NSCA office.
- The NSCA staff assigns a number to your HRF and sends a letter notifying you of receipt and that you will receive an update in 45 to 60 days.
- If the HRF can be immediately handled by the staff, you are again notified that the problem has been resolved.
- If the staff cannot answer the HRF, it is sent to the appropriate

The ideal person for these Committees would have current or recent P&L responsibility, knowledge of operating budgets and be willing to make recommendations to the Board on financial and investment matters. **Finance Committee Mid-Year Statement:** Enclosed with this issue of the Seashore News is a mid-year financial statement prepared by the Finance Committee. The Committee has prepared this statement to keep the Association members updated on the financial status of the Association. Please take the time to review the information.

In conjunction with the financial mid-year report, I would like to provide information that might be of interest to you regarding Reserves as an important financial component of our Association. Equipment and major components (like streets) must be repaired or replaced from time to time. It is a sound fiscal practice to plan and set aside funds over the expected life of the major components, therefore the Association puts a portion of your quarterly assessment into the reserve accounts so, when the component needs repair or replacement, the funds are available.

The following are several important reasons why associations put monies into reserves:

- Reserve funds meet legal, fiduciary and professional requirements that may be required by 1) secondary mortgage markets, 2) state statutes, regulations or court decisions or 3) the community's governing documents.
- Reserve funds provide for major repairs and replacement that we know will be necessary to maintain the assets owned by the Association. For example, the Association has a plan for the continued maintenance of all of the streets which is supported by funds allocated each year based on the reserve study. Since this is a common element, every owner shares in this cost through their quarterly contribution to the reserve fund.
- Reserve funds minimize the need for special assessments or borrowing.
- Reserve funds enhance resale values. Lenders and real estate agents are aware of the ramifications for new buyers if the reserves are inadequate. Many states require associations to disclose the amounts in their reserve funds to prospective buyers.

We are currently working with the Reserve Analyst for the preparation of the Reserve Study for 2013. The Reserve Study is a necessary tool for preparing the annual budget. The reserve review currently being prepared will be completed in late summer and a summary document will be distributed to all Niguel Shores Association owners in conjunction with the annual assessment notice in November 2012.

**Renovation of the Nauticus Slope:** As we enter August, the Nauticus Slope is nearing the end of the "Grow and Kill" phase of the renovation. Even though it may not appear that progress is being made, this is an important part of the renovation. During this phase, the goal is to kill weeds and roots from the previously planted vegetation to provide a fresh canvas for the plantings. The Geotech checked the slope after the vegetation was removed to ensure the stability of the slope and has provided specifications for the proper revetments needed. This work will be completed as soon as possible. The current schedule will allow the planting of the slope to be completed by Labor Day. For this project, the Board hired Mosaic Consulting as the project management team to ensure that this project is completed correctly and efficiently.

Landscape Update: As we enter August, there are many landscape projects underway in addition to the regular maintenance. The Board has approved proposals submitted by Harvest to repair/renovate the irrigation throughout the community. The irrigation project will begin with the front yards of Sea Terrace I and II. The schedule of areas to be addressed in posted on the website. In addition, the annual tree trimming will begin this month. Please go to the Niguel Shore website for more details.

**Rules for Political Signs:** As the political campaigns ramp up for the November election, please note the NSCA Rules and Regulations allow <u>one</u> sign per residence. All political signs must be removed immediately following the election.

**Fabulous 4th of July Celebration:** Thank you to our wonderful volunteers from the Recreation Committee, the Men's Club and Women's Clubs for providing a memorable 4th of July Celebration for the community. In addition, I would like to express a special thank you to Securitas, the Maintenance Staff and Karen Decker for their excellent job in providing services and support for this great event. To show the Community's appreciation of these efforts, the Board of Directors presented Certificates of Appreciation at the July 17 Board meeting.

## LANDSCAPE

Nearly everyone in Niguel Shores is aware, by this time, that we have a new landscape contract. Harvest Landscape has been with us for six months now and is hard at work attending to landscape problems that have been accumulating for the past forty years. But, did you know that Harvest grows its own flowers? And, when our bedding plants need to be replaced, it costs us nothing? It's part of our contract with Harvest. It's intriguing to observe what has been planted, as the new plants are green, and the flower beds slowly fill with a riot of color, so pleasing to the eye.

Another advantage of Harvest Landscape is that they understand our satellite watering system and are able to work with it. As a result, our grass is greener, in spite of the lack of rain this past winter. We do still have brown spots, however, and they will be attended to if residents will report them. Please do that. Submit a Homeowner's Request to the office. Perhaps you have a broken sprinkler or a sprinkler has been blocked by over-growth. Whatever reason, and whatever your landscape problem, a Homeowner's Request is the best way to attend to your landscaping needs.

And lastly, if you are a dog owner and you walk about our community with your pet, PLEASE be a good citizen and clean up after your dog. It only takes a minute and is appreciated by everyone.

## MAINTENANCE

We once wrote about rust being evil. Our Maintenance guys have a different view. For them wood rot and rust represent job security.

The entrance gates and fences are undergoing rust removal and painting. The Manta and Cabrillo Gates have been completed. Mariner and Garibaldi should be completed before this article is printed. The Bluff fence will be painted this summer. The Bluff fence, located so close to the ocean, has the most rust damage requiring considerable grinding and preparation prior to painting. A couple of the posts on this fence are beyond repair and will be replaced.

Wood rot gets our street sign posts, coach light posts, log railings, Garden Home benches, and Sea Terrance II mail boxes. This month we have replaced or repaired a street sign on Dasya, coach light posts on Brisbane and Hobart, log railing posts on Garibaldi, benches on Bluehill and Atlantic, and mail boxes on Via Del Cielo.

Replacing coach light and mail box posts involves building and painting the structures in our shop and installing the electrical fittings for the light posts. At the site new cement footings are poured with brackets to mount the posts above grade level. Mounting the posts above grade level will reduce the effects of wood rot.

The large log posts supporting some of our stairways and railings are repaired with a unique process that makes them stronger and more resistant to rot than the original post. This process involves first cleaning out all the rot and then pouring a penetrating epoxy sealant inside the hollow log. After the sealant has cured/dried for a month we fill the log with an epoxy resin mixed with fine sawdust. This needs a couple of more weeks to cure and then the log is capped with epoxy filler. After two or so more weeks to cure, the final step is to paint.

## TRAFFIC AND SAFETY

We are half way through summer already and, for the most part, everything is going relatively smoothly. However, we should address a few house cleaning chores. Such as reminding all residents that admittance to the ClubHouse area and pool should be accomplished with a fob and resident present. Along that line, food and beverages are prohibited in the pool area. Special emphasis should be placed on glass containers as they pose a threat to everyone's safety.

This past month several locked and unlocked cars were entered by car clouts and were either rifled and/or had property stolen. Several cars were hit on the evening of the Fourth of July. With one car alone, the thieves took two wallets containing money and credit cards. Soon thereafter, with these credit cards, the perpetrators bought pizza, gasoline and charged a movie. Hopefully our local deputies will be able to follow up on that information and arrest the thief. Several residents on Halyard have conducted a survey and determined that in the past two years thieves have hit at least forty-five parked cars in that general neighborhood. Apparently and unfortunately, most of these crimes were not reported to our staff or the police.

Several lessons can be learned from this. These matters should be reported as soon as possible so that appropriate community and police action may be taken to stop these crimes. Locking our cars discourages the opportunist from entering our vehicles and pilfering them and at the same time makes it a bit easier for the police to arrest the suspect. Finally, if we choose to leave items of value inside our unattended parked cars it might be wise to leave the car unlocked as the thief would be less likely to damage the vehicle getting in (yes, this was said tongue in cheek). **Note:** Action is being taken to ensure for extra security patrol during hours that these crimes are occurring.

### VIEW PRESERVATION

"View Friendly" Trees: Under rule 4101 Landscape Improvements: "7. Tall trees that cannot be trimmed (King, Queen and Kentia Palms; Star Pines; etc.) may not be planted." Unfortunately over the years, many of these species have been planted without approval of the Architectural Committee. As these trees grow into homeowners' views, the View Preservation Committee receives a corresponding increase in view impairment complaints. Unless a formal landscape plan has been submitted to the Architectural Committee, it has no way to monitor what trees are being planted by residents. Conversely, many residents are unaware of restrictions on what plants they may use. To avoid the inconvenience and expense of trimming or removing trees, slow-growing and/or maximum height limits should be considered when making landscaping choices.

Residents may contact the Architectural Committee if they have questions regarding landscaping.

#### Janet and Richard Mackaig

Trang the doorbell and was welcomed by your neighbor, the multi-talented artist Janet Mackaig. She invited me in and I was instantly aware that I was surrounded by paintings sculptures, photography, and folk art figures of museum quality. We sat down on a settee facing a table covered with folk art figures. Janet explained that she had acquired these during her lifetime of travel. She and her husband, Richard, love to travel and have visited over 120 countries, collecting symbolic figures that reflect the cultural and religious beliefs of many of their origins.

Janet was born in Santa Monica, California. Early in her life she was exposed to an appreciation of creativity while attending a UCLA experimental school from the third grade through sixth grade. Later, her family moved to the San Fernando Valley where she attended Canoga High School. Janet attended California State University, Los Angeles where she earned a BA and later, a Master's Degree in Art. In addition, she has a standard teaching credential and a community college teaching credential in California. Richard was born in Hollywood and attended Hollywood High. He went on to study at the University of Redlands and USC, where he graduated with a degree in business.

The two met in Laguna Beach during Easter vacation when Janet was 19, and their wedding was a year later. That was 61 years ago. Richard worked for years in a family owned Chrysler automobile dealership in Los Angeles. Eventually, he grew tired of the car business and became a successful commercial real estate broker.

Their daughter, Janet, was born a year after they mar-

ried. She has been a school teacher in Orange County for years, specializing in reading. A son, Steve, came along a couple years after Janet. He was with the San Diego Fire department before retiring and now works in arson investigation.

Richard and Janet also have a purebred black Toy Poodle named "Bonaparte." You may have seen one or both of them walking little "Bo" around the grounds. The couple moved to the Shores in 1977 and quickly set up a small studio on the second floor for Janet to do her magic.

Janet says her artwork has covered the gamut, from drawing, textured pieces, sculpture, photography and printmaking to painting. In the first part of her career, she often combined multiple processes in her art but, since 2004, she has tried

to limit the processes, to keep her work simple and direct. Her work is almost always personal in intent. She calls it her visual haiku attitude, autobiographical in nature, giving some subliminal messages about her life. Often poetry is part of this creative process. Her poetry accompanies some of her paintings. She paints intuitively and doesn't always know where the inspiration for her work comes from.

Janet says that she can't explain her creative process completely, and often notices that, when she sees one of her old paintings, she no longer has the same feelings towards it. It's as if it has become its own entity and she's surprised that she was the artist or creator. She says that she has to ask herself, "Did the painting create itself?" However it happens, the result is usually special. She has won many awards and her art can be found in numerous public and private collections. She has had over 600 juried and one-person exhibitions.

Alas, if you're reading the "print" edition, it's only in black and white, (well, technically grayscale), which doesn't do it justice. committee. Just as each one of the committees has a Board liaison, it also has a staff representative. It is the responsibility of the staff member representing that committee to make sure your HRF gets to the correct committee.

- This is where some time may go by before you hear a response. Most of committees meet once a month. The staff member makes sure that all HRF's received leading up to that meeting are included on the committee's monthly agenda. For example, the Landscape Committee meets the second Monday of the month. If you submit your request after the monthly meeting, say on the second Tuesday of the month, then the Landscape Committee will not review you request until its next monthly meeting. Be sure that you review the committee meeting schedule dates available in the monthly newsletter. This may result in some days saved for review of your HRF.
- The HRF you sent is now part of the agenda for one of the NSCA resident volunteer committees. It is important to note that when you submit a HRF, it is your neighbors, volunteering on a committee, that make every effort to solve your problem. The committee thoroughly discusses and reviews the HRF. A decision is made

that addresses the homeowner's request and is within the guidelines of our regulations. The staff representative immediately notifies you in writing of that decision.

- Occasionally the Committee is unable to immediately answer a request. For example, any request that requires an expenditure not covered in the committee's current budget is forwarded to the Board along with the committee's recommendation and becomes part of the Board's agenda for the next meeting. The Board then makes a final decision and as above, the NSCA staff representative will notify you in writing.
- The staff also uses the information from the HRF to try to anticipate similar issues that may occur in the future and proactively address them. This allows the staff to solve the problem before a HRF is needed.

As you can see from the above, the staff and volunteer committees give every consideration to your requests and will follow your HRF through conclusion.
