

## BYGONE NEIGHBORS

Our newcomers may not know that the magnificent display of multi-million dollar houses rising there on the headlands are being built on land that housed those many trailers and happy weekends at the beach. Several Niguel Shores residents had places there or, oftentimes, their parents did.

Janet Dohner, whose parents, Karla and Dick McNair, had a trailer there in

the 1960s, gave me an original brochure (for the Dana Point Historical Society files) advertising that trailer park



"Each beautifully landscaped mobilehome site will accommodate trailers of every size up to 10 x 60 foot plus cabana; each has a broad, sweeping view of the ocean. A short walk along landscaped paths takes you to the luxuriously appointed Club House. Here in spacious comfort members can relax in the TV Lounge, match wits and luck in the Card Room and dine on tempting and delicious food and snacks in the Coffee Shop. And when your mood calls for outdoor fun, ping pong tables, shuffle-board courts and a sheltered 25 by 60 foot heated swimming pool await your pleasure...as well as the mile-long private beach, ideal for surf bathing, surf fishing and strolling." The community had piped natural gas, a telephone to each trailer through a message-taking PBX Board in the office and TV connections to the master antenna.

The Club was opened in the mid-

1950s by the Chandler-Sherman Corporation who owned the headlands property at the time. The corporation was formed by Harry Chandler, publisher of the Los Angeles Times and General M. H. Sherman, Director of the Pacific Electric Railway Company. They created this major real estate group that, among many other investments, bought 1,388 acres in Dana Point that included the headlands. They were involved, also, in the initial development of Dana Point by S. H. Woodruff in the 1920s. The Chandler

family had several of the trailers on the lower portion of the trailer park on the beach which you can see in one of the photographs. The Dana Strand Club thrived for a number of years until news came that the property was to be developed with housing and the Club was eventually closed. Several of its residents then bought in Niguel Shores and have fond memories of their time in Dana Strand right on the beach. Fritz Hill told about his mother having a trailer there for many years where he continued on page 12

### **FINANCE**

Good News for Niguel Shores! As we enter 2013, the Finance Committee has good news to report concerning the financial health of Niguel Shores. The community reaped the benefit of many improvements and updates in 2012, thanks to the solid stewardship of the Board, the Niguel Shores staff and the countless hours spent by various Committees working on the behalf of all residents. Thanks again for all the hard work!

There is good news to report on the financial health and status of Niguel Shores as the calendar year 2012 came to

- Niguel Shores is expected to end the year with a surplus of monies from the operating budget. This surplus is a result of cost management and the higher income than budgeted for 2012.
- We are projecting that the Reserve Fund will be 85% funded at the beginning of 2013. The 2012 Reserve Study (conducted by an independent service) indicated the current monies needed for planned repairs, enhancements or maintenance are available for implementation in 2013 and future work money is being reserved appropriately in anticipation of longer term needs. Keep up to date through the Seashore News on the planned enhancements to the community in 2013.
- There are no increases in assessments for 2013! Good news for all!!

The Finance Committee is committed to keep residents updated as we move ahead and we look forward to serving the community in 2013.

### LANDSCAPE

Walking the numbers: Have you walked the full acreage of our Niguel Shores Community lately? It consists of the first built Broadmoor homes, 67 in 1969 followed over the next nine years by custom homes, 56; Breakers Isle, 23; Shores Gardens, 144; Berkus, 105; Sea Terrace I town homes, 239; Garden homes, 174; Sea Terrace II town homes, 77; Villas, 75; totaling 960. There are five entrance gates to our community: Mariner Drive, Cabrillo Isle, Selva Road, Manta Court and Garibaldi.

Maintaining the numbers: The common areas of these 960 homes and gates, along with the turf areas, planters, slopes, parks, Beach Bluff Park and over 1600 trees all require maintenance, trimming, thinning, watering and replacing. Harvest Landscape has accepted the challenge and responsibility to maintain these areas and

is working hard with your Landscape Committee representatives: Chairperson Donna Rosecrans and Joan Beyer, Ellen Dovey, Sue Forrest, Kathy Jones, Linda Koppang, Karen Linger, Linda Ross, Janet Traver, General Manager Deborah Baker, Matt Northrop, staff liaison and George Cooley, Facilities Manager. We all have the same goal of beautification using the most cost effective methods allowing our beautiful Jewel by the Sea to shine. Our entrance gates have been brightened with the seasonal red cyclamen and white snapdragons that will take us into 2013.

Demonstration: A small new demonstration garden has been planted by Harvest Landscape in place of a small area of turf to see which plants work best for this area. The location is at the corner of Periwinkle and Niguel Shores Drive, opposite the tennis courts. Check it out.

On behalf of the Landscape Committee, we wish all of you a very positive and Happy New Year! We would also like to take this opportunity to add our thanks to Maintenance Committee volunteer, Suzanne Enis, for the lovely nautical-themed holiday wreaths that decorated our gates during the Season.

### **MAINTENANCE**

Maintenance put up the Holiday decorations and completed several 2012 projects in December. Decorations included the unique seashell wreaths on the entrance gates designed and created by our committee member, Suzanne Enis.

Installation of the new exit spikes at the Garibaldi gate completes the gate hardware restoration on the five entrance gates. Painting the beach bluff park fence completes the painting project that included the five entrance gates and the surrounding fences.

A professional sidewalk safety inspection was completed. Four concrete repairs were done in December and early next year the committee will determine where grinding may be necessary.

Residents entering the Selva Gate and turning right on Windward will appreciate the Windward speed bump being moved back fifteen feet. This allows a smoother, straight on crossing of the bump instead of the teeth jarring angle approach.

Replacement of the pressed brick at the entrance to Salvador Bay and the gates at Manta and Garibaldi completes this 2012 project. This has been an ongoing project which will be completed in 2013 with replacement of pressed brick at three Garden Home street entrances.

### TRAFFIC AND SAFETY

Speeding and Stealing

Racing Team: We hope everyone had a good year and finds themselves looking forward to even better and safer new year. We understand that Santa made a safe and successful visit to our community. However, knowing a bit about everyone's behavior, he apparently felt he had to get out of here quickly and ensured that he stayed clear of the streets around Atlantic and Windward, and also Periwinkle and Niguel Shores Road. This year he strictly approached by air as he was concerned for his team's safety. He took precautions because of tales about members of the famous Niguel Shores Racing Team speeding in unsafe fashion in

these areas. I think Santa actually over reacted as this informal group of speeders generally operates only during week days and during peak traffic hours, not at midnight. From quite a few reports, the racing team is made up of moms and dads that operate sport utility vehicles loaded with children and no matter the speed these vehicles seem to be traveling, they are almost impervious to a speed bump. These racers have generated a good number of complaints from concerned neighbors. Our Dana Point deputies are prepared to take appropriate enforcement action to ensure the safety of everyone. The speed limit for a residential neighborhood is normally 25 MPH. However, this may well be an unsafe speed and citable depending on conditions such as pedestrian traffic, other vehicular traffic, wet streets or turns in the road.

Thieves: There were no reports of Santa parking his sleigh on the streets and leaving it unattended while he visited and left gifts. He clearly knew better as the local thieves would have been on such an open contraption loaded with gifts like flies on honey. For instance, just after midnight one day last month they entered at least three unlocked cars parked on Windlass and got away with miscellaneous property, credit cards and over \$3000 worth of video games destined for charitable causes. I am sure cars were entered on other streets and either no property was taken or the matter was not reported to our deputies. I am sure that it occasionally happens, but I am not familiar with a report of forced entry on a locked car parked in this community. Living in a safe community, we tend to become complacent and sometimes forget to properly secure our valuables. An analogy may be between leaving food out at night and attracting ants or even cockroaches. Last but not least, should you fall victim to a thief, report it to deputies. In doing so, there is a chance you may get your money back, the thief is caught with your valuables and, more importantly, it is in the best interest of our community and ensures that we receive warranted police attention.

By the way, did anybody see Pat O'Brien practicing his skate boarding the other day? Understand it was quite a show. God Bless.

### **GARDEN CLUB**

Well, here we are in the New Year!

Looking back on 2012: The Garden Club membership enjoyed another year of fun, botanic education, social service, a very successful community plant sale and great parties. The year ended with a beautiful Holiday Party in the ClubHouse, complete with a gift exchange and delightful decorations, to a sold-out crowd. Everyone left with a raffle prize. Our Treasurer, Karl Kuhn, reported that our finances were in good order, and the Club was very solvent.

Ringing in the New Year: The Garden Club has planned another full Spring of workshops, lectures, field trips and the ever-popular Beach Bluff Bar-B-Que. We kick off January with a field trip to the Plant Stand in Costa Mesa. They have a huge variety of plants; and we'll hear a lecture on house plants, their care and feeding, and which ones will provide us with green-thumb satisfaction. Note: Members can use their CGC cards for discounts at the Plant Stand.

So you want to grow herbs? Here are some basics: Herb Gardening 101

Uses for Herbs: The most popular use for herbs is in cooking, and nearly every recipe can be enhanced with the addition of appropriate herbs. Can you imagine tomato sauce without oregano? Thanksgiving stuffing without sage? Some dishes are defined by the herbs they contain—pesto without basil just isn't pesto! Many herbs are also believed to have medicinal properties. The echinacea that has become popular as a cold remedy is extracted from the purple coneflower, a common garden perennial.

Where to Plant: Plant herbs where you can get to them easily for frequent

harvesting, especially if you plan to use them in cooking. You can grow herbs in containers or even window boxes. Most herbs prefer full sun—at least 6 hours per day. Herbs that will tolerate some light shade include chives, cilantro, dill, and mint. Remember that if you plant perennial herbs in the vegetable garden, keep them in a separate section so you'll be sure to avoid them during spring and fall tilling. # Travel Tidbits ... Surprising Surinam

here are different types of travelers in the world. Some who like to do meticulous research. They scour the library and internet for every detail and picture of their destination. Their trips hold few surprises and that is the way they like it. Others delight in taking off with a minimum of information and enjoy the adventure of making discoveries on the go. And then there are those of us in between. I had the opportunity to go to Surinam or Suriname (you see it spelled both ways). What did I really know about the country? It is in the very north of South America, wedged between Guyana (where Georgetown is—remember the horrific cult suicide some years ago) and French Guiana which is the site of the European Space Agency's primary launch site. The country was settled in the 1600's by the Dutch when plantations of the New World were thriving based on the slave trade.

What did I learn? Paramaribo, the capital, is centered in the north of the country bordering on the Atlantic. Their very large airport was built by the United States in World War II. From the city you can go dolphin spotting in traditional tent boats or visit a Maroon village known for its wood carving. Maroons are descendants of slaves who ran away from their plantations and survived in the jungle. You can check out the Amerindian pottery made by the original inhabitants of the area.

There are two major rivers that flow through the jungle to the ocean. The jungle is pretty much uninhabited except for scattered Amer-Indian villages. The population is made up of descendants of the original slaves and many people of Indonesian, Indian and Chinese descent. Their ancestors came to work the plantations when slavery was abolished.

The city is busy and crowded. But there is another Surinam. A two hour ride out of town brings you to Bergendal, an Eco and Cultural river resort. Tucked along the Surinam River, the resort offers riverfront and hillside lodges, open air dining, swimming, nature trails and an adventure center where you can kayak, zipline,

hike, etc. Very civilized adventure in the jungle.

If you are tired of the resorts in Mexico, Hawaii and the Caribbean, you might want to try Surinam.


#### SAM IOHNSON
