# FROM THE HELM

**Turf Reduction:** For those of you who were unable to attend the February 12 meeting, Steven Schinhofen, the owner of Harvest Landscape, explained our Turf Reduction Project. Over the next few months we will be removing around 10 per cent of our grass area and replacing it with ground cover and plants. This project is part of the Master Landscape Plan which will reduce our use of water and decrease maintenance.

**Revetment Repair:** On March 19 there is an Open Meeting that I hope everyone will attend. The main topic is the revetment, which protects the homes on Breakers Isle and the Bluff from storm damage. We have a contract with Orange County requiring the county to repair and maintain the revetment. Over the last year and a half we have tried to get the county to do this repair and their position is *that it is an impossible contract to fulfill*. Unfortunately, this is now in the hands of our attorneys and may result in great legal expense to the community. Please attend!

**Entry Gate Signage:** Also, the Traffic and Safety Committee recommended to the Board and the Board approved new signs at the entry gates which will read: *Let the vehicle clear the gate before proceeding*. Hopefully, this will reduce the number of flat tires caused by tailgating.

# EMERGENCY PREPAREDNESS COMMITTEE

As mentioned in earlier issues of the SSN, the Niguel Shores Board of Directors has recently decided to seek residents' input and volunteers to help organize an Emergency Preparedness Committee in Niguel Shores. In February, the Board appointed four residents to this committee. The purpose of this article is to introduce the community to the residents who so generously responded to the call to volunteer for this committee and to give you a brief overview of their plans.

Kent Wellbrock not only volunteered for the Emergency Preparedness

Committee, he has also agreed to serve as the committee's first chairperson. Kent and his wife Gaye and their two children Ryan and Riley have lived in Niguel Shores since 1998. Kent was born in Chicago and served in the Army Special Forces Unit at Fort Bragg, North Carolina. He completed his airborne training at Fort Benning, Georgia. Most of his professional career was in the healthcare industry, having worked for 36 years with Johnson and Johnson Company both here in the United States and overseas. Kent is no stranger to volunteering; he presently



## 2012 Niguel Shores Real Estate Report by Steve Weiser, Niguel Shores Realtor

n 2012, 38 homes were sold in the Shores, an increase of 46% compared to 2011. The average selling price also increased by 9%. Homes rallied to sell faster in 2012. On average homes sold in 83 days versus 119 in 2011, when listing inventories were running at historic lows. Compared to all of Dana Point, The Shores year to year price appreciation at 9% was more than double that for the city.

The chart below shows actual sales and average price for each tract in the Shores. The Pie Chart displays the year to year percentage price change by tract.

Notable changes in price compared to last year were: Inland Garden homes average price was lower than 2011 by 7% (this decrease was largely due to several very low priced 2012 short sales and foreclosure bank sales). Custom Home prices were lower by 26% (reflecting weaker demand for luxury homes and price reductions by motivated sellers). Both the Oceanside Garden Homes and the Villas experienced strong demand pushing prices much higher than the previous year. Finally, there were too few sales in the Terrance or Broadmoor tract to make any pricing changes statistically relevant.

Most indicators point towards an improving 2013 Niguel Shores real estate market. Even though a few tracts showed year to year price reductions in 2012, we expect all tracts to have positive price appreciation and robust sales in 2013. Niguel Shores is strongly 'in demand' again.

Two important dates to mark on your calendar: (1) **Meet the Candidates Night** scheduled for Tuesday, April 16 at 6:00 p.m. This forum provides an opportunity for homeowners to hear from each candidate and ask questions. It is scheduled prior to the mailing of the ballots, so everyone can be prepared to vote once the ballot is received. (2) The **Annual Meeting** is scheduled for Tuesday, May 15 at 7:00 p.m. in the Clubhouse.

**Beach Revetment Discussion — Open Forum March 19:** As mentioned in The Helm article, the Open Forum at the March 19 Board meeting will be focused on the beach revetment and what actions have been taken by the Board with Orange County Parks as related to its repair. This will be an informative meeting.

**Turf Reduction Landscape Project:** On Tuesday, February 12 at 6:30 p.m., Harvest Landscape and South Coast



Water District (SCWD) made a presentation to residents in the ClubHouse explaining why the turf reduction project was introduced, how it will benefit the community and explained the general plans for the areas noted on the maps. By removing slightly more than 10 percent of our 900,000 square feet of turf, we are able to save money, save water and prepare for additional savings should water rates ever increase (which they probably will). The thought of turf reduction may raise some concerns, but actually the areas that have been identified are passive areas: sections that are either smaller patches of turf which have improper irrigation, or areas that are remotely located and hard to maintain. This project will not take away from the beautiful green belts that are appreciated by all.

Thank you to those residents that attended the presentation and/or have responded to the information provided on the Website. Management has received constructive comments regarding the different areas identified for turf reduction and several areas have been modified to address the concerns. The area maps showing the turf reduction project are posted on the Website. Harvest began work on Area 3 in February. The turf removal will take about two to three weeks and then planting will begin. All of this work must be completed and verified by the water district by June 1 for NSCA to receive a water district rebate.

The turf area located along the Mariner Drive entrance was included in the Water District's program, but the Board has not approved this area yet. In March, a special meeting will be scheduled for the Board to interview Landscape Architects for the preparation of designs for the front entrance. Over the last year, there has been much discussion about the entrance so this is a good step forward. The meeting will be scheduled in March and will be properly noticed.

**St. Patrick's Day Celebration:** The Recreation Committee has planned a St. Patrick's Day celebration Sunday, March 17 from 4:00 to 6:00 p.m. at the Community Center patio. Come enjoy complimentary green beer and corn beef sandwiches with the neighbors, friends and family.

## COMMITTEE REPORTS

### EMERGENCY PREPAREDNESS

In the February issue of the *Seashore News*, it was announced that the Board of Directors has established a NSCA Emergency Preparedness Committee. Its primary intent is to provide information and resources to keep our residents up to date on measures they can take to prepare for various emergencies and home safety.

We plan to use monthly updates in the *Seashore News* and on the Website (www.niguelshores.org) to bring to bring useful suggestions and tips on how we can all be better prepared for unexpected events. We chose our first topic as:

How to Prepare for Electrical Power Outages: How about a little quiz to start us off?

- 1. How long will a power outage last?
- 2. How will we/I communicate with people outside my home?
- 3. What will I do to see better after darkness?
- 4. What will I do if my refrigerator/freezer doesn't have power?

- 5. What if I need to get my car out of the garage?
- 6. How will I keep cool/warm if it's Winter or Summer?
- 7. How will I be able to cook if I don't have a gas range/oven? Think you have answers to these questions? Check out some of the suggestions below:
- 1. Many power outages are a result of our local utility having a defect in a generating plant or to regulate electricity in a high usage environment such as extremely hot weather. This could last for a brief period or many hours or even days, thus the reason to be prepared.
- 2. To communicate with someone outside your home you should consider having a cell phone or pager. If you have a computer, keep it backed up regularly and consider buying extra batteries if you use a laptop. Also, having a DC converter allows most laptops to be run off the cigarette lighter in a vehicle. Make sure you have a battery powered radio/alarm clock or one that uses a hand crank or solar power. And, of course, don't hesitate

to walk next door to get assistance from a neighbor. Remember too, if you have to leave home, keep your car half full of gas since gas stations can't pump gas without electricity.

- **3.** You should have more than one flashlight with fresh backup batteries. Candles are a good reserve but make sure they are on the right surface and anchored to insure stability. Don't forget to have matches! You can also purchase lights that plug into outlets and come on in power outages and last for a number of hours. Not a bad idea to turn on one light so you will be alerted to when the power comes back on. For more elaborate backups you might consider portable generators or inverters, but these come at higher costs and other considerations such as gasoline storage and the need to operate outdoors.
- 4. Some important tips for using your refrigerator if the power goes out: if it's only several hours it shouldn't be a problem. Grouping items closer together in your refrigerator will slow warming. Consider using some plastic containers full of water in your freezer so they will keep food cold longer or if you want to move them to a small ice chest to keep medications cold if that's a requirement. Also, keep the fridge & freezer doors closed as much as possible to conserve temperature.
- 5. Many of us have electric garage door openers that would be inoperable without power. Make sure you know how to disengage the mechanism that raises & lowers the door before you attempt to open or close the door. However, many doors are heavy and difficult to open or close manually. Ask that weight lifter next door to help if you must get your car out. Also, some newer garage door openers have backup batteries if you're considering buying a new opener.
- 6. In cold weather you can rely on things you already have in the closet: coats, sweaters, blankets. How about a gas or log burning fireplace? When it's hot, open the windows in warm weather and use some battery powered fans. Sitting on the patio at night under the stars wouldn't be so bad either. :-)
- 7. What if you can't cook without power.... Rough it for a few hours. Fire up the gas grill. BUT, don't forget to have a manual can opener to open those canned good for you and your pets. AND, keep a corkscrew for that bottle of wine with candlelight and some conversation until the power comes back on.

We certainly haven't covered all the bases on being 100 per cent prepared for a range of emergencies we might face in our homes. But, we hope this first edition from the (EPC)

Emergency Preparedness Committee stimulates your desire and need for being better prepared. Talk to you next month

#### MAINTENANCE Events Happen in Three's

Time and Mother Nature are more than capable of keeping our Maintenance Department busy with repairs and refurbishments. However, this past month the normal wear and tear has been getting some unwanted help from three instances of vehicle damage.

A driver failed to set the brakes on a truck he had parked on Selva. The truck rolled across Selva and into our perimeter block wall taking out a fifteen foot section. It took a while to get competitive bids and for insurance claims to be approved. In February a contractor was hired to rebuild the wall, which has now been completed.

A truck hit the Breakers Isle entrance gate damaging the hinges and making it necessary to keep the gate open until repairs were completed. The repair involved removing and replacing some concrete, building a new support system for the hinges and bringing in a fork lift to remove and replace the gate. With repairs completed, the gates were repainted.

At 4:00 p.m. on a Friday afternoon a car hit the Garibaldi Gate. These things usually happen late Friday when the Maintenance

people are about to go home for the weekend. Fortunately, Maintenance was able to keep the gates operational over the weekend. Repairs required replacing four of the gate pickets, fixing the gate arm assembly, fixing the gear box and painting. The contractor had some problems obtaining the correct replacement parts so the gate remained open longer than expected.

### TRAFFIC AND SAFETY

Be a good Host: Last month 165 vehicles were cited for parking in our community without either a bar code affixed or valid guest pass clearly displayed. It might be speculated that in many cases the driver of the vehicle was likely properly in the community, but simply did not want to undergo the hassle of displaying a current pass or renewing an old one. Starting this month, these vehicles will become subject to being impounded. To recover a car from an impound lot is relatively expensive, and truly does not financially benefit anyone living here. Along a similar line, guest vehicles that are parked in designed resident parking slots down at the Bluff are regularly being cited and impounded. Finding out that one's car has been subjected to impound is a pretty negative experience that may be avoided if we as residents take a quick moment to remind our guests to simply lock their parked cars and display their valid guest pass. Of course, if they go to the Bluff, remind them that guests have to park on the top tier.

Lock it or Lose it: Late at night there is a thief or thieves that occasionally walk about in our community. Their target is almost always an **unlocked** car or truck, and they rifle through it taking whatever might be of value to them. During the past month we had at least four such incidents that were reported. In the past couple of months the thieves have taken a substantial amount of loot in addition to the contents of two

wallets that had been trustingly left inside vehicles. I suspect that we have more victims than anyone realizes. In these unreported cases, the stolen property was probably relatively small and/or it was so incidental the victims did not even notice it missing. What appears to be a bit unusual is that thieves that are capering here are opportunists and only **enter unlocked vehicles**. Avoid being a victim and don't leave items of value in your cars, and no matter what, lock 'em up when we park them. Should we fall victim to a crime, we must report it to our police department. The matter may not ever be resolved to our satisfaction, but it will ensure that our community is allocated a proper share of police resources. God Bless.

## GARDEN CLUB

February's meeting was a workshop on dealing with common garden problems, e.g., pests, mulching, watering and plant location. Also presented were some helpful hints for the gardener.

At the March meeting on the 18th, the assembled throng will hear from Karl Kuhn, a serious "birder." He'll speak on migrating birds and feathery residents of Niguel Shores.

**More on Herbs\*** (continued from January): Herbs, like most plants are either annuals like basil, cumin, chamomile, dill and fennel; or perennials like chives, lavender, lemon grass, oregano, rosemary - and let's not forget thyme. Parsley is one of the few common herbs that is a biennial. However, unless you want to harvest the seed, you can treat it like an annual and plant new plants each season. \*These may not be hardy in all regions of the country. Check your zone ratings.

Herb Garden Design: Herbs make great container plants. To grow herbs successfully in containers or window boxes, you'll need a pot that has adequate drainage holes. Use fresh potting soil each year and keep the container well watered and fertilized. Try different combinations such as purple-leaved basils mixed with creeping thyme, or silverleafed sage planted with curled-leafed parsley. Large perennial herbs, such as rosemary and lavender, can have their own America, there are more cellphones than people.

pot and be over wintered indoors in cold climates. You'll be amazed at how attractive and useful these potted herbs can be.

**Soil Requirements:** In general, herbs prefer a moderately rich soil. An overly rich soil (or excessive fertilizing) can lead to vigorous growth. However, many people find that the flavor of over fertilized herbs is bland, probably due to reduced essential oil content. Many culinary herbs, such as thyme and oregano, are of Mediterranean heritage and are accustomed to growing in gravely soils. The soil in your herb garden should have excellent drainage. If yours doesn't, consider growing your herbs in raised beds or containers. Culinary herbs with different leaf textures and colors are best grown close to the house where they can be easily harvested and enjoyed for their beauty. Perennial mints, including spearmint, applemint, and peppermint, are very vigorous and can become invasive. Rather than planting them directly in the garden, grow the plants in containers, and then sink the containers into the garden. This will contain the roots and limit spreading.



Herbs can provide important habitat for beneficial insects. Dill and fennel are two herbs beneficial insects particularly like.

**Broccoli Raab:** If you're into gourmet cooking, one of the latest hot culinary items is broccoli raab. Broccoli raab, (sometimes called broccoli rabe) is actually not broccoli.

It belongs to the turnip family of vegetables but got its name because it grows florets that are similar in appearance to traditional broccoli. Broccoli raab likes cool temperatures, and seeds can be sowed directly into the soil in early spring. Once sown, broccoli raab takes little effort to grow a successful and tasty crop. Give it a try and impress your dinner guests.



# YOU ASKED ABOUT A RULE... What do you mean that's not a driveway? Why can't I park there? by Karen Decker

S ound familiar? If so, then you probably reside at a property within Niguel Shores that was originally constructed with a long driveway apron and not an actual driveway. The Niguel Shores Community has defined a driveway as a hardscape surface placed solely on private property that shall be no less than seventeen feet (17') in length and eight feet (8') in width (*Rule 3134*). These driveway dimensions apply to properties with a front facing garage that were constructed to accommodate parking for two vehicles. Properties with a side facing garage

have been primarily constructed to accommodate parking for one vehicle as opposed to two. So what do you do if you have no driveway and more than two vehicles? Well your Association has come up with a fairly easy process to help you through this dilemma. It has provided under *Rule 6405* a means of parking on the street and in a valid parking space without receiving those pesky citations. Residents that are interested in finding out how to apply for a parking waiver should feel free to contact the NSCA Management Office for further assistance.

# **Childhood Obesity**

You'd have to be on another planet to not be are aware of the fact that overweight and obesity are at epidemic proportions in this country...I mean, between the news media and television shows dedicated to this topic, how could anyone be unaware? But many are. To date, two thirds of all Americans fall into one of these two categories. And just to make matters worse, our youngsters are also suffering from these two maladies. For openers, here are a few statistics from the Centers for Disease Control and Prevention:

- Childhood obesity has more than doubled in children and tripled in adolescents in the past 30 years
- The percentage of children aged 6–11 years in the U.S. who were obese increased from 7% in 1980 to nearly 18% in 2010. Similarly, the percentage of adolescents aged 12–19 years who were obese increased from 5% to 18% over the same period.
- More than one third of children and adolescents are overweight or obese.

How did this happen? Well, if you look back thirty years ago, kids walked to and from school, and also spent more time playing outside at school and at home before dinner. Speaking of dinner, it was prepared at home and included vegetables and usually a glass of milk.



Today, our kids are either on the bus or driven to school. Our frenetic lifestyles convince us we don't have time to cook a healthy meal, so we buy processed convenience fare, or we pick up fast food. With the advent of technology including TV, kids spend inordinate amounts of time with electronic devices from cell phones to video games and everything in between, resulting in little or no physical activity.

Childhood obesity impacts children's lives in the short term with an increased prevalence of cardiovascular disease, prediabetes, bone and joint problems, sleep apnea, and of course the social and psychological problems that come with being overweight. In the long term, children who are obese are more likely to be obese as adults setting themselves up for a much greater risk of cardiovascular disease, type 2 diabetes, stroke, certain cancers, and osteoarthritis to name a few.

Probably all of us have friends or family who are the parents of a child that could be categorized as overweight or obese...but what can we do? Well, we can offer ideas that can help them, like providing their kids readily available healthy snacks like fruit, suggest taking a walk after dinner, turn the TV off especially during meal times (TV makes people eat mindlessly and usually more), and plan physical activity that is fun and family centered like hikes, walks, and outdoor games. Wrap it all up in love, and you can't go wrong! 
