As we begin a new year for the Board, I wish to outline some of the significant items on our agenda for the coming year.

Breakers Isle Revetment: In the June issue of the *Seashore News*, outgoing President Pat O'Brien reported that he was hopeful that we could reach an agreement with OC Parks and the property owners of Breakers Isle that would move forward the project to replace the revetment protecting the Breakers Isle homes and bluff.

We have made progress with OC Parks. They are ready to undertake the planning/approval/construction of a new revetment at County expense (estimated at \$3 million), designed to preserve and maintain the Breakers Isle slope, provided that the County can secure the right to extend the revetment onto the lowest portion of the Breakers Isle slope lots. The Board has consulted with its legal counsel and understands that the Association has the authority to assign its easement to maintain the Breakers Isle slope to the County.

Some of the Beakers Isle property owners oppose this approach and have filed a lawsuit to prevent Niguel Shores from assigning any rights to the County which would allow the improved revetment to extend onto the Breakers Isle slope lots. This matter is now in the Courts for ultimate resolution. We will provide updates on our Website on this important subject.

Master Landscape: A project to reduce the community's turf by 10 percent to conserve water will be largely completed by the time you read this article. Estimated net cost: \$160 thousand. During the next twelve months we will continue to make improvements to our irrigation system to improve its performance and conserve water. Estimated cost: \$30 thousand. We also anticipate completing the planning for the Mercator Slope renovation to be funded in the 2014 budget.

Mariner Entrance Upgrade: We are in the process of reviewing detailed plans for the refurbishment of the

Longtime resident of Tampico Bay Member Women's Club landscape and upgrade of the gate house at the Mariner Entrance. These projects will be implemented over the next several months at an estimated cost of approximately \$300 thousand.

Major Street Maintenance: Proposals have been received for the current year's segments of our ongoing street paving and repairs. This work will be completed in the fall at an estimated cost of \$350 thousand.

Other Projects: Also in planning or under consideration are projects to refurbish the entrance monuments, tennis courts and pool deck.

While all of these projects involve considerable expense, much of it will be funded from our reserves that were established for just that purpose. Overall, our financial condition is sound. The Finance Committee will publish a mid-year review of the community's finances in the August edition of the *Seashore News*.

Finally, on behalf of the Board, as she moves on to new challenges, I wish to extend our best wishes to Deborah Baker for the contributions she has made to Niguel Shores during her tenure with us.

GM REPORT

4 th of July at Niguel Shores is an amazing celebration thanks to the combined efforts of the Recreation Committee, the Men's Club and the Women's Club. On behalf of everyone, thank you to these volunteers for their time, energy and efforts dedicated to making their community a wonderful place to live!

Marine Entrance Landscape Renovation: The plans for the Mariner entrance landscape renovation were delayed a few weeks, but everything was submitted to the City of Dana Point and permits should be issued by the time you read this article. The updated conceptual drawings are posted on the website (www.niguelshores.org). In conjunction with the renovation of the landscape along Mariner Drive, the Board continues to look at plans to remodel the gatehouse, new lighting for the median and updating the monuments.

Turf Reduction Projects: The turf reduction projects are complete and the water district has done its final

inspection to confirm the work and process the rebates. The Mariner entrance turf removal was completed just in time for the Association to receive the full rebate of approximately \$30,000. Harvest Landscape did an amazing job and the areas look wonderful.

Community Center Closed for Water System Test: South Coast Water District is scheduled to do a cross connection test of the office/ClubHouse potable water system from 8:00 p.m. on Thursday July 11 through 5:30 a.m. on July 12. The water will be shut off to all ClubHouse/office facilities during this timeframe so the facility will be closed.

Camp Hobbledehoy: Are you looking for a great summer activity for your children ages 6 to 12? If so, sign them up for Niguel Shores own day camp—Camp Hobbledehoy. This is the 14th year for Camp Hobbledehoy with the leadership of Craig Dunn, Ryan Crane and Peter Chance. There is no camp the week of July 4th, but then it

Call for Volunteers: Several committees are looking for new members. Please consider volunteering to assist NSCA in keeping the Association running smoothly and effectively. The importance of volunteers cannot be over stated—the Association cannot function without them. Many of the current committee members have served the community for many years - it is time to have other homeowners step up and take over their duties. The following committees are looking for new members: Finance, Maintenance, Emergency Preparedness Committee, and Recreation. Important Rule Reminders as Summer Begins:

- Parked at the Beach Lot Please take care to make sure that your guests have their passes properly displayed on the vehicle dashboard and that they are parked within the designated upper parking tier as posted when visiting the Beach Bluff Park. Guest vehicles found without a properly displayed pass or found parked outside of the top parking tier are subject to tow per Rule 6440.
- **FOBS and Security** This is a friendly reminder to bring your FOB to gain entry to the Community

- Center complex. We have a friendly, customer service oriented staff who wants to be helpful but as of June 1 they will not be allowed to "just buzz you in" if you forget your FOB. To keep from putting staff in an unwanted situation, remember to bring yours or provide one for your family members and guests.
- Pool Monitors From Memorial Day through Labor Day, pool monitors will be assigned to the Community Center pool area to enforce the rules and regulations. The Association does not provide lifeguards, so persons using the pool and spa do so at their own risk. Persons under 14 years of age must be attended by and under direct supervision of an adult 18 years of age or older when in the pool/spa areas. Pool and Spa Rules are posted in the area, but please review rules 5102 and 5103 to ensure everyone's enjoyment of the facilities.

Good Bye — As you have probably heard, in early June I submitted my letter of resignation to the Board and my last day at Niguel Shores was June 26. I want to thank the Board for the opportunity to work in this amazing community. I know that my tenure was short, but I truly enjoyed the time served. EMERGENCY PREPAREDNESS

Kitchen Fires—Keep an Eye on what you Fry: It would be such an easy fix if all cooking fires were prevented by someone being in the room—staying in the kitchen and watching your cooking surfaces significantly reduces kitchen fires. As with anything, there are other ways to make certain a kitchen is safe for cooking and entertaining events:

- Always keeps items that can catch fire away from cooking surfaces. These items could include, but are not limited to pot holders, paper towels, loose clothing, cutting boards, plastic utensils and accessories.
- "Keep it Clean" is a motto we teach about preventing kitchen fires. Wiping off splattered grease or spilled

- food on the stovetop burners and the oven decreases any potential fire hazards.
- Always open the oven door to make sure it's empty before you turn it on. It is important to use your oven just for cooking. Using the oven as a storage facility is a recipe for a fire.

If people heed the safe cooking tips listed above, cooking fires would be obliterated for good. But, what if there is a fire? Remember the following three steps:

- Turn off the heat (as long as knobs are on the front of the stove).
- Have a pot/skillet lid in easy reach. Cover the pan with the lid to suffocate the fire. Danger: If you attempt to move the pan or pour water on an oil or grease fire, this will cause

severe burns, make the fire bigger and spread it faster.

■ Get out! Evacuate and call 9-1-1.

MAINTENANCE

As Paul Harvey would say on his nightly broadcast, "and now for the rest of the story."

In 1996 a Men's Club Dolphin Committee composed of Don Ellis, Rick Foth and Jerry Pearl started a fund raising campaign to replace the topiary dolphins at the entrance of Mariner Drive. Frank Turner, a local artist, volunteered his considerable skills to sculpt the dolphins and residents donated \$20,000 to cast the bronze dolphins.

A deep sense of community pride was felt by the residents participating in the formal dedication of the dolphin statue July 4, 1997. It became the task of Maintenance to care for and polish the dolphins. However, the staff was not experienced in the proper polishing and care of bronze art work. It wasn't long before Frank expressed his dissatisfaction with our care of his artistic creation. Frank provided Maintenance with a "special wax" and explained how we were to use this "special wax." It was green in color and provided a patina green to the statue exactly as Frank wanted. He did not reveal what it was or where it could be purchased but assured the staff not to worry; he would provide the wax that would be needed, and he did just that for many years. Frank Turner passed away in 2012 without revealing the source of this special, and soon to be needed, wax.

Enter the wax detective, George Cooley, and his computer search skills. There was no label on the can, only some scotch tape that Frank had labeled "midnight green." The first search for midnight green wax or bronze wax came up with only one hit. Lincoln shoe polish made a midnight green wax. Searching further, George learned that carnauba wax was best

for statues but it must not contain certain petroleum additives. A search for the ingredients of the Lincoln Wax revealed that it did contain carnauba wax with acceptable petroleum ingredients. But the container for the Lincoln Wax did not look like the container provided by Frank.

Another search for "midnight green shoe polish" came up with a rare match for an obscure wax product called Angelus perfect stain Shoe Wax Polish. It comes in midnight green and the cans match perfectly. Angelus Wax has a peel away label which Frank had removed.

So Frank, we broke the code. It's shoe wax! The dolphins continue to look good with just the right patina as directed by a very special artist. We are sure you are smiling, as we do, when we look at our dolphins and remember your contributions to Niguel Shores and the "rest of the story."

TRAFFIC AND SAFETY

Summer Festivities: The regular gloomy days of June are now past us and we can look forward to at least several months of great "beach" weather. During this period a few extra guests may even drop by and, while visiting, take advantage of the beach, pool, picnic areas and the view. While

enjoying the company, please take an extra effort to be a good host by reminding our guests to clearly display their parking passes on the dash, and when parking at the Bluff they should only park their cars on the top tier of the parking lot that is designated for guests. Why? These rules are strictly enforced and violators are subject to having their vehicles towed away.

Fourth of July: The Fourth is the most festive day of summer here in the Shores and, as far as a good wholesome fun day, our activities rival any other community. This is the one day of the year that guests may not park in any area of the Bluff parking area. Only residents with bar codes are permitted. The only exception to this restriction is a vehicle designated for handicapped parking that has to park in those spaces so designated.

The big parade is scheduled to start from the ClubHouse at 10:30 a.m. Traffic entering the community at that time will be stopped and/or diverted to ensure the safety of the participants. We might caution friends what to expect who arrive at that time. Disappointing news about the parade is that Mr. Pat O'Brien and his new protege will not be skate boarding and performing as the event meanders through the community. It seems as though an exemption to the rule prohibiting skate boarding in the street could not be

obtained with short notice.

Crimes: We continue to receive reports about an occasional theft or two from unlocked vehicled parked on the street. As we have said before, no one can remember ever hearing about a theft from a locked vehicle.

Recently, we have experienced several burglaries here in our community. There have also been several other such burglaries in nearby neighborhoods in Dana Point. Deputy Steve Hoffman, our liaison with police services, only a few days ago announced at the Men's Club meeting that the likely suspect was just arrested a few blocks from here. The perpetrator (they only use this term in New York) who is in his twenties had loot that could be tied into three burglaries. His mode of transportation, a bicycle, was reported stolen from our community. Not surprising he also had a variety of narcotics in his possession.

Typically **burglaries** occur during **daylight** hours when no one is at home (lesser crime). For peace of mind, no one could remember a recent night time residential burglary. Along the same line, car clouts normally target unlocked cars because it is easier and also a lesser crime.

YOU ASKED ABOUT A RULE... by Karen Decker

Leasing Your Property in Niguel Shores Community

Many communities, Niguel Shores being one, have certain rules and boundaries concerning leasing out private properties within the association. Fortunately this community has made things relatively simple. Under the January 14, 1991 amendment to the original Conditions, Covenants & Restrictions (CC&R's), Article IX, Section 24 was adopted that restricted the renting or leasing of any lot within Niguel Shores for any period less than one month. As a result of this amendment the Association will not recognize any lease than is less than 30 days in duration.

The following points can be used as a 'quick reference' guide to leasing a property within Niguel Shores:

- The Association is only responsible for initiating gate access to tenants, and only for the period of time that a valid lease has been provided to the NSCA Management Office.
- A lease that is less than 30 days in duration will not be accepted by the Association (CC&R, Article IX, Section 24).

A valid lease must be provided to the NSCA Management, along with the required \$100 tenancy fee (Rule 2715), on the first day the lease is valid.

Payment of fees cannot be accepted and access devices cannot be issued until the lease is valid.

Only the owner of a lot may lease the property. Tenants may not lease out the property they are renting.

MEET YOUR NEIGHBOR

Nancy and Gary Tinnes

Then Mary Crowl told me that Nancy and Gary Tinnes were my next Meet Your Neighbor subjects, I was delighted. They are one of my favorite couples in the Shores. So here I was on a sunny day in early June sitting in their patio, facing a tropical gazebo, surrounded by a lovely garden, and listening to soft Hawaiian music. Nancy and Gary knew that my whole childhood after the age of four was spent on Oahu, and Gary asked if I had noticed what they were wearing: Two colorful "aloha" shirts, which reminded me of our shared love of the Islands. Nancy and Gary visit Hawaii every year, and Gary's connection goes back to his childhood as well. His father had been a musician and played with the Ray Kinny Band on the radio show "Hawaii Calls".

Before his father took the Hawaiian gig, Gary's parents bought a house on a former potato field on Long Island Gary said, and his family never ran out of potatoes while he lived there. Gary attended Queens College in New York City where he had a double major in philosophy and psychology. Before he could earn a degree, he was drafted into the Army and sent to Thailand. It was 1967 and the U.S. was in the middle of the Vietnam War. Gary worked as a criminal investigator in the Army's justice system.

Nancy was born in L.A. County near Long Beach. She went to Long Beach State with a major in physical therapy, earning both an undergraduate and then a master's degree there. Her first job was at the VA hospital in Long Beach where she worked with veterans who were amputees. She then moved on to Children's Hospital where she worked with the sickest children there. Both experiences were deeply troubling to her and she decided to change careers. She accepted an offer to become a flight attendant and didn't leave her flying career for 30 years. She flew first for United Airlines and then later, American Airlines.

After his Army service was over in 1972, Gary drove a taxi in New York City. One day he stopped his taxi at the southeast corner of 85th St. and 2nd Ave. to pick up fare. A young woman stepped into the back seat of his cab. When Gary turned to look at her she said "Hi". Gary replied: "You must be from California". "How did you know?" the young woman exclaimed. Gary explained that New York women and foreign women just call out their destination, but California women say, "Hi". Well, that was the beginning of Gary and Nancy's fine romance. They married three years later in Los Angeles and later they moved to Orange County. Gary had started work for Panasonic in sales and marketing of consumer electronics. Nancy retired reluctantly rather in 2006. She loved her job and loved meeting so many interesting people, among them Ella Fitzgerald, Raquel Welch, Tom and Dick Smothers and many, many, others. You'd be surprised, she says, at the number of celebri-

ties that fly coach class. Even Barbara Bush, along with two bodyguards, flew coach on one of Nancy's flights. (Not while either her husband or son were President, however).

During these years Nancy and Gary had three children, now grown and on their own. The oldest, Christopher, is in insurance. Their daughter Stacy is married to Troy Tertany. They have given Nancy and Gary a grandson named Boden. And their youngest, Matthew, is working at the Watermarc Restaurant in Laguna Beach.

Gary is a talented photographer whose work has appeared in numerous publications and is the official photographer of the SOKA University concerts. (He has a camera that does not require a flash that would disturb the musicians). He also has permission to film performances of the jazz musicians at the legendary jazz club, The Village Vanguard, in New York City, a famous gathering spot for stars and jazz greats since it opened in 1935. He received permission from Lorraine Gordan, the 92-year-old widow of club founder Max Gordan, who has been running the club since he died in 1989. Gary's photograph of Kenny Barron is now proudly displayed by the great jazz pianist in his promotional materials. Recently, Gary and his son-in-law Troy, authored a book featuring Gary's photographs of the beautiful Basilica on the grounds of the old Catholic Mission in San Juan Capistrano.

Nancy and Gary moved to the Shores in 2003, and since then have given much of their time in service to our little community. DISPLAYING THE FLAG

Outdoors:

- ☆ Displayed from a staff projecting from a building, the union should be at the peak of the staff.
- Displayed over a street, it should be hung vertically with the union to the north or east.
- Displayed with flags of states or other flags, it should be in the position of honor—to its own right. The other flags cannot be larger and no flag should be above it. It is the first raised and last lowered.
- ☆ Displayed with flags of other countries, each must be displayed from a separate pole of the same height. They should be the same size and raised and lowered simultaneously.
- Displayed at night: The flag must be illuminated.

Indoors:

- ☆ Displayed in a place of honor, always to its own right, to the right of the speaker with other flags to the left.
- Displayed at the center and at the highest point when with other flags.
- Displayed on crossed staffs with another flag, it is placed on its own right with its staff in front.
- Displayed against a wall, vertically or horizontally, the flag's union should be at the top, to the flag's own right, and to the observer's left.

Raising and Lowering:

- The flag should be raised briskly and lowered slowly and ceremoniously.
- It should be displayed between sunrise and sunset and illuminated if displayed at night.
- The flag is saluted as it is hoisted and lowered with the salute held until the flag is taken off the halyard or until the last note of music, whichever is longest.
- As it is lowered, no part should touch the ground, and then it should be folded neatly and ceremoniously.

Care and disposal:

The flag should be cleaned and mended when necessary and, when no longer fit to serve as a



symbol of our country, should be destroyed by burning in a dignified manner. American Legion Posts and Scout Troops provide this service. Contact them for information.

Prohibitions:

The flag should not: be dipped to any person or thing used as drapery or covering for a desk, platform or for any decoration in general, be used for any advertising purpose, be used as part of a costume or athletic uniform, be marked with any letters, figures or drawings, and never should be used as a receptacle for holding or carrying anything.
