#### Dear Homeowner:

In order to implement self-management at Niguel Shores, your Board of Directors has been evaluating procedures and establishing policy in order to best serve the needs of our community. Although a great deal has been accomplished, we need more input from the community.

According to Article V Sec. 2 of the CC & R's our Association is obligated to promote the pleasure, recreation, health, safety and social welfare of its Members. Just how this is to be provided and under what guidelines has not been an easy task. As a Member of the Association, the Board would appreciate your assistance on the recommendations the Board is currently considering but not yet acted on.

- 1) No organized activities shall take place on Niguel Shores Community Association common property except as approved by the Board of Directors. Fee-bearing instruction shall be only as furnished by the Association. Instructors will be paid by the Association and fees will be paid to the Association. Fee-bearing activities will by considered by the Board upon petition of a significant number of homeowners, under organized leadership, who will assist in obtaining any instructors necessary. Benefits to participants must be of a nature which the community could be expected to commend.
- 2) Under the management of the Niguel Shores Community Association comprehensive recreational and social programs shall be offered to residents of all ages. All direct costs of these programs and activities shall be paid by those residents participating in said programs. A minimal fee shall be charged to outside contractors to off-set the Community Center Recreational Budget.
- 3) Association sponsored and contract recreational and social programs shall be offered to residents of all ages. The direct costs of the outside contract programs shall be charged to the residents participating with no fee charged for the outside contractor.

# C C & R Enforcement Procedure

A new CC&R enforcement procedure has been recently adopted in the effort to effectively enforce the protective covenants (CC&R'S) which are a binding contract between each property owner and the association. Each owner should have received a copy of the CC&R'S from the seller of the property at the time of purchase. Violations should be reported in writing to the Community Center. Renters are equally responsible for following the rules. Violations by renters will include contacting the property owners who are responsible for violations by their tenants.

The procedure will include notice to the violator with reasonable time to correct infractions. If not corrected in a reasonable and definite time, the matter is referred to the association attorney for appropriate legal action. Additional copies of the CC&R'S are available at the community center for those who need them.

### STREET STRIPING UNDERWAY

We will continue to re-stripe the streets indicating stop signs, pedestrians crossing and speed bumps. Single lane parking stalls will be painted at the beach parking lot. Guest parking areas on various streets in Niguel Shores will also be painted for the first time.

## DRAIN FACILITIES INSTALLED

Niguel Shores Community Association is currently under-taking installation of several major drainage systems needed to resolve long standing swampy conditions due to our serious water seepage conditions. One drain is being installed at the community center adjacent to the handball courts on the east border of the swimming pool. Additionally a several hundred foot drain is being placed behind Windjammer at the toe of the slope. This greenbelt has been flooded several times killing all the landscaping. Another large drain system will carry water at the toe of the slope behind Windward, down the greenbelt and out to the nearest storm drain. These repairs are major undertakings that were recommended and designed by our consultant engineers, Leighton & Associates. The projects should be completed in early January 1979.



# TRASH PICK-UP SOLAG REFUSE

The ideal pick-up is 40 gallons maximum, but not to exceed 50 pounds by weight. Maximum amount of containers are, 8. Newspapers must be bundled and tied. Boxes as containers are not legal. However, Solag will accept ashes if there properly boxed. The only disruption to the schedule will be pick-up on WED. instead of TUES, for the New Year. An accelerated program is going forward to restore our Community to the status expected by the homeowners at the time they selected Niguel Shores, and to preserve our commonly-owned properties from deterioration.

Most obvious to all has been the slurry sealing of virtually all our street surfaces and parking lots. Although costing more than \$40,000, this treatment every several years will prevent the far greater expense of major resurfacing.

The firm of Leighton & Associates continues to advise us concerning existing and potential drainage and erosion problems. Approximately \$35,000. has been spent to engineer and complete the reconstruction of 10 sections of slope failure. Approximately \$15,000. is in the process of being spent for drainage ditches and area repair (principally at the foot of the Windward & Windjammer slopes, and in our recreation area.) We know that much of our subsurface area is in varying stages of water saturation. Extreme care on the part of each resident in avoiding excessive irrigation and keeping open his drainage systems is imperative.

We hope that most homeowners are aware of the more vigourous attention being given to lighting, repair, janitorial duties, preservation.

Our 1979 budget provides for accelerated efforts in eliminating slope infestation and replanting. While limited by the discretionary use of homeowner funds, we believe that our progress will be notable throughout 1979.

### NIGUEL SHORES NEWSPAPER AND ALUMINUM RECYCLING PROGRAM

There will be a special pickup of recyclable papers on <u>Jan. 1</u>, (during the night) and two regular pickups - <u>Jan. 15th</u>. & <u>29th</u>.

We are happy to report that our last pickup of Dec. 11 yielded 17,260 pounds, the largest ever for a two-week period. During the past year, during which our recycling program has operated for 11 months, our community has contributed 274,150 pounds, (137 tons) of newspaper & similar type periodicals; this equated to a small forest of 2,329 trees saved from destruction.
