looking forward to a happy and prosperous New Year "1983".

A word about "THEFTS & BURGLARY". It has been reported by the management of a near by Laguna Beach private community that certain thefts and burglaries have taken place recently and that it is believed a "ring" is presently operating in the beach area, specializing in "hitting" private communities. Briefly, it appears the ring makes calls to a given number of homes in and within a specific area to see if the owners/residents are at home. If someone answers, they either hangup or make some excuse for the call. When they have spotted a number of homes close together, they go into the community - possibly on foot - break-in and remove small valuables, money, etc. Having come upon the mode of operation, these communities are devising ways in which their members can help prevent these burglaries from happening. One way which we shall also adopt as a preventative measure is to log reports of incidents of a suspicious nature through the main gate.

Specifically, residents who receive "suspicious" calls should contact the officer on duty at the NSCA main gate. Give the officer your name, address and a brief comment of the type of call you received. If two to three or more calls are reported in any given area, security will request police assistance and the community's security patrol will concentrate their attentions to close observation of the area of potential problem. With the assistance of members, we may prevent Niguel Shores from being a "loser" in this battle of crime.

If in doubt - report the call - any questions about this procedure may be directed to the Association office - BUT REPORT ALL SUSPICIOUS CALLS TO THE MARINER GATE SECURITY OFFICER.


SEA TERRACE II

Nearly all Sea Terrace II residents have agreed to participate in a Neighborhood Watch program aimed at stopping burglaries in the community. The key to the plan is a commitment of neighbors to watch out for each other and to report any suspicious activity to the Sheriff's Department.

Substantial damage to some fences in the community have led the Association to make an insurance claim for this storm damage. All residents are again urged to caution any visitors about the entrance gate and retractable spikes. Severe tire damage can result from attempting to enter when the gate is down and the red light on.

The annual meeting of homeowners is tentatively scheduled for Wednesday evening, February 16, 1983. Three new members of the Board of Directors will be elected. All homeowner members are urged to attend the meeting in person or to submit a proxy so that the necessary quorum can be achieved.

A MESSAGE FROM THE LANDSCAPE COMMITTEE

Niguel Shores is an especially desirable residential development because (among other things) (1) an unusually generous portion of the <u>interior</u> land areas has been given over to open space (31 junior parks and 7 larger areas), and (2) practically all of the <u>visible</u> ground area within the community is landscaped and maintained by the Association.

However, these same features which improve our vistas and our property values in normal times do just the opposite in time of drought. A cut-off of irrigation water would ruin both our environment and our property values. In fact, we don't need to experience an actual drought to affect property values. As the 1985 cut-off date for Colorado River water approaches, the public will become more and more aware of the coming water shortage and less and less interested in purchasing residences in a "greenbelt" community.

Responsible land developers (like the Mission Viejo Company) are now "double piping" their new developments in order to overcome this objection (i.e., installing both a potable water system for residences and a reclaimed water system for greenbelts).

The Landscape Committee has concluded that the only way to protect our landscaping and our property is to support the installation of a reclaimed water project for Niguel Shores and to consider the \$115 increase in tax bill as an insurance payment for the protection of our environment.

IT'S A DOG'S LIFE!

Since the dogs of Niguel Shores cannot speak intelligibly for themselves (except, of course, to Dr. Doolittle!), I am acting as their surrogate spokesperson.

The great hue and cry surfacing periodically in SEASHORE NEWS concerning unleashed and allegedly unmannerly canines in our community seems way out of proportion. In a society where crime, rape, violence and corruption have become virtually a hallmark, it appears strangely inappropriate to zero in on man's best friend.

History, as well as literature, abounds with heroic feats of dogs who have saved entire households from fire, flood and violence. Recent media accounts credit dogs with providing a ray of hope and happiness (as well as actual therapy) for elderly shut-ins, retarded children, mental patients; the lost, the lonely, the forgotten.

RECLAIMED WATER ALTERNATIVES

Some home-owners opposing the water recycling proposal have said they will be unable to attend the January 4th hearing, and wouldn't know how to write the kind of a letter required to voice their protest. As one of those home-owners opposed to the venture, I offer this simple statement:

"South Coast County Water District, Dear Sir or Madam: As a homeowner in the Niguel Shores Community Association, I am opposed to the formation of a special assessment district for the construction of certain reclaimed water delivery facilities in our area."

Some such ordinary letter with the protester's signature is all there is to it.

Why am I opposed? Because I believe there are alternatives far more economical, i.e. 1) Reduce drastically our present water waste;

- 2) Replace excessive lawn areas with drought resisting ground cover;
- 3) Take our chances on a prolonged drought just as we risk the constant dread of a major earthquake.

Congratulations to the Communications Committee and the Seashore News editorial staff for returning to a policy established a few years back of publishing letters from readers. Yea to the policy and thanks!

DROUGHT RESISTANT LANDSCAPING

Mr. John Bulleit has stated the case against the Reclaimed Water System succinctly, and I am in total agreement with him. I wish to add the following point to those made by Mr. Bulleit.

On a walk through the community during the November 30th storm, ten uprooted trees were observed. Doubtless there were more. These occurrences are costly, unsightly, dangerous to persons and property, and are seen with monotonous regularity year after year. They are due to the selection of unsuitable plantings, plus the frequent, wasteful, very shallow watering practiced in this community since its inception.

Southern California is a desert. We would better serve our environment, our water resources, and our checkbooks if we landscaped to reflect this fact. Insistence, to our significant financial cost, on continuing with the current landscaping mode will merely guarantee regular tree uprootings and slope erosions into the foreseeable future.

A formal, secret ballot should be taken as soon as possible on this assessment.

Add 3 quarts of Sherry (If the Colonel isn't


looking). Serve over hot buttered toast made from 25 loaves of Bread. Note: Do not salt!!




