FROM THE HELM

The operations of the Association are controlled by four documents:

- The ARTICLES. These contain a brief description of the purposes and powers of the Association.
- COVENANTS, CONDITIONS, & RESTRICTIONS, (CC&Rs). These contain information regarding the relationships between the Association and its members.
- THE BY-LAWS. These contain information regarding how the Association conducts its business through its directors, officers and committees.
- 4. The RULES. These contain the information provided by the above documents but in a more detailed and useable format.

One of the objectives of this Board has been to assemble the existing rules, regulations, policies, procedures, By-Laws, CC&Rs, and unpublished Board actions into a coherent, usable whole. The various segments are now beginning to come together. The resulting publication will have the Rules and three appendices: A (Articles), B (By-Laws), and C (CC&Rs).

RULE CHANGES

We are in the process of codifying our rules (numbering each paragraph and sometimes rearranging) in order to make reference and modification easier. At the same time we are incorporating any changes that have taken place since the last printing.

BY-LAWS

As was announced in the October News the first draft of the revised By-Laws has been available for reference in the Association office since that time. Some minor changes were made by the Legal Committee and there may be some additional changes by our attorney. The final draft is now available for viewing in the Association office. We will discuss the changes in the February 13 meeting. On February 20 the Board will vote on the adoption of the By-Laws.

NSCA BOARD OF DIRECTORS ACTION, JANUARY 1985

SHORES AND MARINER ENTRY SIGNS

Requested Management to prepare new and revised designs and cost estimates for Board consideration.

STREET SWEEPING CONTRACT

Authorized a renewal contract with Orange Sweeping Service for 1985. Sweeping of streets will take place on the second and fourth Thursdays of each month.

MAINTENANCE STORAGE AREA

Approved construction of a fence with gate behind paper storage building at the Community Center.

TENNIS COURTS

Received Management recommendations for tennis court resurfacing.

FINANCE COMMITTEE

Unanimously approved appointment of Frank Taylor as Chairman of the Finance Committee.

SENIOR ADVISORY COUNCIL

Considered formation of a Senior Advisory Council composed of former Board members which would provide a source of continuity between current and former Boards of Directors and/or managers.

STEIN-BRIEF DEVELOPERS

Received report from Director Owen and tentatively approved a presentation by developer as to the Stein-Brief neighboring projects.

BEACH REVETMENT-PHASE II

Approved additional consulting agreement to determine feasibility of Phase II project plans.

1984 AUDIT

Selected James Zimmerman, CPA as auditor for the 1984 annual audit.

SECURITY COMMITTEE

Accepted the Security Committee's recommendation to postpone the owner vehicle decal program until late 1985.

A SUCCESS STORY

In 1977 Russ Paslaqua proposed to the Mens Club that they start a newspaper collection and recycling program designed to provide "pin money" for the Community and also as an ecological contribution to our environment. The concept was accepted and Russ was appointed to chair the effort. As of December 31, 1984 the Shores householders have contributed nearly 2 1/2 million pounds of paper.

This success story can be told by looking at two figures: The "pin money" has amounted to nearly \$30,000 and the reclaiming process has saved more than 21,000 trees for our environment!

A committee of three, chaired by Russ, reviews proposals for the expenditure of funds. Their main criterion for approval is that any money spent must have the potential of serving the entire community, even though some residents may choose not to utilize the benefits of any given purchase. Recommendations for expenditures go from Russ' committee to the Mens Club for discussion and approval. None of the money has ever been used to directly or indirectly benefit the Niguel Shores Mens Club alone, and there are no plans to do so.

Shores residents reap many benefits from the funds collected. Over \$8,000 has been spent on the improvement of facilities at the Community Center, encompassing such niceties as a piano, planters, acoustic wall treatment, barbeques, projector, speaker system, blinds, bridge tables, lectern, coffeemakers, an outside shower by the pool, locker room renovations, and office air conditioning. The entire clubhouse kitchen equipment has been upgraded to commercial size and quality at a cost of approximately \$2,300. A special service routinely cleans the kitchen, courtesy of the paper fund.

About \$3,500 have been spent on construction items such as roofing the maintenance building and clubhouse corridor areas, and the construction of a storage building. Lastly, materials for maintenance of Shores street signs, at a cost now approaching \$1,000 have been borne by the paper money.

In most cases where items are purchased, or services needed such as engineering, design, and actual construction, generous time and talent from community members have reduced costs to as little as 50% of real cost, so it is fair to assume that great value has accrued to the community for every dollar spent.

While some residents have charities of their own to save their papers for, it is estimated that about 25% of the residents choose to discard their newspapers in the weekly trash. Just think what good things could happen if we had that 25% of you participating!

We are a community of 960 homeowners, governed by 5 Board directors, 3 of whom constitute a quorum empowered to make changes affecting us all.

Nothing made this quite so clear as the observations of a concerned homeowner at the January Open meeting. His concerns revealed that the recent announced "codifying" of our By-Laws (which most of us - myself included - interpreted as a mere tightening of language) would actually seriously restrict our access to information.

Formerly, we had the right to review <u>any</u> information including correspondence, documents, memos, proposals, etc., affecting our community. Such information has now been restricted to only "minutes and accounting."

The president was asked whether it was the Board's intention to explain this restriction then or at any future open meeting. His answer was "no". That denial is not only unfair to the majority of homeowners but a clear abdication of the Board's avowed obligation to be responsive to this community.

Before this By-Law change is adopted, it is urged that the president relent and place the matter on agenda for full discussion at the next open meeting-<u>and</u> that every means be taken to give all homeowners sufficient advance notice of same.





COUPLES NIGHT BRIDGE


