GENERAL MANAGERS REPORT

REMINDERS!

Tenant (non-owner) auto identification decals require periodic renewal. It is important to renew these decals on a timely basis. This year's tenant decals are white with orange numbers. They will expire throughout the year depending on the number on the decal. For example, an orange on white #1 indicates an expiration in January 1988. This decal will be void if not renewed in the first 10 days of February 1988. The system follows for February (#2), March (#3), etc.

It should be noted that all 1987 white on green tenant decals are now expired and void. If your decal has expired, contact the Administrative Office immediately regarding renewal. Bring a copy of your current lease or rental agreement or renewal.


Service Passes for gardeners, pool maintenance and other service personnel automatically expire December 31 and June 30 each year, unless the pass was issued for a shorter specific time period. Most service people should now have their new 1988 service pass. These passes are authorized by the sponsoring resident who must contact the Administrative Office to arrange for new or renewal passes. Remember, you will need complete information: firm name, individual name, street address and telephone number.

The 1987 yellow passes expired December 31, 1987 and were void as of January 10, 1988. This year's passes are blue and will expire June 30, 1988. As an owner or resident, your cooperation and timely follow-through will result in the uninterrupted access of your service personnel.

RULES AND REGULATIONS

Following procedure, revisions in the Associations Rules and Regulations or other governing documents are distributed with the Seashore News.

Attached is a copy of part of the Association's Rules and Regulations amended to reflect a change in collection policy.

The attached page replaces those published prior to this date. Please keep it for reference.

NEIGHBORHOOD WATCH

Securing your home against any unwanted visitors including burglars doesn't have to be a complicated or expensive undertaking. As a start here are some common sense suggestions about doors:

Hinged Doors — Exterior doors of solid core construction or metal clad doors are preferred. Hollow core or composition doors can be easily battered in or bored to gain entry. Door hardware should include a deadbolt lock as well as a key in the knob lock. If there is a window in or near the door, a double cylinder deadbolt lock should be used so that it can be locked with a key from the inside.

Sliding Glass Doors — To prevent removal of the door and frame, a 1-1/4" sheet metal screw should be put into both ends and the middle of the top of the frame. A sturdy deadbolt-type lock available at a local hardware store should be used to supplement the regular door latch.

While there are a number of things we can all do to guard against burglaries, door security is an important first step.

February 5, 1988 will mark the tenth anniversary of the paper salvage program started on that date in 1978 under the auspices of the Niguel Shores Mens Club. It seems appropriate that a report on the success of this program should be included in the February 1988 Seashore News.

The program generally has been a great success, and 1987 in particular was very good. The price of paper remained high for the entire year, and the loads of paper averaged nearly 17 tons per month.

Revenue from sales of paper contributed by our residents amounted to \$9365 (202.5 tons) for the year, and the ten-year total amounted to \$52,870 (1,819 tons) of salvage.

As heretofore, all funds expended were used exclusively to benefit Niguel Shores facilities. During 1987 \$1,054 was spent for supplemental costs in connection with the refurbishment of the multi-purpose room; \$284.50 was used to replace worn-out bridge tables; \$300 went to clean the carpet in the MFR; and \$1,360 went for cement curbing around the Community Center playground.

As of December 31, 1987 there was a balance of \$11,187.24 in the fund, and several projects are planned for 1988.

We would like to increase the amount of paper salvaged in 1988, and to that end we urge all residents to participate by saving newspapers, magazines, telephone books, pamphlets, brochures and junk mail for the program.

The collection center is located on the west side of the Community Center building and is open daily from 9am to 9pm.

Bring your papers in large paper or plastic grocery bags, cardboard cartons, or tied in bundles. You can drive right up to the front of the storage room for convenient unloading.

All residents are urged to help, and friends and relatives outside the community are welcome to join in the salvage program. Please solicit their particit pation.

Our motto, borrowed from our recycling firm, is "Paper recycling today for our environment tomorrow". Please don't trash your papers; let us cash them.

The Mens Club will thank you, the Community Association will thank you, the US Government will thank you, and I will thank you.

REPAINTING

The CCLAs provide that an owner must obtain the approval of the Niguel Shores Community Association before painting or repainting any structure.

The approval should be requested by filling out an application which can be obtained from the Administrative Office. (In tracts 6881, 6884, 7515 and 8602 repainting is done by the Sea Terrace I or Sea Terrace II Association and this approval is not required.)

application should he The accompanied by color chips indicating the proposed color of the house and the The Architectural Committee is trim. responsible to be sure that the repaint colors will blend with the particular range of colors used in that particular tract. In tracts 6782, 6883, 6935, 7203, 7573, 8038 and 9098 a narrow range of colors was used by the developer with emphasis on earth tones and warm off-whites. In tracts 6988, 7156 and 7447 a wider range of colors was used.

The applicant will be notified regarding the approval of the application as soon as the Architectural Control Committee has had an opportunity to review it. (Usually within two weeks.)

If the application is approved, the applicant will be given an "on-site inspection card" which should be posted on the property in a location visible from the street until the painting is complete.

There are no fees or deposits required in connection with this improvement.

PARTICIPATION

For the past few years each Board of Directors and Nominating Committee has been criticized for failing to present the community with a representative slate of candidates in its annual elections. Sometimes there were only as many candidates as there were positions to fill, a deplorable and certainly not very democratic situation.

This year, a hard-working six-person Nominating Committee vowed it would bend every effort to have enough qualified candidates so that the community would be offered a wide choice in the forthcoming election. An appeal to the community was made in last month's Seashore News asking for volunteers to submit their own names or those of their choice. Meanwhile, ea member of the Nominating Committee campaigend vigorously to persuade qualified residents to run for office.

the response has been To date, considerably less than overwhelming. particularly since there are three positions to fill. Those who have bee most vocal in their criticism of the way this Association is managed refuse to run for office. One potential candidate even went so far as to admit reluctance to run for fear of suffering the humiliation of not being elected! What would happen to this country what would happen to the Internation Olympics — if candidates WOLLL participate ONLY if they Wer-e guaranteed to win?

This, then, is another appeal to the truly civic-minded, the truly dedicated, the truly conscientious, to give of yourself, your time, your efforts and volunteer for office. Either that, or cease complaining. You cannot have it both ways.

LANDSCAPE AGENDA 1988

In addition to normal and regular landscape maintenance, several special projects will be undertaken in 1988. These will be in line with our longterm goals of:

- 1. Continuing to beautify the community.
- Reducing the amount of laborintensive planting, such as the tall varieties of eucalyptus and the acacia latafolia, all requiring continual pruning.
- 3. Replacing trees having root systems that cracking driveways and sidewalks with threes or shrubs that will eliminate this problem.
- 4. Substituting more droughttolerant plants whenever possible.

Projects to be undertaken this year include:

- 1. Planting along the fences, mainly around the greenbelt areas in Sea Terrace II and the Berkus homes.
- Planting along the new slumpstone wall along Selva.
- 3. Planting of small canopy-type trees along Niguel Road and Stonehill to help provide a visual barrier against the increasing traffic.
- 4. Slope planting to fill in bare areas throughout the community.
- 5. Slope replanting in selected areas throughout the community. This includes removal of some acacia latafolia and replacement with low-growing acacia or other suitable plants. When this is done, old root systems will initially be left intact to hold the soil while the new plants take hold.

6. Begin an upgrade program to plant patio-type trees in selected locations in front of the garden homes in each of the fourteen bays.



ANTI-STRESS EXERCISE

START WITH THE FOUR "S" — SMILE, SLACK, SAG & SMOOTH.

This is the ultimate mini antistress exercise developed by Charles Stroebel, PhD, MD. <u>Smile</u> and make your eyes sparkle. (Go ahead, do it.) Take a deep breath and as you let it out, let your jaw hang <u>Slack</u>, shoulders <u>Saq</u>, and forehead <u>Smooth</u> out. Do it quickly one more time.

There's a reason for each step. When a person becomes tense, facial muscles tense, which creates a "hard" Smiling breaks that up. stress, breathing tends to be shallow; the deep breath relieves it. Letting the jaw hang slack releases tense jaws and gritting teeth. In fact, it's best to go through the day with jaws relaxed enough so that the front teeth are slightly apart. Tension collects in the shoulders, so letting them relax lets go of more stress. Smoothing out the forehead not only releases tension there, but it is part of a pattern of upper body relaxation.

2301 Accounts Unpaid for 30 Days (11-4-87)

Members whose accounts have a balance outstanding of 30 days shall be assessed a late charge not exceeding ten percent (10%) of the delinquent assessment or ten dollars (\$10), whichever is greater, plus interest on all sums imposed, including the delinquent assessment, reasonable costs of collection, and late charges, at an annual percentage rate not to exceed twelve percent (12%) interest, commencing 30 days after the assessment becomes due. Reminder billings are sent by computer service.

2302 Accounts Unpaid for 60 Days (2-1-85)

Members whose accounts are 60 days delinquent are noticed by registered mail that if payment in full is not received within 30 days, a lien will be filed against the property.

2303 Accounts Unpaid for 90 Days (11-5-86)

Members with delinquent accounts of 90 days are liened. Members are assessed a charge for lien filing and administrative costs (minimum charge \$50.00).

2304 Accounts Unpaid for 91 Days (2-1-85)

Members whose accounts are 91 days delinquent are referred to the Board of Directors for suspension of Association voting rights and use of common area/facility privileges, (including participation in committees, clubs and organized community events) which includes use by the member, his guests and tenants, pursuant to suspension procedures.

2305 Accounts Unpaid for 120 Days (2-1-85)

Members whose accounts are 120 days delinquent are sent to the Association's attorney for collection action, which includes filing a Notice of Default. Members are assessed a minimum fee of \$300.00 for attorney fees.

2306 Accounts Unpaid for 150 Days (2-1-85)

Failure to cure a delinquency of more than 150 days may result in foreclosure proceedings against the property.
