We know there's much business experience and personal savvy among our owners and time spent on the Board does not mean giving up personal pursuits. Think about it!

I've received a couple of calls this month which warrant mention. The first was from a homeowner concerned about our new street sweeping schedule conflicting in certain tracts with the scheduled trash pick-up. This query was immediately brought to our General Manager and he, in turn, has discussed it with Wendt Landscaping. Inasmuch as January's the first month of the new operation, the potential problem will be observed and changes made. Bear with us, we will resolve the problem and your streets will be swept as they should be.

And speaking of trash, the second caller was irate that a neighbor had decided to use her container for overflow from his... and it wasn't even the right container! Unfortunately, this occurs too frequently within our community. On one of the Bays an owner refuses to put out her containers until the last minute because they've been used to overflowing by someone else on the block, leaving a mess to clean up. If your containers aren't the right size, call Solag Disposal and arrange for larger ones. And if you don't want the bigger size, take the time to break down your cartons--stepping on them usually accomplishes the task--and consolidate other waste. If you don't have room for clippings, bag them and hold them for the next week when they can start at the bottom of the barrel. Please be considerate of your neighbors; they face the same problems you do and stealthily imposing on them is not the answer.

- 8. Accepted the Nauticus Isle Slope Monitoring report dated January 12, 1994 from Converse Consultants. This report is compiled and completed each year. Management was directed to mail a copy to each homeowner on Nauticus Isle.
- 9. Authorized the Recreation Committee to participate in the Dana Point Festival of the Whales Parade on February 26, 1994.
- 10. Authorized management to reimburse a homeowner for the cost to remove common area tree roots from sewer line.

GENERAL MANAGER MEETS WITH RITZ HOTEL STAFF RE: LANDSCAPE PROBLEMS

Our General Manager, Rob Cochrane, has met with the new General Manager of the hotel, John Dravinski, and Phil Sellick, Grounds Manager. The purpose of the meeting was to discuss the hotel staff's maintenance care of the landscaping along Cabrillo Isle/Seaward Isle. The hotel was granted an easement by the Association in 1981 to maintain this narrow strip.

Mr. Dravinski has made a commitment to have his staff meet with Rob on a regular basis to review the maintenance care. The hotel grounds staff will also look into a replanting program that may start in 1995. Many of the shrubs have reached their useful lives and several have begun to die out.

The hotel staff did discuss an on-going problem with vandalism to the irrigation valves. On many occasions, the hotel staff has found that someone has ripped out the wiring to the valves or broken off the irrigation heads. If anyone notices people going back into the shrubs between Seaward Isle and the hotel, and it is after 5 pm, please call Mariner gate to report the activity. The gate officer will contact the patrol personnel to check out the activity. If the activity is noticed and our patrol is not on duty, please place a call to the Sheriff's Dept. to report the possible vandalism.

Residents' help with this problem will go a long way toward improving relations with the hotel staff.

TIME TO REMOVE CHRISTMAS LIGHTS AND DECORATIONS

If you have not already done so, please remove the holiday decorations from the exterior of your home. Both the Board of Directors and your neighbors will appreciate your prompt attention to this request.

SEA TERRACE I RESIDENTS WITH REAR YARD DRAINS

Residents with rear yard drains must help out by making sure that dirt and debris are not washed into the drain openings. Most yards have these developer-installed drains, but not all.

Residents are asked to keep leaves or other debris from clogging the inlet. Please be sure not to wash any debris into the drain, thinking the line is big enough and it will pass through. Be sure to check the inlet before and after it rains. When changing landscape, be sure not to raise the dirt level around the drain inlet or block the use of the drain from a neighbor.

The maintenance staff will be responsible for maintaining the drain lines. However, the Association has the legal right to charge the homeowner for the labor to clear the plugged line if the homeowner contributed to the blockage.

Homeowners' cooperation will be appreciated by all concerned.

TRASH CONTAINERS MUST BE PUT AWAY!

Residents are reminded that Rules 9203 and 9204 must be followed. Containers cannot be put out before 7 pm on the night preceding pick-up and must be put away by 7 am the following morning.

Containers must be stored so that they cannot be seen from a neighbor's yard. Leaving them on the driveway is not allowed under any circumstances.

Violating these rules may get a resident a fine from the Board of Directors and a fine from the City of Dana Point.

LANDSCAPE PROJECTS THIS MONTH

Several small improvement projects along Niguel Shores Dr., near the bridge, have been completed. During this month, we hope to complete the following:

- 1. Atlantic Garden Homes continue to remove escallonia hedges and replant with smaller shrubs more appropriate for the space.
- 2. Replace the holiday color with calendulas.
- 3. Villas remove escallonia around 8 utility box areas and replant with rhaphiolepis(pink lady) and day lilies.

During March, our major project will be to dethatch the front yard turf areas within Sea Terrace I. If the weather holds, Wendt Landscaping will be able to complete this project. If we get into a pattern of rain, then this project will have to wait.

We ask for your patience when this project begins. There will be extra noise from the power equipment and the turf will look poor for about four weeks. However, by the middle of Spring the turf should look very good.

THE SILENT WIND CHIMES

Among Norm Pomeroy's many unusual accomplishments was his production of the many individually-styled "whirl-i-gigs" which he called "Silent Wind Chimes." These were "oneof-a-kind" constructions consisting of a wheel of large Mexican shells, which would rotate in even a light breeze; a name or word suggested by the purchaser made of black wire; all set in a filigree black wire frame composed of dozens of small "s" shaped wire pieces spotwelded into an elaborate pattern and studded with colored glass "jewels." Many of us here in Niguel Shores purchased these devices for ourselves and friends. As I watch my "silent wind chime" turn in the breeze, I see it as a memorial to one of the most creative persons I have ever known--Norm Pomeroy.

REMEMBERING NORM



Few in the Shores were unacquainted with Norm's readiness to repair anything for anyone at any time. He was always available, willing and able to be of help on a moment's notice. His shoulder was there to lean upon, but woe to any who might cry in his soup, for not only was this ex-Army sergeant a gourmand, he refused to suffer fools or whiners. You could ask for the shirt off his back but please just don't whimper about it.

He taught us how to use power-tools, hot glue and caulking guns, but more importantly he taught us the real meaning of friendship. He also showed us how to live generously and joyously, and how to die with dignity and courage.

What he meant to us is perhaps best illustrated by the true tale of a neighbor recovering from a stroke. He prescribed the services of a neurological specialist. The lady considered this for a moment and then replied with some vigor, "If it has anything to do with wiring, I'd prefer Norm Pomeroy."

Borrowing Specific Recreation Equipment (02-01-94)

- 1. Only a resident of the community who is a least 16 years of age may borrow badminton equipment, croquet equipment or horseshoe equipment.
- 2. The resident must provide the NSCA office staff with his or her motor vehicle operator's license or NSCA card that names and describes the bearer. A photo copy of the identity card will be made for the Association's records.
- 3. This special Recreation equipment may be borrowed any day of the year.
- 4. Recreation equipment may be borrowed no earlier than 10 a.m. and must be returned to the NSCA office staff no later than 5 p.m. Failure to return recreation equipment by 5 p.m. on the day of check-out may result in preventing the borrower or other members of the borrower's household from using recreation equipment in the future. Recreation equipment (including all of its parts) not returned will be replaced by NSCA and the resident will be billed for all necessary replacement costs to be paid to NSCA within ten (10) business days from the date of the letter demanding payment.
- 5. Recreation equipment must be used only on the community center grounds and only in the area specified for each type of equipment. Borrowed equipment must not be removed from the community center grounds for any reason.
