

3. Report any suspicious persons to the Recreation Center during the daylight hours, and to the sheriff at night.

4. Obtain permanent passes for your new vehicles.

5. Turn in, or scrape of and destroy, passes on vehicles you sell or trade. 6. Compliment the Gate Guards from time to time - their's is a thankless and

lonely job.

7. COME TO THE SECURITY MEETING ON SUNDAY, MARCH 2, 1975, AT THE RECREAT.

Guests or their non-residents using the other lane stop at the guard house, and residents using the other lane expect them to stop. However, if residents use the guest lane and do not stop, this presents an unexpected situation for drivers on the right, which could cause an accident.

At night residents are urged to dim their headlights when approaching the Shores and Mariner gates to reduce the glare. The guards will appreciate this courtesy, and it will help them to do their job more efficiently.

HELP SAVE A LIFE

Where a person's breathing has stopped, and no pulse rate can be detected, emergency first aid treatment is absolutely <u>necessary</u> within a <u>matter of minutes</u> if the patient is to survive. Paramedic units and others have been prowding this service and are doing an outstanding job! Unfortunately there aren't enough of these dedicated people available in our area.

With this in mind, how would <u>you</u> like to learn how to restore the heart beat, and breathing, of a <u>drowning victim</u> or <u>cardiac patient?</u> Through the cooperation of the American heart Association we will have available to us, at no charge, the apportunity to learn how to administer cardic pulmonary resuscitation, or CPR. It is a procedure taught to police officers, paramedics,

firemen, life guards and others involved in rescue operations.

First, the instructors will present films and slides to give us some basic knowledge of the cardiopulmonary system. Then they will make availble two life-like dummys (fully instrumentated) for the purpose of teaching each member, of the class, how to properly administer CPR. Each of us will practice it until we do it correctly. Certificates of qualification will be issued.

The dates for the first class, are March 6th and 13th, from 7 to 10 P.M., at the Community Center. The class will be limited to 30. Call Steve Sonies now and make a commitment.... You owe it to your family to do so.

RULES

Respecting the Use of the Property, Facilities, & Equipment

Of

Niguel Shores Community Center

USE PRIVILEGES

The Niguel Shores Community Center property, facilities and equipment are restricted in use to members of the Niguel Shores Community Association, their families, and guests.

The rules incident to the use and enjoyment of the facilities of the Niguel Shores Community Center shall be structured to provide maximum recreational benefits to the greatest number of persons. To preserve and protect these mutual rights, rules have been established by the Niguel Shores Community Association Board of Directors. Any individual or groups abusing the rights of use granted under these rules, and the By-Laws of the Association, may have those rights suspended at the discretion of the center staff. Such suspensions shall be for specified periods of time as determined by the Board of Directors.

General Rules

- 1. Guests at the recreation center must be accompanied by members at all times while in the center area. Members will be held responsible for the conduct of their guests and their observance of adopted rules. Member's children (18 years or under) are restricted to two guests per day.
- Access to the recreation center is restricted to authorized times and entrances only. Any member who enters during unauthorized hours is subject to trespassing laws and the suspension of the use rights. Violations of this rule by guests of members shall be cause for suspension of member privileges.
- 3. No pets or animals are permitted within the Recreation Center.
- No glass containers or glass objects are permitted on center property without prior authorization by the Recreation Manager.
- 5. Smoking is prohibited in designated NO SMOKING areas.
- Rough or boisterous conduct, profanity, gambling or immoderate use of alcohol is prohibited and will be grounds for expulsion and suspension of privileges.
- 7. Staff has the authority to enforce all prescribed rules. It is the responsibility of each member to report infractions to the Recreation Manager.
- 8. All storage areas, pool filtration rooms, and private meeting rooms are off limits.

- 9. Anyone misusing or vandalizing center facilities will be referred to the local authorities for prosecution and will be subject to suspension of privileges.
- 10. Groups desiring to serve alcoholic beverages must obtain prior consent of the Recreation Manager. Applications must be submitted at least two weeks prior to the date of the event and must indicate the following information:
 - A. Certification of County issued license if liquor is to be sold.
 - B. Signed liability and property release for room use; proof of insurance, as required by the Recreation Manager or Board of Directors.
 - C. Required deposit on room usage (see schedule).
- 11. Shoes or appropriate footwear are required at all times except when activities dictate otherwise, at the discretion of the Recreation Manager.
- 12. Recreation facility users may be required to furnish proof that they reside within Niguel Shores.
- 13. Only one lot membership per lot shall be permitted (i.e., If an owner rents or leases his property in Niguel Shores, either the tenant or the owner may be a center member, but not both. The membership designation, if other than the listed owner, must be listed with the Recreation Manager.)
- 14. Only activities programmed and scheduled by the Recreation Manager and his staff may preclude member usage of pool, playground, lockers, jacuzzi, or trellis area at any time.
- 15. Loitering on or about the Recreation Center area (including parking lot) is prohibited.
- 16. Any member observing infractions of the above rules; vandalism of the facilities; or other malicious acts is requested to report such occurences immediately to the Recreation Manager, the Resident Manager, or Professional Community Management. Cooperation is essential to the orderly maintenance of the center facility.

SCHEDULING

- 1. Niguel Shores Community Center facilities may only be reserved by the waive of release form signed by a responsible representative of the group and approved by the Recreation Manager.
- 2. Recreation facility reservation requests must be submitted in writing to the Niguel Shores Community Center Office between 9:00 a.m. and 6:00 p.m. Monday thru Friday (except holidays).
- 3. Facility must be reserved 31 days prior to scheduled event on a first come first serve basis. Written reservation request must be filed with the Recreation Manager at least 31 days prior to the proposed date of the event.

13. If court cancellation is made at least one hour prior to scheduled time, the court may be rescheduled. If a "don't show" is recorded to the players time (5 minutes late without call), he will forfeit two weeks court scheduling privileges. If unable to make scheduled time, player should call prior to time reserved, so that the court may be rescheduled.

SWIMMING POOL RULES

1. Pool Hours

7:30 am - 9:00 pm Weekends

7:30 am - 9:00 pm Weekdays

- 2. No member or guest is permitted in the pool area or center ground prior to 7:30 am or after 9:00 pm. Member violators will be subject to suspension of use privileges. Non-member violators will be subject to arrest as trespassers. Children must be 12 years old or in the 7th grade in order to go swimming without adult accompaniment.
- 3. All persons must obey rules and requests made by the center personnel.
- 4. Showers are requested by all pool users before entering the pool area.
- 5. All persons with hair that touches shoulders when wet $\underline{\text{MUST}}$ wear a rubber band or bathing cap.
- 6. Chewing gum or eating on the pool premises is not allowed. No glass containers of any kind permitted in the pool area.
- 7. Floating apparatus, glass items, sticks, stones, or any object which is not part of the regular programmed equipment items are not allowed in the pool area. Playing ball on deck is prohibited.
- 8. Swim suits must be worn by persons using the pool. No cut-offs or street clothing.
- 9. Persons with colds, coughs, red or infected eyes, skin eruptions, open wounds, sores or bandages are not permitted in the pool area.
- 10. Non-swimmers or weak swimmers must remain in the shallow water no deeper than their armpits. The lifeguard may request any user to take a safety test and may restrict any user's use of the pool.
- 11. Dangerous practices prohibited: pool users may not run on decks; climb on, sit, jump from fences or other structures; or dive in shallow water. Horse-play or wrestling on decks, ladders, springboards in the pool, or in dressing rooms is prohibited.
- 12. Spitting, spouting of water or blowing nose in the pool is prohibited.
- 13. Emergency or exit signal of lifeguard or center staff must be observed. Swimmers must leave the pool area immediately upon the signal or request of the center personnel, pool personnel, counselors, or group leaders.
- 14. Management reserves the right to expel persons under the influence of alcohol or narcotics from the pool or pool area.

- 4. A. Resident groups: (More than 50% of the persons attending are Niguel Homeowner Association Members) a clean-up fee of \$40.00 and a damage deposit of \$25.00 must accompany the reservation request.
 - B. Non-Resident groups: (Less than 50% of the persons attending the event are Niguel Homeowner Association Members) a clean-up fee of \$100.00 and a damage deposit of \$100.00 must accompany the reservation request.*
 - *Fees and deposits will be refunded if reservation request is denied. Damage deposits are refundable after scheduled event if no damage or extraordinary maintenance occurs as a result of the activity.
- 5. The serving or consumption of food or beverages is limited to multi-use rooms, picnic area, and trellis area adjacent to Main Office. Any group proposing to serve food or beverages must have prior approval by the Recreation ofc. Glass will be permitted in the Multi-Use Room and trellis areas only and only on prior approval of the Recreation Manager.

USE OF TENNIS COURTS

- 1. Tennis shoes and appropriate attire are permitted.
- 2. Children under 6 are not allowed on the courts unless playing tennis, and accompanied by adults. Children over 6 must be players or seated spectators. No activities other than tennis is to occur on any tennis court at any time.
- 3. No food is allowed on courts.
- 4. Court sign-ups will be in the recreation office on a first come first serve basis. No more than one reservation per family per day. Courts may not be reserved more than 24 hours ahead of playing time desired.
- 5. Courts are to be used for tennis only.
- 6. Tennis etiquette is to be observed at all times.
- 7. All scheduled courts must be relinquished when time is up.
- 8. Center sponsored play will have priority over courts 3 and 4 on weekends only.
- 9. Players are encouraged to play doubles when possible and during "prime" times.
- 10. If a court is not occupied within 5 minutes of scheduled time, it will be relinquished for the use of racking players or stand-by players on a first come first serve basis.
- 11. Members must observe posted court rules.
- 12. All tennis clinics, all private charged lessons, or any such group tennis instruction must be approved by Center Manager two weeks prior to being conducted and must be open to all residents. No tennis lessons will be permitted during prime weekend playing times.

- 15. One person at a time will be permitted on the diving board.
- 16. Children under 12 years of age are not allowed in the pool or pool area unless accompanied by an adult when a lifeguard is not on duty.

Jacuzzi Rules

- 1. Shower before using.
- 2. Use restroom facilities.
- 3. No food or beverage allowed in jacuzzi area.
- 4. No smoking in jacuzzi area.
- 5. It is recommended not to exceed 15 minutes of usage per visit.

Sauna Rules

- 1. All persons must be 18 years or older to use the sauna.
- 2. The following categories of personal medical backgrounds are <u>not</u> to use sauna:
 - A. Heart patients, stroke victims or history of cardiovascular ailments
 - B. Epilepsy
 - C. Diabetics or hypoglycemic persons
 - D. Recent head injury
 - E. Under the influence or control of alcohol or drugs
 - F. When feverish or suffering from contagious illness

3. HOW TO USE

- A. Sauna baths are to be taken in three stages with each sauna bath lasting no more than 10 minutes.
- B. After each 10 minute sauna bath, a "cool" shower should be taken. Before taking a second and third sauna bath, you should rest at least 10 minutes.
- C. For your comfort and convenience, a towel may be placed over the hot redwood benches. Bathing suits may be worn if preferred.
- D. Overheating precautions are shortness of breath, rapid heavy pulse, dryness of mouth, and dizziness. Sauna cycles should be discontinued when these signs occur.
- E. Enjoy your sauna and good health!
- 4. IF USING SAUNA ALONE, PLEASE ALERT RECREATION STAFF.

LOCKER AND DRESSING AREA

- Lockers are available on a daily basis only, and then only while using the facility.
- 2. Residents wishing to lock up valuables may do so by bringing their own lock.
- 3. Locks left on a locker over 24 hours will be removed by club management.
