FROM THE HELM

With the start of the repair of the seawall along our beach last week, at long last, the Association has during the past year concluded several major projects that enhance the quality and character of our community.

The swimming pool was repaired, and a new fence will be installed around the pool area in the next few weeks. A cover for the pool was purchased, and its installation already has reduced the cost of heating the pool.

Tennis courts 1 and 2 were enlarged to permit the installation of a fence between the two courts; fencing around all courts was repaired, and new lumite background screening was provided.

The new stairway leading from Abalone Drive down the slope to Niguel Shores Drive has been completed, and landscaping of the stairway and slope has commenced.

Resurfacing of cracked and raised asphalt pathways in the community will begin shortly, as will repair of concrete walks and drives located in the Association's common area.

As each of the foregoing projects is completed, the quality of the physical facilities and landscape of our community improves. Such improvement, however, makes more apparent the impact of vandalism on the care and maintenance of our community.

Several letters have appeared during the past year in the SEASHORE NEWS describing damage and destruction of our Association property due to vandalism, and appeals have been made to members of the Association for help in reducing it.


I wish to thank those members of the Association who have issued the appeal through their letters and those who have offered suggestions on how better to control the problem. If we are successful in this regard, the cost of repair and maintenance of Association property can be substantially reduced. Such savings should be reflected in the operating budget of the Association, on which the annual assessment of our members is based.




CANDIDATES FOR THE BOARD

IMPORTANT

Any exterior changes on your property must be submitted to the Architectural Control Committee for approval. This includes:

Room extensions or additions, including turning atriums into rooms.

Walls or fences, unless replacing existing with exactly the same.

Patio paving (brick, tile, etc.). The reason is to ensure proper drainage, and the drainage must be shown on the submittal plans.

Reroofing, if there is a change from the original roofing material.


All exterior painting, even if repainting the same color. This regulation was recently changed because with the passage of time, newer homeowners do not know the original color and some homes have been changed in color without approval.

Be sure to check the current Architectural Regulations and Guidelines when planning any exterior changes to your property, and be sure to pick up a checklist at the Niguel Shores office.

Some of our residents even have their friends outside the community save papers for us, while we still have a large number of residents who throw them in the trash.

When we moved into Niguel Shores fifteen years ago the air quality index was very low. Recently we have had several days when the index reached well into the unhealthy range. Saving trees alone will only help in a very small way, but it does help, and as citizens of this country we must realize that the time has come to take any steps, no matter how small, for conservation and to save the environment.





CHANGING THE CC&RS

The Niguel Shores Declaration of Covenants, Conditions, and Restrictions (the CC&Rs) lists many of the duties and responsibilitie of the Board and the Members, and defines certain restrictions on their activities. This document was written before the first lot in Niguel Shores was sold (1969) and is considered by some to be out-of-date, verbose, incorrect, incomplete, ambiguous and sometimes oddly silent. The CC&Rs provide that they may be changed if approved by three-fourths membership. Since only about 70% of our members live here, it would be extremely difficult to obtain the 75% approval necessary to improve the document.

However, the CC&Rs do provide that during 1989 they may be changed by a <u>majority</u> approval, rather than 75%. Therefore, in order to determine which changes should be presented to the membership for approval, we are requesting members to indicate their wishes on the attached "straw ballot."

STRAW BALLOT - Circle YES or NO to indicate whether this change should be submitted to the membership for vote. Remove entire page. Return completed ballot to the Administrative office.

- YES NO 1. CC&R changes should require 60% approval of members.
- YES NO 2. CC&R changes should require majority approval of members.
- YES NO 3. Monetary penalties should be possible for violations of present architecture standards.
- YES NO 4. Monetary penalties should be possible for violations of present restrictions on owner's use of property.
- YES NO 5. A capital improvement itself should require the approval of 2/3 of the members. (Now only a <u>special assessment</u> for a capital improvement requires 2/3 approval.)
- YES NO 6. A capital improvement should require the approval of a majority of the members.
- YES NO 7. Arbitration should be required to settle differences between the Association and its members.
- YES NO 8. References to the rights of the Developer and Prudential should be eliminated from the CC&Rs.
- YES NO 9. Maintenance should be defined as restorative rather than preventative.
- YES NO 10. The Architecture Committee should not be asked to base their approval on "adequacy of structural design and material" but rather on "suitability of design and material."
