NEIGHBORHOOD WATCH



Neighborhood Watch is really just a matter of being a good neighbor and of using common sense in securing your home against the entry of a burglar. Neighbors who watch out for each other and who report suspicious persons or circumstances to the Sheriff's Department are providing a timely and effective form of protection against burglars.

By installing good, positive type locks throughout the house and by keeping doors and windows locked even when we are home we discourage would-be burglars who usually look for easy entry into a home. Deadbolt locks or metal screws can be used on windows and gliding glass doors to prevent the removal of the window or door. Deadbolt locks should also be installed on exterior doors. If there is a window in or next to the door a double cylinder deadbolt lock should be used so that it can be locked with a key from the inside of the house.

Securing your home against unwanted visitors doesn't have to be complicated or expensive. While our community has relatively few burglaries, we all need to do those things necessary to keep it that way.

COMPILATION OF MASTER CC&RS

Attached to this issue of the Seashore News is an unofficial compilation as reviewed by legal counsel of the master Declaration of Covenants, Conditions and Restrictions (CC&Rs) and the four amendments to date. This compilation is provided for ease in reading the documents including the amendments. It is not to be construed as an official or legal copy of the CC&Rs. For legal purposes, such as transfer of property, etc., reference must be made to copies of the actual recorded documents.

Niguel Shores has fourteen tracts, each with its own supplementary set of CC&Rs pertinent only to that tract. Each property owner within Niguel Shores should have received at close of escrow a copy of the recorded master CC&Rs, each of the four amendments and the Supplementary CC&R for that property's tract. Should you not have a full set of these documents, please contact the office to obtain any missing documents. The Supplementary CC&Rs for other tracts may be reviewed during regular office hours from 9am to 5pm Monday through Friday. Just call ahead so we can have the documents you wish to review ready for you when you arrive.

Colonel Tom Reath, U.S.M.C., recently returned from the Gulf where he spent the last seven months as the Air Officer with the 1st Marine Division. If at all possible, you are requested to have your vehicles off the street on these dates to allow the street sweeper to do a thorough job.



STREET SEALING APRIL 2



It has been approximately five years and it is time to apply an asphalt slurry to all the streets. The Maintenance Committee has again awarded the contract to Roy Allan Slurry Seal. THE WORK IS SCHEDULED FOR APRIL 16 TO APRIL 26.

Listed below is the schedule of work. This schedule is subject to the weather. If the crews cannot work on a particular day, then they will wait until the weather clears. They ll continue their work in the order listed below. You will receive a reminder notice on your front door 48 hours in advance of your street being coated.

Please notify your service personnel and request that they come on an alternate day if possible. Areas to be sealed will be closed off at 8am and will not re-open until 5pm that day. Residents and contractors will have to park and walk to the home. The schedule was developed so that some available parking was left near the area to be sealed. Residents are advised to be careful where you park. DO NOT PARK IN FRONT OF DRIVEWAYS, FIRE HYDRANTS OR OBSTRUCT THE FLOW OF TRAFFIC. Vehicles that do park in such places will be subject to immediate towing.

An extra patrol will be on duty to make sure residents, visitors, service contractors, etc., do not drive on the streets after the sealant is laid. If any streets are driven on prior to 5pm, then they will be billed for all costs to repair. Residents will be held responsible for the actions of visitors and service contractors.



RECREATION COMMITTEE

At its March 13 meeting the Recreation Committee voted to recommend that the Board of Directors approve a Lecture Series in cooperation with the University of California Irvine. It will include lectures on three related health topics by three professors from U.C. Irvine. The total series will be designated "The Dan Aldrich Memorial Lecture Series". Dr. Daniel Stokols, professor of Social Ecology, will make a presentation on "Establishing and Maintaining Health Environments. Dr. Carl Cotman, professor of Psychobiology will speak on "Successful Aging: The War on Cognitive Decline", and the topic to be covered by Dr. Frank L. Meyskens, Jr. will be "Chemoprevention of Cancer in Humans".

It is expected that these lectures will be scheduled at 7:30 p.m. on Thursday, May 2, Wednesday, May 8, and Wednesday, May 22. There will be no charge for the lectures, but admission will be by ticket only available at no cost in the office. Additional information is included in a separate flyer.


