MARCH BOARD ACTIONS

- 1. Authorized management to issue a \$25 fine to a homeowner if vehicle stored on driveway was not removed by March 10.
- 2. Accepted language to amend the Association's ByLaws, Section 1210(b). Management was directed to see that a copy of the amended language was mailed to all homeowners in the April assessment mailing.
- 3. Appointed Grover Brown as Chairperson of the Finance Committee.

- 9. Accepted bid from Electro Parts for replacement of Mariner gate arm mechanism at a cost of \$2082.

STATUS OF POOL AND TENNIS COURT **MAINTENANCE**

By the time this newsletter issue is received, pool equipment-repairs/replacements will have started. Unfortunately, this work started a week late, hence, the pool may not be up and running by Saturday, April 8. Besides the heater being replaced, the filtration system is also being replaced and improved with new pipes and larger filters. This should allow for better filtration during heavy swim loads which occur in the late Spring and Summer months. While this work is on-going, the spa will be open for use.

Our contractor and maintenance staff will do everything possible to have the pool back up and running for Easter Week. Watch for posters at the Community Center advising when the pool will reopen.

The tennis courts will have their play surfaces completely stripped and new ones installed sometime in May. When this work is in process, repairs will be made to the concrete surfaces of courts 2 & 4. These two courts have been a maintenance problem for many years because of incorrect concrete pouring procedures when originally installed. Discussions were held with a knowledgeable tennis court contractor who provided a preliminary estimate of \$19,000 per court to pour a two inch thick pad over the Board has asked existing surface. The management to seek other repair methods, if available, along with expected cost.

Before the courts are reopened, the maintenance staff will install new wind screens on all four courts.

As of March 21, management expects the courts to be closed during the last two weeks in May. More specific date closures will appear in the May issue of the Seashore News.

ADULT POOL SWIM HOURS MUST BE **OBSERVED BY RESIDENTS!**

The Association has had a rule for many years specifying when only adults may use the pool. During these time periods, those under 18 are not allowed to be in the pool or within the pool fence area. Many residents and their guests ignore this rule, putting staff in a very difficult position.

It does not matter if adults are using the pool or not, children are not to be within the pool fence area, during the hours listed below. Some adults in the community show up-after the start of adult only hours and expect no children in the pool area. If children are there, then staff is expected to ask them to leave. Last year, this issue became very difficult for the staff, and several heated arguments occured between residents.

Each pool entry gate has a sign reminding residents of this rule and lists the hours for adult swim.

There are adults in the community that do not see this rule as an imposition on families. Families may use the pool for many hours each day, yet not during the limited adult only hours listed below:

EVERY DAY: 7 am to 9 am and 12pm to 1 pm

Management would appreciate all residents following the rule and cooperating with staff if asked to leave the pool area.

STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, April 3. You are requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.

CURRENT STATUS OF TREE VIEW PROBLEMS ASSOCIATED WITH TALL **EUCALYPTUS**

Questions were raised about this subject at the March Open meeting. Homeowners should understand that the CC&R's do not apply to those trees located upon common area. Article I, Section 4 provides the definition of a "Lot" within NSCA and there is language that excludes Common Areas. Thus, property owners are bound by the CC&R's to trim trees and shrubs on their lot if the Tree View Blockage Committee requests them to do so, yet the Association is not legally obligated under the same circumstances.

This does not mean the Board of Directors and the Landscape Committee are not sympathetic to this issue. The Board changed policy last year directing the Tree View Blockage Committee to also review common area complaints. They also added a new line item in the budget for tall tree trimming.

The Landscape Committee has been looking at this issue for many months. They are currently deciding whether to remove some of the tall trees and trim others or just to trim them all. Another issue that needs to be determined is how often to trim. A recommendation with a request for funding should be forthcoming to the Board in the next several months.

There are those in the community who do not believe that tall eucalyptus trees upon common areas have been trimmed in this community. In 1993 and 1994, this Association spent \$9,525 to trim tall trees. Below are the locations:

1993


- 1. Eucalyptus grove along Leeward.
- Three (3) large eucalyptus near 2. Marlinspike.
- Twenty six (26) Eucalyptus on 3. Selva at PCH, south of Coral Bay.

Four (4) tall Eucalyptus at Mariner 4. Dr. and Niguel Rd.

1994

- 1. Three (3) Eucalyptus east of the bridge, at the end of Ionian Bay.
- Seven (7) Eucalyptus next to 2. stairway between Sea Terrace II and Villas.
- Eucalyptus on Niguel Shores Dr., 3. behind Spinnaker.
- Four (4) eucalyptus in the upper 4. beach parking lot.

Not all of this trimming was for strictly view blockage, some was maintenance oriented. By doing the above trimming, it showed the high cost in maintaining existing trees. ASSOCIATION TOWS VEHICLES PARKED UPON COMMON AREAS WITHOUT VALID **ENTRY PASS!**

Both the Board of Directors and the Traffic and Safety Committee want to remind residents that there is a tow policy for vehicles parked on the common area without a valid guest parking pass, service pass, resident decal or homeowner decal.

The owner of the vehicle will be responsible to pay the tow company's tow/impound charges. Currently, it will cost between \$85 to \$100 to retrieve the vehicle, plus storage fees.

It has been observed by management that some residents allow others to enter the community through the unmanned gates with their gate key card. Allowing friends or service providers into the community in this fashion is not proper and may result in their vehicle being towed. Under the rules of the Association, all vehicles MUST have a valid pass in plain sight, which can be obtained from the Mariner gate, or for decals, from the NSCA office staff.

The above also applies to those who live in the Villas and Sea Terrace II. Every six months, (March/September) new parking passes are issued to each resident for guests to display on their dashboards when parked on the common area.

Currently, there are three vehicles listed on the roving Patrol's "Authorization to Tow" list. As the summer approaches, management expects other vehicles to be added. Please take the time to see that all visitors/residents to your home have the proper vehicle pass so as to avoid the embarrassment and trouble of being TOWED!

TRAFFIC & SAFETY COMMITTEE

Main objective is to revitalize Neighborhood Watch. As of this date, we have twenty-five active members who have volunteered to be Block Captains (BC). The Block Captain is the key person on the block.

BC Function:

- 1. Make a list of names, addresses and phone numbers of the people on your street.
- 2. Encourage those neighbors who do not participate to do so.
- 3. Encourage participating members to make their homes less vulnerable to burglaries by installing dead bolts and window pins, etc.
- 4. Encourage participants to let their neighbor know when they will be gone for any extended period so that all can watch to protect their property during their absence and contact the Sheriff if they observe suspicious acts, etc.
- 5. Attend block meeting approximately every other month or as needed to share current crime patterns and protective measures.
- 6. BC's are very important and the key stone in our protective program.

ENTRY GATES AT GARIBALDI AND MANTA TO BE REFURBISHED

Management and the Board have been asked about the status of these two gates. The Board is aware of the mechanical problems that have occurred over the last several months. Management has provided the Board brochures on new phone systems that are available. Recently, new information has been received about another phone system option the Board has requested management to pursue. Board will also be meeting with an expert in the field to find out what mechanical gate operators are available. It is the Board's goal to find the latest in current technology.

Management expects decisions to be made in the next several months as to the type of equipment needed. Installation would probably occur in the Summer.

HANDICAPPED PARKING LAW TO BE **ENFORCED!**

This Association has properly marked parking spaces in the Community Center parking lot and the lower Beach Parking Lot. Parking in these spaces requires valid identification from the California DMV. If a vehicle does not have it, the registered owner is subject to the following enforcement action:

> 1. The vehicle can be immediately impounded and towed without the issuance of a violation notice.

OR

2. The vehicle can be issued a citation from a Dana Point Parking Enforcement Officer. The fine will cost in excess of \$200.

Residents are asked to follow the law or face the above enforcement action. Residents are also asked to be sure their visitors follow the law.

ANNUAL MEETING FOR BOARD OF **DIRECTORS ELECTION COMING IN MAY**

RESUME OF GEORGE WILLIAMS Cassandra Bay

In the Fall of 1989, I completed 42 consecutive years of public service. I served 22 years with the Los Angeles Police Department during which time I performed all traditional uniform division law enforcement, investigative, and supervisory assignments. In 1969, while the Adjutant to the Commander of Juvenile Division, I retired from the LAPD to accept a civil service appointment as a Law Enforcement Management Consultant with the State Commission on Peace Officer Standards and Training (POST), headquartered in Sacramento.

While with POST, I provided management consultive services upon request to local police and sheriff's departments throughout the state, helping them to better organize, determine their personnel needs, appropriately deploy their personnel, and set up more sound management and operational practices and procedures. In 1971, I became the first Administrative Assistant to the Executive Director of POST. In the latter assignment, among other responsibilities, I personally was charged with drafting and perfecting the rule making documents for all regulations adopted by the Commission at its quarterly meetings, and subsequently obtaining the approval of those regulations by the Office of Administrative Law, in the Office of the Governor. I retired form State service in the Fall of 1989.

During the last three decades of my professional career I served exclusively in successively more responsible staff, supervisory and management positions that demanded unfailing abilities to deal with the most difficult and complex issues and matters, while working affirmatively with superiors, peers, subordinates and the public.

Mrs. Williams and I have been happily married for 42 years, and have lived in the Shores since June of 1991. While living here, I have been active member of the Mens Club, served on the Maintenance Committee, the Landscape Committee, the Architectural Control Committee, the Entrance Improvement Committee, and the special Vandalism Committee. In 1993, I was elected to the Niguel Shores Community Association Board of Directors, in which I first served as its Secretary and currently as its 1st Vice President.

LIFEGUARD AVAILABLE EASTER WEEK
