# Manager's Report

RECREATIONAL FACILITIES: Now that the warm weather has finally arrived, we would like to remind all residents that we do have rules and regulations for use of the recreational facilities. Some of these are:

Guests at the recreational center must be accompanied by members or be registered at the office at all times while in the center area. Members will be held responsible for the conduct of their guests and their observance of adopted rules.

Access to the Community Center is restricted to authorized times and entrances only. Any member who enters during unauthorized hours is subject to illegal entry and trespassing laws, and violators will be prosecuted. Violations of this rule by guests of members shall be cause for suspension of member privileges.

No glass containers or glass objects are permitted on center property without prior authorization by the Community Center Coordinator.

SHOWERS MUST BE TAKEN BY ALL POOL AND JACUZZI USERS BEFORE ENTERING THESE AREAS.

DANGEROUS PRACTICES PROHIBITED: Pool users may not run on decks, climb on, sit, jump from fences or other structures; or dive in shall water. Horseplay or wrestling on decks, ladders, springboards in the pool, or in dressing in rooms is prohibited.

Consumption of alcoholic beverages on community property by anyone under 21 years of age is not permitted. This includes the beach parking area.

AS A REMINDER: When you deposit aluminum cans at the recycling area, please place them in the proper container. Remember - only aluminum cans - not tin. Do not leave the aluminum cans in plastic bags or sacks.

# FINANCE COMMITTEE

The Finance Committee is in need of help. Any resident in the community who is familiar with internal audit procedures could be of great service. The Association has a new bookkeeping system and we are anxious to set up an internal audit system, but need volunteers. SLOPE DRAINS: A number of private lots in our Community have drains which were installed to take excess water from those lots down a slope to the street or to property below. The entrances or openings to these drains are located in the rear or side yards. The owners of the lots which have this type drain have the responsibility to see that the opening to the drain on their property is unobstructed at all times and that water from the surrounding area can flow freely to the drain. Owners of property with slope drains are requested to check their drains at least twice a year and do what is necessary to assure that the openings are unobstructed and that water will flow freely from the adjacent property to the drain(s).

Harry Otsubo is working with Dick Wendt and Bill Bierman on the restoration of the slide areas throughout the community. When the slopes dry out, we hope to begin this work.

### WINDJAMMER SLOPE DRAINAGE - Status Report

Due to several inquiries concerning the work progress in this area, the following schedule of work to be accomplished is published for the benefit of all residents in the area:

- 1. Finish drainage project (COMPREHENSIVE LANDSCAPING) Completed 4/18/80
- 2. Installation of electrical wiring for lights and pumps (N.S.C.A. Maintenance Personnel) currently in progress. Replacement of sidewalks when electrical lines have been installed.
- 3. Installation of surface drainage (DICK WENDT LANDSCAPING).
- 4. Restore and repair irrigation system (DICK WENDT LANDSCAPING).
- 5. Relandscaping of area. (DICK WENDT LANDSCAPING).

We realize this project seems forever in completing, however numerous problems were encountered. The biggest problem has been the weather in December, January and February. The bad weather prevented the contractor from bringing in his tractors, etc. He had one in and due to the wetness, the tractor sank in the mud. Finally, the contractor managed to finish his job. We are now in the process of installing a new electrical system. This is necessitated by the fact that the previous system deteriorated to such a degree that when the maintenance personnel started to work on it, it fell apart in his hands. The new system will be inserted in conduit. Bids are being accepted for the concrete sidewalks and driveways which were damaged. Work will commence when a bidder is selected. We anticipate that all the work in this area should be completed by the end of May.

MAY pickup of newspapers, magazines, brochures, junk mail will be:

MAY 12 and MAY 26, (Official Memorial Day)

The last paper pickup started at 2 p.m., but because of the large amount of paper it was not possible for our recycler to complete coverage of our area that day, and it was necessary for him to return at 6 a.m. on the following day. While discussing this problem with Mr. Leensvaart, we decided that both our interests would be better served if he could start his pickup earlier in the day. Therefore, we concluded that we should ask our contributors to get their papers out by 12 noon on pickup day. That will give an extra two hours of daylight for the work.

THEREFORE: IN THE FUTURE, WILL YOU PLEASE PLACE YOUR PAPER MATERIALS AT YOUR FRONT CURB BY 12 NOON ON PICKUP DAY?

Our March 24 pickup totalled 24,911 pounds, or 12.46 tons - \$373.67 On April 14 we had 26,060 pounds, or 13.03 tons - 390.90 (Five week period) 50,971 pounds, or 25.49 tons \$764.57 total.

Through April 14, 1980, we have recycled 754,409 pounds, or 379.21 tons. Total income to that date, including aluminum amounts to \$7797.39. Monies used to date on community projects, \$3022.53. Funds in the United California Bank available for further projects. \$4,685.26.

Again, thanks to everyone who participates in this wonderfully worthwhile and patriotic project. We have lots of room for more participants. Just save your newspapers, brochures, magazines, junk mail and place it at your curb in large paper bags, a carton, or tied with string, by 12 noon on the second or fourth Monday of each month, and our recycler will pass by your home and pick it up. They weigh it and send us a check. That's all there is to it. Everyone in the community benefits.


### KEEP YOUR DOG ON A LEASH

There have been complaints about dogs running loose in the area. We realize that dogs need exercise and it is easy to open the door and let them run, but this is not fair to your neighbors and others in the community. Further, some dogs are reported to be irritable and, perhaps, vicious and can present a hazard to children and others. The possibility of injury to others is a risk no one should take.

There is a county ordinance which requires dogs to be on leash and under control when off the owner's property. The Orange County Health Department will enforce this ordinance and pick up stray animals on request. The telephone number is: 634-7301. Whenever you contact the Control Office about a complaint, they need the following information, if available:

- 1. Description of the animal.
- 2. Times of day animal is sighted.
- 3. Locations observed.
- 4. If known, name and address of owner.

Perhaps one of the biggest problems resulting from these dogs running loose is the health hazard. Our youngsters, who play in the sand area can get pin worms or other diseases from these dogs doing their business in this and other areas of the community where children play.

### PARAPSYCHOLOGY AND PERSONAL AWARENESS




# YOUNG PEOPLE'S BOWLING DAY





SLOPE DRAINS: A number of private lots in our Community have drains which were installed to take excess water from those lots down a slope to the street or to property below. The entrances or openings to these drains are located in the rear or side yards. The owners of the lots which have this type drain have the responsibility to see that the opening to the drain on their property is unobstructed at all times and that water from the surrounding area can flow freely to the drain. Owners of property with slope drains are requested to check their drains at least twice a year and do what is necessary to assure that the openings are unobstructed and that water will flow freely from the adjacent property to the drain(s).

Harry Otsubo is working with Dick Wendt and Bill Bierman on the restoration of the slide areas throughout the community. When the slopes dry out, we hope to begin this work.

### WINDJAMMER SLOPE DRAINAGE - Status Report

Due to several inquiries concerning the work progress in this area, the following schedule of work to be accomplished is published for the benefit of all residents in the area:

- 1. Finish drainage project (COMPREHENSIVE LANDSCAPING) Completed 4/18/80
- 2. Installation of electrical wiring for lights and pumps (N.S.C.A. Maintenance Personnel) currently in progress. Replacement of sidewalks when electrical lines have been installed.
- 3. Installation of surface drainage (DICK WENDT LANDSCAPING).
- 4. Restore and repair irrigation system (DICK WENDT LANDSCAPING).
- 5. Relandscaping of area. (DICK WENDT LANDSCAPING).

We realize this project seems forever in completing, however numerous problems were encountered. The biggest problem has been the weather in December, January and February. The bad weather prevented the contractor from bringing in his tractors, etc. He had one in and due to the wetness, the tractor sank in the mud. Finally, the contractor managed to finish his job. We are now in the process of installing a new electrical system. This is necessitated by the fact that the previous system deteriorated to such a degree that when the maintenance personnel started to work on it, it fell apart in his hands. The new system will be inserted in conduit. Bids are being accepted for the concrete sidewalks and driveways which were damaged. Work will commence when a bidder is selected. We anticipate that all the work in this area should be completed by the end of May.

# JUNE 1980:

August is election time. At the present time two people have been accepted to run for the Board. They are Ingrid Andrews and Harrie Whitney. Anyone else interested, call Carol Sue Mullen at 493-1238 or the Community Center office 493-0122.

We have a special Gate Study Committee on how to improve our gates. We hope to give facts and figures to the residents at a future Board meeting.

The Board approved the following:

- 1. A contract to Viejo Sweeping Service for six street sweeps at \$630.00 per sweep.
- 2. Remodeling of multipurpose room kitchen--new commercial stove, hood and installation at a cost of \$4,000 which had been budgeted.
- 3. The Recreation Committee has donated \$600.00 from the Wine and Cheese-Art Faire Party.
- 4. The Men's Club has authorized the purchase of a stainless steel commercial type refrigerator, heavy duty garbage disposal and stainless steel sink from proceeds of paper drive. Thanks again for the support of this project
- 5. A contract to Dick Wendt Landscape Service: Installation of pre-cut concrete vault with heavy duty steel grate, and electric pumps with automatic float switch, 1½" exit line connected to existing 3" line running down to vault in greenbelt at the end of Windjammer. Approximately 30' of trench drain to be installed collecting water to flow into vault. Cost \$2,360.00. This will help to eliminate the water on Halyard.

The next monthly Board Meeting will be held on Tuesday, June 10, 1980, at 8 p.m. in the multi-purpose room of the Community Center.



#### FEES & FINES POLICY

#### INTRODUCTION

The ordinances and laws of county, state and nation apply to our private community as they do everywhre else. Local government is the responsibility of the Niguel Shores Community Association (N.S.C.A.).

The developer of Niguel Shores used the experience of projects similar to Niguel Shores to devise three sets of regulations for our community, i.e., (1) the Covenants, Conditions and Restrictions (CC&R's) also referred to as the Declaration of Restrictions applicable to our deeds, (2) the By-laws of our Corporation and (3) Rules and Regulations (R & R's) which implement the requirements of the first two.

The CC&R's are legal documents recorded with Orange County and as such are written in legal language. It establishes the N.S.C.A. and the Architectural Review Committee (A.R.C.) and many of the rules that apply to A.R.C. matters. The By-Laws established the organization of the N.S.C.A., and rules applicable to its membership and officers. The annual assessment is treated in both documents. In reading the CC&R's and By-Laws you will find references to the developer who is no longer involved at Niguel Shores and are therefore not applicable.

All rules and regulations pertaining to the Niguel Shores Community Association owners, tenants, and guests relating to the privileges and restrictions of Niguel Shores are intended to be for the benefit and protection of such members, tenants and guests and to help insure the privacy and enjoyment of the total community. Compliance and cooperation of all concerned is necessary. Security guards and other Niguel Shores Community Association employees are following their instructions when they require compliance with these rules.

Pursuant to the authority vested in the Board of Directors for the Niguel Shores Community Association, the Board has established the system of fees and fines stated herein, to assist in the enforcement of violations of the Rules and Regulations of the Niguel Shores Community Association. This system of fees and fines shall not be the exclusive remedy of the Association to deal with such violations and all such remedies shall be cumulative. Such fees and fines shall be binding on all the members of the Association in a manner consistent with Section 1.b. of Article X of the By-Laws of the Association.

Fees and Fines may be levied by the Board of Directors in the following categories, which the Board, at its discretion, may expand or limit as it deems necessary following the commencement of operation of such system. All such fees and fines shall be levied in a manner consistent with the requirements provided in Article III, Section 3 and Article X, Section 1 of the Association's By-Laws.

In levying fees and fines the Board of Directors may consider repeated previous violations of the same rule, regulation or such other, by a member as a factor in establishing a fee or fine within the range referenced herein below. Such

fees and fines will not relieve a party causing damage from the responsibility of paying for or otherwise repairing such damage. Members shall be responsible for the acts or omissions of their guests, lessees or invitees.

Fees and fines charged by Niguel Shores Community Association are broken down into five categories. These categories are as follows:

- 1. Administrative
- 2. Multi-Purpose Room Charges
- 3. Security
- 4. General Violations of Rules & Regulations
- 5. Architectural

## I. ADMINISTRATIVE FEE'S

#### II. MULTI-PURPOSE ROOM CHARGES

Fees and deposits may be required and rates are set as follows:

- A. Resident Groups: (\$50.00) Apply whenever more than 50% of the persons are Niguel Shores members or residents. The clean-up fee of \$50.00 is non-refundable.
- B. Non-Resident Groups: (\$200.00) Apply when less than 50% of the persons attending the event are Niguel Shores members or residents. Security/Damage Deposit \$100.00 refundable. Clean-up fee of \$100.00 is non-refundable.

Only checks will be accepted and they must accompany the Reservation Request Form. All fees and deposits will be refunded if the reservation request is denied. The Security/Damage deposit will be used only to defray damage caused by the event or extraordinary maintenance required.

## III. SECURITY DEPOSITS

Charges for security items are one-time only and are refundable deposits for gate cards and decals. Late fees are non-refundable. Deposits for security items are refunded upon the return of key card and decal (decal only if no key card issued) to the Community Association Office. This refund only applies to residents who have or were required to pay a deposit for these security items. A "Set" consists of one decal and one gate card or one decal by itself.

The following fees are charged for these security items:

- a. Homeowner residents North of Selva Road No charge for first two key cards. \$25.00 for each additional key card.
- b. Homeowner residents South of Selva Road No charge for first three gate cards. \$25.00 for each additional key card.
- c. Lessees \$25.00 per set (1 decal and 1 gate card or just 1 decal).
- d. Month-to-Month Renters \$25.00 per gate card. (No decal issued). Quarterly Guest Pass issued in lieu of decal.
- e. Non-resident homeowners whose property is leased or rented are entitled to two sets only at no charge. (Set consist of 1 decal and 1 gate card or just 1 decal.)
- f. Multi-owner residents will be issued two sets per lot. Any amount over this there will be a \$25.00 charge per set (1 decal and 1 gate card or just 1 decal).

# V. ARCHITECTURAL

The following Consulting Architect Fee Schedule has been approved by the Niguel Shores Community Association Board of Directors on the recommendations of the Architectural Review Committee. Date approved: February 26, 1980. Date Effective: February 26, 1980.

### CONSULTING ARCHITECT FEE SCHEDULE

The following fees are an estimate of the cost to be incurred by the Association for the services indicated. The amount billed to individual homeowners will be the actual cost to the Association. Individual estimates of cost can be obtained at the time the first set of documents are submitted. Payment of all fees and deposits is required at the time of application with plans.

- b. New Home Construction: (\$200.00 to \$350.00)

  - (2) Up to 2,500 square feet...... \$250.00
- c. Additions & Alterations...... \$25.00 to \$200.00
- d. Exception Hearing with a required architect in attendance.... \$50.00

### CONSTRUCTION DEPOSIT: (Definition)

A deposit refundable when construction and landscape is done in a workman like manner in accordance with the approved plans and cleanup has been completed.

#### CONSTRUCTION DEPOSIT - Fee Schedule:

a. Minor Addition or Remodel - Landscaping Hardscaping Included.

Up to 300 square feet -

\$200.00

b. Major Addition or Remodel.

Up to 1,500 square feet -

\$400.00

c. New Residence or Major Addition or Remodel.

Over 1,500 square feet -

\$600.00

The Board hopes that it will not be necessary to use extensively the fine system and that Members of the Association will communicate with each other with respect to alleged violations of the Rules and Regulations of the Association and the provisions of the "Procedure to Guarantee Due Process of Law to Members of Niguel Shores Community Association" governing the rights and obligations of all of the Members within Niguel Shores. If, however, such action is impossible or is ineffective to cure an alleged violation, such Member should prepare and submit to the Association Office, a written notice stating the nature of the complaint, the name and address of the party against whom the complaint is directed and the time and date of the alleged violation. The Board will process and dispose of all such complaints as they see fit, provided such processes and hearing procedures to review such complaints and levy fines are consistent with the provisions of the By-Laws, Declaration, as amended, and this Statement of Fees and Fines.
