

#### APRIL BOARD ACTIONS

- 1. Board authorized management to contact Lynn Muir, AIA and inform him that Board approved the cost of \$2500 to prepare presentation for a homeowner meeting to present the entry/exit gate refurbishment plans. The meeting will be scheduled for end of summer/early fall.
- 2. Accepted Resolution of the Board of Directors for the May 17, 1994 Annual Meeting. The Resolution directs either the President or Secretary to not vote the proxies given to the Board. The proxies will be used for quorum purposes only.
- 3. Accepted bid from Modern Tree Service to trim six eucalyptus trees and remove one at Niguel Shores Dr. at Leeward. Cost will be \$355.
- 4. Accepted bid from Modern Tree Service to remove two eucalyptus trees and trim two others in the upper beach parking lot. Cost is approximately \$270.
- 5. Accepted bid from South Coast Welding to construct twelve stainless steel gate warning sign boxes at a cost of \$3120. These will replace existing ones that continue to rust.
- 6. Authorized management to release payment to the Mark Company for repair of the sinkhole on Niguel Shores Dr., in front of the community center parking lot. Cost of the work was \$9700.
- 7. Accepted the 1993 Audit prepared by James L. Zimmerman, CPA. Directed management to have Audit copied and mailed to all owners of record prior to end of April.

- 8. Authorized management to purchase another personal computer for staff use. Cost not to exceed \$1495.
- 9. Authorized management to enter into a new lease to purchase agreement with Pitney Bowes for an updated postage machine.
- 10. Authorized payment of \$300 so that the General Manager could obtain certification from the California Association of Community Managers.
- 11. Authorized management to install mulch along the Garibaldi entry slope at an estimated cost of \$300. Request came from the Landscape Committee.
- 12. Authorized management to accept offer to settle outstanding assessments due the Association from a potential buyer of the property.
- 13. Authorized management to set up City Council Candidate night for Tuesday, May 10, 1994, at 7:30 pm.
- 14. Authorized management to issue payment of \$500 to Fireman's Fund Insurance for policy deductible. This will end Association involvement in February 1993 homeowner lawsuit.

### OUT-OF-AREA OWNERS: WEEKEND STAFF HAVE LIMITED ABILITY TO ASSIST YOU

Owners who do not live here full-time should contact the office staff, Monday through Friday, 9 am to 5 pm, to obtain answers to questions. This should be done <u>prior</u> to arriving on a weekend!

The clerks who work after hours and on weekends cannot change/update your records. Examples of transactions that they cannot help you with are: obtaining a new vehicle decal, issuance or exchange of gate key card, checking in a new owner/tenant, changing "No-Call" card at Mariner Gate, etc.

It is unfair for homeowners to take out their frustration on the after-hours/weekend staff because they cannot assist them. Staff is expected to follow guidelines established by the Board of Directors.

#### **VACATION HOME SECURITY CHECK**

At no cost to residents of the City of Dana Point, Police Services will provide vacation home checks while residents are out of town.

They will provide a physical check of a residence to insure no windows or doors have been left open, etc.

When residents require a vacation home check, they are to call the Laguna Niguel Sheriff Substation at 249-5200 and give the following information:

- \* Name, address, cross street, from what date to what date they require the service.
- \* Who to contact in case of an emergency (name, address, city, area plus telephone number and relationship) and whether this person has a key to the home.
- \* Any other information such as a gardener comes on what day of the week, any pets, name of anyone who will have access to the home during the resident's absence, any car left in the driveway (license, make, color), and any other information which will help secure the home.





# PATROL TO RENEW ENFORCEMENT OF COMMON AREA RULES

There are many rules that our Association must enforce. Two areas of great concern relate to parking and animals. These two types of violations comprise a large portion of the complaints received by the NSCA office staff.

The Traffic and Safety Committee has made several suggestions for more effective enforcement. As of May 9, our patrol will be taking a more active approach in resolving these two concerns:

<u>Dogs</u> - The patrol personnel will be approaching individuals on common areas that do not restrain their dogs with a leash or do not clean up after their animals. The patrol personnel will explain the rule being violated and advise that repeated violations will be referred to the Board of Directors and County Animal Control. Even though we are in a private community, the City Ordinances apply and must be followed.

Parking - The patrol personnel will be placing citations on vehicles parked so as to interfere with emergency vehicle passing. A fire lane is considered to be 26 feet wide. Areas within the community, such as, Atlantic Garden Homes, Shores Garden Homes, Sea Terrace I and II, Villas have narrow streets. Over the years, in these areas, residents and visitors have been parking in front of homes/garages rather than using designated common area parking bays. Unsafe parking has gotten to be a severe problem on some weekends and holidays. The Committee and Board of Directors are concerned that emergency vehicles may be impeded from reaching a home in an emergency.

It is hoped that residents and visitors will keep the seriousness of this issue in mind when parking. Repeat violators are subject to a hearing before the Board of Directors and possible fine. Vehicles repeatedly parked in violation of the rules will be placed on the automatic tow list. To obtain the vehicle that has been towed costs between \$85 to \$100.

Both the Board and Traffic and Safety Committee encourage residents to park their vehicles in their garage, on driveways that are long enough, or use the common area parking bays for vehicle parking. Residents who reside on a narrow street are asked not to park along the roadway so as to reduce the lane of passage to less than 26 feet. Residents are responsible to see that visitors also follow the rules. Visitors that repeatedly violate rules will also have their vehicles added to the automatic tow list.



#### <u>LIFEGUARD ON DUTY - MEMORIAL DAY</u> <u>WEEKEND</u>

A lifeguard will be on duty over the Memorial Day weekend and holiday, May 28, May 29 & 30, from 10 am to 12 noon and 1 pm to 7 pm.

All children between 6 and 14 years of age who wish to swim without adult supervision will be required to pass a swim test. A permission form must be filled out, signed by a parent and returned to the lifeguard <u>BEFORE</u> a swim test will be given.

As a reminder, adult swim is from 7 - 9 am and 12 - 1 pm every day. Also <u>NO ONE</u> under 18 years is allowed in, or in the area of, the jacuzzi.

#### **COMMUNITY CENTER RULES**

The summer season is here again and the community center will again be buzzing with activity. As a reminder, here are a few rules for using the community center:

#### **COMMUNITY CENTER**

All persons using the facilities MUST sign in. No pets allowed.

No bikes, skateboards, or skates allowed.

No glass containers.

Proof of membership or guest status may be required.

Guests using the facilities must be accompanied by a resident, or be registered at the office by the resident.

#### SWIMMING POOL

No one under 14 years of age allowed in pool area without parent or lifeguard supervision.

Adult swim only from 7 am to 9 am and 12 pm to 1 pm. No children in pool area during this time.

Shower before entering the pool.

Hair at or below shoulder length must be banded.

No food or gum in pool area.

No floating apparatus or objects of any kind are permitted in pool.

Swim suits must be worn in pool.

#### <u>JACUZZI</u>

No one under 18 years of age allowed in jacuzzi area. NO EXCEPTIONS.

Shower before entering jacuzzi.

No smoking in jacuzzi area.

No food or beverage in jacuzzi area.

#### **DOG OWNERS**

Leash your pet. Clean up the residue.

#### STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, June 6. You are requested to have your vehicles off the streets and parking bays. This will allow the sweeper to do a better job.

#### LANDSCAPE UPDATE

The largest project this year has been completed by Wendt Landscaping. At the end of Breakers Isle, the last large group of myoporums have been removed and the area has been replanted. Those who live in the area are asked to be patient for the next year while the new low-growing material fills in. For some color, Radiation Lantana has been added in several spots.

The Association received a great benefit from this project. The old myoporum was ground through a chipper and turned into mulch. We were able to obtain over twenty tons of high quality mulch to be spread throughout many areas within the Shores. Instead of paying high dump fees, Wendt Landscaping took about four days to cover many bare dirt areas, thus recycling the material.

#### Projects Planned in June:

Sea Terrace I - continue front yard refurbishment project on Capstan.

Sea Terrace II - on the south side of the lower Manta Court park, behind homes on Faeroe Bay, remove fescue grass and escallonia. Area to be replanted with honeysuckle and shrubs.

Along the Selva Rd. and La Cresta common area slopes, the existing escallonia will be removed. The area will be replanted with the same low growing myoporum shrubs and another shrub that has yet to be determined. This work is necessary because of the recommendation from our consulting engineer and geologist, after they reviewed the conditions that contributed to the slope slide last year.


