In the past in this column, in several ways, I have asked, "Do members and residents read this monthly newsletter?" At the April 17, General Session Board Meeting, it was obvious many of you do read this newsletter. Nearly every seat in the Multi Purpose Room was occupied. Many members there had read the last newsletter and wanted to talk to the Board about the renewal of life guard services, a designated lane for lap swimmers, Jacuzzi use and sanitation, swimming pool use and safety precautions, the remodeling of the Community Center bath/locker rooms, and skateboarding.

After discussion, twelve residents volunteered to form a committee to help in the selection of the new life guard service. The floating lap lane marker will be reinstalled.

As planned work on the bathrooms, including the shower rooms, will be completed before the Memorial Day Weekend. While this work is under way temporary lavatory facilities will be available at the ping pong table location. Also we plan to close the swimming pool for about one week while we resurface and seal the pool decking. When the pool is reopened, we hope to have some new furniture to place there.

At our meeting we discussed the use of our recreational facilities by intruders, the behavior and welfare of children whether or not accompanied by their parent or another responsible adult, vandalism, destruction of property and malicious mischief in and about the Community Center. I believe there was a consensus at the meeting that parents cannot avoid responsibility for their children and that they should not expect that the Association performs baby-sitting services. Unaccompanied children must know that they are expected to behave. It would be of great assistance if parents would just "drop by" to see and be seen by their children. Also there appeared to be agreement with the plan, on a trial basis, to assign a non-uniform employee with good interpersonal skills to generally oversee activities to assure the pleasure, safety and welfare of all residents and their guests while using Community Center.

There was wide interest expressed in the use of a key card system to control the use of the Community Center recreation facilities.

It was suggested that the lower parking lot at the bluff be reserved exclusively for residents.

The members discussed their views both for and against skateboarding in The Shores. We prohibit this activity everywhere in our community accept on cul-de-sacs less than 500 feet in length. Obviously even the most skillful skateboarders are no match for a motor vehicle,

nor should they be "highballing" down Niguel Shores Drive or other streets we intended for through passage of motor vehicle traffic. Waxing of curbs, destruction of landscaping by skateboarders in common areas and eased landscape areas and to their related irrigation systems are serious and expensive maintenance problems. The attention of parents to where and how their children are skateboarding would be of great assistance.

We have scheduled the Annual Board Meeting for May 21, 1996, at 8:00 p.m. At this meeting the principal agenda item is the election of new officers of the Board of Directors. We hope that all of you will attend. Whether or not you can attend, we ask that you complete your proxies and deposit them several days before the meeting at the Association office.

UPDATE WITH LOCKER ROOM RENOVATIONS

Major renovations to the locker rooms are underway. The contractor selected will be doing the following:

✓ The existing multiple entry doors will be eliminated. New single entrance doors will be installed with direct entry into the dressing rooms. The old entry areas will be turned into storage closets for the maintenance staff. On the outside on the new entry door locations, new slumpstone walls will be constructed to screen the entrances from the pool/spa areas.

✓ The tile on the floors, including the showers, will be removed and replaced. This work will also include the tile on the walls in the showers. The tile on the walls in the restrooms will be removed and replaced with FRP board.

✓ In the Mens Locker Room, the new arrangement will allow for one urinal and two toilets, along with new stall dividers. In the Womens Locker Room, the arrangement will allow for three toilets and new stall dividers. These areas will receive new lighting fixtures, hung from the ceilings.

✓ New fixtures such as sinks, mirrors, trash receptacles, will be installed.

As of the end of April, it appears that the work will not be completed by the Memorial Day holiday weekend. As soon as the project is substantially completed, the locker rooms will be opened.

Staff has made arrangements for the use of four portable units, located within the bicycle rack. This was the only area they could be placed and serviced by the company hired to supply the units. We ask that residents and guests treat the portable units as if they were using the bathroom in their homes. VERY IMPORTANT TO READ THE USE SIGN ON THE INSIDE BACK WALL OF THE UNIT BEFORE USING THE FACILITY FOR THE FIRST TIME!

OUT-OF-AREA OWNERS: WEEKEND STAFF HAS LIMITED ABILITY TO ASSIST YOU

Owners who do not live here full-time should contact the office staff, Monday through Friday, 9 am to 5 pm, to obtain answers to questions. This should be done prior to arriving on a weekend!

The clerks who work after hours and on weekends cannot change/update your records. Examples of transactions that they cannot help you with are: obtaining a new vehicle decal, issuance or exchange of gate key card, checking in a new owner/tenant, changing "No-Call" card at Mariner Gate, etc.

It is unfair for homeowners to take out their frustration on the after-hours/weekend staff because they cannot assist them. Staff is expected to follow guidelines established by the Board of Directors.

If you plan in advance, the full-time staff can advise you how to accomplish your task with minimum inconvenience to you. Your cooperation will be appreciated by all concerned. Phone (714) 493-0122.

ELECTION COMMITTEE NEEDED FOR ANNUAL MEETING

Any homeowner interested in serving on this Committee should contact Jeanette Federico in the office. The Committee will be in charge of verifying that proxies are signed by a legal homeowner, and if necessary, the counting of ballots for the election of the Directors.

VACATION HOME SECURITY CHECK

At no cost to residents of the City of Dana Point, Police Services will provide vacation home checks while residents are out of town.

They will provide a physical check of a residence to insure no windows or doors have been left open, etc.

When residents require a vacation home check, they are to call the Laguna Niguel Sheriff Substation at 249-5200 and give the following information:

- * Name, address, cross street, from what date to what date they require the service.
- * Who to contact in case of an emergency (name, address, city, area plus telephone number and relationship) and whether this person has a key to the home.
- * Any other information such as a gardener who comes on what day of the week, any pets, name of anyone who will have access to the home during the resident's absence, any car left in the driveway (license, make, color), and any other information which will help secure the home.

RESIDENT INFORMATION - CITY TO SUPPORT TRAFFIC LIGHT INSTALLATION @ MARINER AND NIGUEL RD.

Staff has been contacted by the City Traffic Engineering department and advised that they are in the process of reviewing whether the intersection @ Mariner Drive and Niguel Road will qualify for a traffic signal. There appears to be a good chance that it will.

Staff was not provided with any details as to when a hearing will be held before the City Traffic Commission. Residents interested in this matter should contact the City to inquire when the hearing is scheduled. In addition, no mention was made as to when the signal would be installed, if approved. Because of the high costs to obtain and install a traffic signal, it may be several years before the funding is available.

COMMUNITY CENTER RULES

The summer season is here again and the community center will again be buzzing with activity. As a reminder, here are a few rules for using the community center:

COMMUNITY CENTER

All persons using the facilities MUST sign in. No pets allowed.

No bikes, skateboards, or skates allowed.

No glass containers.

Proof of membership or guest status may be required.

Guests using the facilities must be accompanied by a resident, or be registered at the office by the resident.

SWIMMING POOL

No one under 14 years of age allowed in pool area without parent or lifeguard supervision.

Adult swim only from 7 am to 9 am and 12 pm to 1 pm. No children in pool area during this time.

Shower before entering the pool.

Hair at or below shoulder length must be banded.

No food or gum in pool area.

No floating apparatus or objects of any kind are permitted in pool.

Swim suits must be worn in pool.

JACUZZI

No one under 18 years of age allowed in jacuzzi area. NO EXCEPTIONS.

Shower before entering jacuzzi.

No smoking in jacuzzi area.

No food or beverage in jacuzzi area.

STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, May 6. You are requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.

LANDSCAPE COMMITTEE UPDATE

The following projects should begin in May:

Broadmoor - additional shrubs will be added to Currently, improvements to the slopes. Windlass, near Niguel Shores Dr. are planned.

Custom Homes - improvements to the corner of Shackleton Isle and Niguel Shores Dr. will occur. Currently, staff is seeking the cost for a landscape architect to consult with the Committee on this project.

Shores Garden Homes - add ten 15-gallon size trees on the upslope of Nauticus Isle, to screen the concrete v-ditch. It is the Committee's intent to use a tree type that will not exceed twenty feet in height.

Sea Terrace I - minor cleanup of the slope along Binnacle Dr.

Wendt Landscape will be fertilizing the shrubs and turf throughout the Association.

POOL/SPA AREAS TO BE CLOSED FOR **MAINTENANCE**

While the locker rooms are being renovated, the maintenance staff will be performing maintenance on the pool/spa decks. Staff has obtained the material to re-coat the decks. They will also be installing new anchors for the lap lane marker. However, the new anchors will be installed in the pool deck for greater strength. Staff has great concern for the anchors attached to the pool wall because many children hang on the lane line. It is possible that the anchors will be pulled out, damaging the plaster.

As of late April, staff anticipates closing the pool/spa areas from Monday, May 13 to Friday, May 17. It is our hope that all the work can be completed during the week so that the areas are available for the weekends. Look to the Community Center for posters providing the specific closing dates.

You should be contacted by a committee member for reservations, but if we miss you or you haven't attended before, call one of us.


