GENERAL MANAGERS REPORT

This July I will have been General Manager at Niguel Shores for seven years. Over that period of time I have made the following observations.

Niguel Shores is a "little city". It has a Board of Directors (city council), committees (city and county operational agencies) i.e., Architectural Control Committee (city building and safety), etc. It employs a manager and staff (city manager, etc.), a landscape contractor and maintenance crew (city facilities), security (police vehicle control functions) and so on. I trust you see the similarities.

Yet Niguel Shores is a community association of 960 units, established for the maintenance, operation and benefit good) of (common Unlike the majority of membership. community associations, Niquel Shores is a unique entity. Most associations are either single family units, condos, towhouses or garden homes. In such communities there is usually a theme of residency such as young adult singles, senior retired, young married with families, and so on. There are usually similarities in age group, income, time of life, activities and interests. This is not the case at Niguel Shores.

At Niguel Shores we have almost all the above types or themes of residency, vastly differing age groups, incomes interests. Unlike neighboring Monarch Bay, Three Arch Bay, and Emerald Bay, Niquel Shores has approximately 18% to 20% of ownership who either rent or lease their units yearly, monthly and even All of this adds another element to the community profile.

Such diversity makes the setting of policy by the Board of Directors and the management and operation of the community interesting, to say the least. It is difficult to set and maintain operational policies and guidelines which meet the majority's expectations and wishes of such a group. Add to this the element of a policy setting group, a Board of Directors, whose members change every two years, if not sooner, and a resulting change in policy or direction of operation and "the plot thickens."

As General Manager, it is my job to try maintain a business-like administration. coordinate activities of the Board, committees, contractors and staff participating in the many operational activities related to such operation. Like any city manager, I must be aware of the ever changing direction which comes about from the Board and committees and. applicable, adjust operating procedures and priorities. In all of this I must remember the individual member and how he or she fits into this operational plan.

It has been my objective, where possible, to maintain continuity of operation, improve procedures, be responsive to all avenues of input, keep level of services and community maintenance high while attempting to keep costs down, and to do so with the best interest of Niguel Shores as a standard.

When I go about my duties I see a neat, clean, attractive community; an active membership whose participation is a positive addition to the community operation; diverse interests and opinions; a give-and-take attitude by most residents, and a dedication by many members who year after year give of their time as Board members, committee members or volunteers, all for the good of the community -- Niguel Shores.



GUEST PARKING PERMITS

Summer is upon us!

As you know visitor permits issued to your regular visitors by the Mariner Gate security do not permit beach parking. Only vehicles displaying valid association owner or tenant decals on their windshields may park there.

As an excpetion, last year the Board of Directors added "Guest Parking Permits" to the community's rules and regulations. To obtain such a permit, residents (owners and tenants) must come to the Administrative Office during regular business hours, post a deposit of \$50 or \$75 and be issued a Parking Permit which maintained by the resident. The permit can be given by the resident to a guest vehicle identification authorization to park in the beach parking lot in conjunction with Visitor Day Permit or Special Entry Permit.

Residents are responsible to ensure the permit is used properly and that such guests obey Association rules and posted restrictions while in the community.

STEIN-BRIEF INFORMATIONAL MEETING



"LOCAL DEVELOPMENT PLANS"

COMMUNITY CENTER

JUNE 10, 1987, 8:00PM

STEIN-BREIF HAS A NEW IDEA AND THIS TIME IT LOOKS GOOD!

For more than a year hundreds of Niquel residents have been Laguna resisting the proposed new commercial center between the golf course and Safeway. South The Laguna Civic/Friends σf the Community coalition has attempted to reduce the size of the project and thus reduce the traffic impact at PCH and Crown Valley Many Niguel Shores residents have participated in the coalition during this time.

Recently David Stein approached community leaders with a new idea which truly answered community felt concerns and at the same dramatically improved upon previously approved plans for a 550room hotel on Niguel Road north of Stonehill Road. He proposes redesign that hotel, the commercial center, and the Monarch Bay Beach Club in a way which dramatically decreases the size of the shopping center while enlarging the hotel. The new plans are designed to reduce traffic on PCH and Crown Valley while spreading traffic inland onto Niguel Road, Del Avion, and Golden Lantern. The golf course becomes larger and the club house moves to the shopping center site. motel, office buildings, theaters and parking ramps are eliminated. Beach Club is included in a new tram system connecting all three elements which are redesigned in a low-rise Continental Spanish style features open space, lakes, waterfalls, and plantings throughout. The result appears to be a dramatic improvement in appearance and better for the entire community from a traffic standpoint. Those who saw the new design were impressed.

Traffic consultant Martin Wallen who represents South Laguna Civic/Friends of the Community will meet with Stein-Brief's traffic engineer within a few days to confirm the revised traffic impacts.

Niguel Shores residents should remember that a 550-room hotel Niguel Road has already been approved by the Board of Supervisors and the California Coastal Commission. Stein-Brief goes forward with this new plan, they will be required to seek approval from our community, the Board Supervisors, and the Coastal Commission for the new complex which include a greatly commercial center, an enlarged 850-room hotel, and an enlarged Beach Club. There appears to be more open space, superior design, better golf course, and improved traffic conditions. architecture is low-rise throughout, Continental Spanish in style, visually exciting because of the use of lakes, waterfalls, plantings, vistas.

Stein-Brief has requested an opportunity to show their new plans to Niguel Shores on June 10, 1987 at 8pm. The impact on Niquel Shores will be substantial. Our participation now will help everyone understand exactly is to be built in neighborhood, and why. Our main gate will lie between two major hotels in any event. So it is indeed important our future that we help developer understand our concerns and at the same time know precisely what he intends to do. We think his new plans are a big improvement. You be the judge. Come to a complete presentation of the new plans in our community center on June 10 at 8pm.

WHICH CITY DO YOU LIKE BEST LAGUNA NIGUEL OR DANA POINT?

Niguel Shores voters will soon have an opportunity to choose their favorite city since the Local Agency Formation Commission of Orange County has decided to hold a special Advisory Election. On November 3 we will vote either to become part of the proposed City of Laguna Niguel or the proposed City of Dana Point.

This Advisory Election will take place only in our coastal area which includes Monarch Bay/Emerald Ridge on the west, Regatta Homes/Niguel Terrace on the east, and a northern boundary not yet decided as we go to press. In any case LAFCO will use the results of the Advisory Election to decide on November 18 precisely where the boundaries of the two new cities will fall.

Dana Point and Laguna Niguel voters will then decide in April 1988 whether or not they wish to incorporate. Niguel Shores voters will already have chosen whether they wish to become part of coastal Dana Point/Capistrano Beach or coastal Laguna Niguel.

Since each of us has a right to decide for him or herself whether to vote in favor of Laguna Niguel or Dana Point, your Niguel Shores Board of Directors has decided not to take sides on the controversial cityhood issue. However, the Community Relations Committee and the Seashore News will do their best to keep you informed as each cityhood campaign develops next fall. Your ideas and comments are welcome.

Any Board member can perform as Chief Financial Officer, given the continued assistance of management and outside consultants.

Last year we exceeded budget for legal expenses by \$63,834. The 1987 legal budget is an unbelievable \$180,000. This is the primary reason for the assessment increase which we all agree must be kept within reason. I, and a majority of the Board, believe this is where we must concentrate our efforts.

Current Board member Joe Lewis and candidate Judge Smith are the best qualified candidates that this time to address the problem. Mr. Lewis has spent six months gaining insight on many legal matters facing NSCA. Judge Smith possesses judicial experience to give depth, understanding and peer guidance to the Board. I recommend your consideration in voting accordingly.

APPLAUSE TO LAFCO

All residents of Niguel Shores can heartily applaud the action of LAFCO, taken at its recent meeting, providing for a choice of cities by the voters of Niguel Shores and other nearby small communities, in an advisory election to be held November 3, 1987.

Until now all we had was a Russiantype election choice -- a "yes" or "no" vote on the incorporation of Laguna Niguel, with the government (Council and Task Force), backed by the heavy inland population supporting a "yes" vote.

Only with a groundswell of straw votes, directed to LAFCO by the voters in Niguel Shores and other nearby communities, did LAFCO provide an alternative, advisory choice -- between becoming a part of the City of Dana Point or part of the City of Laguna Niguel.

In providing for this alternative, advisory vote, LAFCO members, during the meeting, extracted statements from the Laguna Niguel Council members and the Task Force Chairman that they would go along with a choice between alternatives.

But, with one exception, the Laguna Niguel Council members and the Task Force Chairman advised strongly of their preference for only having a "yes" or "no" vote on the incorporation of Laguna Niguel. Had the Laguna Niguel Council members and the Task Force Chairman been given their way by LAFCO, they would have denied us the choice of alternatives, the right of self-determination.

As has been said before, "Democracy is the worst of governments except for all the others." And, democracy at work is truly wonderful!

INCORPORATION CHOICE

A proposal has been offered to the Agency Formation Commission (LAFCO) that the area west of Camino del Avion and Pacific Island Drive, and north and south from Emerald Ridge to Regatta Homes join with Dana Point and Capistrano Beach to form a coastal This is endorsed by Capistrano Beach and Dana Point and is recognized by LAFCO as a financially viable city proposal. Further, LAFCO agrees it would not upset Laguna Niquel's viability as a city.

The Commission resolved on May 6th, after two days of hearings, to clear this challenge by asking the Board of Supervisors to approve an "advisory" ballot at the next November election. The balloting will be limited to those precincts within the contested coastal area.

The advisory vote will be your choice between the coastal city or the city of Laguna Niguel. LAFCO will then have confirmation of the voice of the people and can formally establish the boundaries of the two city incorporation proposals.

The polling predicts that your choice of the coastal city will exceed 90%. We must recognize however that there will be a concerted effort by the Laguna Niguel Community Council to change this choice before November.
