An item which many of you have spoken to me about is the proposed conversion of the Sea Terrace Apartments to timeshare. As covered elsewhere in this edition, there will be a meeting scheduled at the Community Center where the developer's representatives will present what this conversion will entail. At this meeting there will be an opportunity for our residents to ask questions and express their opinions about such a project. This is certainly an important issue for consideration as these apartments are our immediate neighbor across Niguel Road from our main entrance.

Summer vacation for our young people is upon us, and I am sure they are looking forward to utilizing the community facilities and beach. We are fortunate to have such fine recreational amenities for both young and old.

There has been a feeling that there are a fair number of unauthorized people of all ages coming into the Shores and using our facilities. Various methods have been considered by the previous Board to curtail this problem.

The final resolution was to hire an individual who would monitor these areas to determine that only residents and their guests would have access. We were fortunate to find an individual who we believe will be able to handle this, Mr. Fred Thomas. As you are probably aware, we currently require that people sign in when entering the pool, tennis and recreation areas. Mr. Thomas will attempt to enforce this sign-in procedure and generally assist in preserving the facilities against misuse.

As many of you requested we are continuing the policy of having a lifeguard present at the pool during summer vacation. As always it is important that we all take responsibility in this area particularly with the young children.

### **BOARD ACTIONS FOR JUNE**

- ✓ The Board authorized staff to continue to schedule Recording Secretaries Associated to take the regular Board meeting minutes.
- ✓ Authorized staff to pay to Crown Valley Aquatics \$50 towards the Certificate of Insurance, naming NSCA as an additional insured on their policy.
- ✓ Authorized the full-time staff to have Friday, July 5, as a holiday.
- ✓ Authorized staff to reimburse a homeowner \$161.11 for sewer pipe cleaning because of tree The tree is within the front yard landscape easement area.
- ✓ Authorized staff to have Sutton Welding fabricate a new gate with heavier hinges for access to the Breakers Isle concrete drainage channel. Cost for the new gate will be \$800.
- ✓ Authorized staff to contract with Wendt Landscape Service for the monthly hosing of specific street areas to remove "green slime." This service will cost \$352 per month. This was the lower of three bids.
- ✓ Appointed Marjean Hanson to the Tree View Blockage Committee.
- Accepted a contract with Crown Valley Aquatics Services for pool lifeguarding services for this summer. Cost will be \$11.50 per hour worked.
- ✓ Accepted the yearly report, dated 4/25/96, from Converse Consultants for the visual survey of the Association's slope areas.

### NSCA RULES ON TREE BLOCKAGE

It is important that each Member of our Community understand what the rules are governing tree blockage. To clear up any misconceptions, the Landscape Committee wishes to offer the following clarification:

View blockage falls into two categories. The first is a view blockage emanating from Private Property. No member is permitted to obstruct the view of a neighboring property. Complaints regarding this type of view blockage are referred to Tree View Blockage Committee the investigation. If there is a violation, the Homeowner will be required to trim or remove the tree to restore the view.

The other category of view blockage comes from trees located on Easements or Common Areas. In addition to the blockage of view, a second consideration is added, that of the aesthetic value of the trees to the community as a whole. This type of complaint will involve the Management of the Association as well as the Tree View Blockage Committee.

Although no trees are required to be removed from easements or common areas, every effort will be made to trim, in some cases, remove a tree if it is consistent with the general landscaping plan of our community. The Board of Directors is the final authority in this regard.

An example of the foregoing is the effort by the Landscape Committee to survey existing Eucalyptus trees in our community. A plan is now being developed that will recommend the removal of some Eucalyptus trees and replacing them with trees of a lower profile.

We will appreciate your understanding and support of the View Blocking Rules.

### PROPOSED TIME SHARE PROJECT TO BE MARINER GATE PHONE NUMBER TO PRESENTED AT OPEN MEETING IN CHANGE **NIGUEL SHORES**

Plans for the controversial new time share project will be shown to our members on Thursday, August 1 at 7:30pm. Representatives of the property owners will make a formal presentation of their preliminary plans for conversion of the Sea Terrace Apartments (adjacent to Dana Niguel Library) to a time share project called Sea Pines at Monarch Bay.

As we all know, new Time Shares are now forbidden by the City of Dana Point and this proposal to change existing use of this property has generated a great deal of interest, both pro and con.

At the present time a preliminary proposal has been submitted to the City as required of all developments. Meanwhile, the owners requested an opportunity to present their ideas to members of the Niguel Shores Community Association so that the community participation process can begin. It is hoped that community concerns, issues and ideas will be heard.

We have been promised a factual presentation. So the Board of Directors, without taking any position on the merit or lack of merit of this project, has approved this special Open Meeting. We hope every interested resident of the Shores will attend and participate in the resulting discussion of the project on August 1 in the Community Center at 7:30pm.



### **LOSE SOMETHING?**

You might want to check at the Maintenance Department. We have two bikes just waiting for a description by their rightful owner. Items that are not claimed after three months will be given to Goodwill, because we do not have the storage space to keep these items indefinitely.

Each year the telephone number at the Mariner gate is changed. This is to ensure that only current residents have the number.

This year, the number will change on July 8. Official notice of the new number will be sent to all homeowners in the third quarter assessment billing. Tenants were sent the notice by mail on June 21.

### LANDSCAPE COMMITTEE UPDATE

Currently, Wendt Landscape Service is finishing the major slope work on Nauticus Isle. By the time this article comes out, Myoporum Pacificum and Radiation Lantana will have been planted on the first third of the Nauticus Isle upslope. It is hoped by the Committee that the remainder of the Nauticus Isle slope, including a section between Mercator and Nauticus, will be renovated in 1997.

When the above work is completed, Wendt Landscape will trim and thin all coral trees. As many of you know, this work is done twice per year.

During July, the following projects should be started:

Atlantic Garden Homes - Several front yards which have landscape easement areas will be renovated. This is part of a multi-year project.

Shores Garden Homes - Several front yards, which have landscape easement areas, will be renovated. This is part of a multi-year project.

There are several projects from the last several months that have not been completed. It is hoped that during July these will be completed.

The Committee has met with its consulting Landscape Architect, Dale Hadfield, to review his ideas for the corner of Shackleton Isle @ Niguel Shores Dr. The Committee is awaiting Dale's final drawing after providing its input. It is expected that Wendt Landscape will begin the work in July.

The Committee is begining its budget review process for 1997.

The speaker for our July 2 meeting will be Mike Short, a representative of Hewlett Packard. He will talk to us about the Internet.


On July 16 our speaker will be Peter P. Case, District Vice President of Merrill Lynch. His topic will be The County of Orange Bankruptcy.

This is a "Need to Know" memo:

There is a developer currently seeking a zone change for the Sea Terrace Apartments from commercial tourist-serving residential to (timeshares).

The apartments (located at Niguel Road and Mariner) are on 11 acres. The proposed timeshares would be 204 in number, sold 51 weeks or approximately 10,400 families changing places in one year.

This message is to inform you the Niguel Shores resident, so you can keep on top of this, and attend city council meetings when they get on the agenda, and to gather the board together to take a stand on our behalf on the proposed timeshares.

It is the impression of this writer that timeshares would be degrading to our otherwise residential community. It would mean commercial zoning on 11 prime acres, which in a number of years might be changed to a larger number of timeshares.

The way you can help is to sit on petition signing, walk and talk the neighborhood, help prepare mailings, or write your own letter to the planning department of Dana Point, and to the City Council.

But above all, keep your eyes and ears open. It is your neighborhood!! Most important to attend August 1 meeting.







### NOT GETTING SEASHORE NEWS ON TIME?

Don't's jump all over the Manager or office staff - they have nothing to do with its delivery!

The person who delivers your Seashore News is your neighbor - lives on your block. She/he gets the small bundle of papers from another volunteer who is one of nine people in our community of 960 homes who receive a whole shopping bag full of papers to be counted out and distributed to several different block deliverers like yours. These nine people get their bags of paper from yet another volunteer who, you guessed it, counts and bags the papers that have been collated and stapled, when they arrive from the printer, by more volunteers.

There are 65 volunteer members in the delivery system alone! And when one of them happens to be out of town on the day of delivery and their back-up person is either not informed or is also gone, you may get your paper late.

There can be many reasons the paper is not back from the printer on the same day each month. For instance: If the deadline for articles by the 19th falls on a Thursday or Friday, the typing of articles (done by office staff between all their other obligations) can be delayed two or three days; the meting time of the Communication Committee to proof read and edit and the typist to make corrections enter into the timing. Two more people need to make time to cut out and paste up everything to produce the final copy for the printer. Then if Sunday or a holiday happens about this time ...hope you get the picture.

### **5103** Swimming Pool Rules (06-05-96)

1. Pool Hours: 6:45 am - 8:45 pm Daily - Winter months

6:45 am - 9:45 pm Daily - Summer months (6/15-9/15)

- 2. Adult Only Swimming (18 years and older): 6:45 am 9:00 am & 12:00 pm 1 pm, daily.
- 3. All individuals using the facilities must comply with the rules and regulations, and requests made by the Community Center staff.
- 4. Showers are required before entering the pool/spa.
- 5. Hair that touches shoulders when wet, <u>MUST</u> be contained by rubber bands or bathing caps before entering pool.
- 6. Food, alcohol beverages and chewing gum are not allowed in pool or spa areas. No GLASS CONTAINERS of any kind are permitted in pool area or spa. Permitted beverages may be brought in metal, paper or plastic containers only.
- 7. Floating apparatus, toys, sticks, stones, or objects not part of the regular programmed pool equipment, are not allowed in the pool area.
- 8. Swim suits are required while using the pool. NO cut-offs or street clothing are permitted in the pool or spa.
- 9. Persons with colds, coughs, red or infected eyes, skin eruptions, open wounds or sores, or bandages, are not permitted in the pool/spa areas.
- 10. Non-swimmers or weak swimmers must remain in the shallow water, no deeper than armpit level. Lifeguards may request any user to take a safety test, and may restrict use of the pool.
- 11. No running, wrestling or horseplay on decks, ladders, or in locker rooms. No climbing on or diving from fences, or other structures(lifeguard stand) in pool area. No ball playing on pool deck areas.
- 12. Spitting, spouting of water or beverages, and nose blowing in the pool, are prohibited.

- 13. Emergency or exit signals of lifeguards or Community Center staff must be observed by individuals using the facilities. Swimmers must leave the pool area immediately at the request or signal of Community Center staff.
- 14. Lifeguards or Community Center staff may expel persons who are under the influence of alcohol or narcotics from the pool and/or spa areas.
- 15. Children Thirteen(13) years of age and under (under 14) MUST BE accompanied by an adult when using the pool when a lifeguard IS NOT on duty.
- 16. Children under SIX(6) must be under DIRECT ADULT SUPERVISION while in the pool and pool areas, at all times.
