
FROM THE HELM (CONTINUED)

The Board:

- Has voted to replace the unsatisfactory Shores Gate barricade with a different mechanism at no additional cost to the Association. Vote unanimous.
- Is looking into the replacement of the deteriorating Selva fence.
- Has received a report which indicates that there has been no movement of the Nauticus Slope during the past five months and is, therefore, planning repairs to the street and sidewalk.
- Authorized purchase of a postage meter at a cost of \$850. Vote unanimous.
- Is closer to taking action on the water seepage problem in the Windlass Drive area.
- Heard a report from legal counsel that the Sea Terrace II legal action against the Niguel Shores Community Association is continuing.
- Directed legal counsel to take appropriate action against certain homeowners who have refused or have failed to trim trees in accordance with the CC&R's and the Association regulations. The vote was 4 to 1, with Don Lutz casting the negative vote.
- Set Friday, August 21, 1981, at 8 p.m., as the alternative date and time for the Annual election. Vote unanimous.
- Appointed Ralph Bartolome as Election Judge for the Annual Election. Vote unanimous.
- Appointed Don Lutz as the Nominating Committee chairman for next year. Vote unanimous.
- Directed the Manager to utilize the Small Claims Court to collect money owed the Association. Vote unanimous.

MANAGER'S REPORT



Dear Residents:

The South Coast Water District Reclaimed Water Project is being reviewed by J. M. Montgomery, our Engineering Firm. They are doing a preliminary feasibility study as to potential use of such reclaimed water for landscaping purposes here in Niguel Shores.

The Water District office is also collecting information to be compiled into a position paper on the Shores and the communities connected with the impending water shortage in the Southern California area and the use of reclaimed water in its stead for landscaping purposes. The objective by the Board is to obtain as much factual and detailed information as is possible so that a presentation can be made at a later date to the general membership, informing them of the facts. The Board wishes to be sure that all members are fully aware of the potential water shortage and the viable alternatives. While the water shortage may be three to five years off, it may take that long to analyze the alternatives and to implement the programs decided upon to combat the problem.


Slopes/Water Seepage Conditions - As most of you know, most of the slope problems encountered last year have been repaired. In the case of the Nauticus slope, the work done there seems to have corrected the problem according to recent reports from Converse Ward Davis Dixon, our Geotechnical Consultants. The Board and the Staff continue, however, to research and consider the other community problems such as, water behind many curbs and some gutters that do not drain properly. Members who have these problems near or adjacent to their residences should be assured that efforts continue to rectify those problems, both for health, aesthetics and just good maintenance reasons.

Tree View Blockage - A sub-committee made up of members of the Architectural Committee continue to handle the tree view blockage complaints. These volunteers expend considerable time and effort in working with other members of the community in trying to provide reasonable views to its members who have view property. For the most part, members are cooperative. Needless to say, there are always a few who ignore such attempts and/or refuse to comply. The sub-committee is recommending certain names to the Board of Directors of those who fail to comply and is recommending that the Board take these matters to our legal counsel for enforcement. It seems a shame that this becomes necessary. If you've been contacted and have failed to comply with the committee's request, let me urge you to immediately commence the corrective work. When you have complied with the committee's request, please notify the office.

A WORD ABOUT "THE SHORES/AUTOMATIC GATES" From the Manager:

Considerable time and expense have been put into the modification of the Shores entrances. The new "barricade" type equipment has failed to meet the expectations of the security and gate committees, the Board of Directors and the staff. The maintenance of the Niguel Shores Community gates is done by a local firm whose owner is Bill Stevenson. Many of you know Bill and know that he provides considerably more attention to our gates than most any other outside contractors might. For instance, he makes a practice of checking our gates when he or one of his personnel is in route to and from other locations.

The equipment installed at the "Shores Entrance" was manufactured by Delta Scientific Corporation of Burbank, California. In mid-July, after having discussed the on-going problems and outages with the Board of Directors, I contacted Delta Scientific Corporation expressing the frustration and concerns of the membership and the staff.

I am pleased to say that Delta Scientific Corporation responded with an above average business attitude in this matter. The bottom line to the discussion is that Delta agreed to either (1) continue to honor the arranged contract and extend the warranty or, (2) at no expense to the Association, remove the existing equipment and replace it with other equipment which has proven to be operationally satisfactory over long periods of time, or, if none of the above was agreeable, (3) Delta was agreeable to removing all of the equipment and refund all of the monies received under the contract.

The Board of Directors, after careful consideration of the alternatives, elected to replace the existing "barricade" equipment with two Delta Model MTC 31 Motorized Traffic Controllers. Delta is also providing the full maintenance of the new equipment for six (6) months after installation. It is anticipated that the change in equipment will take only a couple of days once it is commenced. The changeover, however, will not take place until some time in the first ten days of August.

In the meantime, members should be assured that the staff and Board will continue to make every effort possible to see that the Shores gate installation is one which does not inconvenience members or staff any more than is absolutely necessary. Your understanding and patience are appreciated.



RECYCLING PROGRAM

The new system of recycling paper by bringing it to the Community Center recycling paper shed is working out very well. The first 40 days from May 28 brought in 38 tons, almost an average of a ton per day. This, of course, included a backlog of paper held in garages by our residents since the last house-to-house pickup of March 23. All in all, most of our supporters seem to prefer this new system of delivery at a single accumulation point, to the old system of "wait for the pickup and hope it doesn't rain after the papers were placed at the curb".

For the benefit of new residents and those not previously participating, the shed is open every day from 9 a.m. until the Community Center closes at night. Residents may deliver their accumulation of paper, consisting of newspaper, magazines, brochures, telephone books and junk mail any time during those hours. The recycler cannot accept carton material cut up, but will accept single cartons containing your paper. All paper must be contained in some way, either in the cartons, or in large grocery bags, or tied with cord. NO LOOSE PAPER PLEASE.

The aluminum program is continuing as before, except that we are arranging to deliver the cans to the recycler when our container is filled. Please flatten your beverage cans to help save space and enable us to collect a greater weight before delivery to the recycler.

Our most recent expenditure from the Community Recycling Funds was \$99.40 for two arm chairs which have been placed in the Community Center meeting room for the use of handicapped persons.

The sponsors of this recycling program are most appreciative of the support by our community, and again thank our residents for their enthusiastic participation. We are helping to preserve our natural resources, and at the same time are providing funds for many needed "extras" which can be enjoyed by all.



After watching all the matches, which I thoroughly enjoyed, I went running for the rule book to look up "foot-faulting" as it was rampant!!!! Here's what the USLTA has to say on that subject:

- Rule 25. Recent USLTA rule interpretations have indicated that the receiver or his partner is authorized to call foot-faults on the server. This call should be made only when the caller is absolutely certain. While in doubles the partner of the receiver may be in a fair position to call a normal footfault, in singles or in doubles the receiver himself would be able to make this call in flagrant cases.
- Rule 25.1 When you feel that your opponent, a net-rusher, is foot-faulting but his violations are not sufficiently flagrant for you to be sure and to call, the situation can be irritating. Compliance with the footfault rule is very much a function of a player's personal honor system. The plea that he only touches the line and doesn't rush the net is not acceptable. If he doesn't footfault when there is an umpire but does when there is no umpire, the time has come for him to examine his own sense of fair play to see if he is the type of person who will cheat provided he thinks he can go undetected or unpunished, and, if he is, to try to make a change. Footfaulting is just as surely cheating as is making a deliberate bad line call.

SWIMMING POOL RULES

HEY, ALL YOU LONGHAIRS!!

Pool Rule #12 provides that hair which touches the shoulders when wet must either be tied back or contained in a bathing cap while the individual is in the pool or pool area. Many swimmers are ignoring this rule, with the result that the pool drain and filtering system are clogged and need costly cleaning and repair.

Swimmers who violate Rule #12 will be instructed to leave the pool area until their hair is contained as required. Please bring a rubber band or bathing cap if hair is at the maximum length or longer. Rubber bands will not be provided at the Association office.


Jamboree Bound

Pepsi Cola/NBA Hotshot, a national recreation program for community youth organizations, now enters its sixth year. It is the largest program of its kind, involving more than 1,300 youth athletic groups and close to 2.5 million youngsters. It is open to boys and girls, ages 9-18. There are six categories of competition; three for boys and three for girls.

Hotshot is a form of athletic competition based on a one-minute display of basketball skills. Winners from local youth organizations participate in area playoff in 23 NBA cities. Area winners then go on to represent NBA teams in national competition.

Despite its competitive aspects, Hotshot is a game that every youngster can play and enjoy, no matter what his or her level of skill. Awards are given to all participants and at all levels of competition.

You have one minute to dribble from half court into the shooting range. Shoot from the hotspots in any sequence you prefer or shoot lay-ups. You will only receive scores for two lay-ups. All other shots must be made from any or all five hotspots marker on the court. If you choose to shoot from all five hotspots, you will get bonus points. One point is subtracted for each infraction, walking, palming, or double-dribbling.


