





9101 County Rules on Animal Control (02-01-85)

The Board of Directors does hereby adopt certain sections of the Orange County Health, Sanitation and Animal Regulations, summarized as follows:

Title 4, Division 1, Article 2, Sections 4-1-455, 4-1-48, 4-1-49, 4-1-50; Article 3, Section 4-1-60; Article 4, Sections 4-1-70, 4-1-71, 4-1-72:

9102 Disturbance by Animals (02-01-85)

No person shall keep any animal on his or her property which by sound or cry shall disturb the peace and comfort of his neighbors.

9103 Animal Restraints Required (02-01-85)

All dogs shall be restrained by a fence, wall, substantial chain or leash not exceeding six feet.

9104 Dogs and Common Areas (02-01-85)

No person having control, care or custody of a dog shall permit such dog to defecate upon any portion of the Common Areas or facilities of this Association. Should, however, defecation occur, all evidence of such shall immediately be removed by the person having control, care or custody of said dog.

9105 Rabies (02-01-85)

All dogs shall be vaccinated against rabies.

9106 Animal Trespass (02-01-85)

No person shall permit any animal under his control, care or custody to trespass upon any private property of another without the consent of such person.

9107 Dog License Required (02-01-85)

All dogs four months of age or older shall be licensed, such license to be renewed per County requirements. All dogs required to be licensed shall wear the current license tag.

9108 Permitted Animals (08-07-91)

No animals, fowl, livestock, insects or reptiles of any kind shall be raised, bred or boarded within Niguel Shores for commercial purposes. Dogs, cats and other household animals may be kept as pets unless, in the good faith judgment of the Board or a committee selected by the Board for this purpose, the dog(s), cat(s) or household pet(s) are determined to be a nuisance to other residents.

9109 Violations (02-01-85)

Violations of these rules and regulations may result in a fine, as set forth in the Penalties, Fines and Fees Rules and Regulations.

9201 Littering Prohibited (02-01-85)

Littering disposal of trash, grass, clippings or other debris on or around the common areas and facilities is prohibited.

9202 Trash Containers (02-01-85)

Trash and rubbish are to be placed in containers adequate to protect the contents from animals and the elements.

9203 Storage of Containers (02-01-85)

Trash containers shall be stored in such a manner that they cannot be seen from the street or other property.

9204 Placement for Collection (02-01-85)

Trash containers shall not be placed out earlier than the evening before nor left out longer than the evening of the scheduled pick up.
