Last month, I wrote, "...we should not mislead ourselves to think that we live in a guarded or security safe community." In conclusion, I said, we personally should exercise proper care for our homes and belongings. Last year I prepared a Wanted poster that we included in the September issue of The Seashore News (it is shown below, reduced in size). In your minds some may be asking, "Just what is he leading to?" The idea I am writing about now, I expressed at the end of the list of wanted persons: e.g., those who, "Understand that consistent with avoidance of imposed regulation, one must behave reasonably and counsel others to do so as well."

#### WANTED

Persons residing in Niguel Shores, who:

- Respect themselves and the rights of others;
- Appreciate the beauty, comfort, convenience and benefits of living in this lovely community;
- Accept responsibility to determine that their children's behavior is within acceptable norms;
- Park motor vehicles correctly, drive safely and courteously, don't exceed posted speed limits, and make a full stop at all STOP signs:
- Obtain Association approval to relandscape, repaint, reroof or remodel the exterior of their homes;
- Demonstrate behavior by following the rules of our community, instruct their children about these rules and apply reasonable supervision;
- Observe, report and prevent malicious mischief, graffiti, and other abuse or destruction of private or community property;
- Participate in Neighborhood Watch, the Association's Committees, and attend the Meetings of the Board of Directors;
- Understand that consistent with avoidance of imposed regulation, one must behave reasonably and counsel others to do so as well.

The question I ask now is, "Must we, and do we want to, establish a little police state?" Because a few residents drive unsafely at excessively high speeds, we have installed speed bumps. Some speeders ignore them, others partially avoid them by traveling in the gutter, or into the gutter and onto the sidewalk. We have been asked to install still more speed bumps and make them more severe, and extend them to the sidewalk. Then there is the vandalization of the grassy common areas caused by residents driving onto them to "leave their marks". To obstruct the free path for this maliciousness we have installed large boulders, that while apparently are somewhat effective are unsightly. Practically all of our streets are too narrow and unsafe for parking except in designated "guest" parking spaces. Still there are residents who do not park their vehicles in their garages and driveways. Some mindlessly leave their vehicles at the curb in blind spots over the crest of a hill or around a curve of a street, destined to be the targets for equally careless speeders. Some park in the curved end of culde-sacs, or place their cars opposite vehicles parked across the street, preventing the unobstructed passage of ambulances or fire fighting equipment. Space does not allow me to continue listing examples, I know by now the idea is clear.

It is residents and their children, family members, and other guests who are accountable for the vandalism, theft and destruction of property, disregard for rules, and discourtesy, if not belligerent and hateful behavior toward their neighbors and others that they encounter in our community. We should not excuse, ignore or accept such conduct, we must personally confront it. (continued next page)

We are not enemies and strangers, and should not treat each other as such, nor should we have to further disfigure and deface our community with unsightly barricades, barriers, speed bumps, red painted curbs with no parking signs, stop signs at every intersection, or have to employ a platoon of armed guards to supervise and regulate our behavior. It has been suggested the best rule is: There is no best rule. Is there any better practice than treating others as you would have them behave toward you?

# THREE EUCALYPTUS TREES NEAR MARLINSPIKE VANDALIZED BY UNKNOWN INDIVIDUAL(S)

Residents living in Sea Terrace I are asked to watch the area along Marlinspike, near Windward/Flying Jib for a chainsaw vandal cutting down Association owned trees. On three separate days, a vandal has cut down a tree. Management has filed a complaint with the Sheriff's Department.

Residents are asked to contact the Mariner Gate personnel if they notice anyone other than Wendt Landscape Service using a chainsaw or any other tools on common area, involving trees. Two of the three incidents occurred on a weekend when Wendt Landscape does not normally work. If available, the Patrol will be sent to investigate.

It is very important to obtain a description of the individual and a license number of vehicle he may be using. Once received by the office, the Sheriff's investigator assigned will be notified.

#### **AUGUST BOARD ACTIONS**

- 1. Pending additional information on the Womens Club request, the Board will allow the hanging of two paintings in the Community Center MPR.
- 2. Residents asking staff to post charitable notices will be limited to a 3x5 card in the Community Center display case. Staff is not to hang notices in any windows of the Community Center.
- 3. At the suggestion of the Maintenance Committee, authorized staff to purchase two metal trash containers and to donate them to the County for use at the bottom of the beach ramp.
- 4. Authorized staff to hire a new after school Recreation Director for two hours each weekday, from mid-September to mid-December.
- 5. Accepted resignation submitted from Dick Luedeke as Chairperson of Recreation, and appointed Marian Pearl as the new Chairperson.
- 6. Accepted bid from Dale Hadfield, ASLA, to advise Board on issues involving Breakers Isle slope. Cost not to exceed \$4260.
- 7. Denied request for reimbursement for tire damage involving the Selva gate.
- 8. Authorized management to purchase new laser printer for office.

#### MAIL BOXES - NO NO NO

However convenient it may be to have your Seashore News delivered to your mail box, it is against Federal Postal Law to use a mail box for any other purpose than mail. Your deliverers have been instructed not to do this and they have all been sent reminders about it with this issue of the Seashore News. House/garage slots may be used, otherwise look under your garage door or some other inconspicuous spot.

#### HOMEOWNER ARCHITECTURAL SUBMITTAL NOTIFICATION BY STAFF

Most homeowners are aware that they must submit specific paperwork and plans for the Architectural Committee to review so that their exterior changes are approved. Committee either approves or disapproves the project, the office staff issues notification to the homeowner.

In the past, homeowners have been able to call the office on the day following the Committee's meeting date to inquire as to whether the plan was approved. Homeowners should be aware that this is no longer possible.

The office staff does not receive the material from the Architectural Committee until the week following the Committee's meeting. Staff will greatly appreciate homeowners not calling the office for at least five days following the scheduled meeting. Having to take many phone calls right after the Committee's meeting is slowing down the office work process. And it does not help when staff has to inform homeowners, continually, that the material has not been received.

Once the Committee material is received, staff begins processing letters of notification to homeowners. Usually, by the end of the week, the letters are signed and in the mail.

#### RESIDENTS/HOMEOWNERS ARE ADVISED GARAGE FOR PARKING **VEHICLES, NOT STORING POSSESSIONS**

It has become evident through observation of open garages that many residents/homeowners are using their garage for storing possessions, not their vehicles. It is the Board of Directors' position that every resident/homeowner is to use their garage and driveway for parking of vehicles. Rule 6405 states:

> Visitor parking spaces in the common areas shall not be used for overnight parking of resident/homeowner vehicles except when the number of vehicles owned by a resident/homeowner and properly registered...is such that no additional vehicles could be parked in the resident's garage or driveway...then such vehicles may be parked in visitor parking spaces or on the street.

The Board has directed management to see that the patrol service begin citing vehicles with decals using common area parking or street spaces for overnight parking. Those found to be in violation will be issued a warning letter and after a second violation a hearing letter will be The Board will then determine at the hearing whether a fine should be issued that will range from \$25 to \$50. A third violation may result in a fine between \$25 to \$100.

For those that have more than two vehicles, you should begin to clean out your garage or see that all vehicles can park on your driveway.

Your cooperation will be appreciated by the Board and your neighbors.

### A NOTE FROM DICK WENDT, OWNER OF WENDT LANDSCAPE SERVICE

What is a weed? A weed is a plant, sometimes a "domestic" desirable plant, but one that is growing in the wrong location. Creeping Red Fescue grass in the right location provides a meadow like landscape that is very beautiful. Brazilian pepper trees properly laced out are a welcome addition to almost any landscape. Both of these plants have a strong survival instinct and when established in the wrong location are difficult to control.

Two of our biggest problems in Niguel Shores are Creeping Red Fescue and Brazilian Peppers growing wildly on our slopes. The Fescue was originally seeded on many of the slopes by the developer. As the Association became more concerned with water usage (Creeping Red Fescue is a grass, so it has relatively shallow roots and is very thirsty) it came into disfavor as a ground cover. It continues to grow up through our ivy, gazanias and other low growing ground cover. The Brazilian Pepper spreads easily by seed and sprouts from roots of existing nearby trees. It soon takes over if not controlled.

Unfortunately, our only control for these "weeds" is to use a systemic herbicide that is not selective. And it is important that the herbicide is absorbed completely by the plant to kill all existing root systems. If the dying plant is removed too soon, the remaining root system will produce new growth and the cycle will begin again. This is the reason for the many unsightly brown, dying weeds and ground covers you may see on some of our slopes.

Your patience is appreciated while our crews are in the process of removing these unsightly areas.

#### MARINER GATE DECAL LANE IS ONLY FOR THOSE WITH **HOMEOWNER/RESIDENT DECALS**

It has been noticed by the Mariner gate personnel and management that visitors with guest passes or special entry permits are using the residents decal lane for entry. Please advise your guests that they cannot use this lane for entry.

The sentry must look at the guest pass or special entry permit to verify whether it is valid. Some guests and homeowners have complained to the office that they or their guests should not have to wait at the gate if they already have a However, they are not homeowners/ residents and must go through the guest lane. It is impossible for the sentry to read the pass from eight to ten feet away.

Homeowners/residents are asked to cooperate and advise their visitors of this policy.

#### CATS WITHIN COMMUNITY MAY BE AT RISK FOR FELINE AIDS

Management was contacted by the President of the Dana Light Homeowners Association the middle of August. Their President stated that a stray male cat was examined by a veterinarian and was diagnosed with feline aids. The cat had to be destroyed.

The cat was seen going between Niguel Shores and Dana Light from Marlinspike Dr. Cat owners who live in this area and allow their cats out of their yard may want to contact a veterinarian to have their cat examined. If the disease is caught early, it can be treated.

Management was informed that cats cannot transmit feline aids to humans.

#### TENNIS COURTS TO BE CLOSED FOR RESURFACING, STARTING SEPTEMBER 6

The playing surfaces are such that the Maintenance Committee recommended to the Board that it is time to resurface the courts. The Board accepted the recommendation and put the work out to bid. A company called Court Concepts will be doing the work.

THE COURTS WILL BE CLOSED, STARTING WEDNESDAY, SEPTEMBER 6. It is expected that the work will take three to four weeks. Staff will post a sign with the expected re-opening date at the Community Center prior to the courts being available.
