FROM THE HELM

September was a busy month for your Board of Directors. You should soon notice some of the projects, recommended by the appropriate committee and staff, and approved by the Board.

- 1. The courts have been scheduled for resurfacing take note of the dates of closure on the calendar and notices that will be posted in the Community.
- 2. The walkways in the greenbelt areas will be patched and slurry sealed.
- 3. The parking lot at the Community Center will be slurried and restriped.

 The Community pool is cleaner due to the purchase of a portable vacuum pump.
- 5. The drainage project on the Breakers Isle slope should soon be completed.
- 6. The coach lights at the Community Center and the parking lot are to be converted to high sodium lighting.

This is a test project to determine the cost saving that can be effected by a change to a lower energy lighting system. Since these lights are on a single meter, the actual savings can be determined before consideration is given to converting the Community's whole lighting system. Preliminary estimates indicate that the savings could be as much as \$15,000 - if the entire Community coach lights are converted in the next year.

- 7. The annual tree trimming is commencing in the Sea Terrace II and Villas areas.
- 8. The new ingress gates at the Manta and Garibaldi entrances are installed.
- 9. A fine was assessed for violation of the CC&R's in regard to parking regulations.
- 10. In conjunction with the recent discovery of a gas leak at the Community Center, our bookkeeper's further discussions with Southern California Gas Co. has resulted in our receiving a \$9,000 adjustment (credit) on our bill.

September was also the month that all Committees, Directors, and staff started to hold meetings, gather figures and make recommendations so that the Finance Committee can prepare the 1983 NSCA Budget. Every consideration has been given keeping the costs down in the way that all believe is best for the Community.

Together

As our growing season comes to an end, we prepare for our major tree trimming to begin. It has become a policy adopted by the Landscape/Maintenance Committee some time ago, that regular tree trimming be limited to one time per year. If views become severly impaired before the next annual trimming, the offending tree should be considered for removal. There are a few exceptions where the Committee has felt that the importance of the offending tree is such that a second trimming to restore a reasonable view has been authorized. In other cases, especially Coral trees, two trimmings per year are often necessary for the health and safety of the tree.

In all cases, the Architectural Committee determines the "reasonableness" of the view, and a determination is then made as to whether more trimming or removal is authorized.

In a few cases, where the Committee and/or the Board has determined that no view is guaranteed, some homeowners have taken matters into their own hands and severe damage has been done to trees and surrounding landscaping. I have been assured by management that these matters have not, and will not, be taken lightly. Police reports are being made and where possible investigations will begin and hopefully arrests made. The Board has stated that a "reward" is offered for information leading to successful prosecution.

Let's try and work together through our Board and its Committees to solve these problems in the community's best interest.



SECURITY COMMITTEE



Your Security Committee has been exploring the possibility of establishing a central monitoring system in our gate house that would be the terminal for any home security system now installed or to be installed in any of our homes in Niguel Shores.

From our studies to-date, it has been determined that this is entirely feasible and would result in a lower cost per month for those subscribing to such a system and would also increase the security by providing a faster reaction ime in response to alarms. In other words, the fire department, police department or medical response would be as fast as it is now, plus the dispatch of our own security patrol.

Those who wish could continue their present service if they so desired; however, it appears that most would want to take advantage of such a service if it can be provided. The cost would be borne by those using the service and nothing would be taken out of existing funds.







This person had a massive heart attack and rapidly became unconscious. Bernie, being exceedingly alert, recognized the life or death situation, an actual cardiac arrest, and immediately commenced C.P.R. procedures. This continued uninterrupted for 15 minutes at which time the victim regained consciousness thereby avoiding death and at the very least, serious brain damage. Shortly thereafter, the para-medics arrived and completed the therapy and took the person to the hospital. Congratulations to Bernie and this certainly points out the importance to all of taking the course in Cardiac Pulmonary Resuscitation offered by many public agencies.

Bernie received a very warm letter from the wife of the patient, thanking him profusely for saving her husband's life.





Some changes in our procedures were adopted by a majority vote at our tennis session on 9/8/82. The new rules are as follows:

With less than 16 players present but an uneven number, those drawing "Alternate" slips will either sit out first round (1 extra player) or play singles (2 extra players) or play Australian (3 extra players).

To be eligible to draw numbers you must be willing to play at least 3 rounds of tennis or stay until 11 a.m., whichever comes first.

Courts 1 and 2 are reserved until noon for those wishing to continue.






