Most of the expenses of the Association are paid from regular annual assessments. Most of operating and other expenses for 1995, i.e., 94% (\$1,574,400) is derived from a \$1,640 annual assessment on each property, which may be paid at \$410 quarterly. Approximately seven days before the date that payment of the assessments is due, each property owner is mailed a quarterly assessment statement. For the convenience of members, there is a 30-day grace period from the date payment is due in which the envelope, containing the check for payment, must be postmarked. Any payment envelope not postmarked by the 30th day of the grace period is noted, and the payment is considered delinquent and is subject to a late charge of 10% plus interest at 10% per annum. Assessment payments are due and payable as follows:

January 1 (delinquent January 31)
April 1 (delinquent May 1)
July 1 (delinquent July 31)
October 1 (delinquent October 31)

Undoubtedly, there were many reasons why each of us selected our homes, second residences, or investment properties in The Shores. The most frequently stated reasons include our lovely location or climate, and the assurance, convenience and benefits of living within this gated homeowner managed community. Many other reasons are mentioned are the beauty of our locale with its many cultural, athletic and other amenities, recreational opportunities immediately available at our Community

Center, elsewhere on our grounds, or within a short distance in the surrounding area. While Niguel Shores was developed more than two decades ago, it clearly shows that it has been given continuous necessary maintenance attention.

For example, full landscaping services for all common areas and all slopes or areas for which the Association has easements for maintenance purposes. Recently our swimming pool equipment, lighting and deck furniture were extensively upgraded, and the multi-purpose room and kitchen were redecorated.

Soon the Community Center buildings will be re-roofed and re-painted. The tennis courts are now being extensively repaired and resurfaced. As an ongoing project, the coach lights are being rebuilt for all of the Bays in the Garden Homes Tracts. The streets within The Shores. before long, will be re-surfaced. Of course, as I wrote about recently, we will systematically be reworking the entrances for each area within The Shores to make them operationally safe, convenient and attractive. These projects are needed and are significant to maintain the attractiveness of The Shores and, by so doing, to large measure, supporting and improving the value of our properties. There are still many other tasks that must also be done, but their time will come. We obviously cannot afford to do all of the things that we would like to all at once. We must try to stay within our budget each year.

# ALL HOMEOWNERS HAVE RESPONSIBILITY TO REMOVE WEEDS IN THEIR DRIVEWAYS!

Most homeowners are aware that they have the responsibility to remove weeds growing within their front yard and driveway. However, there seems to be some confusion for the homeowners in Sea Terrace I, Sea Terrace II, Atlantic Garden Homes and Shores Garden Homes.

The above areas of the community have some "shared" responsibility with the Association through landscape easements contained in the Supplemental CC&Rs. The Association, through its landscape contractor, will maintain all areas eased to it with shrub/tree care and irrigation repairs. In ALL cases, the Association does not have the responsibility to remove weeds within driveways.

Homeowners within these areas are asked to review their properties and take action before the Board has to start issuing hearing letters for the purpose of issuing fines.

# FINAL PROJECTS FOR LANDSCAPE UPGRADES TO BE COMPLETED

During October, the following projects will be completed. This work will finish out the 1995 Landscape Committee upgrade budget:

<u>Custom Homes</u> - The first two concrete downdrains on Breakers Isle will have wire mesh installed and Grewia vines planted. The vines will be trained to cover the wire mesh, thus hiding the unattractive look of the concrete.

On the Breakers Isle downslope, Myoporium will be planted in several bare areas, after old and dead shrubs are removed. This is the first year of a three year project.

Atlantic Garden Homes - The Committee has proposed planting eighteen(18) 15 gallon size stone pine trees along Atlantic Dr., mostly along the west side. This project is to be reviewed by the Board of Directors in October, and if approved, will be done before the end of the month.

Sea Terrace I - a shrub bed will be created along the fence at 33462 Spinnaker, to match plantings done last year, across the street.

The Crossjack and Sextant upslopes to be reviewed again for additional improvements.

Sea Terrace II - a shrub bed will be created along the fence behind six homes on Gourami Bay, within the Gourami park.

<u>Villas</u> - ten(10) 15 gallon New Zealand Christmas trees will be planted along Via del Cielo, between existing Evergreen Pear trees. These new trees will eventually replace the Pears.

Wendt Landscape will be doing regular maintenance such as fertilizing the shrubs/ground covers. The lawns will be fertilized in late November after most are dethatched.

The Steak Dinner climaxed the day, hosted and served by the Mens Club; meals were served to an appreciative group.



# STATUS OF TENNIS COURT RESURFACING

The contractor working on the resurfacing project could not finish the work by the end of September as originally planned. After previous surfaces were removed, it became very apparent that the original concrete on all four courts was laid down improperly. Because of this, the concrete is beginning to loose adhesion in several locations.

The contractor has had to do extensive patching that was not originally planned for. The courts will also receive a second coat of acrylic resurfacer that contains sand. The court colors will change back to dark green for inbounds and California red for out of bounds. The lines will be white.

As of 9/23, it is expected that the courts will reopen the week of October 9. Staff will put up a poster at the Community Center approximately one week in advance of a specific date the courts will open.
