FROM THE HELM

Autumn is probably the busiest time of the year in the business of managing our Association. It's the time when we prepare and approve the budget for the following year.

In early August the various committees start the process. They estimate how much it will cost to do what they'd like to see done in the upcoming dar year. And during August, September and October, each committee meets with the Finance Committee to explain their requests. In each case the Finance Committee may modify a committee's request as the total budget is put together.

Then, in late October, the Finance Committee agrees on their recommendations of the entire budget for the year and presents it to the Association Board. We set aside an entire day to go through the budget proposal, line by line, to be sure we know what we're spending money for and where it's coming from. As in any business - or amily for that matter - hard decisions must be nade. We can't always do the things we'd like to

This year's budget decisions are going to be especially difficult. Our community is 25 years old. Things are beginning to wear out and need epair or total replacement. We've been putting noney into our reserve accounts for the repair and eplacement of every bit of the community, but we nust be sure we spend it wisely. Each year, for the ast 75 years, previous boards have approved a of our reserves and allocated a portion of

our income to those reserves. By law, the Finance Committee and the Board must have help from a professional consultant at least once every three years to be sure the reserves are adequate, but none of this planning and saving makes the decisions easier. Not everybody will get everything they want. In early November, every homeowner in Niguel Shores will see the results of all this work. We'll mail a copy of the 1998 budget to each homeowner. Please take the time to look it over and ask us - the members of the Board - if you have questions.

The whole budget process is the best example there is of the time and talent and experience that is given by volunteers to make this community a good place to live.

BOARD ACTIONS FOR SEPTEMBER

- ✓ Accepted proposal from the Collings Group for a risk assessment and insurance consulting service. This company will review the current insurance policies to see if all of the Association's major liabilities are covered and make recommendations for necessary changes. Cost for the work not to exceed \$1,950.
- ✓ Accepted proposal from EQE International [structural engineers] to perform visual observation of the bridge and provide the Association their professional opinion on the remaining life of the bridge, cost to replace, etc. Cost for the study not to exceed \$3,000.

✓ Authorized staff to waive \$25 lost vehicle decal fee, as requested by homeowner, for cause.

✓ After reviewing two bids, accepted the bid of \$3,156 from Saddleback Ornamental Iron to replace the Community Center entrance gate.

✓ Adopted a policy for current and future Board members to review and sign a "Conflict of Interest" statement.

✓ Authorized the cost to have an architect draft proposed changes to the women's locker room.

- ✓ Authorized the Tai Chi instructor to use the MPR on Saturdays, from September 13 to November 1.
- ✓ Authorized the children's tennis instructor to use one tennis court for lessons.
- ✓ Accepted Marjean Hanson's resignation from the Tree View Blockage Committee and appointed Colby Thompson to the Committee.
- ✓ Appointed Doris Adams and Barbara Crist to the Communication Committee.
- ✓ Appointed Keith Carlson and Susan Buckler to the *ad hoc* Vandalism Committee.
- ✓ Authorized staff to install a concrete pad and move one pool area table, chairs and umbrella to it. The pad will be located on the grass greenbelt between the office and tennis courts.
- ✓ Authorized staff to have Pacific Utility Audits conduct another review of all utility bills to verify NSCA is being properly billed.

✓ Authorized staff to waive the late charge and interest charged to a new homeowner because of an error made by their escrow company.

✓ Authorized staff to refund a \$25 fee charged to a homeowner for lost vehicle decal. Homeowner showed the Board acceptable circumstances to waive fee.

✓ Denied the requests for reimbursements from two individuals that were towed from the community for vehicle parking violations.

✓ Authorized staff to have Penhall cut new, and deepen existing, 2"x 2" channels in concrete drain swales. Cost for the work will be \$3,090.

✓ Accepted the costs for the new Board meeting recording secretary, Sharon Brimer.

✓ Accepted bid from Pacific Sign to create four warning signs to be attached to the Manta & Garibaldi gates. Cost for the signs will be \$173.52.



TIME FOR ASSOCIATION TREES TO BE TRIMMED

Fall is here and under our contract with Wendt

Landscape Service, it is time to trim trees. All trees approximately 20 feet in height or less will be trimmed. These trees must be in common area or within a landscape easement area, as outlined in the Supplemental CC&R's. This trimming project will also include the large Coral trees throughout the community.

A small crew will begin the trimming in mid-October. By early November, additional personnel will be added to the tree trimming crew. It is expected that all tree trimming will be completed by the end of November to early December

STREET SWEEPING SCHEDULE

The schedule date for street sweeping this month is Monday, October 6.

You are requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.

LANDSCAPE COMMITTEE

The last major project for 1997 is about to be completed. Residents on Crossjack should see new turf by the middle of October. Both the Landscape Committee and Wendt Landscape would like to thank the residents on Crossjack for their patience. It appears both the Landscape Committee and Board liked how the new concrete mow strips came out. In future years, as the turf is renovated in Sea Terrace I, the curbs will be part of the project.

The Landscape Committee will be looking at the costs for this project during their October meeting to see if the Sea Terrace II Extraordinary Assessment should include funding to start turf renovation. Staff will be sending a letter to the Sea Terrace II Board to seek their input as to whether the funding should include funds to install the same concrete mow curbs.

The Landscape Committee has spent time with Landscape Architect, Dale Hadfield, to develop a new planting plan for Pacific Coast Highway, tween Niguel Rd. and Selva Rd. The slopes on

It sides of PCH are owned by the Association. The Committee accepted the plan developed and will start implementing it in 1998. The Committee will work on a section of the slopes each year until both sides are renovated. The plan is specific to Niguel Shores, using landscape materials already used within the community. However, the same trees planted in downtown Dana Point, Tipuana Tipus, will be used at the toe of the slope.

TRAFFIC & SAFETY COMMITTEE

- 1. The vehicle counter was installed at the Mariner gate over the Labor Day weekend. The total count for a 72 hour period was in excess of 6,000 vehicles. This will assist the Committee in the design of the new Mariner gates. Other entries will also be monitored.
- 2. The Committee is still looking for a time/date stamp machine that will imprint the information in larger type.
- 3. A Yellow Decal Policy has been implemented and cars will be towed unless on private property. Residents have been urged to make sure they have the new decal.
- 4. The Committee is reviewing plans for the new Mariner gate and will have their suggestions in by October 10.
- 5. The Committee gave Securtec the right to enforce all rules regarding bicycles, skateboards and roller skaters. *Ad hoc* Committee will review the rules.
- 6. It is recommended that NO TRESPASSING signs be put on the chain link fence on the bluff.
- 7. The rules regarding party guest lists will be reviewed because the ones in place are not working.
- 8. Individuals who are not residents and who are using the community facilities must have a valid guest pass. Sponsors should obtain one for these persons.

ASSESSMENT COLLECTION POLICY ATTACHED AS PART OF THIS SEASHORE NEWS

You will find attached a revised Rule 2301 which has been updated to be in compliance with current California Civil Code, effective 1/1/97. Please place this Rule with your copy of the community rules. This Rule replaces those in your copy listed as 2301 and 2306.

There are increases in the costs to homeowners if their delinquency progresses as outlined. These costs are the result of added steps required by the Civil Code changes. To comply with the requirements, the Board has had to authorize their attorney's office to become more involved in the process and their costs must be passed along to those that are delinquent.

The added costs can be avoided provided payment of the assessment is made within the 30-day grace period. As a reminder, all homeowners MUST pay the assessment when due and cannot use the excuse they did not receive an assessment billing notice. Under the law, assessment notices are considered only reminder notices.



A CALL FOR COURAGE

This community is no different from any other where crime exists because most residents are so paralyzed by fear of reprisal or litigation that they lack the courage and conscience to confront vandals and trespassers who violate our space.

Security Patrols, Deputy Sheriffs, and cellular phones are rarely available when needed, leaving us vulnerable and frustrated. Some time ago during an early morning stroll along our beach, I was accosted by a wild-eyed, mop-haired wretch who removed his clothes and strode towards me buff-naked and leering. I froze in terror for what seemed to be an eternity when suddenly Pat Long came upon the scene.

At the time, Pat was chairman of the Traffic & Safety Committee. A senior citizen, short of stature, he was, however, long on courage. In a stern voice, honed by years in law-enforcement, Pat commanded the lout to put on his pants and leave the area. It took the bully exactly one minute to scamper away in cowed compliance.

The lesson to be learned is that no amount of fences, gates, signs, keycards or absent patrols can match a single act of individual courage at the scene. We need more Pat Longs with the guts to accept personal responsibility and the conscience to take decisive action.

ASPHALT STREET PATCHING TO OCCUR IN OCTOBER

The Association has contracted with Anchor Paving to make over 5,200 square feet of asphalt repairs within the main portion of the community. The areas will be addressed which have heavy traffic. The contractor will come in and remove the damaged areas, then fill in with asphalt and roll. They will wait approximately two weeks to allow for settling, then install a cap using a fine asphalt and roll. The cap will bring the repaired areas up to the

surrounding asphalt.

This work does not address all the problems within the community. These repairs should allow the community to get through an expected severe winter. As of this time, the Board will consider re-paving all the streets within the Atlantic Garden Homes during the spring of 1998. The Board and staff are working on a proposed schedule for the remainder of the community that may span the next eight to ten years. Funding this work will also be closely looked at and planned.

MENS CLUB

GARIBALDI/MANTA GATES TO RECEIVE NEW CLOSING TIMING

Those residents using the Garibaldi and Manta gates have seen new signs mounted on the entry gates. Our gate contractor, California Gates, will be changing the timing on the entry gates so that they will start the closing process quicker. Under the new timing plan discussed with and approved by the Board, once the gates begin the closing process, they will not reopen if another vehicle tries to tailgate in behind the authorized vehicle. The gates will continue to close and will damage the second vehicle. If we can find the owner of a vehicle that damages a gate, the Association will pursue them for all costs of repairs and painting.

SEA TERRACE RESIDENTS WITH REAR YARD DRAINS

Residents with developer-installed rear yard drains must make sure that dirt and debris are not washed into the drain openings. Most yards have these developer-installed drains, but not all that are located along the property line with

a neighbor.

Residents are asked to keep leaves or other debris from clogging the inlet. Please be sure not to wash any debris into the drain, thinking the line is big enough and will pass through. Be sure to check the inlet before and after it rains. When renovating landscape, be sure not to raise the dirt level around the drain inlet or block the use of the drain from a neighbor.

The maintenance staff will be responsible for maintaining the drain lines. However, the Association has the legal right to charge the homeowner for the labor to clear the plugged line, or replace the line, if the homeowner

contributed to the blockage.

Our maintenance staff is in the process of checking these drain lines to see if they are functioning. Staff will be using the homeowner's water to flush the line. A letter has been sent to those homeowners affected by this work.

MAINTENANCE STAFF INSTALLING CONCRETE PAD WITH TABLE AND CHAIRS AT COMMUNITY CENTER

The Board has authorized staff to install a 10'x10' concrete pad on the turf area between the office, pool fence and tennis courts. Once completed, one set of furniture from the pool area will be placed on it. Staff, residents and their guests, are free to use it, if unoccupied. The Board felt the Community Center needed an additional, nice seating area.

ARCHITECTURAL DRAWING FOR REVISIONS TO WOMENS LOCKER ROOM TO BE POSTED

Jerry Milner, Board President, has met with several women to discuss their concerns about privacy within the womens locker room. Both he and staff met with an architect to discuss the suggestions Jerry received. It is expected that sometime in October, a drawing showing proposed changes will be posted on a window in the office for resident review and comment.

Residents are reminded that they must follow Article IX, Section 14 contained in the CC&R's:

All service yards or service areas, clothesline areas, rubbish containers, and storage piles on any property within Niguel Shores shall be enclosed or fenced in such a manner that such yards, areas, containers, equipment, and piles will be obstructed from view from any neighboring property or street.

There are a number of residents leaving their containers out so that they are visible from the street. They must not be visible and should be relocated into the garage or side yard. Resident cooperation will be appreciated by surrounding neighbors.

Prompt payment of assessments by all owners is critical to the financial health of the Association and to the enhancement of the property values of our homes. Your Board takes very seriously the obligation under the CC&R's and the California Civil Code to enforce the members' obligation to pay assessments. The Board has adopted this Collection Policy in an effort to discharge that obligation in a fair, consistent and effective manner. Therefore, pursuant to the CC&R's and Civil Code 1365(d), the following are the Association's assessment collection practices and policies:

- 1. Regular quarterly assessments are due and payable on the first day of <u>January</u>, <u>April</u>, <u>July and October</u> of every year. All other assessments, including Special Assessments, are due and payable on the date specified by the Board in the notice of assessment. Unpaid assessments are delinquent thirty (30) days after they are due. (<u>Civil Code Section 1366(d)</u>.
- 2. Assessments, late charges, interest and collection costs, including any attorney's fees, are the personal obligation of the owner of the property at the time the assessment or other sums are levied. (Civil Code Section 1367(a).)
- 3. If an assessment is not paid by the thirtieth (30) day after it becomes due, the Association will send a reminder billing notice regarding the delinquency to the owner at his/her address of record. A late charge of ten percent (10%) of the delinquent assessment will be charged for any assessment which is not paid on or before the thirtieth (30) day after it becomes due (Civil Code Section 1366(d)(2). Interest on all sums due will accrue at the rate of ten percent (10%) per annum commencing thirty (30) days after each assessment becomes due (Civil Code 1366(d)(3).
- 4. If an assessment is not paid by the sixtieth (60) day after it becomes due, the Association will send a pre-lien letter to the owner as required by <u>Civil Code Section 1367(a)</u>, by certified and first class mail to the owner's address of record. (The owner will be charged \$50.00 for the pre-lien letter).
- 5. If the owner fails to pay the amounts set forth in the pre-lien letter within fifteen (15) days of the date of that letter, a lien for the amount of any delinquent assessments, late charges, interest and/or costs of collection, including attorney's fees, may be recorded against the owner's property. A copy of the lien will be sent to the owner at his/her address of record by certified mail within ten (10) days of recordation thereof (Civil Code 1367(b). After the expiration of thirty (30) days following recordation of the lien, the lien may be enforced in any manner permitted by law, including judicial or non-judicial foreclosures. (Civil Code Section 1367(e). The owner will be charged \$75.00 for the lien.
- 6. If the owner fails to pay all amounts due by the thirtieth (30) day after a copy of the recorded lien is mailed to the owner, the delinquent account will be referred to the Association's legal council for further collection, and a minimum of \$300.00 for attorney's fees, plus costs, will be charged to the owner's account.
- 7. If an owner pays all amounts required by <u>Civil Code Section 1366.3</u>, and meets the requirements of that section, the Association will inform the owner that he/she may resolve the dispute as outlined in <u>Civil Code Section 1354</u>, by civil action or other procedures available through the Association.
- 8. After notice and hearing, the Board may suspend the voting rights and the rights to use and enjoy common area facilities, of an owner, and his/her guests and tenants, during any period assessments remain delinquent.
- 9. Nothing herein limits or otherwise affects the Association's right to proceed in any other lawful manner to collect any delinquent sums owed to the Association.
- 10. The Association will charge \$15.00 to the owner for a return check.

NOTE: Quarterly assessment billing notices are considered reminder notices only. You must pay the assessment within the thirty (30) day grace period to avoid a late charge, even if you do not receive a notice. Contact the NSCA office staff for the mailing address of the service processing center in Santa Ana, California if you do not receive the quarterly assessment notice. Be sure your Tract and Lot numbers are listed on your check.
