FROM THE

HELM

In the State of California, all sorts of governmental -state-county-citybodies homeowners association, etc. - are required to have an emergency preparedness plan. Niguel Shores is in the process of developing such a plan and implementing it. Several months ago, the Board appointed an ad hoc committee to work on an emergency preparedness plan. I want to thank Don Beaver, Penni Buff, John Concar, Jerry Moon and Peter Rask for serving on the ad hoc committee with Gerlinde Duffy as the liaison from the Board. We have accepted their recommendations and are beginning to implement them.

This is not something that happens once and then is not thought of again. For the plan to be effective, each of us must be aware of our own situation and review our own preparedness periodically. What happens if we're involved in a fire storm similar to what happened in Laguna Beach a few years ago? What happens if we should have land slippage such as that in Laguna Niguel just last year? What happens if we have a major earthquake such as in the west San Fernando Valley in 1994? What happens if there is a major problem in San Onofre? Each of these possibilities is remote, but each of them exists. And we need to be prepared.

Over the next several months we will be giving you more information about what you should do to prepare yourself and your family for any one or combination of these possible disasters. And we will be asking each of you to get involved in some way. If our community is ever faced with a disaster, we will be much better off if we work together and help each other. The time to organize this all-important cooperation is before the disaster. The time is now.

Your participation will not take a lot of time or a lot of effort. But your participation is very important because you are the one who will benefit from your involvement.

Because of the way our community was built, we have a number of natural groupings of homes, and we will use those groupings in organizing our response to a disaster. When we put all of our neighborhood plans together, we will have a plan for the community that will fit into the city's plan and into the plan for the county.

If you are interested in helping us get organized, do not wait to be asked, volunteer now; first call the office, 949/493-0122, to get your name on the Disaster Preparedness Volunteer List. This is a very important project, and you are the one who will benefit if we ever have a problem. Please participate.

BOARD ACTIONS FOR SEPTEMBER

- ✓ Appointed Miriam Roehlk and Martin Dedrick to Traffic & Safety Committee.
- ✓ Appointed Gretchen Rask to the Finance Committee and accepted her resignation from the Architectural Committee.
- ✓ Appointed the following homeowners to an *ad hoc* committee to look into changes to the landscape and tree view blockage rules: Janet Mackaig, Dee Johnston, Carroll Cox, Bardene Allen and Hal Therolf.
- ✓ Denied a request from a homeowner seeking a replacement proximity device at no cost because a family member lost the original device issued.
- ✓ Appointed Hersey Steinwinter as the Villas Landscape Committee representative. Further, the Board accepted Harry Landis' resignation from the committee.
- ✓ Directed staff to refund unused funds from the summer kids' program back to the parents who paid the fee.
- ✓ Authorized the Recreation Committee to sponsor a weekly Men's Day tennis, similar to the Women's Day tennis program
- ✓ Fined a homeowner \$100 for continued violation of the tree view blockage rules.
- ✓ Accepted bid from Roy Allen Slurry Seal for \$14,694 to apply a slurry coat on the Villas and Sea Terrace II streets.

- ✓ Accepted the *ad hoc* committee's report on emergency preparedness and will appoint another committee in the future to implement the report.

VILLAS/SEA TERRACE II TO HAVE SLURRY COAT APPLIED TO STREETS

The Board has accepted a bid from Roy Allen Slurry Seal to apply a coat of slurry on the asphalt streets. This work is tentatively scheduled to occur on October 12 to October 14. Letters will be sent in advance to those homeowners to confirm actual dates the work will occur and the expected schedule. On the day a street is scheduled for slurry application, residents will have to move all vehicles being used that day outside of the work area by 8:00 am. Further, vehicles will have to remain parked outside the work area, off the streets, overnight.

On the last day of work, the striper will be out to paint new common area parking stalls. Vehicles should not be parked in these locations until the lines have been painted. The Association will not be responsible for paint overspray onto vehicles blocking the crew.

POOL AREA CLOSURE OCTOBER 12-19

The pool area will have to be closed for a week so that our previous contractor can send out a crew to remove and resurface the inner portion of the pool deck. The company acknowledged that the previous crew did a poor job. During this work, the spa will be open for use.

LANDSCAPE COMMITTEE UPDATE

The Landscape Committee welcomed a new member, Hersey Steinwinter. He is the Villas representative replacing Harry Landis. Many thanks to Harry for twenty-some years of community service representing the Villas. Thanks also to Fred Standefer for the tree donation he made to the community.

A new color planting area is soon to appear at the Selva Gate above Tasman Bay, marked at present by the brown patch of grass. Cabrillo and Seaward Isles will receive the same treatment.

At Magellan and Niguel Shores Drive, The iceplant is to be replaced with *myoporum* pacifica.

The yearly trimming of the trees the Association is responsible for will start in October. It is expected the work will extend into November.

During the tree trimming work, the crew will also trim all of the Rhaphiolepis shrubs. The Association has Wendt Landscape Service hroughly trim these shrubs once per year.



TRAFFIC AND SAFETY COMMITTEE REPORT

- 1. The Mariner Gate construction has been delayed because of a water pipe under the proposed new guard house. The board is working with the water company to try to resolve the problem.
- 2. The Breakers Isle Gate is now working and is a great asset to the community. The new gates were paid for by the homeowners of Breakers Isle.
- 3. Traffic is to be monitored at the Cabrillo Isle Gate to address safety concerns.
- 4.. There was a separate meeting held August 27, concerning Lincoln Security and concerns of their performance. The meeting proved very satisfactory and Lincoln is doing a great deal to correct the many complaints that have been received.
- 5. Various locations around the community have been designated for placement of the speed trailers. They have been effective in slowing down traffic.
- 6. There were several requests for additional cards /fobs for the gates. These were denied and a letter was sent to the homeowners with the request that we would like to give the present system an opportunity to work before evaluating the distribution.
- 7. Staff have started to compile costs of vandalism in the community. From June 20 through the first week of August, vandalism costs totaled \$591.45.
- 8. Some new names will be forwarded to the board for consideration of service on the committee.

SHORES BLOTTER

- 1. In August there were several acts of vandalism on Windjammer. Later, in September, it was reported that gasoline had been siphoned out of a car on 2 different occasions. There was also a report that someone had been looking into a home at around 2:00 am.
- 2. After the gate lock at the beach bluff were activated, several persons were seen climbing over the fence. There was rude behavior to the guard on duty. On Saturday, September 13, the locking device was forcibly removed from the Replacement will cost \$500. gate. mechanism will be redesigned to avoid further vandalism. Homeowners are asked to report any further incidents to the patrol, specifically noting license plate numbers.


