Dear Homeowner,

The first five months of self management have been financially sound as reported by Tom Black, our C.P.A., at the September Board Meeting. Mr. Black stated the Association was running \$14,000.00 under budget.

Your association has over the past two years, urged and attempted to assist the South Coast County Water District to provide additional water storage in the Dana Point area, to assure adequate service and fire protection to our community. A bond measure to accomplish this urgently needed facility appears on the November 8 ballot. Please read the fact statement and arguments furnished with your sample ballot and be sure you and your neighbors vote yes on November 8.

The short of talking with Assemblyman Cordova's office on having the Highway Patrol enforcing traffic on our streets seems to come down to two things; one, is current legislation giving an option to the California Highway Patrol to patrol only those communities open to the public and second is the California Highway Patrol vying in favor of that option.

I argued that we are entitled to the patrols because we pay for them, and that our gates and private security make their job easier. They should be able to handle our traffic with fewer patrols meaning less cost to the tax-payer because the traffic is lighter. Niguel Shores has well over 2,000 motor vehicles. That, in my estimation, more than qualifies us by sheer number and need for traffic control. You are being penalized for having private streets and Assemblyman Cordova's office seems to agree with the legislation depriving Niguel Shores of the patrols.

They did suggest we could take down the gates or contract additional patrols from the sheriff. Lets see, you pay your taxes for the patrols, you pay for private security, and now they suggest you pay more for "additional patrols." Do you get the feeling you are being had? Anyone for a refund?

Our new liability insurance policy will be up almost 400% to \$12,000.00 annually, based primarily on nickel and dime claims from residents and guests Please report all accidents to the office, but above all be careful, caution your guests and use your own insurance, whenever possible. The "great ins-

urance rip off" continues and associations are helpless to pay the premiums,

I know the Board joins me in thanking David Stein, Jim Smith, Joe Smith, Ralph Benson and Scott Ferguson with Avco Community Developers for the time and effort spent negotiating the terms for adding the Villas to the Master Association. Avco conceded many items that will eliminate much of the routine maintenance involved in other parts of the community. Such as eliminating the use of underground aluminum wiring and working with the Landscape Committee for proper selection of plants and trees.

David Stein announced his resignation from Avco and now intends to form his own company, our best wishes in your new venture Dave.

Volunteers are still needed for committee work, if interested please contact the Recreation Center. Without volunteer help the Association can't remain strong.

#### MANAGER'S REPORT

#### NEW LANDSCAPE MAINTENANCE CONTRACTOR

A committee consisting of six members of the Landscape Committee, a Board representative and the General Manager received bids from five (5) contractors, interviewed each bidder, rated each against the specifications and presented their findings to the Board of Directors. Then some members of the committee evaluated the work being performed in other areas by the two top rated bidders.

The Board of Directors interviewed the two top rated bidders and selected Comprehensive Landscape. They began word under the new contract on October 17th.

Among the things considered in their selection were:

- A competitive price slightly less then the previous contractor.
- One of the two partners will be the full time supervisor on our project.
- They have an office and storage area nearby.
- Their work in other areas (Big Canyon and Eastbluff) is quite good.

#### EARTH SLIDES

There have been some serious earth slides on several of our slopes. We have had an onsite inspection by a civil engineer from a well known firm of consulting engineers and a geologist who were involved in the soils engineering work during the original grading in our community. Their report includes the following information which could be significant information for property owners:

"Much of the adverse ground water condition is due to the presence of relatively permeable marine terrace sand resting on or interlayered with low permeability Capistrano claystone bedrock or fill materials from this source. Water from the natural infiltration landscape irrigation and possibly, pipeline leaks follow the more permeable sands

to emerge on the clopes or other localities where the ground surface intersects the sand-clay interface. Where slope faces have become saturated, the reduced soil strength will adversely affect slope stability."

The report included recommendations for preventive maintenance and corrective measures. Part of the prevention measures included the following:

"Landscape irrigation should be performed judiciously so as to limit the amount of water available to soak into deeper soils. Our experience has been that most homeowners and particularily associations in charge of maintaining communities, severely overwater planted areas. The excess water is not necessarily conducive to luxuriant plant growth and in addition to wasting water, can contribute to problems in areas of adverse soil conditions due to the seriousness of the problem.

We have contacted another geologist for a confirming or a conflicting opinion on the source of the water and on preventative and corrective measures.

However, we strongly urge all homeowners and those occupying homes under a lease or rental agreement (particularily those with homes above slopes) to be careful to avoid excessive irrigation and check their home and land-scape water pipes for leaks.

#### VILLAS (TRACT 9098)

We have had several meetings with representatives of Avco Community Developers, Inc. regarding landscaping, slope maintenance and other maintenance requirements in the new tract (called the Villas). Avco Community Developers has been very cooperative and at our request has made changes in their original plans which will result in substantial savings to the Association in maintenance costs.

The changes among other things include:

- Property owner has the responsibility for landscape maintenance (in cluding irrigation) on all private property.
- Replacement of aluminum wire with copper wire in the underground electrical systems for street lighting and irrigation system, and other changes which will make the common areas easier and less costly to maintain.

#### ANIMAL CONTROL

The owner of any dog may not permit their dog to run at large without restraint within Niguel Shores. If you are being bothered by this problem you may call the Animal Shelter between 8a.m. and 5p.m. (Monday thru Saturday) to arrange for an officer to come out. The Animal Shelter is a division of the Orange County Health Department and can be reached by calling 1-634-7301.

The C.C.& R.'s prohibit unreasonable view blockages. In addition the Architectural Review Board is specifically empowered to require the trimming or removal of trees or other plantings which the A.R.B. believes interfere with views in an unreasonable manner. The word "unreasonable" is not defined in the C.C.& R.'s in order to allow some discretion in the implementation and enforcement of the covenants and restrictions. To this end the Rules and Regulations of the A.R.B. have been established to limit building heights, control plantings to minimize obstructions, etc. This effort insofar as common area trees are concerned will be carried out on a tract by tract basis as closely as possible.

Residents wishing to call attention to a view problem should do so in writing, in duplicate, addressed to the Architectural Review Board and deposited at the Recreation Center. Necessary forms for this purpose are available at the office.


