Dear Residents,

Unfortunately, this month's report contains some rather disturbing news! I personally have had numerous calls from residents regarding the destruction of the fence alongside the ramp going down to the beach. The Board has worked very hard to have the County remedy the erosion of the banks, repair the lights, etc., since this is County property, not ours. The County put the fence up on Friday and on Saturday evening a group of teen-agers took it upon themselves to tear it down. What prompts young people to initiate and participate in such wanton acts of vandalism and destruction??? This will cost all taxpayers money! Anyone having witnessed the incident or having knowledge of individuals participating in same, PLEASE, call Bill Bierman, our General Manager, at the Community Center office.

On Tuesday evening, October 16th, several hundred teen-agers were having a "party" on the beach. About 50 cars were in our beach parking lot - 4 with stickers! There were approximately 50 teen-agers in the parking lot and roughly 300 more on the beach. The Sheriff's Department was called in to handle the situation and six squad cars responded. We do appreciate the cooperation given us by the Sheriff's Department. We also wish to thank those residents who gave us their in-put regarding the above situation. Residents—you do have to get involved in order to keep this community great If you see any vandalism or unusual activity, PLEASE call the Sheriff immediately at 770-6011. Secondly, call the office at 493-0122.

Manager's Report

I would like to report to all the disappointed residents who made reservations for the Hollywood Bowl trip (only to have the transportation cancelled at the last minute) that we have been attempting to get your money refunded, both for the transportation and the unused tickets. However, the bus company with whom the arrangements were made, refuses to acknowledge our letters or telephone calls. Therefore, a Small Claims Court Action Suit against the bus company has been filed and as soon as we get a determination on this claim, we will let you know.

Our motorcycle riders are cautioned that as soon as reports are received concerning reckless driving, failure to obey traffic laws and creating a nuisance in general, action will be taken by the Community Association to correct the problem. These individuals are not only endangering themselves, but others in the community as well. This does not include the damage these individuals are doing to common property and once these individuals are observed doing this damage, reimbursement for the damage will be claimed.

We would also like to caution parents having small children who are playing on the various embankments and slopes. By permitting these youngsters to play in these areas it is not only dangerous to the youngsters themselves, but it is also destroying both the ground-cover and the irrigation system as well.

Although no cost estimate is available at this time for damages incurred during the beach party episode referred to in Board President, Phyllis Luengen's report, it cost money to clean up the large accumulation of trash and empty beer bottles and cans that were scattered all over the parking lot - YOUR MONEY. It's too bad we have some individuals who abuse the privileges and facilities of this community, discard trash, tear down fences, admit friends as guests and then destroy property which is for the benefit of all, and create a general nuisance to others! Parents, do you know where your youngsters are and who their friends are??? The Community Association has requested that the Sheriff's Department patrol this area at intervals - regular and irregular!

An employee of the Community Association will be touring the entire area during the next several weeks in the early evening to check and ensure that all lights are working properly and to clean the glass on these lights. This cleaning and replacement of burnt out light bulbs will be done street by street.

As you know, November 6th is Election Day. Therefore, all activities scheduled for the multi-purpose room on this date will be cancelled.



This is to advise all residents that plans are in progress to change the guard service effective either December 1st, or January 1st.

Rules and regulations as laid down by the Association will be followed by the new guard service. Be prepared!

If any one has a complaint concerning the rules or the guards, that complaint should be directed to the General Manager. There is no excuse for crudeness or vulgarity towards a guard who is attempting to carry out the rules given him by the community!!!

PROCEDURE TO GUARANTEE DUE PROCESS OF LAW TO MEMBERS OF NIGUEL SHORES COMMUNITY ASSOCIATION

After extensive discussion, a motion was made, seconded and unanimously passed and the following resolutions were adopted:

RESOLVED, that any owner of real property in this Association who has made application to any Committee of the Association, or any owner who is affected by any Committee decision may appeal the decision of any such Committee to the Board of Directors of this Association; and

FURTHER RESOLVED, that the following procedure is adopted to guarantee due process of law to members of Niguel Shores Community Association:

- 1. The appealing Owner shall give written notice to the Board of such appeal as follows:
 - a. The name, address and telephone number of the Owner or Owners;
 - b. The legal address of the real property affected, if any;
 - c. The name of the Committee applied to;
 - d. The date when the Owner applied to the Committee;
 - e. The date when the Committee acted;
 - f. The Committee's decision;
 - g. The Owner's statement, in detail, of the purpose of his application to such Committee.
- 2. A hearing shall be set by the Board not more than thirty (30) days from the date of the receipt by the Board of the Owner's Notice. The meeting shall be held at the offices of the Association.
- 3. The Board shall give notice to other interested parties not less than ten (10) days prior to the date of such hearing.
- 4. The Owner shall have the right to representation of his choice, including legal counsel.
- 5. The hearing may be open or closed, at the discretion of the Owner.
- 6. The hearing may be recorded at the discretion of the Owner. The cost of recording and the preparation of any transcript from a recording shall be borne by the Owner.
- 7. Prior to such hearing the Owner shall have access to all relevant and material Association records.
- 8. The Owner shall have the opportunity to cross examine any witnesses presented by the Association.
- 9. The Owner shall have the opportunity to present evidence at the hearing.
- 10. The Board's determination after hearing shall be in writing setting the reason therefore by findings of fact and conclusions of law.

FURTHER RESOLVED, that this procedure shall take place immediately.



Recycling Program

Newspaper pickups in November - - 12th and 26th.

There will be three weeks interval between the last October 22nd pickup and the first November 12th pickup.

Last month's recycled materials were:

Newspapers

. 26,800 Pounds (13.4 tons)

\$214.40

Aluminum

170 Pounds

42.50 \$256.90

Since the program started in February, 1978, we have recycled 551,644 pounds of newspapers, (275.92 tons) and 1,175 pounds of aluminum. In terms of trees saved from destruction, at 17 trees per ton of newspaper, our recycling has accounted for 4,691 trees. In terms of beverage cans recycled, at 19 cans per pound, we have recycled the equivalent of 22,325 aluminum cans.

In all, we have received \$4,838.27 for paper and \$288.51 for aluminum for a total of \$5,126.78. Expended to date for projects beneficial to the community \$2,816.29, and cash on hand available for further projects in future 2,310.49.

Please don't let up on this important project. We all know the benefits to our country, and to our own community.

Each month we lose some of our residents who move away and are replaced by new families who may not know the details of our recycle system. For their benefit, I repeat the formula:

Save all types of newspapers, Pennysavers, and similar periodicals. Telephone books must have pages torn out because the glued binding is not usable. No slick or shiny magazines can be used because the paper has clay in it and is not suitable for this recycle process.

Place your papers on your front curb on the 2nd and 4th Monday of each month, no later than 2 p.m. Do not tie them, but simply stack them with a weight on top. Use a cardboard carton, or even large shopping bags, although the bags must be discarded by our recycler. The carton will be left at your curb along with the weight used.

Between pickups, just stash the papers in your garage. Please don't throw them in with your weekly trash. We will all benefit!

Bread

PUMPKIN BREAD

From the Kitchen of Nancy Taylor

1½ cups sugar 2 eggs ½ cup oil Mix and beat well 1 cup canned pumpkin 2 cups flour 1 tsp. cinnamon ½ tsp. cloves ½ tsp. nutmeg Add to above mixture ½ tsp. allspice Mix well, until smooth. 1 tsp. salt 1 tsp. baking soda 1 cup raisins 1 cup nuts Add to above mixture and blend in.

Bake at 350 degrees about 1 hour and 15 minutes in loaf pan.
