# FROM THE HELM

Recently a child from Niguel Shores was hit by an automobile while crossing the intersection of Selva and La Cresta. Although he suffered multiple fractures, at last report, his recovery was progressing satisfactorily.

As a result of this and previous such accidents, a concerted effort is being made by a group of local parents, the PTA, and school officials to have traffic signals installed at intersection. Each member of our Board of Directors has signed a strong letter support urging the responsible Orange County officials to take the required steps without delay. However, heavy support from individuals is essential for success, so we ask and hope for your participation -- one of strong influences on public officials is a preat volume of pertinent correspondence.

The intersection is inherently dangerous for all pedestrians due to the steepness of Selva and the proximity of the gates at Garibaldi and Cape Cove. The inevitably continuing increase in traffic is certainly making a bad situation much more dangerous, not only for the school children, but for adult pedestrians and even automobile traffic.

While we can only regret the recent tragic accident and extend our sympathy to the victims, we can make a forceful effort to prevent the next one. Lengthy letters are not necessary. A short note indicating your awareness of the conditions and urging prompt action will be equal to the need. Please join the effort and send your comments to:




