

NEIGHBORHOOD WATCH

While our Neighborhood Watch program continues to function without a regular chairman, all is not well. In the past four weeks our Niguel Shores office has received reports of seven break-ins, attempted break-ins or thefts. In all cases they were first reported to the Sheriffs Department and then to our office. This is a recommended procedure which permits us to alert the community when burglaries or attempted burglaries occur.

These crimes did not occur in any single area but were spread around. Streets on which incidents occurred were Windward, Dosinia, Moonsail, Hobart Bay, Magellan Isle, Salvador Bay, and Brisbane Bay. The incidents point up the need for all of us to look out for our neighbors and make our Neighborhood Watch an effective burglary prevention program.





2751 Legal Basis for Suspension of Rights (2-1-85)

The authority of the Board of Directors with regard to the suspension of voting rights and the right to the use and enjoyment of the common areas of any member and his guests and delegatees is pursuant to the authority provided in Section 304 of the By-Laws of the Association, Article IV, Section 3 of the Association's Covenants, Conditions and Restrictions, and Section 7341 of the California Corporation Code.

2752 Suspension of Rights (10-4-89)

The voting rights and <u>/or</u> the right to the use and enjoyment of the common areas of any member, and his guests and delegatees, may be suspended by action of the Board of Directors for any one or more of the following reasons:

- (1) The members assessment account remains unpaid and delinquent for a period of ninety-one (91) days or more. Such suspension shall remain in effect until all unpaid and delinquent assessments are paid in full.
- (2) The personal conduct of the member and/or his guests and delegatees (including tenants), constitutes a violation of the Rules and Regulations adopted and published by the Board of Directors and governing the use of the common areas and facilities and the personal conduct of persons thereon. Such suspension shall be for a period not to exceed thirty (30) days.
- (3) Physical or mental impairment which presents an unreasonable risk of injury to, or threat to the safety of, the individual involved or other members and their guests and delegatees who are entitled to the use and enjoyment of the community center facilities. Such suspension shall be limited to the community center facilities and shall be under such conditions and for a period to be determined by the Board of Directors in accordance with the rules and procedures set forth in NSCA Rules 5101 and 2753.

2753 Procedure for Suspension (2-1-85)

- (1) The member, or other person whose rights are the subject of suspension, shall be given written notice of the nature of the conduct for which suspension is considered, the nature of the suspension action to be taken, and the date, time and place at which the Board of Directors will take action upon the proposed suspension of rights. The notice shall be sent by first-class mail not less than fifteen (15) days prior to the date of the Board of Directors' meeting at which action on the proposed suspension of rights is to be considered by the Board.
- (2) At the time of the scheduled meeting of the Board of Directors, the member or other person, shall be entitled to be heard by the Board either orally by attending in person, or by presentation in writing. Any presentation in writing must be received at the Association's management office not later than 3:00 PM of the day scheduled for the Board's meeting.
- (3) The member or other person shall have the right to be represented by an attorney of his choice and to present evidence, written and/or oral, on his behalf at the scheduled hearing before the Board. He shall also have the right to cross examine any witnesses presented on behalf of the Association.
- (4) If the member (or other person) and/or his attorney intend to be present and be heard at the meeting, he must notify the Board in writing of such planned attendance of himself and/or his attorney at least five (5) days before the scheduled date of the Board's meeting. Failure to do so may result in a continuance of the hearing to a later date.
- (5) Any suspension of rights of a member or other person by the Board of Directors shall not be effective for at least five (5) days after the date of the Board of Directors meeting at which the member, or other person, was provided an opportunity to be heard. Notice of Suspension by the Board shall be in writing and sent to the member, or other person, by first-class mail.

4001 Definitions (7-1-85)

Common Property Property owned by the Association or owned by members and eased to the Association for landscape purposes.

Common Areas Same as Common Property

<u>Private Property</u> Property owned by a Member and <u>not</u> eased to the Association for landscape purposes.

4101 Landscape Improvements (7-1-85)

An application form and two sets of plans are required for the proposed planting or placement on private property of any tree or hedge, or any shrub which at maturity and without pruning thereof, would exceed three feet in height. (CCR 7-1) The plans are to be submitted to the Architectural Control Committee and shall include the following:

- 1. Plot plan, drawn to scale, showing existing building outlines, fences, walls, etc. Fence and wall heights must be shown. A plot outline of adjacent property must also be included.
- 2. Location and elevation of all proposed plants which will exceed three feet in height and the relation of same to neighboring property.
- 3. Drainage plan.

4102 Approval by Default (7-1-85)

In the event the Architectural Committee, or its designated representatives, fail to either approve or disapprove such plans and specifications within thirty (30) days after the same have been submitted to it, it shall be conclusively presumed that the Architectural Committee has approved such plans and specifications. All improvement work approved by the Architectural Committee shall be diligently complèted. CCR 7-3

4111 General Policy (7-1-85)

All trees and shrubs shall be trimmed, pruned and topped as necessary to remove any growth, either lateral or vertical, which unreasonably interferes with the view from any other homesite. The guidelines given in these rules are general and do not limit the responsibility and authority of the Association to adjust the guidelines to specific situations.

4112 Pad-Level Plantings (9-6-89)

No tree growing on private property at pad level shall be allowed to exceed the height of the highest elevation of the nearest adjoining roof segment, unless such height does not unreasonably interfere with the view from another lot. In areas where a lateral view obstruction is involved, plantings at pad level are limited to a height of three feet, or the height of side yard walls or fences in the lateral view lines at the view end of the "viewing" house.

4113 Slope Plantings (7-1-85)

No tree or shrub growing on a slope shall be allowed to grow higher than three feet above the top of the slope or bank, unless such height does not unreasonably interfere with views from any other lot. No planting shall be permitted to remain on any slope which might damage or interfere with established slope ratios, create erosion or sliding problems, or interfere with established drainage functions or facilities. (CCR 9-17)

4114 Overhanging Plantings (7-1-85)

No tree, shrub or planting of any kind shall be allowed to overhang or otherwise encroach upon any sidewalk or other pedestrian way, from ground level to a height of ten (10) feet, without the prior approval of Architectural Committee. (CCR9-19)

4115 Diseased Plantings (7-1-85)

No plants or seeds infected with noxious insects or plant diseases shall be brought upon, grown, or maintained upon any part of Niguel Shores. In the event of the default in the performance of this provision, and if such default shall not have been cured within five (5) days after written notice thereof, the Association shall have the right to enter upon any lot within Niguel Shores and, at the expense of the Owner of said lot, remove infected or diseased plants and/or spray the same and/or take such measures as may be necessary in the opinion of the Association to protect the same and/or the Community from the spread of such infection. (CCR9-13)

4121 Planting Maintenance (7-1-85)

All landscaping of every kind and character, including shrubs, trees, grass and other plantings shall be neatly trimmed, properly cultivated and maintained continously by the Owner thereof in a neat and orderly condition and in a manner to enhance its appearance. (CCR9-18)

(11-1-89)

5101 Use of Community Center (10-4-89)

The Niguel Shores Community Center property, facilities and equipment are restricted to use by members of the Niguel Shores Community Association, their families, and guests.

The rules for use of the facilities are structured to provide maximum recreational benefits to the greatest number of persons, and have been established by the Association Board of Directors to preserve and protect the mutual rights of the members. Violation of these rules and regulations may result in suspension of the right to use the facilities.

The right to use the community center facilities may also be suspended by reason of the physical or mental impairment of such member, or of his/her family members, guests or delegatees where, in the reasonable opinion of the Board of Directors, such physical or mental impairment presents an unreasonable risk of injury to, or threat to the safety of, such person or other members and their family members, guests and delegatees who are entitled to the use and enjoyment of the community center facilities.

The duration and any conditions of suspension of the right to use the facilities shall be determined by the Board of Directors in accordance with the notice and hearing procedures outlined in NSCA Rule 2753, except that such right may be immediately and temporarily suspended by the Board of Directors pending the hearing provided for in Rule 2753 for a period not to exceed thirty (30) days.

5102 Rules for Use of Community Center (4-1-85)

- 1. All persons using the facilities are required to sign in when entering the Community Center.
- 2. Guests using the facilities must be accompanied by a member, or be registered at the office by the member. Members are responsible for the conduct of their guests and observance of the rules.
- 3. Access to the Community Center is restricted to authorized hours. Any member or guest who enters during unauthorized hours is subject to illegal entry and trespassing laws, and may be prosecuted. Violations of this rule may be cause for suspension of member privileges.
- 4. Staff has the authority to enforce all rules and regulations. Members are requested to report infractions of the rules to management.
- 5. No pets or other animals are permitted within the Center.
- 6. Glass containers or objects are not permitted on Center property.

- 7. Smoking is prohibited in designated NO SMOKING areas.
- 8. Rough or boisterous conduct, profanity, gambling, or immoderate use of alcohol is prohibited.
- 9. All storage areas, pool filtration rooms and private meeting rooms are off-limits.
- 10. Misuse or vandalism of Center facilities may be cause for suspension of privileges and referral to local authorities for prosecution, an property owners shall be subject to the fine system.
- 11. Skateboarding and rollerskating are not permitted in the Community Center or parking lot.
- 12. Individuals using the facilities may be required to furnish proof of membership or guest status.
- 13. Loitering is prohibited in or about the Community Center and adjacent areas.
