MORE DEVELOPMENT ON NIGUEL ROAD

Ritz Pointe (D.T. Development Co.) wants to build 190 new condominiums on Niguel Road across from the Tennis Villas and below the new Monarch Hills Apartments. They have every right to build on their own land.

They have already built up a 13' pad on Niguel Road at Corniche. Take a look. On top of this they want to erect too many 35' tall (3 story) condos with flat roofs on which they plan to place air conditioners and other equipment. This would create many new buildings almost 50' high in an area which supposedly is zoned 35' above Niguel Road.

Questions of density, increased traffic, and consistency with the proposed new Dana Point General Plan have not been satisfactorily answered. Yet City Staff recommends the project.

It is important that many residents of Niguel Shores appear at the next public hearing of the Dana Point Planning Commission when this Ritz Pointe condominium project will again be heard. (7 pm Tuesday, November 20, at City Hall, 33282 Golden Lantern.)

Our hope is to improve the project, not stop it.

THE URBAN COYOTE

In recent months, the number of sightings within Niguel Shores of this predator has grown to 10-15 per month. It seems they have discovered the 'good life' here in The Shores. However, we now know that some of the missing cats and small dogs have been taken by coyotes. One was actually seen killing a cat on the greenbelt behind Danzig Bay late one afternoon.

We must remember that their natural prey consists primarily of small animals, birds, and rodents. The following has been excerpted from the Orange County Animal Control handout on coyotes.

"In form and size, coyotes resemble a small shepherd or Collie dog, with pointed ears, slender muzzle and bushy tail. Coloration of the animal may vary from light grey to nearly black to red or nearly white. Most active at night or during early morning hours, their good eyesight and keen sense of smell are of great value in locating food sources, such as small live animals, carrion, fruits, garbage Of some value or pet foods. in repelling these animals in residential area are the presence of radios, vehicle activity and lighted areas, which seem to have an effect on these animals."

"Orange County Animal Control will respond to complaints about coyotes which have become a threat to humans and/or their animals. Because of the nature and characteristics of the coyote, our Wildlife Officer will make a determination of what techniques or methods may be utilized in attempting to capture or repel the animal."

"Traps may be set upon private properties, at the request of the owner, once liability is waived."

"These suggestions may help if you have a present problem with coyotes or may be of benefit in the prevention of problems:

DO


- * Feed pets indoors or promptly remove feed dishes when pets have completed their outdoor feeding.
- * Store bags of commercial pet food indoors.
- Clear brush and dense weeds from around the area.
- * Fence your yard to keep out unwanted animals.
- * Fut trash in strong barrels with tight—fitting lids.
- * Upon sighting, attempt to frighten or drive off by waving arms, hollering, or throwing stones.

DOM'T

- * Feed or provide water for coyotes or other wildlife.
- * Use plastic bags as trash containers.
- * Put trash out the night before pick-up but rather the day of service, at the latest opportunity.
- * Allow small domestic pets to run at large at any time. They are an easy prey for coyotes.

"Remember, treat the Coyote as you would any wild animal, do <u>not</u> attempt to capture, feed or make "friends" with it."



2701 Basic Policy on Penalties, Fines, Fees (02-01-85)

- (1) Whereas it is the policy of the Niguel Shores Community Association to protect the rights and privileges of the members and to enforce the CC&R's and Rules and Regulations of this Association, therefore pursuant to the authority vested in the Board of Directors of said Association by the CC&R's and by the By-Laws, the following system of penalties, fines and fees is hereby established and supercedes all previously adopted systems for such penalties, fines and fees.
- (2) This system shall be binding on the members of the Association, and shall not be the exclusive remedy of the Association to deal with violations of the CCER's, By-Laws or Rules and Regulations. Members shall be responsible for the acts or omissions of their guests, lessees or invitees.
- (3) All penalties and fines, pursuant to this Rules and Regulation, shall be imposed by Board action after reasonable notice and hearing, as set forth hereinafter:

2702 Violation of CC&R's (02-01-85)

Pursuant to Article XI, Section 4 of the CC&R's, the Association has the right to prosecute a proceeding at law against any person or persons who have violated or are attempting to violate the CC&R's, and the losing party shall pay any attorney fees of the prevailing party as may be fixed by the court.

2703 Non-Payment of Assessment (02-01-85)

In addition to the right of the Association to bring an action at law against the Owner for non-payment of assessments, (as set forth in Article VI of the CC&R's), Section 304 of the By-Laws provides that the voting rights and use of the common areas by any member, his guests and delegatees, may be suspended by action of the Board of Directors during any period when assessments owed by such member remain unpaid.

2704 Continuing Violation of Rules (10-03-90)

Section 304 of the By-Laws also provides that the right to use of the common areas and facilities may be suspended by the Board of Directors for violation of the Rules and Regulations relating to the use of the Common Areas and the conduct of Members thereon, for a period not to exceed thirty days.

(11-05-90)

3145 Painting (10-05-90)

- 1. Approval must be obtained from the Committee for painting/staining or repainting/restaining, including fences, walls, planters, etc. Color chips must be provided with the submittal. Color choices are to be designated for each area of the house to be painted/stained; for example, stucco walls, wood siding, garage door, garage door trim (if any), fascia board and/or underside of eaves, window trim, doors, patio or house overhangs and posts.
- 2. Garden Homes (Tracts 6782, 8038, 6883, 7302, 7573).
 - A. Colors are to harmonize with the existing slumpstone.
 - B. Fascia board color must be the same on all four sides of house/garage, including side of house at the lot line.
- 3. Broadmoor Homes (Tract 6935). All exterior walls and trim are to be painted the same color scheme at the same time.
- 4. Villas (Tract 9098). Developer painted all houses in this tract the same color because of architectural design and construction material (stucco houses and walls). Required colors are:

Stucco (houses and walls): Dunn-Edwards #514 Bone China (or equivalent)

Trim: Dunn Edwards #79 Norfolk Brown (or equivalent); Dunn Edwards #9 Tawny (or equivalent); or Dunn Edwards #514 Bone China (or equivalent)

- 5. Gutters, metal flashing and vents (pipes) on top of roofs to be painted to blend with house.
- Repainting/restaining shall be accomplished within ninety (90) days after approval.

3146 Private Parking Areas (04-04-90)

Existing open parking spaces on private property shall not be reduced to less than the space necessary to park two automobiles.

3150 General Regulations (04-16-86)

Regulations relating to the utilization of existing structures are shown in Rules 3151-3159.

3151 Exterior Antennas (04-16-86)

Exterior antennas of any kind are not permitted.

3152 Backboards (04-16-86)


- A. Backboards must be solidly constructed and board and hoop firmly affixed to garage or other structure.
- B. Backboards must be painted or stained to match background structure, and must be neatly maintained and painted when necessary.

3153 Flag Poles (04-16-86)

Installation of free-standing flag poles on private property is not permitted.

3154 Garages (04-16-86)

- A. All required garage spaces shall be fully enclosed and garage doors shall be kept closed except when in use.
- B. Garages shall not be converted into living quarters, sleeping quarters, offices, or other similar use.
