# OCTOBER BOARD ACTIONS

- 1. Raised the Fidelity Bond to \$1.2 million, on renewal in November.
- 2. Changed Rule 6440, C.1 from a two (2) hour tow notice to a one (1) hour tow notice. (See attached rule).
- 3. Authorized management to purchase 100 new chairs for MPR. Board may donate old chairs to a charity.
- 4. Authorized management to make other purchases such as: concrete planters for community center, table and chairs for office meeting room and radio communications system for staff.
- 5. Denied three (3) claims for tire damage involving entry gates.
- 6. Contracted with Converse Consultants for measurements and review of Nauticus Isle down slope.
- 7. Authorized management to continue use of PVC pipe as gate arms, in place of wood.
- 8. Authorized management to pursue investigation of costs for rebuilding all entry gate mechanisms. All exit gate mechanisms will be removed and replaced with spring loaded spikes.

# <u>MAINTENANCE</u> <u>DEPARTMENT</u> <u>DUMPSTER</u> <u>-</u>

Homeowners and residents are asked not to use the dumpster at the community center. This bin is used by staff for removal of community center and maintenance department debris.

Maintenance has put a cover over the bin and locked the access doors. This was necessary because of resident dumping and contractors doing weekend work. The bin was being filled up to the point that our staff could not use it.

Homeowners who come here on weekends and holidays have complained to staff on this policy. The only advice that can be given is to take your trash with you or make arrangements with one of your neighbors. You can hopefully include your trash with theirs or ask that they put your trash bags out on pick-up day.

Several homeowners have requested that the Board change or waive the rule that states trash shall not be put out more than twelve (12) hours in advance of the pickup day. Our association's rule matches that of the City of Dana Point. Even though the Board can change its rule, it cannot change the City's ordinance. Homeowners who put out early may be subject to a fine from the City Code Enforcement Officer.

If the Board decides to change the policy or accept any homeowner suggestions, you will notified through the newsletter.

Thousands of dollars in mature trees have been lost by their destruction, and property values affected. It's time we residents ask ourselves what is wrong. The Shores has an enormous landscaping budget and yet doesn't have the beautiful mature look of an area that has been here so long. Should decisions be made by committee people who don't know what they are doing when so much money is involved?

- C. <u>Tow-Away Procedure.</u> When the vehicle is to be towed away, the following steps are to be taken in accordance with these rules and the provisions of Section 22658.2 of the California Vehicle Code (CVC).
  - 1. At least one (1) hour prior to the removal of a vehicle owned by either a member of NSCA or a member of the public who is not a member of the Association, the designated representative of NSCA as identified in sub-paragraph 6 below shall affix Notice of Violation to the vehicle which shall contain the following:
    - a. A statement that the vehicle will be towed if not removed, within one (1) hour from time notice left on vehicle.
    - b. The identity of the provisions of the CC&Rs, Bylaws or these Vehicle Rules which are violated;
    - c. The time the notice was affixed to the vehicle.
  - 2. Tow-away service is called by authorized representatives of NSCA as designated in sub-paragraph 6 below.
  - 3. The tow away/impound service shall give, or cause to be given, notice of the removal to the registered owner of the vehicle and to the local law enforcement agency in accordance with CVC.
  - 4. Towing company receipt is filled out by towing service, signed by NSCA representative and a copy returned to Administrative Office.
  - 5. Removal may be made WITHOUT NOTICE of any vehicle parked in a marked fire lane, within 15 feet of a fire hydrant, in a parking space designated for handicapped without proper authority, or in a manner which interferes with any entrance to, or exit from, Niguel Shores or any lot, parcel, or area owned by a member or the Association within Niguel Shores.
  - 6. The following representatives of NSCA are designated, in the order listed below, to authorize a tow-away:
    - a. The General Manager;
    - b. The NSCA Board President;
    - c. The Board Liaison to the Traffic & Safety Committee;
    - d. Any other Board member;
    - e. Access control contractor
- D. Abandoned Vehicle. When it is believed that the vehicle is abandoned, the Sheriff's office will first be requested to handle the matter.
- E. Responsibility of Owner for Violation of Rules. The owner of any vehicle and/or residential lot in violation of these rules shall be subject to the Enforcement Procedures. Owners of residential lots within Niguel Shores (Association Members) are further responsible for Rules compliance and the violations thereof by their guests, tenants and delegatees.

Re: Refurbishment of Niguel Shores Entries

Since the Fall of 1989 until October 1991, an Ad Hoc Refurbishment Committee diligently pursued plans relative to modernizing our entry areas which have not been altered to any appreciable degree since the establishment of the Shores.

The committee -- representating all tracts within NSCA -- spent infinite hours deliberating possible changes, exploring other communities, consulting with landscape architects (with the Board's sanction and approval of over \$12,000 for plans); yet, in the final analysis, no specific cost estimates were supplied by which to finalize a proposed presentation to the community, primarily homeowners who might or might not incur an extra assessment for the improvement of our entries, foremost of which would be the Mariner access.

Two very general concept renderings emerged from the committee's activity and can be viewed in the office. Among the ideas generated were enhancement of the monument sign at Niguel Road; the construction of a companion monument across Mariner at the southwest corner of Niguel; masking of the various utility structures; modification of the guard house; lighting and landscape changes. Besides Mariner, the other gates -- Ports O'Call/Cabrillo, Selva, Garibaldi and Manta Court (Shanny) plus the La Cresta/Selva monument would also be updated in conformance with the master plan.

The Board of Directors wants your input! Because any such considered refurbishment falls in the area of capital improvement, the Board does not want to act without homeowner support. Therefore, will you take a few minutes and complete the straw vote ballot attached to this memo? Please mail it in, or drop off your vote at either the office or at the "ballot box" located at the Mariner guard house, exit side. We need your response no later than November 15, 1991.
