
### ENTRY REFURBISHMENT COSTS DISCUSSED AT OCTOBER 19 MEETING

The Board of Directors discussed the costs provided to them by Lynn Muir, architect of the improvement drawings. The total cost discussed for the refurbishment is estimated to be \$522,000. This would represent a cost to each homeowner of \$544.

The Board has agreed that a ballot will be issued for the purpose of voting on the project. It is expected that at the earliest this ballot will be mailed out during the first quarter of 1995.

The Board has discussed how this project may be implemented, either all in one year or doing the project over several years, and payment options for homeowners. No decisions have been made on these issues.

Regarding the Entrance Refurbishing Project as described by the Lynn Muir renditions at the September 21 Open Board Meeting.

Any increase in costs -- even only a "one-time assessment" -- wrecks havoc with my personal budget and causes me major concerns. What profit higher property values if one can no longer afford to live here?

Maintaining as large a complex as the Shores is costly enough. Let's concentrate on that, and leave face-lifts to Zsa Zsa Gabor and investmentseekers.

I understand Mr. Muir was paid \$2,500 for his work. His highly professional efforts certainly deserve that -- the project, however, did not, and does not, deserve one dime.

I love Niguel Shores as is -- warts and all. Sue me.

# <u>LANDSCAPE COMMITTEE UPDATE</u> - TREE TRIMMING

The office staff have received many requests from residents to trim common area trees for views. All of these requests are being held until November. Our contract with Wendt Landscaping Service specifies that most common area trees under twenty feet will be trimmed once per year in November/December.

Management has received assurances that the crews will start trimming on November 1st. Most of the complaints are from Sea Terrace I and this is where they will start.

The crews will also be lightly trimming all of the common area Coral trees. This work is done twice per year.

There are two remaining planned projects for this year: Slope refurbishment will occur in Broadmoor, on Windjammer, between Lateen and Niguel Shores Dr. Front yard refurbishment on Marlinspike and Halyard, in Sea Terrace I. It is hoped that these remaining projects will be completed by November 18.


### **MENS CLUB**


