Previously the Board reported that we would start resurfacing the streets on the South side of Selva. It turned out that the contractors bidding on the job left out a street, and that additionally our people had taken square footage measurements of these streets and were in disagreement with the contractor's numbers. This should be straightened out by the time you receive this newsletter, and hopefully we can get started.

ROOFS -- This has been discussed before, but I believe it bears repeating. The Community is at an age when a considerable

number of roofs need replacement. important to obtain a permit from the City of Dana Point and to obtain architectural approval from the Association's Architectural Committee. This seems rather routine, and it is. However, some don't seek approval and find out after the fact that the material they have chosen is not a material approved within the Community. At this point, it is expensive to rectify. The City of Dana Point looks for these jobs that have not been permitted, and then they tag the job and require a permit after the fact. The procedure within the Shores is not complicated if you are using approved materials; better to find out sooner than later. Check with the Association office to implement this approval.

BOARD ACTIONS FOR OCTOBER

- ✓ After reviewing bids from two insurance agents, chose to accept the recommendations provided by Glenn Robinson, RobCo Insurance The Finance Committee contacted three insurance agents, with two responding. The total approximate cost will be \$35,679.
- Authorized staff to have After School Recreation Director to use liability waiver forms for all kids that participate.
- ✓ Authorized staff to hire California Civil, Inc. to perform a survey of the property line between NSCA and the Ritz-Carlton Hotel.
- Agreed to reimburse a Sea Terrace II homeowner \$950 for digging up main sewer line to home and making repair, provided staff is present at time work commences and staff verifies the cause of the problem is directly related to a tree or shrub in the landscape easement area.
- ✓ Authorized staff to purchase a computer for the part-time Administrative Assistant, provided cost does not exceed \$1500.
- ✓ After reviewing two bids, authorized staff to contract with M&K Masonry to install a sixinch thick concrete slab, with re-bar, on the beach bluff in the area around the concrete benches and picnic tables. Total cost for the project - \$6,410. The slab is a requirement of the State's reclaimed water use rules, as enforced by South Coast Water District.
- ✓ Reviewed revised bid from Commercial Fence and Iron Works with changes requested by Board and accepted new cost of \$2,023. They are constructing new gates for beach parking lot road.
- Appointed Jerry Moon to the Traffic & Safety Committee.
- Authorized staff to contract with Dove Companies for an inspection of the locker room remodel work, provided cost does not exceed \$1,000.
- ✓ After reviewing four bids for printing of new homeowner vehicle decals, Board authorized staff to accept bid from either Dalco or B&S Screen Printers for 5000 decals. Cost will be approximately \$1,000.
- ✓ Authorized staff to reimburse homeowner's guest \$74.87 for damage to tire at Breakers Isle gate.

- ✓ After seeing presentation by City staff on the three sidewalk alternatives for the west side of Pacific Coast Highway, the Board voted to support the third alternative. This plan is for a sidewalk that is five feet wide which meanders within the eight foot public easement. There will be multiple three-foot wide landscape pockets to screen the view of the sidewalk.
- Appointed the following homeowners to serve on an Ad-Hoc Committee to make recommendations to the Board of Directors on Rules and Regulations, contracting and contract management: Peter Rask (Chair), John Hall, Dick MacKaig and Grover Brown, with Jerry Milner as the Board Liaison.

LANDSCAPE COMMITTEE UPDATE

The Committee has decided to complete two additional projects in 1996:

- ✓ 15 gallon size Tipuana Tipu trees will be added along Mercator Isle and Nauticus Isle. The trees will be along the upslope side of the streets, approximately four feet back of curb. These trees are one of the fastest growing that can be planted.
- ✓ The corner of Stonehill @ Niguel Road will be improved with the planting of a 36" box Coral tree, after the acacia is cut back. The tree will be located approximately ten feet up the slope face. The acacia will be cut back in a fan shape. Flax will be planted as a buffer, just below the remaining acacia, with red Bougainvillea planted on the open slope face, in and around the new Coral tree. On the flat portion of space, below the slope, Daylily's will be planted in mass.

The Committee has looked at the issue of view blockage from the new Coral tree and they do not believe the tree, at maturity, will pose a problem.

It is believed that these projects will be completed in early to mid-November.

A little P.R. would help reduce the stridency and anger many people express when they enter our community office.







2101 Budget Preparation (04-01-85)

The preparation of the Annual Budget will consist of the following steps. Before the process begins the Board will establish target dates for each step:

- A. The Finance Committee will be asked to indicate any increases or decreases in the level of service to be rendered in their area and the reasons for such change.
- B. Each Committee will be asked to indicate any increases or decreases in the level of service to be rendered in their area and the reasons for such change.
- C. Management will prepare a listing of all income and expense items showing actual to date, estimate for current year, estimate for the next year based upon committee requests, estimate for next year based upon management requests.
- D. The Finance Committee will schedule meetings with each Committee submitting budget requests. The chairman of the committee, the Board Liaison to the Committee, the Board Liaison to the Finance Committee, the President of the Association, the Manager and the Controller will be asked to attend. At these meetings each item will be explained and discussed.
- E. The Finance Committee will submit their recommendation to the Board along with the resulting assessment figure.
- F. Management will prepare a tentative budget document showing for all income and expense items: actual to date; estimate of actual for current year; estimate for next year based upon the recommendation of the (a) Finance Committee, (b) Operating Committee, (c) Management.
- G. The Board will review the document described in (6) in the presence of the Finance Committee Chairman.
- H. The Board will determine the final budget items and the amount of the assessment.

2105 "Over-Budget" Procedure (04-01-85)

The Board will be notified by Management whenever the estimated expense for the year will probably exceed the budget for the year or when the estimated income for the year will fall short of the budget. The Board must then either adopt a policy which will increase income or reduce expense or determine where other budget savings can be effected.

2253 Written Bids (09-04-96)

It is the policy of the Board of Directors to obtain the following written bids for all purchases:

Under \$2,500, one written bid.

From \$2,500 to \$10,000, a minimum of two written bids.

Over \$10,000, a minimum of three written bids.

2301 Accounts Unpaid for **30** Days (02-02-94)

Members, whose accounts have a balance outstanding for more than 30 days are assessed a late charge of 10% or \$10.00, whichever is greater, plus interest figured at 10% per year. The mailed quarterly assessment payment must be canceled by the U.S. Post Office by the 30th day of the month due. If not, then the late charge and interest will be assessed. Reminder billings, with the late charge and interest due, are sent by the NSCA office staff.

2302 Accounts Unpaid for 60 Days (10-05-88)

Members, whose accounts are 60 days delinquent, are noticed by certified mail that if payment in full is not received within 15 days, a lien will be filed against the property.

2303 Accounts Unpaid for **75** Days (10-05-88)

Members, with delinquent accounts of 75 days, are liened. Members are assessed a charge for lien filing and administrative costs (minimum charge \$50.00).

2304 Accounts Unpaid for **90** Days (10-05-88)

Members, whose accounts are 90 days delinquent, are referred to the Board of Directors for suspension of Association voting rights and use of common area/facility privileges (including participation in committees, clubs and organized community events), which includes use by the member, his guests and tenants, pursuant to suspension procedures.

2305 Accounts Unpaid for 90 Days (03-06-96)

A member's account which is 90 days delinquent, will be referred to the Association's attorney for collection. The member will be assessed a minimum charge of \$300 for attorney fees plus other related costs.

2306 Accounts Unpaid for **120** Days (02-01-85)

Failure to cure a delinquency of more than 120 days may result in foreclosure proceedings against the property.
