# DEAD ANIMAL POLICY

At its recent meeting, the Board reviewed and adopted a formal policy regarding the removal of dead animals from private property and from common the dead animal If its removal is domestic pet, the responsiblity of the pet owner. If the cannot be determined identification tags and the dead animal is on private property, the property is responsible for the animal's removal and disposal. County Animal Control is to be contacted for removal, 834-6848.

If the pet owner cannot be determined and the animal is on common area, it will be removed by Animal Control upon notice from either the resident reporting the situation or the Association office.

If the dead animal is non-domestic, such as a possum, skunk or the like, and is on private property, the resident must notify County Animal Control. If the animal is located on common area, notify the Association Office. The staff member will call Animal Control to have the animal removed.

If the incident occurs outside normal office hours (9 am to 9 pm, Monday through Sunday), please notify Animal Control directly.

#### MULTI-PURPOSE ROOM RESERVATIONS

As a new policy, the Multi-Furpose Room of the Community Center may now be reserved for private functions by property owners.

An adult property <u>owner</u>, who will be present at the affair, shall request a reservation <u>subject</u> <u>to availability and governing rules</u> and pay a rental fee of \$80.00 (\$40.00 upon reservation). This money will be forfeited if the reservation is cancelled within 60 days of the date of the event.

One week before the event, the owner shall pay the balance of the fee, \$40.00 plus a \$200.00 refundable deposit which may be used to pay for any damage or special clean-up or rule violations that may occur.

If damage exceeds the deposit, the resident sponsor shall be responsible and will agree to reimburse the Association without reservation.

Alcoholic beverages may not be served to minors. Guests at the affair will confine themselves to the immediate vicinity of the MPR and walkway to the restrooms. The pool, tennis courts and jacuzzi and sauna areas shall be off limits.

Froper notice and an alphabetized guest list (typed or printed) shall be provided to the office at least 3 days prior to the event. Parking may be in the lot or along Niguel Shores Drive.

The event sponsor shall provide proof of homeowner's personal liability insurance with a minimum of \$300,000.00 and sign a hold harmless agreement.

For use of any Association equipment, please contact the office.

The maximum number of guests present shall be 100.

# WHAT'S DOING IN SEA TERRACE II

Our painting is completed and our beautification of Sea Terrace II marches forward.

We are so fortunate to reside in such a wonderful community, enjoying the clean air and the the ocean, "friendly beach people". The Sea Terrace II Board will attempt to keep you constantly informed as to decisions that directly affect Hopefully most of what surroundings. we do will please you. The Sea Terrace II Board is trying to reflect your wishes.

Recently we had controversial views on whether to retain eucalyptus trees in many front yards. These trees have needed to be severely trimmed each year to restrict yearly growth not to exceed the height of the houses. The alternative was to remove them entirely to be replaced with more suitable trees. Flame and Peppermint trees have been recommended.

The consensus of the Sea Terrace II Board was in favor of retaining the eucalyptus trees. We are going to try to trim them less severly to see if we can get by with one trim a year. If the regrowth is too profuse, we will have to revert to more severe trimming and accept the unsightly, scalped appearance of our trees until the regrowth appears.

We are also retaining the Alder trees in the greenbelt area behind Manta Court and plan to add a grove of trees in the greenbelt. The trees will be a mixture of Flame trees (deciduous) and Feppermint trees, or the like (non-deciduous), which should mature in three to five years. This will assure us of having lovely trees in our greenbelt in the eventuality of losing any other trees to natural demise.

We will be planting about seven Flame trees throughout our area in various front yards. We hope this will give all our residents an opportunity to become acquainted with a new look in trees in our area.

Phase I and II of our front yard planting is in progress. By the end of 1990 we hope to have 2/3 of our area planted. Ivy removal and planting of appropriate plants for both sun and shade areas are being processed.

The aim of our Board and the Landscaping Committee is to see Sea Terrace II beautiful. We are aiming for the same goal: to be happy living here and proud to be in Sea Terrace II.

Sea Terrace II residents will be pleased to learn that through the joint efforts of Kim Tate, Manager; Dick Wendt, Landscaper; and Ed Adams, Sea Terrace II, front yard maintenance costs will be reduced. A time-labor study proved that it would be possible to pare several thousand dollars from this budgeted item. The amount will be credited in next year's budget. Our sincere appreciation and thanks are offered to these three for such a note-worthy achievement.

It will soon be nominating time for members of the Board. Any interested parties please contact the Board by dropping a note at the front office. It will be forwarded to our Nominating Committee to be named shortly.

# 3137 Walls and Fences (01-18-89)

- A. Property line walls and fences shall be constructed of a material which is consistent with the design character of the residence. Chain link and grape stake fences are prohibited except as temporary fences during actual construction of another structure.
- B. Height and location of all fences shall be such that views are not obstructed. The general rule is that fences on the view portion of the lot may not exceed three feet in height, including any wind screen attached to top. Committee approval is required as set forth under preceding sections.
- C. Any addition to or replacement of an existing fence which changes the height, color, material or placement of the fence requires Committee approval.
- D. Sea Terrace Townehomes Association I (Tracts 7515, 6881, 6884) members may replace existing wood fences with same design or with slumpstone of specified color, material, size and height to conform to community standards on file at the Association office. All fences must conform with previous fencing regarding height and placement. Wrought iron is also an option for the original front fence only. Members are responsible for costs and Association and County permits, where applicable. The exception to the choice of wood or slumpstone is not applicable to rear fences adjacent to greenbelt areas. These fences are to remain wood.

# 3138 Driveways (01-04-89)

- A. Any change in original driveway must have approval of Committee.
- B. Asphalt or asphaltic concrete driveways are not permitted.
- C. Install the following across the front of the driveway by the sidewalk to take care of NSCA electrical and water lines. Pipes are to be extended one foot on both sides of driveway so connections can be made.

One 3/4" PVC electrical conduit One 3/4" PVC water pipe

# 3139 Roofs (11-07-90)

- A. Any change in type of roofing or deviation in color from the original requires the approval of the Committee.
- B. Roofing materials for pitched roofs:

Wood shingles, wood shakes, clay tile, concrete tile, concrete shakes, metal tile (e.g. Decra and Sierra or equivalent), supraslate (or equivalent) composites made of various mixtures including perlite, cement, wood fiber, etc. (e.g. Hardishake, Maxi-tile, Great Shakes or equivalent).

# C. Gravel

Gravel may be used on flat roofs only, and all flat roofs must have gravel on top for aesthetics. Color of gravel shall be submitted for approval to the Committee (no white gravel allowed). Generally color will be beige or brown. Gray may be approved when this goes best with house color.

D. Metal flashings and vents (pipes) to be painted to blend with house or roof (whichever is less noticeable).

# 3141 Front Yard Improvements in Sea Terrace I and 1I (02-21-90)

No improvements or changes of any kind, including structures (driveways and walkways) may be made in the front yard of any lot in Sea Terrace I (Tracts 7515, 6881, 6884) and Sea Terrace II (Tract 8602) without the prior written approval of the Architectural Control Committee (Committee).

- 1. Easements have been granted to the Niguel Shores Community Association for the maintenance of the entire front yard of each lot in these tracts. Any application for encroachment or improvement on these easements will require applicant's written agreement to waive the Committee's thirty (30) day approval or disapproval provision of the Covenants, Conditions and Restrictions (CC&Rs) and applicant shall agree to a sixty (60) day Architectural Control Committee review period.
- 2. All applications submitted under this section for improvement(s) will be reviewed by the board of Directors of the Sea Terrace Association in which the lot is located for their comments and recommendations. Their recommendations will be considered by the Architectural Control Committee prior to the Committee's final approval or disapproval of such an application.

# 3155 Mail Boxes (04-16-86)

Mail boxes shall be built into or attached to building walls or fences, with the specific location to be approved by the Committee, except in tracts 8602 (Sea Terrace II) and 9098 (Villas) where mail boxes must be on posts already provided.

# 3156 Service Yards (04-16-86)

All service yards and clothesline areas shall be enclosed or fenced in such a manner so that they will be reasonably obstructed from view of any adjacent lot or street.

# 3157 Signs (11-07-90)

Commercial signs and signs other than occupant identification, security, or street number are not permitted on private property with the following exceptions:

- 1. A member may display one sign advertising his or her residence for sale, lease, rental or exchange, or advertising directions to the residence, or on the real property of phother with that person's consent. The sign shall be no larger the 18"x 24", shall be done in a professional manner, and may be accompanied by one agent or informational rider no larger than 6"x 24". Realty signs shall be removed within five days following entry into escrow. No sign shall be permitted to remain because of a contingency. Notification of continued showing to be handled through normal realty channels.
- 2. A single sign by a construction firm placed in the front yard only during actual construction not to exceed 18"x 24" and/or safety signs and/or safety lights in any number and size as necessary to protect the community at construction sites.

# 3158 Projections Above Roofs (04-16-86)

No projections of any type shall be placed or permitted to remain above the roof of any residential building with the exception of chimneys, vent stacks and solar panels.

# 3171 Inspections (04-16-86)

The Committee and/or its consulting architect may inspect the property prior to the proposed construction and at times during construction as conditions may warrant and upon completion.

# 3172 Enforcement (04-16-86)

The Committee has the right to require correction and/or removal from the premises of any item within the jurisdiction of the Committee, which is in violation of the CC&Rs or these Regulations. The Committee will instruct the Manager to advise the property owner of violations and inform the owner of pending action.

# 3181 Architectural Fees and Deposits (01-04-89)

- A. For certain types of home improvements a consulting architect's fee is charged. The fee must be submitted with the application and is not refundable. The amount of this fee is listed on the current Architectural Fees and Construction Deposits Schedule (obtain a current schedule at office).
- B. The consulting architect may charge an additional fee upon approval of the application, depending upon the extent and complexity of the proposed improvements. This additional fee is not refundable.
- C. A construction deposit will be charged for certain types of construction (obtain current schedule at office). This construction deposit will be refunded upon presentation to the Association of written notification by the Committee of satisfactory completion in accordance with the approved plans and clean up of debris.
