

### NOVEMBER BOARD ACTIONS

- 1. Approved "Mission Statement" submitted by Tom Reath, Chairperson, and approved the committee's request to change its name from Refurbishment to Entrance Improvement.
- 2. Approved refinements to Rules 6505, 6512 and 6603 (copy attached).
- 3. Approved the 1993 NSCA Budget, Breakers Isle Extraordinary Budget, and Sea Terrace II Extraordinary Budget. These budgets were mailed out November 12.
- 4. Accepted audit and tax returns bid from James Zimmerman, CPA, for the 1992 fiscal year.
- 5. Authorized an additional expenditure of \$915.16 to complete the Tot Lot refurbishment in December.
- 6. Accepted the Traffic & Safety Committee's recommendation to change from Bonafide Security Service, Inc., to Westridge Security, Inc. Change to occur in January.
- 7. Accepted bid from M&K Masonry to tear out and replace stamped concrete in courtyard entrance to Multi-Purpose Room.
- 8. Adopted policy on how to handle parking passes for residents in Sea Terrace II and Villas who have parties. (See article in this issue.)

# SEA TERRACE II/VILLAS POLICY FOR PARTIES - GUEST PARKING PASSES

The issue of how management is to handle groups or parties at resident homes has been decided.

If you have a group of individuals, such as a bridge group, church group, etc., that regularly visits your home, come to the office during regular office hours to pick up additional parking passes just like the ones you received in the mail. The expiration will not occur until we change extended service passes; hence, they can be repeatedly used.

Residents who are going to have a party or a one-time function are asked to notify the office 72 hours in advance of the party date and inform the office as to how many vehicles are expected. Guest parking passes for that date will be made up for your use. Come to the office to pick them up prior to your function and be sure your guests put them on their dashboard.

Please keep in mind that all vehicles parked on common areas must have a valid decal or parking pass. Also, you can only pick up extra guest parking passes during regular office hours, Monday through Friday, 9 am to 5 pm, unless other arrangements are made in advance!

### "55 ALIVE" SENIOR DRIVING CLASS

Two "55 Alive" senior driving classes were held in November. Because the classes are limited to 30 people, a dozen or more interested residents were not able to get into a class. Consequently, arrangements have been made with AARP for another class on December 10 and 11.

Completion of the course entitles people to receive a discount up to 10 percent on some automobile insurance policies. ### CHANGES IN WEEKLY TRASH COLLECTION

Many of you are aware that the City of Dana Point has made changes in how trash is collected. The City must follow new State law AB939 which mandates all cities to reduce landfill disposal by 25%. To accomplish this, the City and Solag are going to start a recycling program. This new program is MANDATORY, not voluntary!

Beginning in January, Solag will deliver to each home a "black" container for trash and a "blue" container for recycling. following areas will receive two sixty qallon containers: Berkus, Broadmoor, Customs and Breakers Isle. The following areas will be receiving two thirty-five qallon containers: Garden and Shores Garden Homes, Sea Terrace I, Sea If the Terrace II and Villas. containers are not right for your situation, you may contact Solag thirty days after the initial delivery of bins to change sizes or obtain additional containers. Additional containers will add to your monthly cost.

The cover letter for the NSCA 1993 budget included a statement that the Association had removed your trash collection charges from the budget. Because of the complexity of the new program, it is no longer possible to assess each home equally. Starting January 1, 1993, Solag will be billing you directly.

The fees per month are as follows:

- (2) 60 gallon containers \$13.50
- (2) 35 gallon containers \$12.01

Residents must pay even if they do not use the service. A minimum fee of \$9.79 must be paid per month.

Solag will be using new automated pick-up equipment; hence the new containers. You must use only these containers and no others! All debris must be in the container. They will no longer pick up bags of trash, tied together landscape debris, trash in your own private containers, etc. Solag will mail the new rules to each home sometime in December.

The following items are to be put in the "blue" container: newspaper,\* cardboard, paper, junk mail/catalogs, magazines, phone books, glass bottles/jars, aluminum/tin cans, plastic containers and miscellaneous metals.

To aid in the disposal of large amounts of yard waste or bulky items, each resident may contact Solag two times per year for oncall pick-ups at no extra charge. Two bulky items, which must be manageable by a two-man crew, may be placed out for pick-up on your regular collection day. You must call Solag in advance to arrange pick-ups. Solag will come out more than two times per year, but there will be a charge.

Residents will still be expected to follow the association and City rules regarding trash pick-up. Container storage must be in a garage or behind a fence. Containers cannot be visible from the street.

Any questions you may have, after you receive information from Solag should be directed to Solag or the City of Dana Point. The NSCA office staff will not be able to answer on behalf of those entities.

As a helpful hint regarding your old standard trash barrels, you might think about using them for storage of earthquake preparedness materials.

### NIGUEL SHORES PAPER SALVAGE PROJECT

The new Dana Point recycling program to become effective here on January 1 should have no effect upon our own paper recycling operation.

There is no law or rule that forces you to deposit your paper in the Solag container. You may recycle the other materials as required, but continue to bring your paper to our recycle facility at our recreation center as you have in the past.

Our present buyer, Pacific Recycling Company, Inc., has agreed to a slightly higher buying price for all paper contributed by our residents, but they specify that magazines, junk mail and other forms of non-newspaper material be segregated from the so-called pure newspaper.

You may use paper bags or plastic bags, but no cartons. There are five large metal bins provided for newspapers and one bin right in front marked with a sign stating "For non-newspaper materials only." Simply place your contributed paper into the correct bin and that's the end of it.

To those of you who might find the bags too heavy to lift into the bins, just pile them on the floor in front of the bin and our maintenance men will place them in the bin for you.

In the 14 plus years since the recycling program began, we have recycled 2,925 tons of paper, saved innumerable numbers of trees from destruction, and helped the environment by reducing the amount of waste filling up our landfills.



### 6501 Permits-General (09-24-92)

- A. All permits issued prior to the effective date of these rules shall be valid for their stated duration. The following rules shall apply to the renewal of such permits and to the issuance of any new permits after the effective date.
- All owners and operators of all vehicles entering and using the common areas of Niquel Shores shall comply with the following permit requirements, except that these rules shall not apply to vehicles operated and owned (1) by public officers or entities when operated during the discharge or attempt to discharge any duty of such public office or entity, or (2) by licensed real estate salesmen and brokers when entering in conjunction with the sale, lease or rental of property within Niguel Shores (See REALTOR ENTRY and ENTRY OF PUBLIC OFFICER rules, Rules 6605 and 6606).

### 6502 Permits Required (09-24-92)

The owners and operators of all vehicles to be parked, maintained, used or operated upon property and streets within Niguel Shores shall obtain a valid entry permit for each such vehicle as herein provided. The issuance of an entry permit is subject to the owner's/operator's compliance with the conditions of issuance of the permit and these Vehicle Rules. Vehicles found on common area are subject to towing if a valid permit is not in plain sight. See Rule 6440.

### 6503 Permit Issue (09-24-92)

Except as otherwise provided, all permits will be issued only at the Administrative Office of NSCA (located at the Community Center) and shall not be issued by mail or telephone request.

### 6504 Permit Register (12-16-86)

- The management shall maintain a written record of permits issued (other than Visitor Day Permits) which is to be indexed by owner's last name and/or vehicle license number.
- B. The record shall contain the following information:
  - 1. Owner's application.
  - 2. Owner's first and last name, address, tract and lot
  - Type of vehicle (passenger vehicle, motorcycle, motor 3. truck, recreational vehicle, other).
    Make, model, year, color and license number of vehicle.
    Vehicle wheelbase dimension and vehicle height dimen-
  - 4.
  - 5. sion, if applicable.
  - 6. Date of issuance of permit.
  - 7. Expiration date or duration of validity of permit.

### 6505 Display of Permit (11-18-92)

A current and valid permit issued in accordance with Series 6500 and 6600 of these rules must be easily visible through the windshield from the outside of the vehicle at all times that the vehicle is parked or operated upon property or streets within Niguel Shores. See Rule 6440 for enforcement.

### 6511 Gate Access Package (09-24-92)

A gate access package consists of one vehicle decal/permit and one key card. Gate access packages are issued only to authorized persons and vehicles as provided below. A resident/property owner may have a maximum of six (6) packages, unless a different quantity is provided for below. If more than six (6) packages are desired, or other needs require them, a written appeal must be submitted to the Board of Directors, and approval given, before an excess package is issued by the office staff. Key cards will only be issued with a decal/permit. If a resident desires an extra key card, a written appeal must be submitted to the Board of Directors and approval granted. The vehicle that is to receive the decal must be brought to the office for a staff member to apply the decal.

### 6512 Permits-Authorized Persons (11-18-92)

### A. PROPERTY OWNERS:

A new owner must come to the office within fifteen (15) days of close of escrow to fill out forms and obtain gate access package(s). (Refer to Rule 2711 for fine).

To be eligible for a gate access package, an owner must be a licensed driver and provide a copy of his/her vehicle registration for verification of vehicle ownership. In addition, a current "Owners Information Declaration" must be on file with the NSCA Administrative Office. The property owner must sign the authorization form at the office before a gate access package is issued.

1. On-Site Property Owners may obtain one gate access package per licensed driver with vehicle, up to a maximum of six such packages. Family members/relatives who are not full-time residents may obtain a gate access package provided the owner is present and attests to the relationship.

### 2. Resident Owners whose property is RENTED:

- a. Owner: Maximum of two gate access packages.
- b. Agent Managed: No gate access package issued to agent. Owners and their agents must execute an NSCA Owner/Agent Agreement. (Forms are available at the Association Administrative Office.) The agreement is kept on file and a service pass is issued to the agent.

### B. <u>TENANTS</u> (Renters, Lessees):

Must come to the office within fifteen (15) days of date that tenancy begins to fill out forms, pay fees and obtain gate access package(s). (Refer to Rule 2711 for fine, which owner is responsible for).

To be eligible for a gate access package (one vehicle decal/permit and one key card), a person must be a resident on at least a monthly basis, a licensed driver, have a vehicle, and provide a copy of his/her vehicle registration for verification of vehicle ownership. In addition, a current "Tenant Information Declaration" and a copy of the tenant's rental or lease agreement (signed by both owner and tenant) must be on file with the NSCA office. The person who is listed on the lease must sign the authorization form at the office before a gate access package is issued.

- 1. Tenants who are residents and licensed drivers, may obtain a gate access package upon payment of a fee, half of which is refundable upon return of BOTH the vehicle decal and the key card. Family members/relatives who are not full-time residents may obtain a gate access package provided the tenant is present and attests to the relationship. TO FACILITATE REFUND, present deposit receipt when requesting refund. Vehicle decals may be renewed at no charge upon presentation of a copy of a renewed lease or rental agreement. Tenants are also limited to a maximum of six gate access packages (see Rule 6511).
- C. <u>Corporation/Partnership Ownership</u>. For purposes of these rules, the officers of a corporation and the general partners of a partnership who reside in a property owned by the corporation or partnership will be considered "property owners"; all other persons residing in such residences will be considered "tenants".
- D. Others. On a case-by-case basis, management may approve issuance of key cards to NSCA service invitees, such as newspaper distributors, cable TV firms, or others. A written request and deposit may be required by management.

### 6513 Transfers Prohibited (09-24-92)

Key cards and owner and tenant vehicle decals/permits are the property of NSCA and are not transferable to guests, friends, service contractors or other unauthorized persons or vehicles. Any unauthorized use may result in a fine; or withdrawal of key card or decal/permit use privileges temporarily or permanently, depending upon the circumstances and ruling of NSCA Board of Directors.

6514 Stolen, Lost or Damaged Gate Access Items (00-00-00)

Stolen or lost key cards or vehicle decals/permits will be replaced only upon proper execution of an NSCA "Loss Report Declaration", and payment of a NON-REFUNDABLE charge. Returned damaged key cards or decal/permits will be replaced free of charge, as long as the serial number is intact. See Rule 2714 for fee.

6515 Proof of Residence (12-16-86)

Proof of residence for issuance of gate access package may be required by NSCA as follows:

### A. Property Owners

- 1. <u>Current Owners</u>: Identification which corresponds with NSCA records (e.g., Driver's License).
- 2. New Owners: Copy of RECORDED grant deed, certified escrow closing statement, or other documentation satisfactory to NSCA.

### B. Tenants

- Identification (e.g., Driver's License).
- Copy of rental or lease agreement.

### 6516 Issuance of Gate Access Packages (09-24-92)

- A. Registration items will be issued in person only, during normal business hours Monday through Friday, or in case of extenuating circumstances, as approved by management.
- B. Registration items may be issued to NON-RESIDENT OWNERS by certified mail upon written request, approval by management, and completion of an updated "Owners Information Declaration", and receipt of a copy of vehicle registration, AND receipt of a SPECIAL HANDLING FEE of \$15.00. Registration items will be forwarded by certified mail to the address on record with the Association.
- C. Vehicle registration items requested on behalf of a minor (under the age of 18) will be issued only in person TO THE MI-NOR'S PARENT OR GUARDIAN.

- 6602 Conditions for Permit Issuance (12-16-86)
- A. All permits (except Visitor Day Permit) will be issued only on the following conditions:
  - 1. Upon application by the owner of the vehicle.
  - 2. NO PERMIT will be issued for any vehicle which has a wheelbase dimension exceeding 135 inches or a height dimension exceeding 80 inches. (Exceptions may apply on a case by case basis only upon prior approval of management and for the specific purposes of emergency vehicle repairs, or where the motor vehicle is used in the temporary construction or maintenance of any improvements to a residential lot or common area.)
  - 3. To all passenger vehicles, except passenger vehicles which are also recreational vehicles which are provided for in subparagraph 4 below.
  - 4. Subject to the limitations set forth in Section 6517: AUTHORIZED VEHICLES above, to passenger vehicles which are also recreational vehicles if primarily used, designed, and maintained in the day-to-day transportation of persons.
  - 5. To all vehicles other than passenger vehicles and recreational vehicles only upon the following terms and conditions:
    - a. On a "Service Permit" basis only; and for the specific purposes of emergency vehicle repairs or where the vehicle is used in the temporary construction or maintenance of any improvements to a residential lot or common area; or
    - b. For the same day pick-up and/or delivery of property or persons.
- B. <u>Duration of Permit</u>. Permits shall be valid only for their stated duration. <u>Upon expiration of the term of any permit</u>, a new permit may be issued upon re-application. Expired permits must be returned to NSCA management prior to issuance of a new permit.

The Guest Parking Permit is issued to verified resident members and tenants of the Villas and Sea Terrace II, for use by their guests. These parking permits are good for entry to the entire community and beach parking lot. Two permits per residence are allowed with no initial deposit required. An owner who has leased his property to a tenant may not obtain a Guest Parking Permit. The Guest Parking Permit is to be maintained by the resident member or tenant to whom the permit is issued and registered. The resident member or tenant is totally responsible for the permit's proper use, maintenance and return. This is considered a security item. If not returned to NSCA, a charge of \$50.00 per permit will be sought. If a deposit is on file, then it will be forfeited. Should the Guest Parking Permit be lost, stolen or destroyed, a replacement Guest Parking Permit will require a deposit. (See Rule 2714). Deposits are non-transferable.

Residents in this area will periodically received by mail special guest parking permits that are only good for this area of the community. The permites cannot be used to enter the main portion of the community or for beach lot parking. They will have an expiration ate and visitors must use them to park on the common area or the vehicles will be subject to towing!

### 6604 "No Call" List (12-16-86)

- A. Resident Property Owners and Tenants may authorize admittance of regular visitors without prior call to the guard at the main gate by submitting written authorization to the Association office on the "Visitor No Call List".
- B. A maximum of four such authorizations shall be permitted for each property address at any one time.
- C. Revisions to the Visitor No Call List shall <u>cancel</u> all previous authorizations.
- D. Authorizations must be signed by the OWNER OF RECORD OR TENANT.
- E. Visitors on the Visitor No Call List will be issued a Visitor Day Permit by the guard which shall be displayed in the vehicle while in the community.
- F. RESIDENTS SHALL NOT BE PERMITTED ENTRY BY "NO CALL" AUTHORIZATION. Admittance of owners and tenants shall be in conformance with these rules.
- G. A visitor's "No Call" status may be denied or revoked, at the discretion of management, for the visitor's failure to comply with the CC&Rs and/or the Association's Rules, including, without limitation, these Vehicle Rules.
