Recently I have heard the comment that The Niguel Shores Community, in many respects, operates as a small city. It is also said we function as a democracy. Having said this, I would like to explore this metaphor briefly.

Four other members of the NSCA Board of Directors and I have been elected at large, usually for two year terms, which begin on alternate years for some of us. For example, next year three positions of the Board will be available for nomination and election of candidates. So, in a sense, Board members can be said to serve as city council members. The Association employs a General Manager (city manager), and a staff of office and maintenance personnel. In addition certain continuing contractual services are provided, e.g., at Mariner Gate and patrol vehicle-control, landscaping, and legal services.

The Board meets twice monthly to decide on necessary business matters which include authorization for new expenditures. In addition, approval of contracts, policy decisions, suggestions/complaints referred to the Board for resolution, short/long term planning, policy development, legal matters, etc. The time spent in these monthly meetings, just while in session, usually totals eight hours. None of the Board members' time is compensated.

The committee also assists the Board of Directors in the preparation of the Association's Annual Budget.

The Landscape Committee's members reside in and represent each of the eight larger areas of the Community. They are responsible for ongoing attention to the needs of their respective areas and conferring with the residents about their landscaping concerns. The committee works with the General Manager and the Landscape Contractor in the development of specific landscape plans.

The business and other approved activities of the Association are greatly facilitated by the participation of approximately 60 very dedicated members of the Association, who serve in the following eight standing committees:

The Architectural Committee which considers approval of homeowner proposals for the modification of the exterior of their properties. The Communications Committee which edits and circulates the NSCA monthly newsletter the SEASHORE NEWS.

The Finance Committee which advises the Association's Chief Financial Officer on financial investments.

The Maintenance Committee's members, because of their expertise, advise the General Manager and the maintenance personnel regarding projects that need attention in the Community Center and in the Association's They also recommend common areas. methods/techniques that can be used.

The Recreation Committee advises the General Manager and the Board regarding recreational facilities, activities and programs some of which activities are sponsored directly by the committee.

The Traffic and Safety Committee is concerned with a wide variety of matters, that may affect the welfare of the residents of the Community, related to traffic and safety. The Committee works closely with the General Manager and the Gate and Vehicle Control Services Contractor.

Finally, in alphabetical order, the Tree View Blockage Committee assists in the correction of verified tree view blockage complaints related to private property and makes recommendations to the Board regarding complaints about trees in common areas within the Community.

The Architectural and Tree View Blockage Committees meet twice each month. All of the other committees meet once monthly.

I believe it is clear that the business of our Association, is dependant upon the thousands of uncompensated hours of service that these committee members expend. The members of our volunteer "city government" deserve respect and our thanks.

The Community Center has been used by residents for over twenty years. Beginning this month, necessary repair/replacement work will begin. Many projects will occur over the next four to six months.


On behalf of the Board of Directors, Maintenance Committee and staff, we ask for your understanding and cooperation while this work proceeds. Below is a list of work and when it may begin:

- Both the office and MPR will be reroofed. Work to begin 11/27 and should be completed by 12/8.
- The posts supporting the patio roof within the Community replaced. Center will be Additional structural work will also be completed. Once this work is done, the flat roof will be extended to the end of the joists. Work should start in December and be completed by January.
- Once the above is complete, the Community Center will be repainted. This work will most likely start in January February.

The Board is also looking at its options for improvements to the locker rooms. Depending on costs, remodeling the restrooms is a high priority. It is the hope of the Board and staff that all work will be completed before next summer.

Homeowners and residents should keep the above hours in mind if you need assistance from the full-time Administrative staff. The office clerks who work weekends and when the office is closed cannot help with vehicle decals, special entry permits for guests, etc.



RESIDENTS/HOMEOWNERS ARE ADVISED GARAGE FOR **PARKING** VEHICLES, NOT STORING POSSESSIONS

It has become evident through observation of open garages that many residents/homeowners are using their garage for storing possessions, not their vehicles. It is the Board of Directors' position that every resident/homeowner is to use their garage and driveway for parking of vehicles. Rule 6405 states:

> Visitor parking spaces in the common areas shall not be used for overnight parking of resident/homeowner vehicles except when the number of vehicles owned by a resident/homeowner and properly registered...is such that no additional vehicles could be parked in the resident's garage or driveway...then such vehicles may be parked in visitor parking spaces or on the street.

The Board has directed management to see that the patrol service begin citing vehicles with decals using common area parking or street spaces for overnight parking. Those found to be in violation will be issued a warning letter and after a second violation a hearing letter will be The Board will then determine at the hearing whether a fine should be issued that will range from \$25 to \$50. A third violation may result in a fine between \$25 to \$100.

For those that have more than two vehicles, you should begin to clean out your garage or see that all vehicles can park on your driveway.

Your cooperation will be appreciated by the Board and your neighbors.

LANDSCAPE COMMITTEE UPDATE

Wendt Landscape has begun the turf dethatch They will be doing all Association work. common areas, along with the front yards in Sea Terrace II. Please be patient while the turf "greens up." Fertilizer will be applied within several weeks of the completion of this work.

In 1994, all the front yards in Sea Terrace I were completed. These front yards will be done again in 1997.

Wendt has also begun the yearly trimming of trees under twenty feet. His crews will also trim all the coral trees. This work will most likely be finished before Christmas.

Winter color plants are currently being installed. It is our hope that the English Primrose will last until April. Christmas holiday season, Wendt Landscape will again donate Poinsettias for many common These plants should be installed by December 15.

A problem has arisen with the geraniums along Atlantic Dr., near the Selva gate. Many have begun to die because of fungi. The lab reports that even if the area is treated with chemicals, the fungi will return. Staff has decided not to replant with geraniums. Wendt Landscape will install additional Agapanthus to fill out these areas. The problems in these areas are made worst by underground water and irrigation runoff from the turf. It is expected that the additional plantings will occur in early December.

During December, several new projects will be completed, through savings in the 1995 Landscape budget:

> • At the intersection of Stonehill and Niguel Rd., new shrubs to be added to this area. Several trees may also be included.

- At the intersection of Niguel Shores Dr. and Leeward, the remaining corner on the Sea Terrace I side will have turf removed and new plantings installed to closely match the Berkus side.
- Additional plum trees to be added to turf area in front of Community Center parking lot. Shrubs will be used to screen off power box in same area.

MARINER GATE DECAL LANE IS ONLY FOR THOSE WITH HOMEOWNER/ RESIDENT DECALS

It has been noticed by the Mariner Gate personnel and management that visitors with guest passes or special entry permits are using the residents decal lane for entry. Please advise your guests that they cannot use this lane for entry.

The sentry must look at the guest pass or special entry permit to verify whether it is valid. Some guests and homeowners have complained at the office that they or their guests should not have to wait at the gate if they already have a pass. However, they are not homeowners/ residents and must go through the guest lane. It is impossible for the sentry to read the pass from eight to ten feet away.

Homeowners/residents are asked to cooperate and advise their visitors of this policy.

STREET SWEEPING SCHEDULE

The scheduled date for street sweeping this month is Monday, December 4. requested to have your vehicles off the streets and out of the parking bays. This will allow the sweeper to do a better job.

NOVEMBER BOARD ACTIONS

- 1. Accepted donation of El Camino Real "bell" from Dale Baltimore. Bell will be installed on turf area between office and pool.
- 2. Set the NSCA 1996 budget at \$1,574,400. Quarterly assessment per home \$410. Staff has mailed to all homeowners a copy of the adopted budget.
- 3. Set the 1996 Sea Terrace II Extraordinary Landscape Assessment at \$15,160. Set the 1996 Breakers Isle Extraordinary Assessment at \$7,769. Staff has mailed a copy of these budgets to the affected homeowners.
- 4. Formally reviewed and accepted the 1996 reserve study completed by Reserve Data Analysis.
- 5. Decided to continue using a bypass code at the Garibaldi and Manta gates. Staff is to change the code every three months.
- 6. Decided to open the pool area at 6:30 am every morning, beginning January 3, 1996.
- 7. Appointed Alice and George Freundlich to Recreation Committee.
- 8. Accepted bid from Converse Consultants to perform yearly visual slope survey. Cost approximately \$4,500.


