# FROM THE HELM

First things first. We're already into the holiday season, and on behalf of the other members of the Board, I wish you the joys of the holidays. It's a time to reflect on how fortunate we are to live in a beautiful location and be surrounded by nice neighbors.

Now for a couple of mundane matters. I've had some questions about the arrangements we make with the instructors who come to the community to give lessons of various types. In each case we require the instructor to sign an agreement that the Association will not be held liable for any mishap that may occur in any connection with that instructor's activity. This includes the time when the participants are going to and from the activity. The Board is very careful to try to protect all of us - members of the Association from potential lawsuits. If the Association is sued, we are all sued, because our quarterly assessments ultimately pay for it - insurance, legal service, or a settlement or award. We treat all the instructors alike in requiring each of them to sign the agreement drawn up by our attorney.

There's another serious matter that you'll be hearing more about in the next couple of months. Roofs.

We've talked about this subject before, but somehow we've failed to get the message to everyone. Each of our homes is getting to the point when we'll need to do roofing repair or replacement. In every case, you need to have a building permit from the City of Dana Point and you need to have the approval of the Association's Architectural Control Committee. Next month we hope to include in the Seashore News

a flyer that will give you step-by-step information on how to obtain the permit and the approval. In the meantime, because we've had a number of cases where approvals were not obtained ahead of time, the Board has decided to charge the offending homeowner a \$100 fine. This is effective December 1, 1997.

If you are going to do work on your roof, come to the office and get an Architectural Committee Exterior Modification Submittal form. The process is not difficult to follow.

Last, there have been incidents of vehicle vandalism to the green belts. Residents who can provide identification of the individuals involved, or vehicle descriptions can be eligible for a monetary reward. Contact either our roving patrol or the office with relevant information. Happy Holidays.

# LANDSCAPE COMMITTEE UPDATE



The Board has accepted Dick Wendt's bid to implement the Landscape Committee's plan to address the problem of the large eucalyptus trees along Pacific Coast Highway. Starting in December,

some of the trees will be removed and the remaining trees trimmed. The Landscape Committee has worked a long time developing a plan they believe balances the requests on both sides of the issue, those that want all the trees cut down because of view blockage and those that want to keep the trees natural.

Most of the work will be done in December with some of the very tall eucalyptus trees being trimmed in January.



# BOARD ACTIONS FOR NOVEMBER

✓ Authorized staff to have Wendt Landscape install boulders at the end of Flying Jib to prevent vehicles from driving on the green belt. An additional boulder will be installed on the upward slope side of the beach lot access gates to prevent vehicles from going around the gates after hours.

✓ Accepted bids from Full Power Electric to install a new electrical pedestal near the beach bluff and to replace four existing electrical pedestals at a cost of \$2,750.

✓ Appointed Bob Converse to be the Chairperson of the Nominating Committee.

✓ Accepted staff recommendation for holiday office hours.

✓ Denied the request for a late charge to be waived because the homeowner did not provide extraordinary circumstances as to why the assessment was not paid.

✓ Authorized staff to expend \$495 to improve the capabilities of the property management software used in the office.

✓ Authorized staff to expend \$610 to purchase two new 3'x3' display cases to be installed at the Garibaldi and Manta gates to display Association posters.

✓ Denied homeowner's request to be reimbursed for sewer line blockage because evidence was not presented that the Association's maintained landscape was responsible for the problem.

✓ Accepted the bid from Roy Allen Slurry Seal to install road slurry over most of the streets within Niguel Shores at a cost of \$61,280. The work will be done in January.

✓ Appointed Laura Ranks to the Communication Committee.

✓ Authorized staff to hire another After-School Recreation Director.

✓ Accepted the bid from Gary Porter, CPA, to perform the 1997 audit of the Association's financial records and prepare the tax returns at a cost of \$2,875.

✓ Authorized staff to reimburse 50% of the costs for auto damage a homeowner's guest suffered at the Breakers Isle gate.

✓ Authorized staff to negotiate the final payment due Oliver-Mahon Asphalt, Inc. for extra work completed, but not included in the contract for the asphalt overlay in the Villas/Sea Terrace II. The matter was settled at a cost of \$8,950.

✓ Accepted the bid from Wendt Landscape Services to remove and trim large eucalyptus trees at a cost of \$6,575. These are trees along several sections of Pacific Coast Highway.

✓ Approved change to Rule 2711, and authorized a \$100 fine for violation of Rule 3139 - Roofs, effective December 1, 1997.

An architect is in the process of completing a rebuilding plan for the gate renovation which will be reviewed with the Board on Once the Board has had the December 10th. opportunity to see the plan, any changes will be made and the final plan posted at the Community Center for all homeowners in the community to review and comment upon.

It is expected that staff will be able to post the plan sometime after December 17th. Written comments can be submitted to the office through January 16, All written comments received will be provided to the Board of Directors for their January 21, 1998 meeting.

#### ROAD SLURRY WORK TO OCCUR IN JANUARY

The Board has accepted the bid from Roy Allen Slurry Seal to install a coating of road slurry throughout most of the Association's streets. This work should begin in early January and will take approximately two weeks to complete. This is work the Association schedules approximately every five years to extend the life of the asphalt roads. A separate letter will be sent out to all residents providing a time frame as to when their street is scheduled for this work.

Not all streets will be affected. The Association will not be covering the streets in Broadmoor Homes and Atlantic Garden Homes. These areas will be receiving an asphalt overlay in the summer of 1998. Also, we will not be installing the road slurry on the streets in the Villas/Sea Terrace II because they recently received an asphalt overlay. This area of the community will be addressed in the fall of 1998.

When the work occurs, each street will be closed for 24 hours. Residents will have to park overnight along streets that have already been sealed, or have not yet been sealed, and walk to their homes. The weather will be a very big factor as this work progresses and may cause changes to the schedule. Our staff will make every effort to get notices out to residents involving changes to the schedule by hanging them on front doors. To make this extensive project as smooth as possible, the Association greatly appreciates the residents' cooperation.

One reminder must be stressed. When driving on the newly laid road slurry, for approximately one week residents must have their vehicle in motion while turning the steering wheel. Sitting still and turning the wheel of the vehicle will cause a condition referred to as "dishing." In 1991, the last time the roads where covered with road slurry, many residents complained that there was something wrong with the product because of the marks/peeling of the new surface under vehicle tires. An expert came out and said the product was laid correctly; the problem was the fault of the drivers. Again, it is very important to be in motion while turning the vehicle.

# TRAFFIC & SAFETY COMMITTEE REPORT

- 1. A report from the Board indicated the plan for the Mariner gate renovation is on hold until the survey and deed for Mariner Drive is obtained from the City.
- 2. We are in the process of counting vehicles at the gates in the community. The Selva gate will be next.
- 3. There is a current Access Control Manual in effect. It is requested that every Committee member have a copy so we will all be familiar with the rules.
- 4. Various items of safety and security were noted for improvement:
- a. A vehicle was witnessed going through the exit at Selva gate without tire damage. It was recommended this be corrected.
- b. A panel of wrought iron gates for the Stonehill Drive entrance needs to be secured. The chain should remain in place.
- c.. Cars have been driving on the grass from the Flying Jib cul-de-sac to Crossjack. It is recommended that boulders be installed to prevent this. This has been approved by the Board.
- d. The City of Dana Point will give us the Neighborhood Watch newsletter to add to the Seashore News. Please read the copy attached to this issue.
- 5. The Committee will review the procedures for party guest lists. Anyone with suggestions for this policy, or with complaints about the current process, is invited to call Marion Evans, 661-3248, who will take all suggestions.

#### December 16


