BOARD ACTIONS FOR FEBRUARY

- ✓ At the request of Jerry Moon, Chairperson of Traffic Safety Committee, accepted resignations from Sharon Stewart and Myron Miller. Then, appointed Marion Evans and Larry Coffing to the Traffic & Safety Committee.
- ✓ At the request of John Dickerhoff, Chairperson of the Communication Committee, accepted resignation of Terry Scott and appointed Grace Densmore to the Communication Committee.
- ✓ Upon request of resident, agreed to waive \$25 fee for replacement of kevcard/vehicle decal because the resident's vehicle was stolen.
- ✓ Authorized Don Ellis to work with a draftsman, at a cost of approximately \$200, to complete construction drawing for additional renovations to the Community Center locker rooms. Once completed. staff is to post the drawing in the office for any interested homeowners to view. This should occur in early March.
- ✓ Authorized staff to reimburse a homeowner up to \$1,200 for repairs to his rear yard wall. The damage is from minor slope movement. The Board turned down the homeowner's request to completely replace the wall.
- ✓ Denied request from a visitor for reimbursement for tire damage suffered at the Breakers Isle entry gate because gate malfunction could not be determined by staff.

- ✓ Authorized staff to reimburse several residents and a guest for tire damage suffered at the Garibaldi gate because the maintenance staff confirmed a malfunction of the gate.
- ✓ Authorized staff to reimburse a homeowner for damage to vehicle suffered at the Mariner gate when gate arm was accidentally dropped on top of the vehicle, as verified by the sentry.
- ✓ Authorized the General Manager to attend the Spring conference for CAI.
- ✓ Authorized staff to have Dale Hadfield. ASLA, work with the Landscape Committee on a plan for landscape renovations involving the property along Cabrillo Isle/Seaward Isle that is between NSCA and the hotel. Cost for this work will be \$600 and will be split with the hotel. Also authorized staff to have California Civil, Inc. create a drawing showing the property line between the hotel and NSCA, as it relates to our sidewalks/streets and the hotel's wall. Cost for this work will be \$445 and may be split with the hotel.
- ✓ Accepted the Recreation Committee's schedule of events for 1997.
- ✓ Authorized staff to purchase another concrete trash container for the beach bluff. This will replace the last one that was vandalized/destroyed. Cost will be approximately \$600.
- ✓ Agreed to a contract, drafted by the Board's legal counsel, with Trend Construction for the renovation of the Garibaldi/Manta gates at a cost of \$87,775. Trend was selected after review of four written bids and in consultation with Lynn Muir, AIA.

✓ Authorized staff to have Converse Consultants complete their yearly visual survey of the slopes NSCA is responsible for, along with reading ground water wells. Cost for this work will be approximately \$5,700.

✓ Authorized staff to reimburse a homeowner for driveway replacement because of damage caused by tree roots from a tree within a landscape easement area. The Association is responsible for the tree.

✓ After reviewing two bids, accepted the bid from A&M Pool Plastering for repairs to a leaking return line to the spa and its replastering. Total cost for the work will be \$3,100.

✓ Accepted Bob Theel's resignation as Chairperson of the Landscape Committee and representative for the Atlantic Garden Homes. Appointed Janet MacKaig as the new Chairperson of the Landscape Committee.

LANDSCAPE REPRESENTATIVE NEEDED FOR ATLANTIC GARDEN HOMES

Bob Theel, who has been the Landscape Committee representative for the Atlantic Garden Homes, has resigned from the Committee. Bob informed the Board of Directors that business commitments will keep his available time very limited. The Board of Directors and the members of the Landscape Committee greatly appreciate the time and efforts made by Bob over the last three years.

Anyone living in the Atlantic Garden Homes may submit name, address and background to the Landscape

Committee for consideration. All materials received by the NSCA office will be provided to the Committee. They will review the material submitted and make the decision as to who is the best candidate to recommend to the Board of Directors.

Members of the Landscape Committee work with Dick Wendt & Raul Gomez [landscape contractor], NSCA staff and homeowners on landscape problems and landscape improvements involving their area of the community. Questions can be answered by any of the current Landscape Committee members.

Interested individuals should submit the requested material by March 6 so that the Committee can review it at the March 10 meeting.

LANDSCAPE PROJECTS FOR MARCH

During March, Wendt Landscape will be trimming all of the Raphiolepsis [known as pink lady] shrubs throughout the community. We have over a thousand of the plants and it will take the crews some time to get to all of them. These shrubs are trimmed once per year and we want to wait until after the current bloom cycle is complete. The shrubs currently have many "pink" blooms. Most of the shrubs will be thinned out and reduced in size.

The following projects will occur in March:

> Custom Homes - there will be an additional five Bronze Loquat trees added to the upslope side of Cabrillo Isle, near Breakers Isle entry.

> Atlantic Garden Homes - along Atlantic Dr., thirteen Tipuana Tipu trees will be added where there is open space in turf areas.

<u>Sea Terrace I</u> - the turf in the front yards and common areas will be dethatched. This is done every three years. Improvements will be made in and around the two seating areas on each end of Halyard Dr.

<u>Sea Terrace II</u> - twenty Oleander shrubs will be added to the slope below Gourami Bay along and near Manta park.

Shores Garden Homes Mercator Isle, six Tipuana Tipu trees will be installed along the upslope. On Nauticus Isle three Ficus Rubiginosa trees will be removed. These trees are along the upslope in the middle of the street. Once removed seventeen Tipuana Tipu trees will be installed along the upslope, along with several Flax shrubs. Along the south side of Niguel Shores Dr., from Ports O'Call to Mercator Isle the ivy will be removed on the slope, then Myoporium Pacificum and Flax will be planted. In this area where there are several heavy wet spots from underground water, river rock will be used to mask the areas.

For those areas that are going to receive new Tipuana Tipu trees, the installations may be delayed because adequate size trees are difficult to find. Dick Wendt has spent several weeks calling tree suppliers and has been unable to locate decent 15 gallon size trees.

COMMUNITY CENTER LANDSCAPE TO BE RENOVATED

The Landscape Committee is in the process of making decisions on

improvements to the landscape in and around the parking lot. Currently, the turf between the parking lot and sidewalk will be removed along with the topiary dolphin. replanted with area will The be Rhaphiolepis, dwarf Flax and Gazania. Several Plum trees and a New Zealand Christmas tree will also be added. A new community center sign may be ordered and installed in front of the utility boxes to further mask them. A large area will be left open for the possible installation of the dolphin statue that is currently under consideration. Once installed. Landscape Committee will use annual color plantings to enhance the statue.

On the tennis court side of the parking lot, the eucalyptus trees will be removed and four New Zealand Christmas trees installed. The area around the current location of the community center sign will be completely changed. A concrete mowing edge will be installed to shape the new planting area. The area will be improved using Rhaphiolepis, dwarf Flax, Gazania, Day Lilies and Agapanthus.

On the exit side of the parking lot, around the Coral trees, the turf will be removed and a concrete mowing edge installed. The area will be improved using Rhaphiolepis, Gazania and Flax.

At this time, the final plan has to be accepted by the Landscape Committee, then forwarded on to the Board for review and approval. It is possible the new plan will be implemented in early April.

FURTHER INTERIOR CHANGES/ADDITIONS

The Board is in the process of considering additions, such as dressing screens in each dressing room and the installation of new sinks and counter in the women's restroom, to address several

homeowner's concerns. By the time this issue is delivered to residents, interested individuals can view the drawing that will be used for bidding purposes. The drawing will be mounted on the office window, facing the pool. Written comments may be submitted to the office for transmittal to the Board. Please submit all written comments by Wednesday, March 12.

STATUS OF ASPHALT REPAIRS FOR VILLAS & SEA TERRACE II

Many residents are aware that the Board hired a pavement engineering firm, LaBelle Marvin, to evaluate the condition of the streets and make recommendations on repairs. The Board has received the report and met with the engineer to discuss his recommendations.

The Board has directed staff to work with the engineer to modify the bid specifications that will be used for competitive bids. This work should be completed by mid-March so that bids can then be sought. At this point, the actual repairs may not occur until May or June.

CONTRACTOR CHOSEN FOR **GARIBALDI AND MANTA** GATE RENOVATIONS

The Board has chosen Trend Construction to complete the long planned gate renovation projects. Trend was chosen from four general contractors that Lynn Muir, AIA, found to submit written bids. The bids were based on material and drawings Lynn Muir put together. The contract that was used was drafted by the Board's legal counsel.

specific Once information is received from the contractor, a letter will be sent to all residents within the Villas and Sea Terrace II advising them of items they should be aware of. At this time, the con tract calls for work to start on Monday, March 3 and be completed by Friday, April 18. Both gates will be worked on at the same time. The existing gates will continue to be used as long as possible. However, there will be a period of time when nothing will prevent outsiders from entering.

All residents are advised to watch for directions from the contractor's personnel regarding entry and exit. At various times during the renovations, one side or the other will be closed.

RESOLUTION OF THE **BOARD REGARDING** SATELLITE DISH INSTALLATION ATTACHED TO THIS ISSUE



Attached to this issue of the Seashore News is a copy of the resolution adopted by the Board on February 5 dealing with the installation of satellite dishes or television antennas. Any homeowner desiring to install a dish MUST read this resolution and make a submittal to the Architectural Committee prior to installation. Architectural Committee will use this resolution as part of the review process.

Under the FCC rule, the Association must allow the installation of a satellite dish that is one meter (approximately 39 inches) or less in size, if the installation site is allowed under the FCC rule. A homeowner that wants to install one of the "large" satellite dishes, which does not fall under the FCC rule, may not be able to because the Architectural Committee can turn down the homeowner's submittal.

At a later date, this resolution will be incorporated into the NSCA Architectural Regulations and Guidelines. Please put this resolution with your copy of the NSCA Rules and Regulations.



THE SHORES BLOTTER

SECURTEC regularly submits weekly reports of any incidents that have occurred as they make their patrol of the Shores. There were not any major incidents of crime between January 24 and February 15. However, the following were reported:

- 1) Several incidents of a portable basketball backboard being left on the driveway. It is important for homeowners to know this is in violation of the CC&Rs.
- 2) Two incidents of vandalism where a driver rode onto the grass on the south side of Windward; between Halyard and Crossjack; and just above the curve of Marlinspike and Windward. These areas need to be repaired by the landscaping contractor at a cost to the Association. Homeowners are asked to report anything of this nature with the license plate number, if possible.
- Two boys violated the rules on bicycles in the Office and Community Center area; they were rude and used obscene language and gestures when confronted by patrol. The sheriff was called and Association Management was notified.

TRAFFIC AND SAFETY COMMITTEE REPORT

Work of the Committee

1) We are proceeding with the investigation of cost for a new fence and gate in the beach parking area leading to the beach. Bids are being obtained for the work which we hope to have completed before the

summer. We are looking at a card entry system to the beach area and welcome comments from residents of the Shores. Positive feedback was received at the open meeting in regard to the lighting of the beach parking area. This has been put on hold.

- 2) Horizontal bars are to be installed in the storm drains at the bluff area to avoid safety hazards.
- The committee recommended that patrol hours of SECURTEC be increased on Fridays only.

SPA TO BE CLOSED FOR REPAIRS

The Board of Directors has accepted the bid from A&M Pool Plastering for necessary work on the Community Center's spa. Signs will be posted at the Community Center when the specific time period the spa will be closed. At this point, it is estimated the spa will be closed for a two-week period.

The contractor will be doing the following work:

- 1) The concrete deck next to the spa will be opened to repair a leaking return line and the deck repaired.
- 2) The plaster and tile will be completely removed.
- 3) New blue tile and three coats of plaster will be installed.

NIGUEL SHORES COMMUNITY ASSOCIATION RESOLUTION OF THE BOARD OF DIRECTORS RELATING TO THE INSTALLATION OF EXTERIOR ANTENNAS

WHEREAS, Article IX, Section 5 of the Declaration of Establishment of Protective Covenants, Conditions and Restrictions for Niguel Shores Community Association (the "CC&R's") provides, in relevant part, that "No outside television or radio pole or antenna or other electronic device shall be constructed, erected or maintained on any building or on any property within Niguel Shores or connected in such a manner as to be visible from the outside of any such building."; and

WHEREAS, on August 5, 1996, the Federal Communications Commission ("FCC") adopted a rule regarding, among other things, the Association's ability to restrict antenna placement on the individually owned lots and homes;

WHEREAS, with respect to those types of antennas to which the FCC rule is not applicable, Civil Code Section 1376 permits the Association to continue to prohibit certain types of antennas as provided in that Section; and

WHEREAS, the FCC rule and Civil Code Section 1376 do not limit or restrict the Association's ability to continue to prohibit amateur radio, citizens band radio, or most other types of receiving or transmitting antennas within the development.

NOW, THEREFORE, be it resolved, that the Association hereby adopts the following architectural guidelines and policy related to the installation of antennas:

A. Statement of Intent.

This Rule serves three purposes:

- 1. To allow for the installation of outside antennas that can not been seen from another lot or home, or from the Common Area, provided prior architectural approval is obtained;
- 2. To prohibit all outside antennas that can be seen from another lot or home, or from the Common Area, with the exception of certain types of television antennas protected by new FCC Regulations; and
- 3. To implement reasonable regulations concerning the approval and installation of visible television antennas designed to receive television broadcast signals over-the-air, and visible satellite dish receiving antennas and visible microwave cable receiving antennas, with a diameter or diagonal measurement of one meter or less.

B. Definitions.

- 1. The term "Concealed Antenna" means an exterior television or radio pole or antenna or other electronic device installed in such a manner such that:
 - a. the antenna or device is not visible from another lot or home, or from the Common Area; and
 - construction materials specifically designed to hide the antenna or other device are not visible from another lot or home, or from the Common Area.

For example, a small satellite dish installed in a corner of a fenced patio area on ground level so that it can not be seen from another lot or home, or from the Common Area, is a Concealed Antenna. However, a small satellite dish affixed to the top of a fence so that the dish can be seen from another lot or home, or from the Common Area, is not a Concealed Antenna. A small dish screened by construction materials, such as lattice work, so that the lattice can be seen from another lot or home, or from the Common Area, is not a Concealed Antenna.

- The term "Visible Antenna" means an exterior television or radio pole or antenna or other electronic device installed in such a manner so as to be visible from another lot or home, or from the Common Area.
 - 3. The term "Allowable Antenna" means:
 - a. a Concealed Antenna; or
 - b. a Visible Antenna which is a television antenna designed to receive television broadcast signals over-the-air; or
 - c. a Visible Antenna which is a satellite dish receiving antenna or a microwave cable receiving antenna, with a diameter or diagonal measurement of one meter or less.
- 4. The term "Prohibited Antennas" means all antennas which are not Allowable Antennas.

C. Antenna Policy.

- 1. The only type of antenna permitted within the community, subject to the limitations provided below, are Allowable Antennas.
- 2. Prohibited Antennas are not permitted anywhere on a lot, on a home, or on the common area within Niguel Shores.

- 3. Allowable Antennas may only be installed on property which the lot owner has the exclusive right to use. A lot owner may not install an Allowable Antenna on common area.
- 4. The Association may regulate placement or indicate a preference for installations of:
 - (a) a Visible Antenna which is a television antenna designed to receive television broadcast signals over-the-air; and
 - (b) a Visible Antenna which is a satellite dish receiving antenna or a microwave cable receiving antenna, with a diameter or diagonal measurement of one meter or less.

as long as the placement does not unreasonably increase the cost of the installation, or render reception impossible or substantially degraded. In accordance with the FCC rule, the Association may require reasonable screening or painting of an Allowable Antenna as part of the approval process. The Association's Architectural Control Committee may, from time to time, adopt rules or guidelines in accordance with this policy.

5. Prior to installing an Allowable Antenna, the owner shall request and obtain architectural approval from the Architectural Control Committee. Regardless of any provisions within the Association's CC&R's, Rules or Architectural Regulations and Guidelines to the contrary, the Architectural Control Committee shall approve or deny a request to install an Allowable Antenna within twenty-one (21) days following the submission of an application to the Architectural Control Committee.
