### FROM THE HELM

Have you returned your ballot concerning the proposed amendment to the by-laws?

- If you are an <u>owner</u> of property in the Shores, you received a ballot and an explanatory cover letter in the latter part of January. The proposed change to the bylaws is to require that a person be a "member" of the Association that is, must <u>own</u> property in the Shores in order to be on the Board of Directors. In order to change this part of the by-laws and the articles of incorporation, 75% of the property owners must vote "yes". We need every owner to vote.
- This change was recommended to the Board by a committee we appointed to review the by-laws. The Board of Directors unanimously agree with the proposed amendment. We would like to see owners vote in favor of it. But most of all, we want everyone to vote either for or against.
- As of mid-February, we've received a little over 600 ballots. The deadline for voting is April 1. If we've not received a ballot from you, we'll be calling you to encourage your vote. If you've misplaced your ballot, we have extras at the office. Please come in and get one so we can have your vote.
- Now, some thank you notes:
- Thanks to the Niguel Shores Womens Club for buying a beautiful, artificial Christmas tree for the Community Center. It will be used for the first time next Christmas.
- Thanks to the Recreation Committee for buying two concrete trash containers for the beach bluff park. The Committee made a little money on their social affairs and, over the years they saved enough to pay for this very practical gift to the community.

- Thanks to Werner Richter for his generous contribution of the new street signs you see throughout the Shores. The Association provides the material and Werner provides his time and talent to do the woodwork and the painting. The maintenance staff puts them up.
- These kinds of contributions by individuals and groups are some of the factors that make Niguel Shores a great place to live.

The current "goldenrod" service permits will become <u>invalid on Friday</u>, <u>April 10</u>, <u>1998</u> and the new "blue" service permits will be implemented. For your convenience the office will be open from 9:00 am to 9:00 pm Monday through Friday.

PLEASE NOTE: Your service personnel will not be given entry to NSCA without the proper permit displayed visibly within their vehicles. There will be no exceptions.

It is the responsibility of the resident to make the necessary arrangements to turn in request form to the Association office and to make sure the passes are picked up.

#### **BOARD ACTIONS FOR FEBRUARY**



- Appointed Ian Ross to the Communication Committee.
- Accepted Phil Magwood's resignation from the Communication Committee.
- ✓ Rescinded prior motion accepting bid from M&K Masonry, then accepted bid from Morgan Augustus Masonry, Inc. for \$2,820 to install a slumpstone wall on Ports O'Call at Salvador Bay.
- ✓ Accepted bid from Trend Construction, amounting to \$3,150, to install new vinyl replacement windows in the NSCA office.
- Accepted gift of \$600 from the Recreation Committee to purchase two additional concrete trash containers for the beach bluff area and authorized staff to pay the difference of \$361.13 for the order to be placed with Quick Crete. The cost includes two new lids for the existing concrete containers.
- ✓ Accepted a survey prepared by President Jerry Milner for distribution to the Villas/Sea Terrace II homeowners asking for input regarding Garibaldi and Manta gates.
- ✓ Issued a \$50 fine to a homeowner because of a continual architectural violation upon the lot.
- Authorized staff to reimburse a homeowner \$181.13 for repairs to the home's water supply line from tree root damage. The tree was located within the Association's landscape easement area.
- Authorized staff to purchase ten replacement pool lounges for \$600 plus tax.
- Authorized staff to use Robert Fischer Plumbing on two projects within the Community Center, with the maintenance staff performing part of the work.
- ✓ Authorized staff to have WilTel install a battery backup for the office phone system. Cost will be \$1,058.
- ✓ Accepted the Nominating Committee's recommendations for the 1998 Board Elections: Jerry Milner, Don Johnston, John Buehler, Dick Brame, Gerlinda Duffy & Sid Kahn. There will be three openings on the Board.
- ✓ Authorized staff to have the City Clerk supply the Dana Point City Council meeting agendas and the Planning Commission meeting agendas, to the board

of directors at a cost approximately \$40 per year.

- Adopted policy regarding rule violation involving decaled vehicles parked on common areas overnight. Staff and Securtec will only investigate a violation after receiving a written complaint from a resident.
- ✓ Authorized a homeowner to continue making new street name signs with the dolphin below the name, for all streets within the Association. Staff will install the new signs as they are completed.

### LANDSCAPE COMMITTEE UPDATE



The extensive irrigation system installation along the lower slope on Breakers Isle should be finished. The work went well and both Wendt Landscape Service, the Landscape Committee and Board of Directors want to thank the residents of Breakers Isle for their

cooperation. We expect some new slope plantings to standardize what is on the slope, which will be starting sometime in April, weather permitting.

Several months back, the Landscape Committee decided on a change involving color plantings used within the Atlantic Garden Homes and Shores Garden Homes. Annual color was not used and Wendt Landscape was directed by the Committee to install dipladenias. These shrubs have a large pink flower. By using a perennial shrub, costs can be reduced because they should last several years. The wet weather has been hard on the shrubs during the last several months. The Committee may ask Wendt to install some annual color plants in April to improve the areas until the shrubs have a chance to become established.

The Committee is currently working with Wendt Landscape to make several changes with the plant containers at the Community Center. The changes are expected to improve the look of these containers. Resident patience is greatly appreciated.

### TRAFFIC AND SAFETY COMMITTEE



- 1. Talks are on-going with the city in regard to annexation of Mariner Road. This needs to be accomplished before work can begin on the Mariner Gate.
- 2. The bids are being secured for the Breakers Isle Gate and Guard House improvements.
- 3. The committee will review the Rules and Regulations regarding the number of parking packages issued to each household including gate passes and also review who should have access to the Shores and who can be denied entry.
- 4. The Manta gate loop function has been returned to its original configuration because of multiple damage claims. The Board is considering adding "arms" to the Manta and Garibaldi gates to discourage tailgating.
- 5. The Committee is concerned with overnight parking regulations and Securtec is encouraged to issue citations.

Do you have problems with animal control? Delores Keyes of Costal Animal Services Authority recently called to assure NSCA her agency is willing to cooperate.

Just follow these simple procedures:

- 1. ROUTINE MATTERS such as loose, injured or dead animals, call shelter at 492-1616 Monday through Saturday, 10:00 am 4:00 pm and Sunday 12:00 pm 3:00 pm. Before/After hours, call Sheriff who will contact animal officer on duty. If an animal is loose, try to tie it up and hold it.
- 2. For EMERGENCY MATTERS such as animals posing a threat, or that have bitten or mauled someone call Sheriff at any time and he will contact the animal officer on duty.

The shelter will enforce all city ordinances whether on public or private property. Volunteers staff the counter. A supervisor is also available.

#### **EL TORO - JETS OR NO JETS ?**

One of the most important events in recent Orange County History is unfolding in the media and in the courts. To Orange County residents the words "El Toro" are as familiar as "El Nino". There is a controversy!

Both sides - those favoring a massive airport and those favoring much more people friendly uses for the Marine facility at El Toro - are presenting extensive campaigns to convince the public and obtain their support.

Taxpayers for Responsible Planning (TRP) are in the forefront of those who oppose this airport. They, along with others, are developing viable, people friendly non-aviation uses for the Marine Base. They are attempting to pursue the interests of both South and North County residents in pointing out drawbacks of using El Toro as an International Airport. A few of these drawbacks include:

- l) <u>Safety</u> Both the Airline Pilots Association and the Allied Pilots Association oppose the proposed flight patterns. Who would want to take a commercial flight when even the pilot feels it is unsafe?
- 2) <u>Pollution</u> Noise and Air. Landings and takeoffs every 30 seconds during the day and every five minutes from midnight till dawn doesn't sound like an idyllic countryside not to mention the tons of exhaust from the planes.
- 3) <u>Congestion</u> Hundreds of thousands of extra vehicle trips every day on the streets and freeways of Orange County.
- 4) <u>Costs</u> Costs <u>can</u> be measured in dollars when determing the cost to bring a military airport with limited flights up to the standards required for an International Commercial Airport. But how do we measure the costs in dollars when evaluating the quality of life for ourselves and future generations?

On the other hand, the "Orange County Report" a flyer presented by the proponents of an airport at El Toro notes that this would substantially increase industry and tourism. From this publication one can see that our community is 10 miles directly down the flight approach path. It also claims, however, that quieter jets of a future generation will mitigate the noise. Donation of this airport by the government is presented as a multi-billion dollar gift to the County - sort of like the proverbial free lunch. Most of the members of Niguel Shores Community Association are aware that this Board of Directors has taken a unanimous position against the development of an International Commercial Airport at El Toro. We did so because it is our strong belief that such an expansion would have serious consequences for the quality of life and the overall property values of our Members.

We urge you to get involved in this matter that is of great importance to us all!

#### 1701 CONFLICT OF INTEREST POLICY FOR DIRECTORS (02-04-98)

Any new member of the Board will be advised of this policy, upon entering office, on the duties of his or her office.

All Directors shall exercise their power and duties in good faith and in the interest of, and with utmost loyalty to the Association and Owners. All Directors shall comply with all lawful provisions of the Association's protective covenants, By-Laws, and Rules and Regulations.

All Board Members will sign an annual Disclosure Statement at the Organizational Meeting of the new Board of Directors.

In the event a contract or other transaction is contemplated between the Association and a Director, or in the event a contract or other transaction between the Association and any entity in which a Director has a material financial interest is contemplated, the Director shall make full disclosure of the Director's interest and the facts surrounding the contract or transaction. When the Board votes on the contract or other transaction, the vote of that Director shall not be counted. Further, at the time of voting in favor of a decision involving another Director's material financial interest, a Director must believe that the transaction contemplated by the decision is just and reasonable to the Association. For the purposes of this Policy, a material financial interest in an entity is defined as a financial interest exceeding five hundred dollars (\$500.00).

Further, each Director shall comply with the reporting requirements of <u>California</u> <u>Corporations Code</u> Section 8322, or any successor statute.

Any duality of interest or possible conflict of interest on the part of any Director shall be disclosed to the other Directors at the first meeting of the Board of Directors at which the interested Director is present after the conflict of interest is or should be discovered. Such disclosure shall be made a mater of record in the minutes of the Board Meeting at which the disclosure of the conflict of interest is made.

Any Director having a duality of interest or possible conflict of interest on any matter shall not vote or use his or her personal influence on the matter, and he/she shall not be counted in determining the quorum for the meeting. The minutes of the meeting shall reflect that a disclosure was made, the abstention from voting, and the quorum situation.

The foregoing requirements shall not be construed as preventing the Director from briefly stating his or her position on the matter nor from answering pertinent questions of other Board Members since his or her knowledge may be of great assistance.
