# FROM THE HELM

As you probably are aware, Niguel Shores Community Association is issuing new blue vehicle decals for our cars These are to replace the windshields. vellow stickers which have been in existence for many years. I cannot stress enough the importance of going to the office and getting your new stickers installed. The deadline is May 19 which seems like a long way away, but here we are, and it is April already. All of us are interested in security, among other reasons. That is why we live in a gated community. After May 19, the Board will have a dilemma because it will need to enforce in some manner the proper display of the correct sticker. Needless to say, it will be easier for all involved if each of us gets these stickers changed in a timely manner.

The Manta and Garabaldi gates are progressing on schedule; the target completion is April 18. As of this writing we are on schedule. There have been a few mid-course corrections for minor items but

overall the project seems to be progressing well. As you are aware, the new gate technology will permit the use of our present key cards as well as a garage door type opener (digital transmitter) such that you do not have to open your car window to operate the gate. The cards will be handled as they always have and your present card will work.

As you are aware, we have been planning to resurface the streets on the west side of Selva. The Board has obtained three bids but, due to inconsistencies in the bids and the size of the job, felt it to be prudent to retain a professional to evaluate how this job should be done. This report has been finalized and we are going to re-bid the job making the necessary modifications to the bid package. We are sorry for the delay, but believe the end result will be better for the community.

# CHANGES IN CALIFORNIA LAW WILL ADD COSTS TO DELINQUENT HOMEOWNERS

As of January 1, 1997, the California Legislature has enacted a change in California Civil Code Section 1367, Lien for Delinquent Assessments. The change in the law requires the NSCA office staff to perform additional steps in the placement of a lien upon a delinquent homeowner's property. Several of the steps require the Board of Directors attorney's office to obtain the grant deed of the homeowner's property; to file the lien, to release the lien when payment is received. Unfortunately, these extra steps, mandated by the California Legislature, will cost the delinquent homeowner approximately \$100 of additional costs if a lien is placed upon the property. In addition, the recording costs for the filed Lien and Release of Lien have been increased by the County of Orange.

It is unfortunate the California Legislature does not realize how their actions increase costs to homeowner associations. This Association has no choice but to follow the strict mandates of the law and to pass the costs on to the delinquent homeowner. To avoid the problems of this revised law, all homeowners should pay their assessment on time. The quarterly assessment is due on the first day of the quarter and will be delinquent if not paid by the end of the month. An assessment statement is mailed out to be paid in the months of January, April, July and October. The Association collection policies are clearly listed in the yearly budget mailing you receive in the month of November.

# HOMEOWNERS ARE RESPONSIBLE TO REMOVE WEEDS IN DRIVEWAY

It is important for homeowners to remember they are responsible to keep their driveways clean from oil debris and to remove weeds. All homeowners have an obligation under the CC&R's to maintain their property in a neat and clean condition.

Several homeowners within Sea Terrace I and II, Atlantic Garden Homes and Shores Garden Homes believe keeping their driveway free of weeds is the responsibility of our landscape contractor, which is not correct. Our landscape contractor will not enter upon any driveway to remove weeds, either by hand or with chemical spray.

# SKATEBOARDING, ROLLERBLADING AND BIKE RIDING ARE NOT PERMITTED AT THE COMMUNITY CENTER

Parents need to discuss the Community Center Rules with their children. Under the Rules, skateboarding, rollerblading and bike riding are not permitted within the Community Center parking lot, tennis courts or within the building areas. Frequently, children ride into the Center and go down to the locker rooms. Going past the windows of the MPR is dangerous if they fall or are pushed toward the windows.

The office receives continual complaints from residents because they are forced over when walking or children nearly collide with them. This situation is going to result in a serious injury in the future.

At this point, the office staff is left with obtaining the names of the children breaking the Rules. Many have been told by

staff not to do these activities, yet ignore the warnings. Thus, hearing letters will be sent to the parents of children who continue to break the Rules. At the time of the hearing, the Board will decide if the situation is serious enough to issue a fine to the parents.

It is hoped by the Board and staff that parents will take the time to discuss this issue with their children so that the hearing step is not necessary.

- ✓ Authorized staff to dispose of old files listed in a memo dated 2/24/97. Board wanted only those files that were older than 1/1/96 disposed of.
- homeowner after it was determined the office staff erred in listing the wrong for the assessment mailing address statement.
- staff to issue Authorized reimbursement check for \$495.65 for punctured tires at the Breakers Isle entry gate, provided a release of claim is signed by the individual.
- Reviewed language submitted by the Maintenance Committee/staff, then authorized staff to purchase new signs for each vehicle entry gate and to remove the old, duplicate signs.



During the month of April, Wendt Landscape will be making improvements to the landscape at the Community Center. All of the improvements will be in and around the parking lot. The plan for improvements has been under review by the Landscape Committee since early 1996. This plan entails the removal of the remaining Eucalyptus trees near the tennis courts, the Coralloides tree next to the entry to the parking lot, and several areas of turf will also be removed. New shrubs, trees and ground cover will be installed, along with several concrete mow curbs. This plan contemplates the installation of the proposed "Dolphin" statue.

During April, the following work will also be completed:

Custom Homes - Heavy trimming of the Myoporum shrubs will occur on the lower Breakers Isle slope above the beach. Areas with "holes" in the shrubs will have new shrubs planted to fill in. At two street corners along Niguel Shores Dr., new landscaping will be installed, using Flax, Day Lilies & Honeysuckle.

Sea Terrace II - Work will continue on the Selva slope and La Cresta slope. Removal of Asparagus Fern and Fescue will be completed. Those bare areas that require additional Myoporum Pacificum will receive them. Some old Acacia will be removed on the La Cresta slope, with Myoporum Pacificum used to fill in. This same type of work is on-going on the interior slopes that surround the Manta park greenbelt. Once the existing Honeysuckle begins to look good, the last remaining Escallonia shrubs will be removed. The Committee plans to use some Rhaphiolepis "Majestic Beauty" shrubs to replace the Escallonias.

All Areas - The shrubs and turf will be fertilized.

Staff has received the completed proposed plan for relandscaping the strip of land between the Shores and the Hotel, along Cabrillo Isle/Seaward Isle. This plan will be discussed with the hotel staff in the coming weeks. It is hoped this work will occur this summer.

The Landscape Committee would like residents to know there is a serious problem with the rabbit population on the west side of PCH. Many of the new ground covers are being eaten by the rabbits just after planting. They also like the grass as evidenced by the rabbit droppings all over the beach bluff and the entry to Breakers Isle. Wendt Landscape does not have to mow the beach bluff area because the grass is "mowed" by the rabbits. The office staff and the Landscape Committee have heard from residents complaining that items in their yards are also being eaten. There is consideration on taking steps to control the number of rabbits.

Residents are reminded that children under 14 years of age must be accompanied by an adult, even when the lifeguard is present.

# RESIDENTS MUST FOLLOW **RULE 3125 - WASTE WATER** DISPOSAL FOR POOLS, SPAS, PORTABLE SPAS, ETC.

The office staff has become aware of several residents in the community who empty swimming pool waste water by pumping it onto the Association's common area, such as the surrounding landscaping or the streets. Under Rule 3125, residents are to pump their waste water through their This is also a home's sewer system. requirement under the Plumbing Code, which is enforced by the City of Dana Point, Code Enforcement Office.

Whether you have an existing pool, spa, etc., or are considering the installation of one, your contractor/maintenance service provider must install a minimum three inch P-trap in the home's sewer line and connect the disposal pipe, from the equipment, to the P-trap. For those who are considering a pool/spa installation, please seek the approval of the Architectural Committee before any work is commenced.





#### 1401 Appeal of Committee Decisions (02-01-85)

Any owner of real property who has made application to any committee of the Association may appeal the decision of the committee to the Board of Directors, as follows:

- A. Give written notice to the Board of such appeal within a 60 day period after the date of the notification of the disputed decision and including the following information:
- 1. Name, address, telephone number of owner.
- 2. Legal address of real property affected, if any.
- 3. Name of committee to which application was made.
- 4. Date of application to committee.
- 5. Date of committee action.
- 6. Committee's decision.
- 7. Owner's statement, in detail, of the purpose of his/her application to the committee.
- B. A hearing shall be set by the Board of Directors not more than sixty (60) days from the date of receipt by the Board of the owner's notice of appeal. The meeting shall be held at the Association's office.
- C. The Board shall give notice to other interested parties not less than ten (10) days prior to the date of such hearing.
- D. The owner shall have the right to representation of his/her choice, including legal counsel.
- E. The hearing may be open or closed, at the discretion of the owner.
- F. The hearing may be recorded at the discretion of the owner. The cost of such recording and the preparation of any transcript from a recording shall be borne by the owner.
- G. Prior to the hearing, the owner shall have access to all relevant and material Association records.
- H. The owner shall have the opportunity to cross-examine any witness presented by the Association.
- I. The owner shall have an opportunity to present evidence at the hearing.
- J. The Board's determination after such hearing shall be in writing, setting the reason(s) for such determination.

#### 1301 Motion Identification (05-01-85)

The names of Board Members making, seconding, or voting on motions will not be mentioned in the minutes of the meeting unless so requested by the Board Member.

#### **1311** Approval of Minutes (05-01-85)

- A. Between Board Meeting #1 and #2, the final draft copies of the minutes of meeting #1 will be distributed to the Board Members by the recording secretary.
- B. At Board Meeting #2, the recording secretary will note any corrections made by the Board.
- C. If no corrections are made, the minutes will be signed by the Board Secretary and filed in the Minute Book.
- D. If any corrections are made, the recording secretary will retype the corrected page(s) and redistribute the minutes to the Board Members. The corrected minutes will be signed by the Board Secretary and filed in the Minute Book.

#### 1315 Deferring Board Action (05-01-85)

When a proposal is made for (a) a significant policy change or (b) an expenditure of non-budgeted funds of over \$1000, such proposal will be made at a Board meeting and, upon the request of any Board Member, action will be deferred until a subsequent meeting.

#### 1320 Notice of Special Meeting of the Board of Directors (03-05-97)

The Board of Directors holds its regular monthly meetings in the multipurpose room at the Community Center on the first and third Wednesday of each month, except for the months of May and December during which it holds its regular meeting only on the first Wednesday of the month. NSCA members can review the Seashore News calendar to confirm the date and time of the scheduled meetings.

Except for Executive Session or Emergency meetings of the Board, the notice of the date, time, and place of a Special Meeting of the Board will be given to NSCA members at lease four (4) days prior to the meeting, either by printing the date, time, and place of the meeting on the Seashore News Calendar,or by posting a written notice of the meeting in the glass cabinet case located on the outside wall behind the pedestrian entry gate to the Community Center. The notice will be given pursuant to California Civil Code Section 1263.05(g).

#### **5221 Policy** (06-30-92)

The Seashore news shall not be used as an instrument for promoting the point of view of individuals or organizations showing a preference regarding political, religious, ethnic, or racial issues.

#### 5222 News Articles, Announcements and Reports (06-30-92)

News articles, announcements and reports are limited to those of the NSCA Board; NSCA Club announcements and reports; news of community activities; and manager reports. Articles may be submitted only by residents or owners, on forms supplied by the office and are limited to 250 words. See Rule 5221.

Submissions must include the writer's name and telephone number. Typing is preferred, but handwriting is acceptable if it is neat and legible. The committee members read each item to assure that the subject is acceptable, the language is clear and grammatically correct and that it does not exceed the work limitation. An attempt will be made to discuss questionable articles with the writers before approval.

#### **5223** Deadline for Submissions (06-30-92)

It is planned that the News will be distributed on or before the first of each month. Therefore the submission deadline is the 17th of the preceding month. Late submissions will be accepted only if the chairman determines that the article is important and that it will not delay publication.

#### **5224** Voice of the People (03-19-97)

Letters to "Voice of the People" are restricted to residents and owners of Niguel Shores property on subjects of general interest to the community. Writers may submit letters for consideration for publication with the understanding that opinions contained in letters that are published are those of the writers, not necessarily of the Committee. Letters which, in the opinion of the Committee or Board of Directors, may invade the privacy of other individuals, subject the Association to potential liability, or otherwise be in bad taste, will not be published. The writer's address and phone number must accompany their letters and only the names of authors will be published with their letters. Letters are limited to 200 words. See 5221.

5225 Neighborhood Ads (05-04-94)

Only residents or owners of Niguel Shores property may submit ads. No ads are allowed which offer any type of SERVICE. No one may act as AGENT for another person or company. No commercial products may be advertised.

#### ACCEPTABLE ADS:

- 1. Personal goods held for personal use.
- 2. Real property including rental of same.
- 3. Personal announcements.

Length of ads is limited to 30 words including phone number. Payment is made by check to NSCA. See office for current advertising rate. All ads must be submitted on or with a signed form supplied by the office. All ads are read and approved or disapproved by the committee.

**5227 Production** (06-30-92)

Submissions are edited and proofread by the committee and finished copy is then pasted up with artwork by volunteers. Copies are printed by an outside firm and are collated and stapled by NSCA volunteers.

5228 Distribution (06-30-92)

The Niguel Shores area of 960 family homes is divided into ten districts and the NEWS is delivered to an area coordinator in each district who maintains a team of block chairpersons to deliver the NEWS to house slots or under garage doors, if possible, or out of sight. Postal laws prevent placing the NEWS in mailboxes. Extra copies are mailed to homeowners living outside Niguel Shores; the remaining issues are kept in the office during the month.

No other material shall be distributed with the SEASHORE NEWS except with the approval of the Board.
