which has culminated in a personnel manual for our Association. This is something we've needed for a number of years. Now our employees know what we expect of them and what they can expect of us, and we meet the requirements of state and federal laws.

- Good job, guys, and thank you.
- At our meeting on March 18, the Board accepted our architect's draft proposal for the renovation of the Mariner gate. The plans are displayed at the Community Center. If you would like to make a comment or suggestion, we would appreciate it if you would do so in writing, and this will be a topic for discussion at the evening Board meeting on April 15. The Board wants to know what you think about this proposal and we would like to have, in writing, any alternative suggestion.
- When you receive this newsletter we will know the results of our three-month effort to amend the bylaws concerning the qualifications to be a member of the Board of Directors. Hopefully, we will have secured the 720 "yes" votes on the issue. As I write this, we are very

close. Properly, it's not easy to change our bylaws and articles of incorporation, but this is an issue that has needed attention. I'll stick out my neck and thank everyone who voted "yes." I'm certain the amendment has passed.

- The next major issue is the annual election of members of the Board of Directors. Soon you will be receiving a ballot. This year there are three seats of the five seats on the Board open for election. The five people who serve on this Board have a great deal to say about how their community of over 2000 people live. It is an important discussion on your part. Please give careful consideration to the candidate and vote. In my opinion, if you don't vote, it's difficult to justify a complaint with the Board in the future. This is your chance to make a difference.
- We've been considering some kind of a party to recognize and thank all the people who volunteer their time and effort to make the Shores a great place in which to live. So far we've identified, by name well over 100 people, and a good number of them are involved in more ways than one. I want to take the opportunity to thank each of you, not by name (that would take the whole issue) but when you receive your invitation to whatever we decide to do as recognition, consider it as a sincere thank you from the Board, and from every owner and resident in Niguel Shores.

BOARD ACTIONS FOR MARCH



- ➤ Fined a homeowner \$100 for a continued architectural violation.
- Fined a homeowner \$50 if the architectural violation was not resolved by a specific date.
- ➤ Denied a homeowner's request to waive a late charge because extraordinary circumstances were not provided.
- Reviewed the preliminary re-design for Mariner Dr., completed by Architect Marshall Ininns. Staff has posted the plans at the Community Center for viewing by homeowners. Written comments, if any, are due in the office by April 13.
- Authorized staff to complete the rewiring of the Kara Bay coach lamps, using conduit and copper wire to replace the aluminum wire. This street is a test to see what it will cost to complete wiring replacement and will be applied to other streets.
- Accepted the bid of \$9,200 from Trend Construction to complete further remodel work in the Women's locker room. The remodel plan was designed by Architect Marshall Ininns with input from the Board and several homeowners.
- ➤ Accepted the bid of \$14,247 from Custom Concrete Coating to resurface approximately 50% of the pool deck.
- ➤ Appointed the following homeowners to the Election Committee for the May Annual meeting: Bob Borland, Linda Ross, Terry Scott, Skip Eissfeldt and Jack Christiansen.
- Authorized staff to print and mail a new survey to all homeowners regarding the use of locking devices on community perimeter gates and at the Community Center. Survey responses are due in the office by April 13.
- ➤ Authorized staff to have Saddleback Valley

Ornamental Iron add additional fencing on either side of the pedestrian gate leading into the upper beach parking lot, near the Breakers Isle vehicle gate. Cost for the work - \$665.

LANDSCAPE COMMITTEE UPDATE



The Board of Directors has completed an easement agreement with the Ritz-Carlton Hotel involving the landscape strip between Cabrillo Isle/Seaward Isle and the hotel's

boundary wall. Since the hotel was built, the hotel's staff has maintained this landscape strip and irrigated it because part of the strip is owned by the hotel. As many homeowners in the custom homes know, the maintenance has been somewhat poor. With the agreement completed, our landscape contractor is maintaining the area.

The first step in the transition is to disconnect the hotel's water from the irrigation system, then connect it to our reclaimed water supply. Fortunately, there is an unused reclaimed water meter at the intersection of Cabrillo Isle and Seaward Isle. However, the change in wiring from our nearest irrigation clock to the valves will require the street to be cut and later patched.

Later in April, Wendt Landscape will implement a conceptual planting plan put together by the Landscape Committee with the assistance of Dale Hadfield, a Landscape Architect. The general plan uses large shrubs along the hotel's wall to screen it and the buildings, with colorful shrubs in front of the large ones. A portion of the replanting will be paid for by the hotel. It is hoped all work will be completed in April.

With summer coming, new color plantings will be installed around the community sometime in May.

During April the following projects will be completed:

- Honeysuckle to the Stonehill slope.
- ✓ Improve the upslope along Capstan Dr. by adding thirty-five 5-gallon shrubs.
- Remove the remaining Escallonias on the slope along Selva Rd.[below Sea Terrace II] and replant with (Myoporum Pacificum) as ground cover and thirty-five 5-gallon shrubs.
- Remove the remaining Escallonias on the slope along La Cresta [below Sea Terrace II] and replant with (Myoporum Pacificum) as ground cover.
- within the Manta greenbelt.
- Add approximately thirty-eight 1-gallon Agapanthus plants on the north side of the Villas greenbelt, between Vista D'Onde and Vista D'Oro.
- ✓ Remove the remaining nineteen Evergreen Pear Trees in the Villas and replace with fifteen 15-gallon New Zealand Christmas Trees. This work will complete the three year project.
- ✓ Add twelve 15-gallon Melaleuca shrubs behind parking bays along Via Capri.

The office has received a few requests from residents that the Association's coral trees are blocking views. Once these trees are finished blooming, estimated to be sometime in May, Wendt Landscape will begin trimming all coral trees.

HOMEOWNERS ARE REMINDED TO MAINTAIN/REPAIR THEIR HOMES

All homeowners are reminded that they are responsible for maintaining their homes by painting, landscaping and making repairs in a timely fashion. This requirement also applies to walls and fences that surround the home. Failure to maintain your property will cause the Board to issue fines, or in extreme cases, take legal action.

The above matters also apply to those that live in Sea Terrace I and II. Upon review of the community, since the winter storms have arrived, staff has noted wooden utility doors have been damaged and wood fences are leaning/fallen and require replacement. Please make the necessary repairs/replacements so that enforcement action by the Board is not necessary.

PROJECTS WILL REQUIRE CLOSURE OF POOL AND WOMENS LOCKER **ROOM**

The Board of Directors has accepted bids from contractors to complete two projects. Staff is trying to arrange the projects to occur at approximately the same time, after Spring break. scheduled for April 11 through April 19. Look for posters providing specific closure dates at the Community Center.

The renovation work planned for the womens locker room will take approximately two and one-half weeks to complete. The installation of a new pool deck surface will take approximately one week to complete. The current plan calls for both the pool and womens locker room to be closed at the same time. The demolition work can occur in the first week along with some of the remodeling work. Staff will attempt to have the Womens locker room partially open the second week for limited use. After the first week, staff will try to have the contractor start

after 10:00 am, thus allowing the early morning swimmers limited use of the locker room. Again, posters will be put up at the Community Center advising when the facilities can be used.

ANNUAL MEETING SCHEDULED FOR MAY 19

The annual meeting to elect three board members is scheduled for Tuesday, May 19, 8:00 pm, in the Community Center MPR. Look in your mail for the annual Meeting notice and proxy that is scheduled to be mailed by staff to all homeowners by April 6. If you have not received the mailing by April 15, please call the office and request another notice and proxy be mailed to you. Proxies should be immediately returned.

Please review, sign and date your proxy then return it in the envelope provided. PLEASE DO NOT INCLUDE YOUR **OUARTERLY** ASSESSMENT **PAYMENT** IN ENVELOPE! Every year this happens, and the homeowners will be assessed a late charge because the service center did not receive it for deposit. When the proxy envelope arrives at the office, it is not opened by staff. All envelopes are held until the Election Committee meets on Monday, May 18 and then they are opened. All assessment payments are to be mailed to our service center in Santa Ana for processing and must be received by April 30.

HOMEOWNERS SHOULD UPDATE OWNER DECLARATION

When homeowners purchased their homes, they had to check in at the office after the sale closed. When they checked in, staff asked you to fill out an owner's declaration form which provided the office staff with necessary information.

All homeowners, both on-site and off-site, should contact the office for a New Owners Declaration Page. It has become very apparent to staff that the information on many homeowner declarations is out of date. Please contact the office, Monday through Friday, 9:00 to 5:00 pm, and staff will assist you by either mailing or faxing the form to the homeowner. When the form is returned, staff will update the computer records. Phone numbers are very important so that staff can contact you, particularly if there is a problem with your property. Homeowner cooperation is greatly appreciated.

BOARD WILL BE WORKING WITH ARCHITECT ON REVISED DESIGN FOR TORII GATES


Homeowners who are in either Atlantic Garden Homes or Shores Garden Homes drive under the torii gates every day. For many years, these wood structures have endured trucks rocking them and several gates have been ruined because of trucks. The Board has signed a contract with an architect to come up with a redesign of the structures by raising the clearance of the structure to equal what CalTrans uses on freeway bridges, approximately 14'-9". Raising the structures will necessitate having a structural engineer do new calculations on the materials to be used. The other weak part of the original design is the 8x8 wood posts which are

buried directly into a concrete foundation. Both insects and drainage [moisture] cause damage to the posts, weakening them. Thus the architect will explore using hollow steel posts that will be covered with wood.

The Board's goal with this work is to have a design that will assist in cutting the Association's costs to maintain the structures over the years and keep trucks from damaging the structure. The architect will also explore using the beams and decorative cross beams as part of the rebuilding process. Hopefully, the Association can have the structures rebuilt with the existing reserve funds. This redesign work will take several months to complete.

Going Out? Remember these baby-sitting tips!

Often when considering Crime Prevention, we think of material possessions that belong to us, things we can lock up or secure. But Crime Prevention should extend to even more valuable treasures: our family. Here are some tips to consider when choosing a baby-sitter, or when baby-sitting yourself:

 Choose baby-sitters you know or who have been recommended by someone you trust. Try to avoid answering advertisements for sitters.

Explain what you as an employer expect from the baby-sitter. Know how much the sitter charges and when they

must be home.

- Always leave an emergency contact number. Include a list of allergies, medications or special instructions for the baby-sitter. Inform a trusted neighbor that a baby-sitter will be staying with your children while you are out.
- Explain how your door and window locks function. If you have an alarm, demonstrate how to operate it.
- Find out if the baby-sitter has been trained in First-Aid and CPR.

For the baby-sitter:

- When your employers return home, report on what happened, especially if you noticed anything unusual.
- Be sure you have an escort home. This should be one of the conditions under which you accept any baby-sitting job.
- Have your employers make a safety check with you throughout their house.
 Find out if their home has emergency exits, a smoke alarm, and a fire extinguisher.

Check and Credit Card Fraud Consumers beware!

In an age when monetary transactions are increasingly being conducted electronically, consumers are learning that crime evolves along with technology.



Dana Point Police Services would like to inform residents of new crime trends in an effort to protect you and your property. The

following information should decrease your chance of becoming a victim:

 Check your credit cards frequently to make sure that they are in your

- possession and have not been taken or switched. The fewer cards you have, the easier it is to know their whereabouts.
- When ordering checks, ask for an estimated day of arrival from your bank. If they are late, notify the bank as soon as possible.
- Do not have your drivers license number pre-printed on your checks. This ensures that the merchants will ask for proper I.D., which deters would be criminals.
- Keep a personal record of all account numbers, including cancellation numbers. This list should be located in a safe place, yet be accessible.
- Do not carry a written form of any personal identification numbers in the same location as credit cards or ATM cards.
- Closely check each monthly statement against your receipts.
- Always sign the back of all credit cards. Additionally, you can write "Check ID" next to your signature. This will clue the merchant to ask for a second form of identification.

What Happens Now???

No one looks forward to becoming a crime victim. In fact most people are of the belief that crime is something that happens to someone else. In the unlikely event that you become a victim, the following few paragraphs should help you through the very difficult time to follow.

Often in the first hours, days, or weeks after a crime has been reported, a victim may be confused about what happens next. A deputy might be expected to call and keep the victim informed about the case. This normally will not happen unless there are unusual circumstances.


Normally the deputy will take a report at the scene. The deputy will write the report and

submit it to a supervisor for approval. The report will be forwarded to the Investigative Division. Your case will be assigned to a specific investigator, within 3-5 working days, who specializes in your type of case, such as: burglary, assault, auto theft, or fraud.

If there is workable suspect information, the investigator will continue to work on the case. If there is no workable suspect information, the investigator will contact



Support Services. Reports are not available at City Hall or the Aliso Viejo Substation.

Sheriff's Department at 770-6011, and ask for

If you have additional information to add to your report, you can contact the investigator at 425-1900.

Dana Point Police Services knows that being the victim of a crime is often very traumatic. The legal procedures involved can be equally frustrating. If you have any questions, please feel free to call the Community Support Unit at 248-3580. One of the Deputies will be happy to answer your questions.

House numbers & 911

In the event of an emergency, normally you would call 911 for assistance. The dispatcher will send the appropriate help to your location. Sometimes the response time of the Fire Department or Police Services can mean the difference between life and death. Frequently when we arrive on a street we find that the house numbers are missing or obscured from view.

Do not rely on numbers painted on the curbside! A parked vehicle or trash can can obscure those numbers from view. Make sure that you have clearly visible house numbers on your home. Any delay in our response time can be fatal.

As a free service to the residents of Dana Point, the Volunteers in Police Support are currently surveying homes while on patrol. If they find that your home address is not visible, or missing altogether, they will leave you a notice advising you of that Dana Point Municipal Code Section 8.01.001 requires that you have clearly visible house numbers.

O.C. Check Thieves Target Mailboxes



Mail theft has, unfortunately, become a popular crime in the past few years. This is particularly true in South Orange County due to the large numbers of curbside mailboxes.

The most common theft is from the curbside mailbox. Thieves are looking for outgoing checks being mailed and incoming blank check deliveries and credit card deliveries. Theft by breaking into mail trucks is also on the rise.

The thieves commonly will use chemicals to alter the completed checks so they can cash them. They also try to write several checks

from a new check delivery, or make several charges with a charge card, very quickly. More often than not the criminals will rack up several thous and dollars in cash



and merchandise before you even know that you are missing anything.

Straightening that sort of mess out, after the fact, can be extremely frustrating at the very least. Here are some things you can do to protect yourself:

- Always drop outgoing mail off at the Post Office or a secure mailbox, rather than your unsecured curbside box.
- Try to pick-up incoming mail as soon as possible after it is delivered.
- If possible, have your new checks and credit cards delivered to a secure mailbox.

If you suspect that you are the victim of mail theft or fraud, immediately call: Dana Point Police Services, The Post Office, and your bank or credit card company. The sooner we are all aware of the problem, the better chance we have of putting a stop to it and hopefully apprehending any offenders.

Calling 9-1-1 for serious emergencies.....When to call, what to expect.

9-1-1 is the number to call to get help when there is a life threatening emergency. Examples would be: fires, serious accidents, medical emergencies, dangerous crimes in progress, or anytime someone's life is in danger.

When you call 9-1-1, your call will be answered by a Sheriff's Department dispatcher. The dispatcher will ask about the emergency and then immediately dispatch help from the Fire Department, Sheriff's Department or Highway Patrol. If you are in doubt about whether or not an emergency exists, call 9-1-1.

When you call 9-1-1 from most phones, the dispatcher can tell where you are calling from. Cellular phones are answered by the Highway Patrol and your location IS NOT DISPLAYED, so you will have to tell them.

When calling 9-1-1, try to be calm. Provide the dispatcher with as much information as possible and try to answer all of the questions. This allows us to send you the help you need as quickly as possible Always let the dispatcher hang-up first, stoon the phone until they do.

Teach your children the appropriate use of the 9-1-1 system. Inappropriate use of the 9-1-1 system results in a system overload and can prevent people, who have a legitimate emergency, from getting the help they need.


