Last October we launched our Niguel Shores Emergency Preparedness Program. We sent a package of material to each residence. In that material was a registration form that we asked to be returned to the office so we'd know—in case of an emergency— where there would be residents who might need help, and we wanted to know which residents would be willing to help their neighborhood.

So far about 200 households have responded—that's only about one fifth of the community.

We all understand it's not easy to get enthusiastic about emergency preparedness when we've never experienced an emergency in Niguel Shores and when we cannot believe we will ever have such an emergency. But the fact that the situation is a complete surprise and occurs over a short period of time is what makes it an emergency. The time to prepare for it is now — before it happens.

Perhaps you read the newspaper article three or four weeks ago about the fact that seismologists have just discovered a major earthquake fault running south from Long Beach right along the ocean front—right in front of Niguel Shores. The article said that they do not think it is a threat, but every time you go to

San Juan you can see the Mission that was destroyed in a quake about 200 years ago. We do need to be prepared.

The Ad-hoc Emergency Preparedness Committee feels that perhaps the registration form in the Emergency Material packet was confusing and too complicated. So they have designed a new form. At the back of the Seashore News is the new form -on yellow paper. If you have already returned the original form, you need not complete a new one. But if you haven't responded yet, please complete this simpler form and return it to the office. None of us know when this information might be important.

On another subject— we've recently had several questions about the street sweeping in the community. Further on in this issue you will find an article explaining the system we use and why. With almost 14 miles of streets to keep up, this is a big job, we want you to know how it is done.

#### MARCH BOARD ACTIONS

- ✓ Appointed Pat Long to the Landscape Committee as the Sea Terrace II representative.
- ✓ Appointed Dan Johnson and Gigi Blume to the Recreation Committee.
- ✓ Accepted the proposal from LaBelle Marvin for pavement engineering services involving Broadmoor Homes for \$3,500. This work is needed before asphalt overlay bids can be obtained.
- ✓ Accepted bid proposal from Anchor Paving to work with NSCA maintenance staff to install conduit and patch asphalt for rewiring of the coach lamp fixtures on Salvador Bay, Brisbane Bay, Montego Bay and Sidney Bay. Work is to be scheduled in the months of April and May. Cost will be approximately \$23,383.
- ✓ Accepted proposal from Jim's Welding to fabricate ten double fixture coach lamp arms costing \$1,121. Seven of the arms will be used to create coach lamp lighting along Mariner Drive.
- ✓ Authorized staff to complete purchase of Mariner Gate resident lane barrier gate from Lincoln Security and bar code reader.
- ✓ Authorized staff to have the infected eucalyptus trees along Magellan Isle removed. This will include all eucalyptus along the street because it is only a matter of time before all begin to die out. The Board and Landscape Committee are reviewing what species of tree to use as replacements.
- ✓ Accepted the Nominating Committee's recommendations for Board candidates:

- Andrew Boush, John Buehler, and Robert Enger.
- ✓ Accepted bid from The Dove Companies to modify three torii gate structures, amounting to approximately \$6,600. These structures have been recommended for modification by an outside inspection company because they are not safe. During April, the structures to be changed are Kara Bay, Bluehill Bay and Nauticus Isle. The heavy tops will be removed, side posts cut down and new post tops added. The existing coach lamps will be remounted.
- ✓ Accepted proposal from CTA Pool Service to: drain pool, acid wash plaster, remove existing single 7hp pump motor and replace with three 3hp motors. Work will cost approximately \$3,915.
- ✓ Authorized the ad-hoc Torii Gate Design Committee to expend up to \$2,000 for design services from a licensed professional.

## STREET SWEEPING OF THE COMMUNITY'S STREETS

Questions have been raised by several residents as to what Wendt Landscape Service is responsible for when "sweeping the streets." Street sweeping has been a problem throughout the years with several contractor changes and different equipment being used. Under Wendt Landscape Service, both the Board and staff believe we are receiving greater service and sweeping. The streets are swept once per month, on the first Monday of each month, unless a holiday forces a change in schedule.

The truck used by Wendt is a vacuum truck, not a sweep truck. This equipment has a vacuum intake bar in contact with the asphalt surface that picks up light/loose debris. It will not pick up gravel, rocks, algae, water, etc. It will pick up dry, light debris, which includes sand and some



dirt. In the month of March, Wendt Landscape took nearly four tons of debris to the dump.

The way the streets are swept was changed approximately three years ago. Currently, two men with blower backpacks walk in advance of the vacuum truck, blowing debris in the gutters out into the street. This also includes the common area parking bays. The vacuum truck makes several passes over the asphalt surfaces, but does not go into the gutters because the dry, light debris has been blown out onto the street. Further, if the truck uses its side rotating brush in a wet, dirty gutter, all that will happen is a mess will be made, which will generate resident complaints. The truck is not designed to move water, mud, algae, etc. Those areas that are heavily impacted by standing water/algae are cleaned by Wendt Landscape Service nine times per year by brooming and flushing before the vacuum truck is used.

The Board hopes this explanation clarifies how the streets are swept.

## MARINER ENTRY/EXIT GATES TO OPEN IN APRIL

In early April, most of the construction work will be done and residents will be able to return to utilizing Mariner gate as before. There have been several articles written in past Seashore News about changes that will be utilized by Lincoln Security Service, such as the "PIC" [personal identification code].

An important change involves the double entry lanes of traffic that continues to funnel down to one lane after you pass the iron swing gates. Residents will have a separate lane for entry that will require the use of a keycard. If a resident is entering without a keycard, then you must use the guest lane. The iron swing gates will be open during daylight hours and closed during night

time hours. This policy will lessen the wear and tear on the gate motors.

Residents will notice that each entry lane is controlled by a barrier gate arm. Under the gate plan desired by the Board of Directors, ONLY ONE GATE ARM may be raised for traffic to pass at a time. Thus, if the guest lane gate has been opened by the sentry, the resident lane barrier gate will not open and allow the resident to enter. When the guest lane barrier gate closes, the resident will be able to use their keycard to open the gate to enter. This staggering will allow vehicles to be separated as they merge into one lane.

There is no stop sign at the Mariner Drive intersection with Niguel Shores Drive. Those entering the intersection from Mariner have the right of way. Vehicles on Niguel Shores Drive, at this intersection, have stop signs and warning signs advising vehicles to yield to incoming traffic from Mariner.

Residents need to be patient when using the resident entry lane because of the situation described above. Again, only one vehicle may pass through the entry gate at a time.

## LANDSCAPE COMMITTEE UPDATE

Pat Long will be the new area representative for Sea Terrace II replacing Marie Gibson. We would like to thank Marie for all the time and effort she gave to the Landscape Committee.

There were three items remaining in Old Business from February and they are being addressed now.

Seventeen Homeowner Requests were reviewed. Two of the requests are private property matters; the Landscape Committee does not handle these requests. Five of the requests have been completed. Their area representative is answering the others or the Landscape Contractor is doing them this month.

The committee reviewed plans and ideas regarding the landscaping at the Mariner Gate

entrance, prepared by a landscape architect. Also, Dick Wendt's planting schedule for February. There were nine items for February and all have been completed but two. These will be done as soon as the plants are available.

In March there are seven areas of planting scheduled. Three have been completed, one is ongoing, and the rest will be completed near the end of March if the plants are available.

The committee is well aware of the rabbits feeding on our newly planted landscape. The General Manager has pest management bids coming in for control in our common areas so we hope to have the matter under control before the rabbits take control.

The Landscape Contractor has sprayed for the giant aphids that have attacked the hibiscus plants several times. In some instances we will be replacing these plants with different shrubs.

Many eucalyptus trees along Magellan Isle are bleeding because o an attack by borers. The bleeding is the trees natural defense system. Several of the trees are dead/dying and require immediate removal. The Board of Directors has decided it is in the best interest of the Association to remove all of the eucalyptus and replant approximately eight to nine trees in May.

## TRAFFIC & SAFETY COMMITTEE

- 1. Final recommendations were made on the new Gate Passes and given to the Board. Some format changes were also made.
- 2. The Committee gave some recommendations that certain homeowners would be notified about parking violations and storage in garages. They will have 30 days to comply. Parking issues involving tenants will be the owners problem.
- We discussed various options for access of non-residents who participate in NSCA activities. We decided on an action that

- could be uniformly used by various organizations.
- 4. Immediate family members of non-resident owners residing in the property will be treated as tenants and receive tenant identification for vehicles.
- 5. The Mariner Gate will start asking for identification codes now to get residents used to the idea and to alert others of the need to have a code name for calling in guests.
- 6. Lincoln has been authorized to start towing vehicles with multiple citations.
- 7. Friday Night is party night at the Beach Parking Lot and Lincoln has been asked to patrol the area.
- 8. Residents must all have a "code" when the New Mariner Gate opens for use. PLEASE COME BY THE OFFICE IN REGARD TO THIS!
- 9. There was no vandalism during the month of February!




#### **SHORES BLOTTER**

#### RESUME OF ANDREW BOUSH

## COMMUNITY CENTER POOL NEWS

NSCA has hired a lifeguard who will be on duty during Spring Break from 1:00 pm to 6:00 pm daily starting Saturday, April 3 through Sunday, April 11.

<u>PLEASE NOTE</u>: children 6 years of age and younger must be accompanied by an adult, even though the lifeguard is on duty. Everyone must wear appropriate swim attire and must shower off before entering the pool area. Wetsuits or diapers are not appropriate swim attire. No toys or floating devices are allowed in the pool.

Following Spring Break, the Community Center pool will be closed during April for repairs for about a week and a half. The pool will be closed on Monday, April 12.

The pool will be drained and the pumps will be replaced. Then the pool will be acid washed, refilled, filtered and chlorinated.

## TO EVERYTHING THERE IS A SEASON...


The primary purpose and intent of the general plan for the community, as established by the CC&Rs, is the preservation of natural views from all members' lots. Article VII, Section 1, gives the Tree View Blockage Committee the right to require any member to remove, top, trim, or prune any shrub, tree, or hedge which the Committee believes *unreasonably* impairs the view from any lot. To keep trimming costs to a minimum, the Committee suggests homeowners bear in mind that trees or shrubs might be trimmed below the stated maximum height so that normal growth will not require re-trimming more frequently than once every six months, or even once a year.

Specifically, Rule 4111 states: "All trees and shrubs shall be trimmed, pruned, and topped as necessary to remove any growth, either lateral or vertical, which unreasonably interferes with the

view from any other home site." These guidelines are general and do not limit the responsibility and authority of the Association to adjust the guidelines to specific situations.

NOTE: Association common area trees are not subject to the same rules as private property trees, but the Landscape Committee does listen to your requests.

As we come into Spring, trees and shrubs start to sprout, and bloom and shoot up and out. With all of the rain we had last year, and all of the sunshine we had this winter, please take a few minutes and look at the landscaping in your yard. As things warm up, your neighbors will be spending more time outdoors enjoying their views, and that is whin the Tree View Blockage Committee gets very busy. Any help you can offer by being proactive will be appreciated. Thank You!




#### **WOMENS CLUB**
