#### FROM THE HELM

The most important item to report in this issue is the fact that the amendment to the by-laws and to the articles of incorporation passed. We needed 720 "yes" votes and the six members of the ballot committee validated 726. The by-laws and articles now state that a person must be a "member" of the Niguel Shores Community Association, i.e. own property in the Shores, in order to be nominated for and to serve on the Board of Directors. We received a total of 760 ballots, and I thank each of you, on behalf of the Board, who took the time to vote. And especially I thank the 28 people who made telephone calls and knocked on doors to get out the vote in the last four weeks.

And regarding the survey you all received about five weeks ago, the response was very good. We received 559 completed questionnaires. The numbers were significantly in favor of limiting access at the beach bluff gate, 488 yeses; at the community center it was 475 yeses; at the Mariner gate it was 451 yeses. The use of a proximity device received 397 yeses. Whether we use a card or a fob was essentially even, 257 compared to 234. The question about the number of cards or fobs, of course, showed more diversity, one per adult received 245, one per resident up to 4 received 207, and one per resident up to 6 received 101.

At the Board meeting last Wednesday evening, after much discussion from Association members

and among the board members, some decisions were made. First, we will install a proximity device at the beach bluff gate as soon as possible. Second, we will install a proximity device at the community center, but the gates will be unlocked (at least to begin with) from 9:00 am to 6:00 pm. Third, we will put off a decision concerning the Mariner gate until we finish the new gate. And by the time you read this, a couple of board members will have met with a group of members to talk about how many cards or fobs to give out and how to go about it. We'll keep you informed.

Speaking of the Mariner gate, that too, was on the agenda. There were only a few comments, pro or con, concerning the conceptual drawing that was posted at the community center for the past month or so. And there were a few new suggestions for us to consider. The Board will now work with the architect to further refine the design and, I'm sure, the "new Board," will have another evening meeting to discuss the plans before they go out to bid.

You notice I emphasized "new Board." Yes, it's time for our annual election. Each of you should have received a ballot early in April. We need to have 481 properties represented by proxy (your ballot mailed in) or in person at 8:00 pm on Tuesday, May 19, in order to hold the election. As I write this in mid-April we have 324 ballots returned to the office. If you haven't voted yet, please do. It's very important to you and to the Shores.

#### **BOARD ACTIONS FOR APRIL**



Accepted ten submitted roof cover materials approved by the Architectural Committee for use by homeowners.

wishing to re-roof may select from these manmade material types or submit a new material.

- ➤ Directed two policies in the employee handbook to be altered to match current practice.
- ➤ Denied the Landscape Committee's request to remove a coral tree on Garibaldi, between Gourami Bay and Vista Grande, because the Board felt the tree was not an unreasonable view blockage problem.
- Approved the request from the Recreation Committee for a tennis social event, on the tennis courts, for Sunday, May 17.
- ➤ Accepted the resignation of Linda Ross from the Election Committee and appointed Peggy Bucci, Ann Christiansen, and Ceacy Johns to the Election Committee.
- ➤ Directed staff to purchase proximity locking devices for the beach parking lot pedestrian gate and the community center access gates from Mako Systems, Inc. The cost for this project will be approximately \$16,528.
- Accepted the final draft of the 1997 NSCA Audit completed by Gary Porter, CPA. Staff was directed to mail a copy to all homeowners, by April 30 as required by the California Civil Code.
- Accepted the bid from Eric Jon Berger Construction for the renovations to the Breakers Isle entry/exit gates. Estimated cost for the work, payable by the Breakers Isle homeowners, is projected to be \$66,397.
- ➤ After review of a total of three legal services proposals, the Board decided to stay with Dick Fiore's law firm, Fiore, Walker, Racobs & Powers, Irvine.

#### POOL AND WOMEN'S LOCKER ROOM WILL CLOSE IN MAY FOR REPAIRS AND RENOVATIONS

Staff has finalized the contract to make repairs to the pool deck. Starting Monday, May 4, the pool area will be completely closed. An outside company will come in and sandblast a portion of the old deck to remove it. Then the company will apply a new surface of several layers. The Association can only afford to complete about half of the deck, and fortunately the outer half is still in good shape. It is expected that the pool will be closed for two weeks. Look for a poster at the community center providing the opening date.

The Board is also going to have the Women's locker room renovations done at the same time as the pool deck. Thus, starting Monday, May 4, the Women's locker room will also close for the work to begin. This work is projected to take approximately three weeks to complete. As of now, April 20th, it is expected that the locker room will be completely closed for use the first two weeks of the project. Once the majority of the work is completed, it is expected that the locker room will be open from 7:00-10:00 am for the early morning swimmers. The construction crew will start after 10:00 am and work until the evening. It is hoped the women's locker room will be usable from 6:00-9:00 pm once we are into the last week of the project. Again, please look for a poster at the community center providing the women's locker room schedule.

### BREAKERS ISLE GATE RENOVATION PROJECT

The NSCA Board has accepted the bid from a general contractor to complete this extensive project. Staff estimates that the work may start sometime in June and may take two months to complete. Staff will try to maintain work hours of 8:00 am to 5:00 pm, Monday through Friday. Weekend work will only be approved by staff if it is absolutely necessary.

The actual work should only affect the residents on Breakers Isle. They must watch for traffic control because only one side of the gate will be open at a time. Residents in the area will be affected by equipment noise, and for that we apologize.

Staff will include updated articles in future issues of the Seashore News.

#### MARINER GATE PRELIMINARY DESIGN

The Board received some input and suggestions from residents at the April 15 meeting. The final gate design will be discussed with the architect in May. Staff was able to obtain a colored elevation drawing of the swing gates and pilasters that are behind the gate station building. The drawing has been posted at the community center for resident review.

Staff estimates the gate design will be finalized in May so that construction drawings can be put together for bidding. The "new" Board may decide to discuss the final design at the June board night meeting. It is projected by staff that the Board will know what the new design will cost by the first meeting in August. Staff does not expect work to start before this fall.

# LANDSCAPE COMMITTEE UPDATE



Last month, a lengthy article was included which outlined improvements that were to start in April. Several of the projects will carry over into May for

completion. Please be patient while the work is on-going and keep in mind that the Landscape Committee is trying to improve aspects of the overall look of the community.

During March, the office received several inquiries as to why Wendt Landscape does not mow every week in the wintertime. Under the contract, Wendt Landscape, starting in mid-November, mows every other week because the turf does not grow in cool weather. This cost savings is reflected in our yearly contract. It is estimated that the cost to mow, edge and dispose of the cuttings is approximately \$3900 to \$4000 each time the service is performed.

In mid-April, Wendt's mow crew begins weekly mowing every Monday.

During the latter half of May, Wendt Landscape will begin trimming the large coral trees throughout the community. The trimming will be severe; however, the trees will begin to leaf out almost immediately.

Also during the end of May, Wendt Landscape will be making improvements to the color plantings. Some areas will receive ivy geraniums and others will receive burgundy and white *impatiens*. These new plantings are expected to last until November.

Sometime at the end of May or early June, Wendt Landscape will begin the yearly trimming of the *rhaphiolep*is shrubs. They should be through their yearly "pink" bloom and ready to be thinned out. This project will take approximately two months to complete. Wendt Landscape will trim these shrubs in all areas of the community.

# TRAFFIC AND SAFETY COMMITTEE



- 1. Fence wings on the Breakers Isle beach lot pedestrian gate have been installed and painted green to match the rest of the gate.
- 2. Visitor's Day Permits will not allow re-entry after 12 Midnight. The permits will still be valid for parking until 2 pm the next day if the vehicle does not leave Niguel Shores Community Association. Guests will need to be called in for a new pass the next day if the visitor plans to stay past 2 pm.
- 3. Henceforth, the Association will not decal vehicles with commercial signs of any size or type without an appeal to the Board and their authorization.
- 4. During late May, the maintenance staff will be installing new concrete street lights in Broadmoor Homes. The existing light fixtures will be used on the new poles.
- 5. The Security Contract has been sent out for bid. Residents are asked to submit written comments on the current contractor.

#### THE SHORES BLOTTER

- 1. There were skateboard incidents on March 13, 14, 15, 17, and 20, and twice on March 14 and 18. In all cases the young people, when informed of the rules regarding skateboarding, complied with the officers requests. They did not know of the rules.
- 2. On March 14, a Cox employee damaged his tires when he attempted to follow someone through the Selva gate. A realtor's car was damaged by the Garibaldi gate when following another vehicle.
- 3. There was an accident on March 14 on Niguel Shores Drive and the sheriffs arrived. Both occupants had been drinking; one had an arrest warrant, and two children in the car were not using seat belts. Both subjects were arrested for property damage, felony DUI, and child endangerment.

# MARINER GATE DECAL LANE IS ONLY FOR THOSE WITH HOMEOWNER/RESIDENT DECALS

It has been noticed by the Mariner gate personnel and management that visitors with guest passes or special entry permits are using the residents decal lane for entry. Please advise your guests that they cannot use this lane for entry.

The sentry must look at the guest pass or special entry permit to verify whether it is valid. Some guests and homeowners have complained at the office that they or their guests should not have to wait at the gate if they already have a pass. However, they are not homeowners or residents and must go through the guest lane. It is impossible for the sentry to read the pass from eight to ten feet away.

Homeowners/residents are asked to cooperate and advise their visitors of this policy.

## MARINER GATE POSTAL CHANGES

The USPS collection box at the Mariner gate will be moved to the flag pole "island" in the community center parking lot during the month of May. The permanent relocation of the box is necessary due to the anticipated changes in the new Mariner gate.

The box will be relocated and positioned so that vehicles can drive up to the box and the driver can place mail in the collection box without leaving the vehicle.

Also, the Dana Point postmaster has indicated that the pick-up times will be changed allowing for a later pick-up of either 3:30 pm or 5:00 pm. The collection times will be posted when the box is relocated.

#### **COMMUNITY CENTER RULES**

The summer season is here again and the community center will again be buzzing with activity. As a reminder, here are a few rules for using the community center:

#### **COMMUNITY CENTER**

- All persons using the facilities MUST sign in.
- No pets allowed.
- No bikes, skateboards, or skates allowed.
- No glass containers.
- Proof of membership or guest status may be required.
- Guests using the facilities must be accompanied by a resident, or be registered at the office by the resident.

#### SWIMMING POOL

- No one under 14 years of age is allowed in pool area without parent or lifeguard supervision.
- Adult swim only from 7:00 to 9:00 am and 12:00 to 1:00 pm. No children in pool area during this time.
- Shower before entering the pool.
- Hair at or below shoulder length must be banded.
- No food or gum in pool area.
- No floating apparatus or objects of any kind are permitted in pool.
- Swim suits must be worn in pool.

#### **JACUZZI**

- No one under 18 years of age allowed in jacuzzi area. NO EXCEPTIONS.
- Shower before entering jacuzzi.
- No smoking in jacuzzi area.
- No food or beverage in jacuzzi area.

#### **OUT-OF-AREA OWNERS:** WEEKEND STAFF HAVE LIMITED ABILITY TO ASSIST YOU

Owners who do not live here full-time should contact the business office staff, Monday through Friday, 9:00 am to 5:00 pm, to obtain answers to questions. This should be done prior to a weekend arrival!

The clerks who work after hours and on weekends monitor the community center. They conduct business. cannot They cannot change/update your records. Examples of transactions that they cannot help you with are: obtaining a new vehicle decal, issuance or exchange of gate key card, checking in a new owner/tenant, changing "No-Call" card at Mariner Gate, etc.

# VACATION HOME SECURITY CHECK

At no cost to residents of the City of Dana Point, Police Services will provide vacation home checks while residents are out of town.

They will provide a physical check of a residence to insure that no windows or doors have been left open, etc.

When residents require a vacation home check, they are to call the Laguna Niguel Sheriff Substation at 249-5200 and give the following information:

\*Name, address, cross street, from what date to what date they require the service.

\*Who to contact in case of an emergency (name, address, city, area code plus telephone number and relationship) and whether this person has a key to the home.

\*Any other pertinent information, e.g. a gardener comes on a certain day of the week, any pets, name of anyone who will have access to the home during the resident's absence, any car left in the driveway (license, make, or color), and any other information which will help secure the home.
