FROM THE HELM

The pedestrian gate access system is about to be activated. A flyer giving the activation date and a description of how to use your card or fob will be mailed. It is really quite simple, but it will take some getting used to.

We expect to start construction on the new Mariner Gate sometime in August. The changes that will be made will entail some congestion and perhaps some short delays in coming into the community and/or exiting. Please be extra careful after construction begins because of the changing traffic patterns and because of the workers in the area. I, for one, will be using the Selva gate or the Ports-O-Call/Cabrillo gate for coming and going most of the time. Our guests, of course, will have no choice but to continue using the Mariner Gate. You may want to alert them to the fact that there is construction going on.

Now that we have completed the planning for the Mariner Gate, we are ready to start on the Ports-O-Call/Cabrillo gate. The first draft of the plan for the new gate at that location is posted at the Community Center. Please take a few

minutes to look it over and if you have any suggestions, please put them in writing and send them to me at the office.

At our evening Board Meeting on August 19, we will have a discussion concerning the Ports-O-Call/Cabrillo gate design. Please come and give us your ideas.

After we consider your suggestions, we will display a final plan for three or four weeks and then go out to bid. We want to start construction on Ports-O-Call/Cabrillo as soon as the construction at Mariner gate is completed.

Also in the near future we will be paving the streets in the Atlantic Garden Homes. Our consultant has done some coring in several locations and is doing an analysis of the soils under the streets. Based on the data from these tests, the consultant will write the specifications for the paving company to follow. Since the streets in this area are culde-sacs, there will be some inconvenience for a day or two as each street is paved. We will do our best to keep you informed and minimize the disruption.

BOARD ACTIONS FOR JULY

- Accepted the bid from Anchor Paving for patch work involving the re-wire project on four additional Atlantic Garden Homes streets. Bid was approximately \$9,998.
- ✓ Authorized staff to proceed with rewiring of an additional four Atlantic Garden Homes streets. Streets will be trenched, conduit laid, backfilled and asphalt laid so that all coachlamps are powered using copper wire.
- ✓ Re-appointed the existing Committee Chairpersons, including Bob Borland, Recreation Committee, and Larry Coffing, Co-chair Maintenance Committee.
- ✓ Accepted Dick Luedeke's resignation from the Recreation Committee.
- ✓ At the recommendation of the Traffic & Safety Committee, accepted the proposed Rule 6212, Skateboard Ramps, which is attached to this issue of the Seashore News.
- Appointed Lori McNaught, Gay Powers and Mollie Fields to the Recreation Committee.
- Allowed the Kids Summer Program to proceed after receiving assurances from several involved homeowners that the program can be self-funded.
- Appointed Janet Mackaig and Carroll Cox, along with two additional homeowners, to an ad-hoc committee that will rewrite the Landscape Rules and submit the revisions to the Board for review/approval.
- Appointed Jerry Moon, Don Beaver, Peter Rask, Penni Buff, Don Baer & John Concar to an ad-hoc committee to look into an emergency preparedness plan.

- Accepted the \$800 proposal from Converse Consultants to review drainage problems within Broadmoor Homes.
- Decided to make changes to the employee medical/dental/life insurance plans, resulting in a reduction of premiums. Changes are effective either July 1 or August 1.
- Accepted the bid from Saddleback Valley Ornamental Iron to replace a 4' tall wrought iron fence above the beach bluff at the end of Seaward Isle. The cost of \$1,950 will be split by NSCA and the Ritz-Carlton Hotel.

SPINNAKER DRIVE TO RECEIVE NEW FRONT YARD TURF

Starting in early August, Wendt Landscape will be killing the existing turf, installing new concrete mow curbs between the turf and shrub beds and then installing new hydroseed turf. This project will take approximately six weeks to complete, and an additional four weeks while the grass grows. When completed it will be the same as the one completed last year on Crossjack. A letter has been sent advising all Spinnaker residents about the project. Both Wendt Landscape and the Landscape Committee will appreciate residents' patience while this project progresses.

COACHLAMP RE-WIRE PROJECT TO PROGRESS

Our maintenance staff will be working on this project into August. Our staff, Wendt Landscape and Anchor Paving will be involved digging trenches, installing conduit, pulling copper wire, connecting to the coachlamp fixtures, then backfilling the trench and installing an asphalt cap. This project will cause residents some problems because they will not have use of their driveways for one or more days. Letters will be sent to the affected residents prior to the work starting.

As of mid-July, the following streets will be completed: Coral Bay, Bothnia Bay, Marmara Bay and Taranto Bay.

TORII GATE STRUCTURES NEED REBUILDING

Both the staff and the Board have been involved with Architect Marshall Ininns regarding what needs to be done with the wood structures that span the entries to the Bay streets. Marshall has informed the Board that the structures cannot be rebuilt as currently designed because the structural building codes have drastically changed in the last three years. The four wood posts that hold up the structure will have to be rebuilt using hollow steel posts. Marshall has completed a new design that currently meets the codes that will be used for bidding.

Later this summer or early fall, the Board will review bids and decide how staff will proceed with this project. It is projected that currently there is not enough money to rebuild all of the structures because of the increase in costs caused by code changes. It is expected that the worst structures will be addressed in 1998, including a new structure on Mercator Isle. Staff expects a plan will have to be created for future replacement of the remaining structures. Staff expects the Board to provide additional information in the future.

ASPHALT OVERLAY PROJECT FOR ATLANTIC GARDEN HOMES ASPHALT SLURRY PROJECT FOR VILLAS/SEA TERRACE II

Staff received the asphalt pavement engineer's report on the condition of the streets in late July, which includes the construction specifications. By the time residents receive this issue, the project should be out to bid. Staff is expecting this project to begin sometime in September and stretch into October. Once the details are known letters will be sent to all residents within Atlantic Garden Homes, advising them of the schedule. Problems developed during the asphalt overlay project in the Villas/Sea Terrace II last year, thus residents need to be flexible when changes occur to the schedule. Currently, our staff expects the work to be spread over three weeks.

Staff expects the Villas/Sea Terrace II to have their asphalt streets covered with road slurry. This is the same product the main portion of the community received last January/February. Our consulting asphalt engineer stated that the Association should wait one year before installing this product. Staff expects this project to proceed sometime in September/October. Residents will receive a letter in advance of the work that will provide the schedule. expected the road slurry work will take one day, with residents being allowed to drive on the streets sometime late the following day. During the second day, a stripping crew will have to paint all new lines.

HOMEOWNERS THAT RENT/LEASE THEIR HOMES NEED TO REVIEW THE RULES

Homeowners who rent their homes need to be aware that the individuals they turn their home over to must check in and register at the NSCA office. If you have renters who are not properly registered, they cannot use the community center facilities and will not be allowed to call in their friends through the Mariner gate. Without a decal on their vehicles, if found parked on common area streets/parking bays, their vehicle(s) will be subject to towing.

It does not take much time to fill out the form and provide a copy of the lease to the office staff. Please advise your tenants there is a \$25 registration fee and they will also have to pay a \$50 per vehicle package, with \$40 refundable upon return of the vehicle decal and keycard.

It is the responsibility of the homeowner to see that their tenant follows the rules of the Association. It is the homeowner who will have to come before the Board if a hearing is held for the purpose of suspending common area privileges and/or fine because of the tenant's continued violation(s).

Knowing the rules and advising the tenants about following the rules should keep homeowners from being inconvenienced by having to attend a hearing with the Board.



LANDSCAPE COMMITTEE



The Chairman of the Tree View Blockage Committee, Carroll Cox, was invited to attend the

July Landscape Committee meeting to discuss procedures presently used on decisions involving tree removal and trimming for tree view blockage. After the discussion it was decided an ad hoc committee be formed to review the procedures presently used by both committees and then make recommendations to the Board of Directors.

The 1999 proposed budget for landscaping was reviewed and will be presented to the Finance Committee.

Some of the proposed PCH tree planting will begin in late August.

The giant aphids on most of the hibiscus in the community have now been sprayed twice with a systemic chemical. After the chemical takes effect the hibiscus will be trimmed.

There are still four homeowner requests that have not been completed as yet, but they are not forgotten.

This month there were thirteen homeowner requests. Most have been completed.


LANDSCAPE COMMITTEE WILL ACCEPT DONATIONS TO PLANT COMMON AREA TREES

The Landscape Committee recommended to the Board that they adopt a policy to allow residents who choose to participate to contribute to a fund to purchase trees. The Board accepted the recommendation at their July 20, 1994 meeting.

Residents wishing to participate can send a check for the current cost to purchase a 15 gallon tree to the NSCA office. Our landscape contractor is charging \$61 per tree in 1998. The Landscape Committee is charged with deciding where to plant the donated tree(s) and to choose the tree type. Residents are allowed to make monetary contributions; however, all other decisions involving the trees will be decided by the Landscape Committee.

After a tree is planted, the office will notify the donor, by letter, of the approximate location.

The donations will be gratefully accepted by the Landscape Committee.



TRAFFIC AND SAFETY COMMITTEE REPORT



- 1. Mariner Gate plans were again reviewed and have gone out to bid. The contract should be awarded in August and the work could start as soon as September.
- 2. The Committee reviewed preliminary drawings for the Cabrillo Isle Gate. Lincoln Security will monitor traffic flow at the two gates and report at the August meeting.
- 3. Work on the Breakers Isle Gate is proceeding as planned.
- 4. Proximity device update: a notice will be given approximately ten days before the gates are activated. The Committee recommended that the gates be activated on a Monday and not on a weekend. Signage will give instructions for use.
- 5. The Board has received input from Lincoln Security on golf carts used in other areas and will soon implement rules and regulations of same.
- 6. The Committee requested that a reminder be given to homeowners about remembering or writing down their code word when conducting business with the Mariner gate.
- 7. There have been positive responses to the new security guards - Lincoln. The speed trailer has been effective and will continue to be used every other week at different locations.
- 8. The Committee recommended that only vehicles with decals be permitted in the lower tier of the beach parking lot.
- 9. The Committee responded to a

- complaint by a homeowner and will adjust the timing of the Garibaldi gate closure..
- 10. The Committee asked the Board to appoint two additional members to the Committee.
- 11. The Committee requested that it receive the reports of vandalism in the community and the costs of same in order to report to the homeowners.

- 1. On June 6 three boys were reminded of the skateboarding rules.
- 2. The fence by the iron gate at the beach had been pulled back to allow entry after the parking lot was closed. There were reports of a party at the parking lot the previous night.

- 4. On June 30, the sheriff was called for a disturbance at the beach parking lot. Three suspects were stopped by the police for allegedly smoking marijuana, but no incriminating evidence was found.

6605 Realtor Entry (07-01-98)

When property in Niguel Shores is for sale or rent/lease, real estate agents and prospective purchasers or tenants will be granted entry only as follows:

A. Owner Call-In

- 1. <u>Mariner Entrance</u>: The property owner may call the Mariner gate to authorize entry for a specific agent/client on the day the property is to be shown.
- 2. <u>Manta or Garibaldi Entrances</u>: Owners in The Villas and Sea Terrace II must receive the agent's call on arrival at the gate and execute entry procedures.
- B. <u>Letter of Authorization</u>. Property owners may authorize admittance in the owner's absence until the property is sold or rented/leased by submitting a Letter of Authorization to the NSCA business office. The letter shall include the owner's name, address of the property listed, and shall designate the specific real estate agent or firm to be admitted. If the property is on a multiple listing and the owner wishes all real estate agents to be admitted upon proper identification, and the letter must so state.
 - 1. <u>Mariner Entrance</u>: Gate personnel will verify authorization from the Letter on file and will permit entry. *It is not necessary* for the real estate agent/firm to call the NSCA business office in advance.
 - 2. <u>Manta or Garibaldi Entrance</u>: After entrance authorization has been verified at the Mariner Entrance by gate personnel, real estate agents/firms call the Mariner Gate on arrival at the Manta and/or Garibaldi Entrances and the Mariner Gate personnel will execute entry procedures.
- C. <u>Identification</u>. Each agent will be required to show Mariner Gate personnel his/her Department of Real Estate identification card, and to present a real estate business card upon which has been written the date of the visit and the address of the property to be shown. Only that property for which authorization has been granted shall be shown.
- D. <u>Caravans</u>. Caravans are permitted within Niguel Shores only on Thursday mornings, between the hours of 9:00 a.m. and 1:00 p.m., or at such other times as the Board of Directors may designate. Drivers of caravan vehicles must present identification as required above.

6211 Skateboards (07-15-92)

No person shall ride or cause to roll or coast any skateboard, roller skate, roller hockey or other conveyance powered by human power except a bicycle on the roadway portion of any road within Niguel Shores. Does not apply on cul-de-sacs less than 500 feet long.

6212 Skateboard Ramps (07-01-98)

A skateboard ramp is not permitted to be placed or used on sidewalks or through streets at any time, or on cul-de-sacs more than 500 feet long at any time.

Skateboard ramps must be removed from the front yard and stored away from the view of neighboring properties and streets each day by sunset, or when not in use.
