FROM THE HELM

I was hoping to write this issue of the "Helm" for the *Seashore News* as a cheerful good news article. It will at least start that way but unfortunately it is going to be a "good, bad, and ugly" presentation.

First the good. Congratulations to all who combined to make the July 4th celebration one of the best ever! I am nervous to try and single out all of the groups to thank for their participation; but I will try. Thanks to the Recreation Committee, the Family Club, the Women's Club, the Men's Club. Thanks to the numerous volunteers and special thanks to all of the parents, children and dogs who gave us a bang-up parade! The games were busy. Some of the sand castles even survived a day or two of high tides. Also, our special thanks to all those who helped that I have missed in these accolades.

Now for the bad. As many of you are aware your Association is involved in architectural litigation. This note is to bring you as up to date as we can and to advise those who had not heard of the litigation. At the June open meeting I read the litigation disclosure statement that we include with the escrow documents for home purchasers. Anyone who wishes a copy of this statement may receive one by dropping by the office. I truly wish that I could give you more information at this time but we are dealing with client/attorney privilege. Anything that we discuss with third parties (that's you) blows the privilege thus we cannot discuss it further. Consider this an early warning, however, that our dues <u>could</u> be affected.

The UGLY is SERIOUS. It has been *reported* to us that on June 26 at approximately 4:30 PM some

person or persons threw a frozen water filled balloon from our bridge over PCH. This "ice" missile reportedly struck a vehicle passing below and smashed its windshield as well as doing other damage to the interior. Fortunately the driver was not hurt. Fortunately he did not lose control of his vehicle. Fortunately there was not an accident Fortunately his children were not with him. Fortunately there was no other immediate damage. UNFORTUNATELY it happened.

Consider the implications. Just what might have happened? It has been brought to my attention that in early July a similar happening occurred on a state freeway when a brick came down from one of the overpasses. The child of the driver of that car, last I heard, was in intensive care. I am sure that none of us would purposefully hurt another in this manner; but intentionally does not enter into such mindless "pranks" when the results can create property damage, personal damage or even death. I am sure that none of us wants to be guilty or have a family member found guilty of negligent homicide.

Your Board and Management are acting as quickly as possible to determine what actions can be taken to minimize the possibility of a dangerous recurrence in our community. This investigation is being coordinated with local Cities and with Traffic Engineering experts. To properly protect your Association tall fencing all along the bridge might even be required. That is just a guess right now. We will evaluate the experts advice.

The most effective way to immediately curb such activities is for each of us individually to make sure that all member of our families and every one of our guests is fully aware of the catastrophic results that could affect us. We should also be as reasonably sure as possible that everyone that we or one of our family

members calls in on a pass is just as fully informed.

NEXT OPEN BOARD MEETING FOR COMMITTEE REPORTS IS AUGUST 16 AT 7:30 PM

BOARD ACTIONS TAKEN IN JULY

- ♦ Accepted the recommendation from the Finance Committee to adopt their policy entitled "Plant Equipment Disposal Policy." The Board adopted the policy with one or more changes.
- ◆ Appointed Phyllis Tezer to the Communication Committee.
- ◆ Appointed Jerome Nickerson to the ad-hoc Information Systems Committee.
- ♦ Authorized staff to reimburse a homeowner \$2,700 for sewer line repairs because the section of the line in question was within the common area.
- ♦ Authorized staff to have the center landscape island, behind the swing gates, modified to satisfy the O.C. Fire Authority. The island needs to be shortened by approximately six to eight feet.
- ♦ Authorized staff to bring in an engineering/geologist consultant to review a complaint of underground drainage from the common area affecting a home.
- ♦ Authorized Wendt Landscape Service to remove a eucalyptus tree near Marlinspike and Flying Jib, which the Landscape Committee supported. Cost to remove is \$175. The Board also authorized the removal of a eucalyptus tree below 24162 Vista D'Oro at a cost of \$170.
- ♦ Authorized the Recreation Committee to use the tennis courts on August 13th for a tennis exhibition.

◆ Authorized staff to accept the proposal from USIS to install surveillance cameras to monitor the bridge at a cost of \$8,170. This project will be paid using contingency funds.

STREET SWEEPING MONDAY, AUGUST 7

Please keep all cars off the streets and out of the parking bays. This will allow the sweeper to do a better job.

LANDSCAPE COMMITTEE

The first draft of the 2001 Landscape budget was presented at the July 10 meeting. Dick Wendt highlighted various aspects of the budget and answered questions from committee members. The budget will go back to the Board for further review and modification.

Year 2000 projects are nearing completion. Major activity will occur in the Atlantic Gardens area with masking utilities and improving common areas. Because this is a three-year project, not all streets will be done this year.

Wendt has scheduled slope cleanup and shrub trimming on Magellan Isle to take place in the near future.

Please remember that if you are using Orthene or some other type of systemic substance to control white flies, do <u>not</u> use it on fruit trees or vegetable plants.



In addition to the incident on the bridge, two residences on Manta Court sustained broken windows from a projectile. If you know anything, you are encouraged to contact the office or the sheriff.



- 1. Bridge Over PCH: It was reported someone dropped or threw an object over the bridge and damaged the windshield of a passing car. We as an Association may be liable for damages that occur. Insurance policies do not cover punitive damages. One solution being considered is to construct an ugly, unsightly and costly wire cage over the bridge. If you have any information on this incident, you are encouraged to come to the office or contact the Sheriff directly if you wish to remain anonymous.
- 2. Vandalism: The community continues to be hit with damage to the coach lamps, and the rear window in the Mariner gatehouse was broken. So far this year we have spent \$740 on these senseless acts.
- 3. Beach Lot: The county has completed replacement of the fence along the public walkway. This should help keep trespassers from entering the beach bluff area.
- 4. Parties: Several residents and their guests have been inconvenienced recently because they have not informed the office in advance so that the necessary arrangements for the use of community property could have been made, i.e., guest passes prepared, extra trash receptacles and electrical outlets provided. It takes only a few minutes in advance to save time and trouble on the day of the event.
