FROM THE HELM

USE OF THE POOL/SPA AND OTHER COMMUNITY AMENITIES. Some musings ... The Random House Dictionary describes community as "a social group of any size whose members reside in a specific locality, share government, and often have a common culture and historical ... "joint heritage"; have possession, enjoyment, liability"; and also as ... "a group sharing common characteristics or interests perceived or perceiving themselves as distinct in some respect from the larger society within which it exists."

NSCA is a gated community and as such strives to enjoy and protect its possessions from liability. within and without. However, no matter how exclusive a community, it is still part of society at large and subject to its rules and regulations. It can be argued, therefore, that people choosing to live in a gated essentially community subject themselves to a dual set of rules.

The special amenities supported by all homeowners

(pool/spa, tennis court, children's playground, beach bluff area, etc.) are utilized regularly by only a small percentage of residents, who, however, become attached to them in an almost proprietary fashion. Yet, they still belong to all of us and must be shared accordingly. An alternative, which is utilized by other homeowner associations, would be to maintain the amenities through special access fees; i.e., you use it, you pay for it. convinced that NSCA members do not want to go that route.

There is wisdom in the argument that different age groups have different agendas/needs, and that safety should be the overriding factor in keeping the hyperactive away from the frail. This is why we all need to work on a viable solution, such as predicate the use of the pool on activity rather than age which is discriminatory under the law (federal and state). Kudos to the Recreation Committee, which is trying to come up with a safe, mutually agreeable solution for all pool users. Please support their efforts. Continued next page

BOARD ACTIONS IN AUGUST

Appointed Bernie Fornadley to the Information Systems Committee.

Authorized the purchase of a new Dell computer, along with additional office furniture.

Accepted the Controller's recommendation to obtain a new digital postage meter and scale in October at a cost of \$125 per month.

Authorized the expenditure of \$865 to modify the transponder equipment at the Cabrillo Isle gate.

Accepted Liz Kelsch's resignation from the Recreation Committee.

Accepted the Womens Club donation of July 4 profits and directed they be given to the Recreation Committee.

Authorized the permanent use of contractor's permits contained in NSCA Rule 6601 (D) (3).

Adopted NSCA Rule 6112 Access Control Signage to prohibit residents from placing traffic control signs out. See Rule attached to this issue of the Seashore News.

Amended NSCA Rule 6407 Visible Parking and NSCA Rule 6517 Authorized Vehicles to require golf carts to be registered with the Association. See Rules attached to this issue of the Seashore News.

NEW RULES ATTACHED

New rules have been adopted by the Board of Directors and are attached to this issue of the Seashore News.

Rule 6112 concerns access control signage such as Children at Play signs. Such signage is prohibited by Rule 6112.

Rule 6407 and Rule 6517 have been amended regarding concern registering and parking of golf carts. It is now required that golf carts be registered with the NSCA business office if they are going to be used in the community.

Please place the pages attached to the Seashore News with your set of Rules and Regulations so that you will have the most current rules adopted by the Board of Directors.

LANDSCAPE

This is budget time. Each area rep has toured his/her area with Dick Wendt and proposed projects for next year. The total of these proposals plus the maintenance contract with Wendt Landscaping will now be sent to the Finance Committee.

The proposal to replant the slope between Leeward and Stonehill was discussed further. All owners in the immediate area have been sent a letter explaining the proposal, and they have been invited to attend a special committee meeting on Tuesday, September 4, at 7:30 pm to discuss the proposal.

The committee discussed revising our policy concerning plantings, done by owner, in areas eased to Association for landscape maintenance. proposed policy will be sent to the Board for approval.

The Committee handled an additional sixty-six issues.

COMMUNITY CENTER GATES TO BE LOCKED

EFFECTIVE SEPTEMBER 10

Now that school is back in session and summer is winding down, heavy use at the community center should be coming to an end for Therefore, the Board of Directors has decided to go ahead and lock the community center gates all day, everyday. The Board was convinced by various committees and through Homeowner Request Forms complaints, that there is a constant stream of non-resident foot traffic into the community and using the facilities on a regular basis.

The community center gates will be accessible only by PROXIMITY CARDS OR FOBS from 6:45 am to 8:45 pm daily. Just as you now must carry your proximity device with you to use at the beach, at Cabrillo Isle, and at Mariner Drive, you will need to carry your proximity device with you to use at the community center. The park area will continue to be accessible without a proximity device.

The NSCA Office Staff will not be available to unlock the gates for you. The gates are controlled by computer program and can be unlocked only with your proximity devices. However, the front gate will be held open for special events like Mens Club, Womens Club, and Open Board Meetings.

If you have misplaced your proximity device(s), please contact the NSCA Office Staff Monday through Friday between 9:00 am and 5:00 pm. If you need additional proximity devices for your household, please read Rule 6101 for eligibility requirements.

TIME TO RENEW 6-MONTH EXTENDED SERVICE **PERMITS**

SERVICE PERMITS for service providers and vendors, other than construction workers, will be issued by the NSCA Office for the 6-month period running from October 1, 2001 through March 31, 2002.

The YELLOW Service Permits, which expire September 30, 2001, will be replaced with NEW GOLDEN ROD colored Service Permits. The old yellow permits must be replaced no later than October 14. The application is attached to this issue of the Seashore News.

If all existing permit information is still current, you need only to complete the very top portion of the application with the resident's information, and then sign the very bottom portion of the form in the signature "box".

If this is a new request, or the service provider's information has changed since June 2001, still complete Section 1, 2, or 3 for each service provider. Each household is entitled to six (6) 6-Month Service Permits total.

Return the new golden rod colored application to the NSCA business office in person or by mail to: 33654 Niguel Shores Drive, Monarch Beach, CA 92629, or by fax to 949/831-0116. The permits may be picked up by the resident or the service provider starting October 1, 2001.

6-month Service Permits are issued to those who perform repetitive services on a regular schedule such as housekeepers, nursing care/therapy, landscape maintenance, pool maintenance, etc.

6-month Service Permits cannot be issued to employees of home-based businesses, because the City of Dana Point does not allow home based businesses which require employees other than the resident of the home.

6-month Service Permits cannot be issued for subcontractors performing construction type work on a time limited basis. Please obtain a separate application for construction type work from the NSCA business office.

SHORES BLOTTER

Early in the morning of August 7, some person(s) committed a very serious crime in our community by breaking all of the carriage light glass and bulbs plus some fixtures and lamp poles along the walkway behind the Atlantic Garden Homes. In addition, there was graffiti on the handball court and the irrigation system was damaged in the area. This senseless act will cause an expense well over \$800 to repair. If you can provide any information as to who may have done this, you are encouraged to contact the office. Remember, your response will be confidential.



TRAFFIC AND SAFTY

1. Mariner Gate. A new system is in place to provide easier and faster processing of your guests and service personnel. Be sure that your "Declaration" form is current and up to date. Information from this form was used to input the names on your no-call list as well as your service providers.

Have you changed your phone number recently? What about your emergency contact? How about your no-call guests or your service providers? If so, now is a good time to update your files in the office. It is simple and easy. You can do it in person, by mail or by FAX. Just obtain a "Declaration" form, make the required changes and return it to the office.

Community Center. Beginning Monday September 10, the gates at the community center will be locked 24 hours a day requiring anyone who desires to use the community center facilities, the pool/spa, tennis courts or the recreation center, to use a FOB to access the gate upon entering or leaving the premises BETWEEN 6:45 am and 8:45 pm daily. If you need a FOB, contact the office before the 10 so you will not be inconvenienced.

GROUP TENNIS LESSONS UPDATE AND REGISTRATION

The Board has approved the proposed group tennis lesson program. However in order to encourage the participation of young players the proposed schedule of group lessons has been changed. The lessons for older juniors, 13 and over, will be offered at 3:00pm on Wednesdays, and lessons for younger juniors will be offered at 4:00pm. Lessons for beginning adults will be moved to 2:00pm. So the tentative Wednesday schedule will be as follows:

There is no control at Garibaldi without spikes since cars can follow through by tailgating. We have also witnessed entries on the exit side of our gate after a vehicle leaves the Villas, a terrible accident waiting to happen. Polls are not an issue since residents using other entrances have not been and need not be polled.

Some homeowners are probably not aware that Garibaldi had spikes from the very beginning, and through an error/oversight, they were not replaced when the gate was renovated.

The Board has committed to spikes at the Garibaldi entrance. Let's support them and install the spikes that are a necessary and required protection of this gated community.

RULE 6112 Access Control Signage (8-15-2001)

Pursuant to California Vehicle Code 21465, no person shall place, maintain, or display upon any private property or in view of any street within Niguel Shores, any sign, device, or marking which is or purports to be an imitation of or resembles an official traffic control device, or which attempts to direct or control the movement of traffic, or which hides from view any official traffic control device.

At no time is any such signage allowed to be placed on any common areas of Niguel Shores by individuals other than those authorized by the association. An example of a sign which *is not allowed* to be posted is a "Children at Play" sign.

RULE 6407 Visible Parking (8-15-2001)

Passenger vehicles and recreational vehicles, where these vehicles are used <u>primarily</u> in the day-to-day transportation of persons, are allowed to be visibly parked:

- A. Provided said vehicle does not exceed a 135 inch wheelbase dimension or 80 inches overall height dimension (including roof-mounted appurtenances); and
- B. Provided camper shell, or other appurtenance mounted above or behind the vehicle operator's compartment (cab), does not extend more than six inches above the chassis' original roof line; and
- C. Provided the vehicle has no unsightly external rigging or appurtenances and does not carry a commercial message or logo; and
- D. Provided if the vehicle is a GOLF CART, the golf cart has been registered with the NSCA business office and a decal has been issued per Rule 6517.

RULE 6517 Authorized Vehicles (8-15-2001)

Key cards and vehicle decals/permits will be issued only to passenger vehicles and recreational vehicles (where these motor vehicles are used <u>primarily</u> in the day-to-day transportation of persons):

- A. Provided said motor vehicle does not exceed a 135 inch wheelbase dimension or 80 inches overall height dimension (including roof-mounted appurtenances); and
- B. Provided any camper shell, or other appurtenance mounted above or behind the vehicle operator's compartment (cab) does not extend more than 6 inches above the chassis' original roof line; and
- C. Provided the motor vehicle has no unsightly external rigging or appurtenance and does not carry any commercial message or logo; and
- D. Provided, if the motor vehicle is a GOLF CART: 1) the golf cart is owned by the resident and the resident can provide proof of ownership; 2) the golf cart is driven by a licensed driver; and, 3) the resident carries liability insurance covering damage caused by all drivers of the golf cart. Golf carts cannot be operated on greenbelts or walkways within the community. A "motorcycle" style decal will be affixed to the golf cart. NOTE: (A keycard will not be issued with the decal, because golf carts are not allowed to be driven on public highways, which means the golf cart will not exit any NSCA gates, and therefore will not need entry through any NSCA gates.)

TIME TO RENEW 6-MONTH EXTENDED SERVICE PERMITS

SERVICE PERMITS for service providers and vendors, other than construction workers, will be issued by the NSCA Office for the 6-month period running from October 1, 2001 through March 31, 2002.

The YELLOW Service Permits, which expire September 30, 2001, will be replaced with NEW GOLDEN ROD – colored Service Permits. The old yellow permits must be replaced no later than October 14. The application is printed on the reverse side of this notice.

If all existing permit date is <u>still current</u>, you need only to <u>complete the very top portion</u> of the application with the resident's information, and then <u>sign the very bottom portion</u> of the form in the signature BOX.

If this is a new request, or the service provider's information has changed since June 2001, still complete Section 1, 2, or 3 for each service provider. Each household is entitled to six (6) 6-Month Service Permits total.

Return the *new golden rod colored* application to the NSCA business office in person, by mail to: 33654 Niguel Shores Drive, Monarch Beach, CA 92629, or by fax to 949/831-0116. The permits may be picked up by the resident or the service provider starting October 1, 2001.

6-month Service Permits ARE issued to those who perform repetitive services on a regular schedule such as housekeepers, nursing care/therapy, landscape maintenance, pool maintenance, etc.

6-month Service Permits CANNOT be issued to employees of home-based businesses, because the City of Dana Point does not allow home based businesses which require employees other than the resident of the home.

6-month Service Permits CANNOT be issued for sub-contractors performing construction type work on a time limited basis. Please obtain a separate application for construction type work from the NSCA business office.
