RIGHTS & RESPONSIBILITIES

NSCA FORUM BOARD MEETING

Wednesday, November 19 7:30 pm

Our association is not unlike other human enterprise. Human beings—residents, management staff, committee members and the Board—may occasionally struggle in trying to balance what is right, fair and reasonable. However, our common bond is to create a community environment that promotes harmony, enhances communication, and reduces the potential for conflict.

The following basic principles related to community association living are but a few of the many that are worth noting:

Homeowners have the right to:

- 1. A responsive and competent community association.
- 2. Honest, fair and respectful treatment by community leaders and management staff.
- 3. Participate in governing the community association by attending meetings, serving on committees and standing for election.
- 4. Live in a community where the property is maintained according to established standards.

Homeowners have the responsibility to:

- 1. Read and comply with the governing documents of the community.
- 2. Maintain their property according to established standards.
- 3. Vote in community elections and on other issues.
- 4. Ensure that those who reside on their property (e.g., tenants, relatives, friends) adhere to all rules and regulations.

Community leaders have the right to:

- 1. Expect owners and non-owner residents to meet their financial obligations to the community.
- 2. Expect residents to know and comply with the rules and regulations of the community and to stay informed by reading the *Seashore News* and other materials provided by NSCA.
- 3. Respectful and honest treatment from residents.
- 4. Conduct meetings in a positive and constructive atmosphere.

Community leaders have the responsibility to:

1. Fulfill their fiduciary duties to the community and exercise discretion in a manner they reasonably believe to be in the best interests of the community.

- 2. Exercise sound business judgment and follow established management practices.
- 3. Balance the needs and obligations of the community as a whole with those of individual homeowners and residents.
- 4. Encourage input from residents on issues affecting them personally and the community as a whole
- 5. Support events that foster neighborliness and a sense of community.

We are very fortunate, in that Niguel Shores embraces and practices many of these principles in our daily interaction and management of operations, but we are not perfect. Your Board, management staff, committee leaders and committee members are dedicated, with your help, to fostering the most vibrant, responsive and competent community association in America!

BOARD ACTIONS

- ▶ The Board selected the architectural firm of Robert Borders and associates to develop a master plan to renovate the Community Center Complex for a total contract price of \$48,100.
- ► The Board awarded a contract to Converse Consultants to conduct the 2003 slope assessment study in an amount not to exceed \$6,900.
- ► Eucalyptus trees on the north and south side of Pacific Coast Highway have been removed and replacements have been planted.
- ► The Board requested a plan from the Landscape Committee to plant additional pine trees in the Mariner entry to Niguel Shores. Submittal of a plan is pending.
- ▶ Legal Counsel submitted and the Board approved an updated Litigation Disclosure Statement that advises there is no pending litigation against the Association.
- ► The Board conducted several violation hearings and imposed appropriate fines.

Board Action Continued...

- ▶ Jerry Pearl, Jack Christiansen, Boyd Van Ness and David Ontiveros were appointed to the Community Facilities Renovation *Ad-hoc* Committee by the Board.
- ▶ The Board directed Management to contact the owners of the various advertising dispensers and mail pickup boxes located at the Cabrillo entrance and request that they be removed from Niguel Shores property.
- ▶ Boyd Van Ness was appointed as a member of the Finance Committee.
- ▶ Communication Committee chair Kathy Jones, general manager Carol Porcella and Board liaison to the Communication Committee Mary Crowl have been appointed by the Board to supervise the content and administration of the Niguel Shores web site. Also appointed by the Board are Bernie Fornadley as webmaster and Forrest Owen as advisor.
- A contract was awarded to USIS for an amount not to exceed \$11,508 to install equipment that will connect the Manta and Garibaldi vehicle gates for remote controlled accessibility by the NSCA Office bringing them up to the standards of the other NSCA vehicle gates. The contract includes the cost to install fob-activated locking mechanisms at the Garibaldi pedestrian gate and one Manta pedestrian For convenience, keypad locks will be gate. installed on the second Manta gate on both sides of the gate. The code will be the same as the Stonehill pedestrian gate code. (Please call the office if you don't have the code number.) Installation is anticipated to be completed by November 15 at the very latest.

MESSAGE FROM THE GENERAL MANAGER

UPDATE ON SEA TERRACE COMMUNITY PARK - Dana Point City planning staff has advised that the Conceptual Development Plan for Sea Terrace Community Park has been put on hold temporarily until additional public input can be obtained. The matter will be brought before the City Council at their October 22 meeting. However, plans to build the new library appear to be on track. According to staff, the new library facility will be a single story building relocated nearer to the existing library.

Arnold Cordova, NSCA President, is working with local community association leaders in a joint effort to promote a "passive use" park design and to oppose any proposed commercial uses of the park. He reports that the key issues are commercial use, objectionable noise levels and increased traffic. On August 27, Mr. Cordova, along with two other Association leaders affiliated with the Dana Point Civic Association and the Monarch Bay Association, presented their views on park development to the City Council in the public hearing session and also submitted a letter "for the record."

The NSCA Board of Directors encourages residents to write individual letters to the City Council members voicing concerns and to send a copy to the NSCA office. It is important to keep a paper trail that voices the objections of the key issues by NSCA residents for future use. The Board wishes to thank all NSCA residents who attended the City's public input sessions.

City Hall advises they will keep the Niguel Shores Board of Directors and NSCA Management apprised of any new developments as they emerge. Watch for updates in coming editions of the *Seashore News* and/or special fliers if important developments warrant notice between editions.

OPEN GARAGE DOORS - I have had several Homeowner Requests recently complaining of garage doors being left open for long periods of time. So I have driven throughout Niguel Shores in the past few weeks observing for myself if this is a random matter or worthy of a few words in the Seashore News. Turns out it's worthy of a reminder that CC&Rs, Article IX, Section 6 of General Restrictions states, "When garages are not in use, garage doors shall be closed." The CC&Rs were established for the benefit of all members within the Association to assist in preserving property values in the community and promoting harmony among neighbors. Residents' cooperation in complying with this section of the CC&Rs will be greatly appreciated.

TRAFFIC AND SAFETY

- 1. With daylight savings time coming to an end, each resident should be sure to check light timer setting adjustments, especially for homes that have lighted house numbers.
- 2. Mariner Gate: There continues to be a high number of guests being turned away because no prior authorization was given for them to enter. Residents must notify the gate well in advance to allow the officers time to process guest information. Remember, residents must include their PIC identification number when calling in, or faxing in, a guest. A request is not valid without the proper PIC code.

- This plan would seriously degrade our Niguel Shores environment, health and general quality of life through: many-fold increases in traffic on Niguel Road and at the intersection in front of our main entrance resulting in noise pollution, air pollution, light pollution from putting course and amphitheater performances and traffic congestion.
- Financial burden to be imposed on all Dana Point property owners through the imposition of proposed long-term bonds, the retirement of which could add significantly to our property tax. I believe that this financial burden is particularly inequitable, as demonstrably the greatest proportion, if not the majority, of the people using this park will be either from out of the area, non-property owners (the rental complex across the street, for example), or persons without such facilities currently available to them (unlike we, who already pay for them).
