- The Board conducted several violation hearings and imposed fines.
- ➤ The Board reviewed and approved the 2003 tax returns compiled by Schonwit and Associates, CPAs.

#### **MESSAGE FROM** GENERAL MANAGER

#### MODIFIED OFFICE HOURS

In the interest of better serving NSCA residents, the Board has agreed to a 60-day trial of amended office hours commencing on August 1 as follows:

- The office will open at 8:30 am instead of the current 9:00 am opening time.
  - The office will be closed from 12:30-1:30 pm.
- The office will remain open until 5:30 pm instead of closing at 5:00 pm as is the current practice.

The new hours will allow many residents to conduct their business at the office before and/or after their work hours. During open hours there would always be a full complement of office staff available (with the exception of vacations and when an employee is ill) to better serve the needs of residents and guests.

#### USE OF POOL, SPA AND SAUNA

Please be aware of and comply with the signs that are posted at the pool and spa area. Just a reminder that food and beverages are not allowed in the pool and spa area. PETS ARE NOT ALLOWED UNDER ANY CIRCUMSTANCES IN THE POOL OR POOL AND SPA AREA. Floating devices, toys, body boards and rafts are not allowed in the pool and spa area. Swim fins, goggles, face masks and kick boards are

allowed unless conditions are crowded. The lifeguard will monitor the use of these items and may, during crowded times, request that they also not be used. Persons under 14 years of age must be under direct adult supervision at all times while in the pool and spa. Diving, running and playing ball on the deck is prohibited, and skateboards and scooters are not permitted on the pool and spa area decks. Alcoholic beverages are not permitted in the pool and spa areas and the lifeguard, office staff and/or guards may expel persons who are intoxicated.

Refer to your Rules Handbook for additional rules relating to pool and spa safety, usage and enjoyment.

#### **BEACH BLUFF DONATIONS**

If you are interested in making a donation for the furniture at the Beach Bluff, please contact the office. We are looking for donations for the benches, picnic tables and the shower. Plaques will indicate, "Donated by ......", "In Memory of .....", etc. You will be offered the opportunity to buy all or a portion of a piece of furniture. Prices have not yet been established and will be determined by the number of respondents. First come, first served.

#### CARE OF BEACH BLUFF FURNITURE

It was reported that a family reserved three of the picnic tables by stapling vinyl tablecloths to the underneath portion of the tables, their family name sheets on the edges of the tables. The staple holes have penetrated the finish and will let in moisture, causing deterioration of the new furniture. If not removed, the staples will rust and could cause injuries in the future.

There are other methods of achieving the same result of reserving a table that without damaging the furniture. One way is to bring some twine or string and wrap the table like a package. The sheet with the name can be taped to the tablecloth or slipped under the string.

We advise that you DO NOT USE any kind of tape directly on or under the tables as the sun can melt the glue onto the tables and leave a sticky residue. Please help to maintain and preserve your beautiful new furniture so that it can be used and enjoyed for many years to come.

#### ARCHITECTURAL CONTROL COMMITTEE

There are two frequent problems with applications for change that invariably delay approval at least two weeks. The first is simple: sign the application. The signature block, on the reverse of the form, is often overlooked. Secondly, for any addition, the plans must show "accurately placed outlines and locations of the houses on either side of the property" (Rule 3118 2,b) applies). Please be sure that your architect / draftsman understands this.

Finally, please note that rule 3181 allows the Association to charge a fee for those projects done without a permit, including those submitted "After the Fact."

By now, all residents of Niguel Shores have had an opportunity to spend some time down at the greatly improved Beach Bluff. ## TRAFFIC AND SAFETY COMMITTEE

- 1. If you are planning a party, be sure to provide your guest list well in advance so your guests will not be delayed at the gate. If you are expecting between 4 and 9 guest vehicles you can FAX the list, with your PIC, to the gate at 487-5432 or deliver it in person. If your are going to have a party with 10 or more guest vehicles, you MUST submit an alphabetized list, with you PIC, to the office 48 hours prior to the event. DO NOT give this list directly to the gate officer. UNDER NO CIRCUMSTANCES WILL THEY ACCEPT YOUR LIST IN PERSON. The office staff will prepare the passes in advance so that they will be ready when your guests arrive. Failure to do so will cause your guests unnecessary inconvenience.
- 2. With the summer upon us and the long daylight days, we tend to leave the doors and windows open to take advantage of the cool breezes. Beware of strangers in your neighborhood. Remember a residential burglary takes place every 15 seconds. DON'T BE A VICTIM.

There is a free service offered by the City of Dana Point under the Neighborhood Watch Program entitled "Vacation Home Security Check." You are encouraged to take advantage of this program and with the help of your neighbors and/or friends in the community you can better safeguard your residence while you are away.

1) Repair/replacement costs to maintain existing common facilities, by law, is supposed to be fully funded in the annual budgeted process as a reserve. We have a \$1.5 reserve. Why is it so under funded?

Why is the current reserve not being used to fund repairs and upgrades?

- 2) Almost all construction projects receive professional oversight but experience shows that does nothing to prevent cost overruns!
- 3) What is the source of the "several hundred thousand dollars" of funds to cover any overrun? If taken from our "reserves," they must be replaced within the year ("Davis Sterling Sec 1365.5, Para d).
- 4) Most NSCA residents have determined it costs less to upgrade their homes rather than bulldozing and build anew. Why not the Association?

Niguel Shores was once a community of retirees and weekend homeowners where people planned to live for 20-30 yrs. Many current residents have not lived here for long periods, do not plan to be here for the millennium, and make little use of common area facilities. Hence, large one-time investments do not make economic sense! And a reputation for high special assessments will not enhance property values.






