# **BOARD ACTIONS**

- ► The Board held various violation hearings in Executive Session.
- ▶ The Board approved a contract with Fence Menders to replace approximately 140 linear feet of chain link fence along the south side of the Beach Bluff with metalized wrought iron; amount not to exceed \$13,460.
- ▶ The Board approved a request for \$7,200 to purchase Shepherd hooks for installation by NSCA mainteance staff on top of the existing wrought iron fence at the foot of the Beach Bluff to keep trespassers from climbing the fence.
- ▶ The Board approved a contract with Simon Gonzales Builders for replacement of 60 linear feet of metalized wrought iron fence at the end of Bluehill Bay near the NSCA guard house; not to exceed \$4,450.
- ▶ The Board approved proposals from Wendt Landscape for replacement of landscaping at the Beach Bluff that includes new sod, additional shrubs, new sprinklers, dump fees and topsoil for a total amount of \$23,700.
- Discussion of a request to upgrade the Beach Bluff with installation of a fireplace and barbecue was tabled.
- ▶ The Board approved a contract with TNT Welding for demolition and replacement of 1,270 linear feet of wrought iron fence along the swale below Breakers Isle with vi-

nyl fence. The total for the project is not to exceed \$68,000 and will be paid for solely from Breakers Isle Reserve funds.

- ► The Board approved proposed revisions of NSCA Rule 3142 as pertaining to siding options for Sea Terrace I and II Townehomes and Rule 9501 pertaining to lateral sewer line repair. The Board authorized management to mail the proposed revisions to homeowners for their comments prior to final approval of the rules in compliance with new legislation effective on 1/1/ 2004.
- ▶ The Board discussed establishing a Welcome Committee for new residents, but tabled voting on the matter pending further discussion at a future meeting.
- The 2003 Audit Report was approved.
- ► The Recreation Committee's request for approval to plan and schedule a four-night Mexico Cruise in January 2005 was granted.
- ▶ A resolution was passed authorizing the Niguel Shores Community Center Renovation Project to proceed with a membership vote to levy a special assessment in accordance with California Civil Code 1366(b) to fund the project.
- ▶ Jack Christiansen was appointed inspector of the May 18, 2004, Annual Election with Bob Borland, Grover Brown, George Evans, Gerlinda Duffy, Ann Christiansen and Patty Therolf as Election Committee members.
- ▶ The Board passed a resolution whereby the first vice president and secretary of the Association were appointed to vote the election proxies as stated on the books of the Association for the matter of electing three (3) members to the Board of Directors and other such matters as may legally come before the members at the May 18, 2004, Annual Meeting.
- ▶ The Board approved an amount not to exceed \$3,000 for installation of a water meter and water hookup for the shower at the Beach Bluff.
- ► The Board approved a motion to authorize the cost for labor and materials to build five picnic tables with benches, five miscellaneous benches and four trash receptacles for the Beach Bluff for an amount not to exceed \$15,000.

# **NEW DISASTER GUIDELINES**

The Chair of the O.C. Board of Supervisors, Thomas W. Wilson, recently bulk-mailed new San Onofre emergency evacuation guidelines to all Niguel Shores households.

If you did not receive this information or discarded it, here are the main changes:

- 1. Effective April 26, 2004, there is only one reception center in case of a mandated evacuation: the Orange County Fairgrounds in Costa Mesa.
- 2. The radio stations providing continuous update during a Level 4 emergency have been changed.
- 3. The primary northern evacuation route has been changed so that all NSCA areas will utilize PCH to get to Costa Mesa.

I have updated our Disaster Manual accordingly. Please bring your own manual to the NSCA office and have the staff replace pages 11 and 12.

# TRAFFIC AND SAFETY COMMITTEE

Motorized scooters cruising the streets in Niguel Shores are governed by the California Vehicle Code.

CVC Section 21235 says in part:

Operator must be 16 years old.

Operator must wear a helmet.

Must ride on the right hand side of the road.

May not ride on the sidewalk except to enter or leave adjacent property.

In addition, the CC&R's prohibit riding within the Community Center or the adjacent greenbelt area.

To my knowledge, no previous Board of Directors has ever called an emergency meeting immediately prior to the election of a new Board, and certainly

not to approve or disapprove any major action that would affect the community so drastically as to cost the members \$2.5 million dollars or more for a major renovation. Such high handedness indicates an immediate need for the newly elected Board to realize that they should be listening to the voices of the residents and take into account the number of homeowners' comments at Association meetings and the many letters written to the Seashore News that have been so heavily on the side of moderation regarding the necessary upgrading of our Community Center.

A building addition at the Bluff is not possible due to special deed restrictions on the Beach Bluff lot and the Coastal Commission. Our 32 year old Community Center buildings will require over \$1 million to "fix" and we still have old buildings. There is only one proposed plan – a member-generated revision of the original plan. The Board is required by the CC&R's and Civil Code to maintain the common areas. If the Plan is rejected the Board will have to generate large amounts of funds to handle repairs which will substantially increase your annual dues.

The proposed plan was <u>professionally</u> developed over 18 months and represents hundreds of man hours spent on your behalf. Professional oversight will be used to complete the project within budget. Several hundred thousand dollars is currently available to cover any overrun.

Most of the negative comments are the same ones we heard ten years ago when the topic was entrance improvements. If we had listened to them at that time, we would still be using the old entrances. \$1.3 million to repair vs. \$2.3 million to expand and improve. The options are annual assessments or more moderate annual assessments. The choice is yours to make. Dick Mackaig


