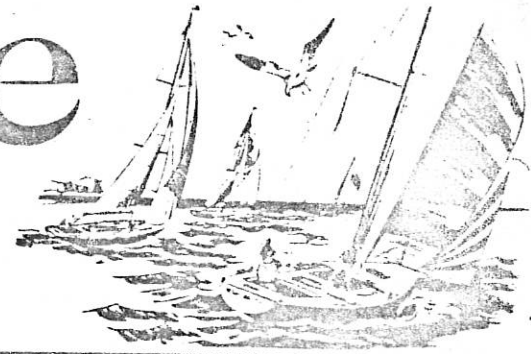
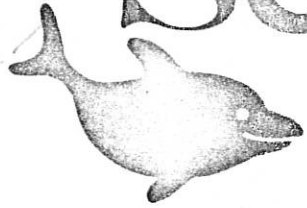


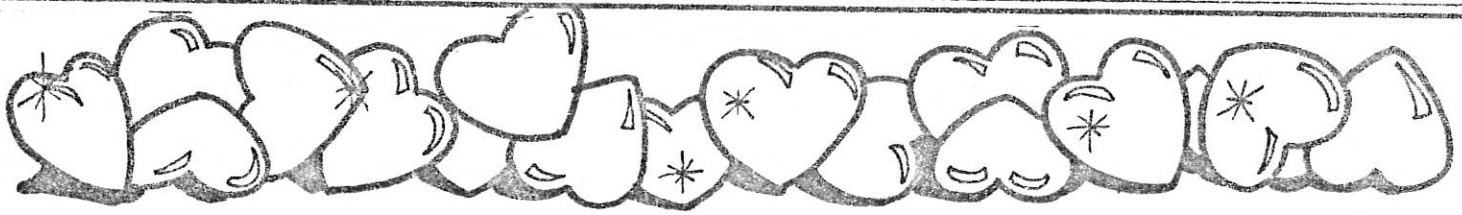

NON-PAYMENT OF ASSESSMENTS

Under Article VI, Section 3, of the "Master" Declaration of C. & R.'s the Association has the obligation to initiate a foreclosure sale of any property for which assessments have not been paid.

A foreclosure sale is basically as follows:

1. A Notice of Default is filed and a time period of three months begins to run. During this time period the default may be cured by paying to the Association the delinquent assessment plus accrued interest and all foreclosure costs.

2. Any time after three months have elapsed a Notice of Sale is filed and a time period of twenty days begins to run. After the twenty days the property may be sold at auction to the highest bidder for cash.

3. The cost of saving property from foreclosure sale after a Notice of Default is filed is not inexpensive:

A. Interest runs on the unpaid assessment at ten percent per year;

B. Lien fees are \$25.00 per quarter;

C. Filing fees are \$9.00 or more;

D. Title Reports are \$100.00 or more; and

E. Trustee fees are \$100.00.

Thus the defaulting homeowner suffers a penalty of \$234.00 or more if quarterly assessments are paid more than ninety days late. All costs and fees must be paid to stop the foreclosure sale. Payment of only the unpaid assessment does not stop the foreclosure sale.

In addition, a foreclosure may harm a homeowner's credit. TRW does not always collect data from the County Recorder's office where the notice is filed, but it does do so in some cases.

In calendar 1979, forty-one homeowners in Niguel Shores were delinquent more than ninety days in the payment of quarterly assessments and as a result foreclosure procedures had to be initiated. Thirty-two of the homeowners paid their assessments after the foreclosure was started and suffered these penalties. One exception was made when a case of financial hardship was presented to the Association. The remaining nine foreclosure sales are either in the three-month period or the twenty-day period.

Manager's Report

1. Association Quarterly Maintenance Fees - As a reminder to all residents who are either in the process of selling their homes or who anticipate selling in the near future, your Homeowners Quarterly Maintenance fees are still payable on the scheduled date. Even if your property is in escrow, it is still your obligation to make this payment. Recently, a homeowner failed to make his quarterly maintenance payment, simply because he was misinformed by a real estate agent that since he had a firm buyer and that his property was in escrow that he need not bother, and it would all be settled in escrow or when escrow closed. Failure to make this payment, even if your property is in escrow, could result in a lien being placed on your property after 60 days and default proceedings started after 90 days. If, after you make your quarterly maintenance payment your escrow closes, its better for the Association to refund that pro-rated portion rather than to have the Association lien your property simply because you felt the payment could wait. In addition, by failing to make this payment it will result in added, unnecessary expenses such as lien charges and legal fees in the long run.

2. Vandalism of Light Fixture - Recently a report was received in the office that the street light at the cul-de-sac on Breakers Isle was inoperative. When our maintenance men responded to this request it was found to have no less than four holes in the upper portion of the light fixture. These holes, no doubt, were caused by a firearm, larger than an air-rifle or B-B gun. This is dangerous to residents walking or living in the area, as well as, a case of damaging property. Anyone sighting, hearing or having knowledge of this type of incident is urged to contact the Association office immediately.

3. After several months of searching, a new Recreational Coordinator has been found. Our new director is Mrs. Rosada Noland. Rosada attended San Francisco State College with a major in Elementary Education. We all look forward to Rosada joining our staff.

4. During the past several weeks, a resident has been disposing of his trash at the intersection of Windward and Halyard. Anyone seeing or knowing who this individual is, should contact the Community Association office so that we can correct this problem.

We would like to express our thanks and appreciation to all residents residing on Taranto, Danzig, Amundsen and Tasman Bay for their patience and cooperation with the dirt, sand and rock situation on their streets while construction work is in progress correcting the water drainage problem. Also, thanks to the residents on Windjammer who look out over this construction. Work should be completed shortly on this project and the area will be cleaned up.

REMINDER - There are only two weekends left in which to obtain your new decals. Please do not wait until the very last moment!!!

1. A \$15.00 late charge per vehicle for issuance of decals will be assessed unless prior written arrangements are made through the Niguel Shores Community Association office at 33654 Niguel Shores Road and approved by the General Manager before the last "issuance" weekend (Feb. 9th and 10th) has ended.
2. All renters will be charged \$25 per set for each decal or decal and key card, refundable upon return of each item.
3. Non-resident property owners, whose property is rented to others, will be limited to no more than 2 decals total.

The current green decal must be returned at the time the new decal is obtained. However, in order to expedite the decal issuing process, we are asking that you remove your own decal and bring it along with the other required documents.

We would like to ask that all people planning on using the Community Center parking facilities during the first and second weekends of February kindly park their vehicles on the street so as to leave the parking lot open for vehicles needing new decals. This would help tremendously in expediting the decaling process. Your cooperation would be very much appreciated.

Recycling Program

Our recycler, D & J Recycling Company, has made a change in paper mills, and has requested a change in our preparation of paper for pickup. Heretofore, he has asked that the papers not be packaged by tying, but remain loose with a weight on top. NOW, IT IS JUST THE OPPOSITE. He must have the recycled material packaged, either in paper bags, cartons, or tied with string. Any containers, such as cartons will not be returned as they are needed to contain the materials for rehandling. Please do not use plastic trash bags.

However: There are a number of benefits to us that will more than make up for the slight inconvenience in changing our past habits.

Effective immediately, all types of paper are acceptable. This means that all your glossy magazines, brochures, and paper of this type can be disposed of through our recycling program. Thousands of pounds of magazine paper that formerly went into the trash can now be recycled. Telephone books need not have the covers removed, or pages torn out. The only restriction made by the mill is, NO CARBOARD AND NO CARBON PAPER.

Take a look at the "Rate per ton" shown for January 14, above. You will note that we are now receiving \$26.00 per ton instead of \$16.00. The additional tonnage from magazines, brochures, etc., plus the increase in rate per ton should result in a sizeable increase in our income from this source, and will make possible additional improvements to our community facilities, using these funds.

Now, more than ever, it behooves us to set aside our waste paper, newspapers, magazines, brochures, and even the Real Estate publications put out by the Real Estate Board for the benefit of its members. In the past we have had to reject these books because of the glued bindings, but now, we welcome them -- the more the better.

Our recycling program has taken on a whole new look, and with the help and cooperation of our residents, our tonnage should grow considerably.

One sour note has appeared in our recycling program. Someone is stealing, (Yes, I said stealing) the papers placed by our residents at their curb for our recycler. Last January 14, Mr. Leensvaart encountered a half-ton light colored pickup truck with a camper body, leaving our community loaded with papers intended for our program. The truck was driven by a blonde young woman, accompanied by a small child. A man with her picked up the papers and threw them into the back of the truck. It was after dark, about 6 P.M. and we couldn't obtain a good description of the occupants. All the papers on the first three cul-de-sacs in the Berkus Homes area, Abalone, Doşinia and Cockleshell Drives were taken before our man reached that area. He estimates that we lost about 1½ tons, a matter of about \$39.00. The authorized trucks have "D & J Recyclers" or "Newspaper Recyclers" painted on the side of the trucks, and no one else has authority to remove your papers. Please help us police this area on pickup days, and if you see anyone picking up papers in a camper, or any unmarked vehicle, please call the Community Center Office at 493-0122 and above all, get the license number.

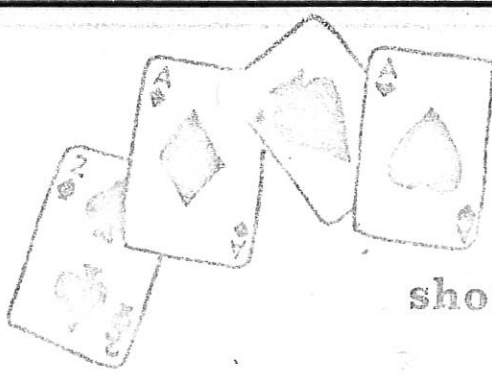
Again, thanks for your help and cooperation in this wonderfully worthwhile program.

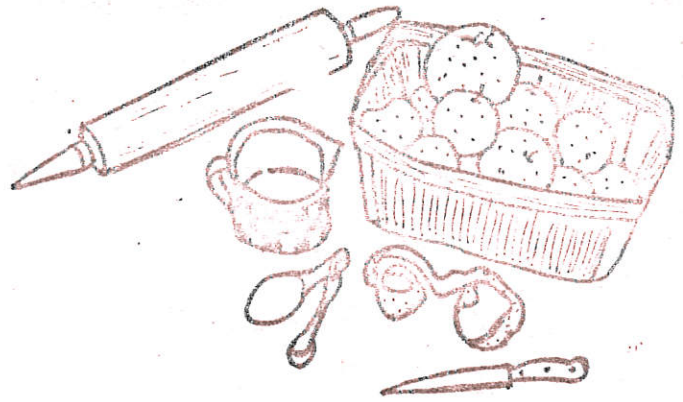

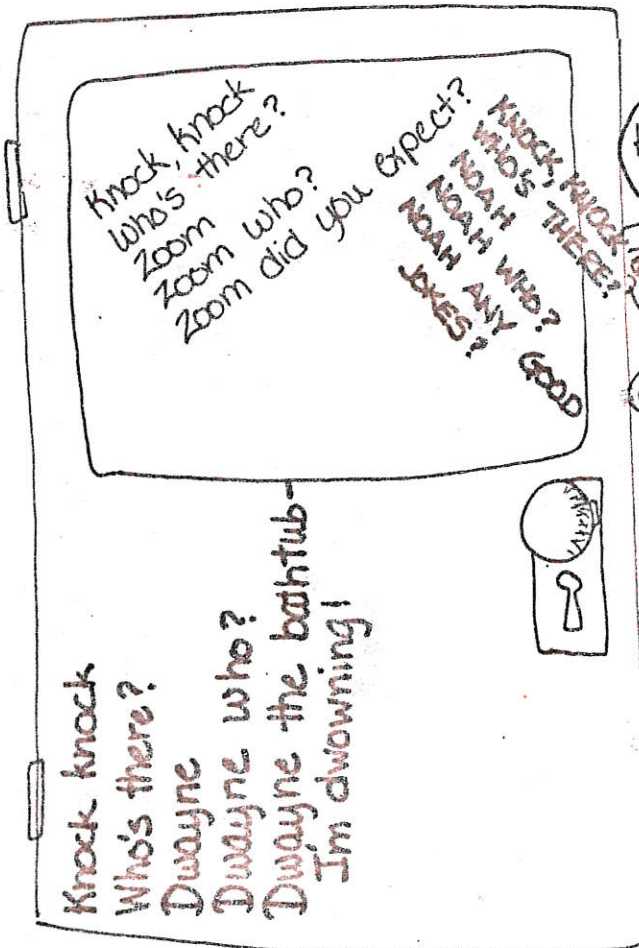

"LEMON TORTONI PIE"

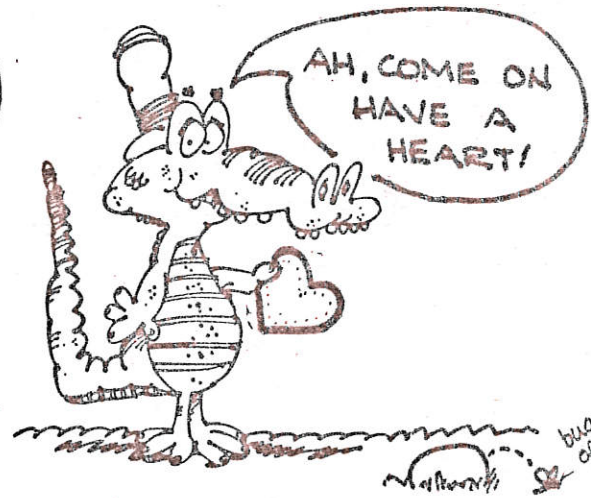

- 1 4 oz. can frozen lemonade concentrate, thawed

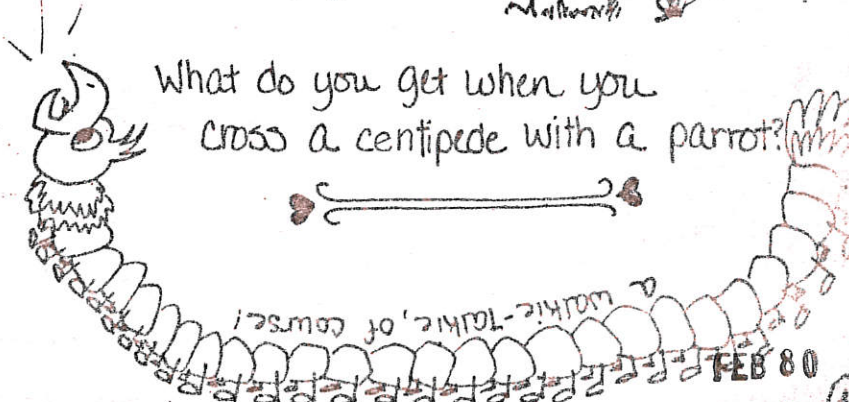
